The General Conference took note of this report at its twenty-sixth plenary meeting, on 8 November 1989.

INTRODUCTION

(1) At its first meeting Commission I, on the recommendation of the Nominations Committee, elected Mr Siegfried Kaempf (German

Democratic Republic) Chairman.

(2) At its second meeting the Commission modified the proposals of the Nominations Committee for the posts of vice-chairs and rapporteur and constituted its Bureau as follows: Chairman: Mr Siegfried Kaempf (German Democratic Republic); Vice-Chairwomen: Ms Rachida Titah (Alagria) Ms (Cecilia Gallardo do Caro (Fi (Algeria), Ms Cecilia Gallardo de Cano (El Salvador), Ms Nanzadyn Itgel (Mongolia), Ms Ingrid Eide (Norway); Rapporteur: Mr N'Tji Idriss Mariko (Mali).

- (3) The Commission went on to examine and approve the draft agenda and the draft timetable of work set out in document 25 C/COM.I/l, revised as follows: (a) items 8.1 and 8.2 of the agenda, entitled respectively 'Sexennial Report of the Executive Board on the contribution made to Unesco's activities by international non-governmental organizations in categories A and B' and 'Report by the Director-General on changes in the classification of international non-governmental organizations', to be dealt with together at the eleventh meeting; (b) the presentation of item 8.3 of the agenda 'The role of National Commissions for Unesco and their contribution to the work of Unesco' to be moved from the eleventh to the twelfth meeting.
- (4) The following items of the General Conference agenda were submitted to the Commission for consideration:

(5) The Commission examined the items on its agenda in the course of 20 meetings, held between 18 and 30 October 1989.

(6) On 4 November 1989, at its twenty-first meeting, it adopted its report setting down the decisions it had taken and listened to its Rapporteur's oral summing up of the main lines of the discussion.

ITEMS 2.1 AND 4.5 - DISCUSSION UNIT 18 -TRANSVERSE THEME 1: WOMEN AND ITEM 5.2 - UNESCO'S CONTRIBUTION TO IMPROVING THE STATUS OF WOMEN

At its second and third meetings Commission I examined Unit 18, Transverse Theme 1: Women and item 5.2 - Unesco's contribution to improving the status of women. Fifty-two delegates of Member States and four representatives of non-governmental organizations took the floor.

Unit 18 - Transverse Theme 1: Women

MEDIUM-TERM PLAN (1990-1995)

(8) The Commission recommended that the General Conference adopt the draft resolution concerning the transverse theme 'Women', proposed in document 25 C/4, Annex I, as amended by the working group the Commission had set up from among its members, which had examined <u>inter alia</u> the proposals contained in 25 C/4/DR.19 submitted by Norway, Denmark, Finland, Iceland and Sweden and the recommendations of the Executive Board set out in paragraphs 13 and 14 of 132 EX/Decision 5.1.5 and submitted under cover of document 25 C/15 Add.2 (25 C/Resolutions 108 and 109).

The Commission recommended that the General Conference approve paragraphs 439 to 451 of document 25 C/4, adding in paragraph 440, line 7, of the English version, after 'national authorities', the phrase: 'The international scientific community', and invite the Director-General to take it into account in the finalization of document 25 C/4 Approved (Medium-Term Plan (1990-1995)).

PROGRAMME AND BUDGET FOR 1990-1991

- (10) The Commission recommended that the General Conference take note of the summary of activities relating to improvement of the status of women presented in Appendix XII of document 25 C/5.
- (11) The Commission also recommended that the General Conference endorse the recommendation of the Executive Board in document 25 C/6, paragraph 112, that the summary of the activities proposed under the transverse theme 'Women' be included in the Programme and Budget for 1990-1991 itself rather than in a separate appendix.

<u>Item 5.2 - Unesco's contribution to improving the status of women</u>

(12) The Commission recommended that the General Conference adopt 25 C/DR.238, submitted by Italy, as amended by its sponsor (25 C/Resolution 18).

(13) Lastly, the Commission recommended that the General Conference take note of document 25 C/15 'Unesco's contribution to improving the status of women - Report by the Director-General'.

ITEMS 2.1 AND 4.5 - DISCUSSION UNIT 19 -PART II.C(i) - GENERAL INFORMATION PROGRAMME; CLEARING-HOUSE; STATISTICAL PROGRAMMES AND SERVICES

(14) Commission I devoted its fifth, sixth, seventh and eighth meetings to con-sideration of Unit 19, which covered three transverse programmes: General Information Programme; Clearing-house; Statistical programmes and services. Forty-four delegates took the floor, as did the representatives of four non-governmental organizations.

MEDIUM-TERM PLAN (1990-1995)

General Information Programme

(15) The Commission recommended that the General Conference invite the Director-General to take account of the general thrust of 25 C/4/DR.15, submitted by German Democratic Republic, in the finalization of document 25 C/4 Approved (para. 467).

The Commission recommended that the General Conference approve the modification proposed in paragraph 72 of document 25 C/108 (Recommendations and proposed modifications formulated by the Executive Board concerning the Draft Medium-Term Plan and Adminis-trative Plan for 1990-1995) and invite the Director-General to take it into account in the finalization of document 25 C/4 Approved (para. 469).

(17) The Commission recommended that the General Conference adopt the resolution proposed in Annex I to document 25 C/4, as modified by the Commission during its deliberations

(25 C/Resolution 117).

(18) The Commission recommended that the General Conference approve paragraphs 462 to 473 of document 25 C/4, as amended by the decisions taken concerning 25 C/4/DR.15 and document 25 C/108.

Clearing-house

(19) The Commission recommended that the General Conference approve the general thrust of the amendment proposed in paragraph 72 of document 25 C/108 and invite the Director-General to add at the end of the first sentence of paragraph 478 in document 25 C/4 Approved the following phrase: 'and without recourse to the

creation of new institutions'.
(20) The Commission recommended that the Conference adopt the resolution General proposed in Annex I to document 25 (25 C/Resolution 112). proposed

(21) The Commission recommended that the General Conference approve paragraphs 474 to 484 of document 25 C/4, as modified by document 25 C/108.

Statistical programmes and services

(22) The Commission recommended that the Conference adopt the resolution General

C/4 proposed in Annex I to document 25 (25 C/Resolution 113).

(23) The Commission recommended that the General Conference approve without change paragraphs 485 to 490 of document 25 C/4.

PROGRAMME AND BUDGET FOR 1990-1991

General Information Programme

(24) The Commission noted that Islamic Republic of Iran, sponsor of 25 C/DR.27 and 25 C/DR.28, had decided to defer them until the twenty-sixth session of the General Conference.

(25) The Commission duly noted the with-drawal of the following draft resolutions: 25 C/DR.55, submitted by Venezuela; 25 C/DR.58, submitted by Gabon; 25 C/DR.147, submitted by

(26) The Commission informed the General Conference that the authors of 25 C/DR.68 (Venezuela and Colombia) had expressed agreement with the Director-General's comments on

subparagraphs (a), (b) and (c).

(27) The Commission noted the following draft resolutions: 25 C/DR.18, submitted by Czechoslovakia; 25 C/DR.32, submitted by India; 25 C/DR.56, submitted by Venezuela; and informed the General Conference that their sponsors would submit requests under the Participation Pro-gramme for 1990-1991 in accordance with the

procedures in force.
(28) The Commission recommended that the General Conference invite the Director-General to take into consideration, in the finalization of document 25 C/5 Approved, the part of 25 C/DR.141, submitted by Bulgaria, Hungary and Yugoslavia, that suggests modifying paragraph 15033 of document 25 C/5 (the part concerning paragraph 15017 having been withdrawn by the sponsors of the draft resolution during the discussion).

(29) The Commission recommended that the General Conference invite the Director-General to take account of 25 C/DR.146, submitted by Nigeria, in the implementation of the activities

for the biennium.

(30) The Commission recommended that the General Conference approve 25 C/DR.23, submitted by Chile, Colombia, Mexico, Peru, Spain and Venezuela, which would entail expenditure of US \$55,000 over and above the budget proposed in document 25 C/5 (i.e. the budget without rein-forcement), provided that the extra expenditure could be met from the amount agreed upon for budgetary reinforcement or any other additional resources included by the General Conference in the provisional budget ceiling, or else from

extra-budgetary funds.

(31) The Commission did not endorse the amendment to resolution 15.1 (25 C/5) proposed by 25 C/DR.119, submitted by Austria. However, given the interest shown in the subject of the draft resolution, it recommended that the

General Conference invite the Director-General to take it into account in the implementation of

the activities for the biennium.

(32) The Commission did not amendment to resolutions 15.1 and 15.2 (25 C/5) proposed in 25 C/DR.57, submitted by the USSR. In the light of paragraphs 4 and 5 of the Director-General's reply, however, it concurred in the principle of establishing a Pan-European network of scientific and technical libraries, and informed the General Conference that the sponsor of that draft resolution, supported by other Member States of the Europe region, would submit under the Participation Programme for 1990-1991, in accordance with the procedures in force, a request for a meeting to be held to prepare the ground for a feasibility study on

the creation of such a network.
(33) The Commission recommended that the General Conference adopt resolution 15.1 proposed in paragraph 15003 of document 25 C/5, as modified by the Commission during its discussions (25 C/Resolution 15.11).

(34) The Commission recommended that the General Conference approve an appropriation of US \$8,186,200 for the General Information Programme, including US \$3,369,400 for the programme (para. 15041), it being understood that the figure was subject to alteration in accordance with adjustments resulting from the ance with adjustments resulting from the decisions taken by the General Conference on the provisional budget ceiling and by the joint meeting of the Administrative Commission and the five Programme Commissions.

(35) The Commission recommended that the General Conference take note of the work plan, paragraphs 15004 to 15041, as modified by the decision concerning 25 C/DR.141.

Clearing-house

(36) The Commission noted 25 C/DR.46 and (36) The Commission noted 25 C/DR.46 and Corr., submitted by the Islamic Republic of Iran, and informed the General Conference that its sponsor would submit a request under the Participation Programme for 1990-1991 in accordance with the procedures in force.

(37) The Commission endorsed the principle of 25 C/DR.5, submitted by Morocco, Belgium and Poland, and recommended that the General Conference invite the Director-General to seek additional extra-budgetary funding for

dditional extra-budgetary funding for developing CDS/ISIS and IDAMS software during the 1990-1991 biennium and to take account during the preparation of document 26 C/5 of the concern expressed by the sponsors of this draft resolution, which was shared by the Commission.

(38) The Commission recommended that

the General Conference adopt without change

resolution 15.2 proposed in paragraph 15043 (25 C/Resolution 15.12). On the adoption of the report France expressed reservations regarding the second subparagraph of paragraph 2(a) of resolution 15.2, considering that the pilot project should be deferred, inasmuch as its implementation before the results of the feasibility study were known would be feasibility premature.

(39) The Commission recommended that the General Conference approve an appropriation of US \$3,449,000, including US \$1,523,600 for the programme (para. 15059), it being understood that the figure was subject to alteration in accordance with adjustments resulting from the decisions taken by the General Conference on the provisional budget ceiling and by the joint meeting of the Administrative Commission and the five Programme Commissions.

(40) The Commission recommended the General Conference take note of the work plan relating to the clearing-house (paras.

15044-15059).

Statistical programmes and services

(41) The Commission recommended that the General Conference adopt 25 C/DR.199, sub-mitted by Federal Republic of Germany, as modified by its sponsor during the discussions (25 C/Resolution 15.131).

(42) The Commission recommended that the General Conference adopt without alteration the resolution proposed in paragraph 15061 (25 C/Resolution 15.13).

(43) The Commission recommended that the General Conference approve an appropriation of US \$4,984,200, including US \$1,403,500 for the programme (para. 15081), it being understood that the figure was subject to alteration in accordance with adjustments resulting from the decisions taken by the General Conference on the provisional budget ceiling and by the joint meeting of the Administrative Commission and the five Programme Commissions.

(44) The Commission recommended that the General Conference take note of the work plan relating to statistical programmes and services (paras. 15062-15081).

ITEM 6.11 - PROPOSED AMENDMENT TO ARTICLE 4.1 OF THE STATUTES OF THE INTERGOVERNMENTAL COUNCIL FOR THE GENERAL INFORMATION PROGRAMME

(45) The Commission, having examined the proposal made by the Legal Committee concerning the amendment to Article 4.1 of the Statutes of the Intergovernmental Council for the General

Information Programme (25 C/COM.I/3), recommended that the General Conference adopt the text of a new subparagraph (f) (25 C/Resolution

The pilot project about which France had reservations had been submitted in connection with the proposed budgetary reinforcement. As it was not endorsed by the General Conference in the vote on the Appropriation Resolution for 1990-1991, at its thirtythird plenary meeting, reference to it was dropped from 25 C/Resolution 15.2.

(46) Commission I examined the first part of Unit 21 at its eighth and ninth meetings. Fifteen delegates took the floor.

(47) The Commission recommended that the General Conference take note of paragraphs 73 and 74 of document 25 C/4 Add.

PROGRAMME AND BUDGET FOR 1990-1991

(48) The Commission recommended that the General Conference adopt 25 C/DR.217, submitted by Federal Republic of Germany, as amended by the Commission (25 C/Resolution 16.1).

(49) The Commission took note of the with-drawal during the discussion of 25 C/DR.235, which had been submitted by Australia and

seconded by Japan and Malaysia.
(50) The Commission took note of the budget of US \$1,840,600 proposed for the Office of the Assistant Director-General for General Programmes and Programme Support (para. 15701).

(51) The Commission took note of the budget of US \$4,085,500 proposed for the Office of Publications and Periodicals of Unesco (para.

(52) The Commission took note of the budget of US \$26,119,200 proposed for the Office of Conferences, Languages and Documents (para. 15901).

(53) The Commission recommended that the General Conference approve an appropriation of US \$32,045,300 for Part III (para. 15601), it being understood that the figure was subject to alteration in accordance with adjustments resulting from the decisions taken by the General Conference on the provisional budget ceiling and by the joint meeting of the Administrative Commission and the five Programme Commissions.

(54) The Commission recommended that General Conference take note of plan (paras. 15702, 15802-15808 the work and

15902-15905).

(55) At its sixteenth, seventeenth and eighteenth meetings Commission I considered the second part of Unit 21, concerning the Office of Information/Unesco Courier. Forty-one delegates took the floor.

(56) The Commission recommended that the General Conference take note of paragraphs 64 to 72 of document 25 C/4 Add., 'Draft Medium-Term Plan and Administrative Plan 1990-1995

(57) The Commission recommended that the General Conference approve 25 C/DR.95, concerning the celebration of the 500th anniversary of the birth of Francisk Skorina, submitted by Byelorussian Soviet Socialist Republic, Mexico, Greece, German Democratic Republic, Poland, Czechoslovakia, Union of Soviet Socialist Republics, Ukrainian Soviet Socialist Republic, Argentina Bulgaria, and

(25 C/Resolution 15.231).
(58) The Commission recommended that the General Conference approve 25 C/DR.124, and Add., concerning the 750th anniversary of the birth of Yunus Emre, submitted by Turkey (25 C/Resolution 15.232).
(59) Draft resolutions 25 C/DR.205 and

25 C/DR.216, submitted respectively by Ukrainian Soviet Socialist Republic and Czechoslovakia, were not admissible under paragraph 1 of Rule 78A of the Rules of Procedure of the General Conference. The Commission took note of the importance of these two draft resolutions, however, and recommended that the General Conference invite the Director-General to give priority to the requests of their authors, submitted in accordance with the normal procedure under the Participation Programme for 1990-1991.

(60) Draft resolution 25 C/DR.252, submitted by Brazil, which would have entailed expenditure of US \$415,000 over the budget proposed in document 25 C/5 (i.e. US \$12,963,000 for Chapter 4, Part II.C(ii)), was, under paragraph 1 of Rule 78A of the Rules of Procedure of the Seneral Conference, not admissible. In view of the support received by this draft resolution, however, the Commission recommended that the General Conference approve it. provided that the additional expenditure it, provided that the additional expenditure could be financed by means of budgetary rein-forcement or of any other additional resources included by the General Conference in the provisional budget ceiling, and that it invite the Director-General to ensure that this increase, if approved by the General Conference, is equitably distributed between the editions of the Unesco Courier published at Headquarters and those published away from Headquarters.

(61) The Commission recommended that the General Conference approve an appropriation of US \$12,963,000 for Chapter 4, Part II.C(ii), paragraph 15401, it being understood that the figure was subject to alteration in accordance with adjustments resulting from the decisions taken by the General Conference on the pro-visional budget ceiling and by the joint meeting of the Administrative Commission and the five

Programme Commissions.

(62) The Commission also recommended that the General Conference take note of the work plan for the Office of Public Information/Unesco Courier (paras. 15402-15432).

- (64) The Commission recommended that the Conference take note of documents General 25 C/37 (Sexennial report of the Executive Board on the contribution made to Unesco's activities by international non-governmental organizations in categories A and B) and 25 C/38 (Report by

the Director-General on changes in the classification of international non-governmental organizations).

(65) The Commission also recommended that the General Conference adopt, without any amendments, the draft resolution contained in part IV ments, the draft resolution contained in part 10 of document 25 C/37 (Sexennial report of the Executive Board on the contribution made to Unesco's activities by international nongovernmental organizations in categories A and B) (25 C/Resolution 15.213).

ITEM 8.3 - THE ROLE OF NATIONAL COMMISSIONS FOR UNESCO AND THEIR CONTRIBUTION TO THE WORK OF UNESCO

(66) The Commission examined item 8.3 of the agenda at its twelfth, thirteenth, fourteenth and nineteenth meetings. The delegates of 71 Member States and three observers of non-governmental organizations took the floor.

(67) At the close of the discussions the Commission asked a working group consisting of Cuba, France, German Democratic Republic, Malaysia and Senegal, under the chairmanship of Algeria, to examine 25 C/COM.I/DR.2, submitted by German Democratic Republic, China, Cuba, Ethiopia, Greece, Indonesia, Kuwait, Lao People's Democratic Republic, Malaysia,

designed so as to provide younger generations with values that generate behaviour patterns enabling them to cope with societal problems ...'; in the second sentence, add 'and will be implemented in conjunction with Major Programme Area I'; fourth sentence in place of 'health, drug abuse and AIDS prevention', read 'health, drugs and Acquired Immunodeficiency Syndrome prevention'. In paragraph 94, first sentence, continue after the addendum proposed by the Director-General, '(Moscow, 1988) aimed at enhancing the place, role and prestige of physical and sports education at school and in society'; second sentence, insert after 'non-governmental organizations' the words 'voluntary sports organizations' and add at the end of the sentence 'taking account of the respective spheres of competence of the different partners'. ITEM 7.1 - FOLLOW-UP TO THE FIRST CONSULTATION OF MEMBER STATES ON THE IMPLEMENTATION OF THE REVISED RECOMMENDATION CONCERNING TECHNICAL AND VOCATIONAL EDUCATION: REPORT BY THE EXECUTIVE BOARD'S COMMITTEE ON CONVENTIONS AND RECOMMENDATIONS

(43) The Commission discussed item 7.1 of the agenda and recommended that the General Conference take note of the report of the Committee on Conventions and Recommendations

regarding the follow-up to the first consultation on the implementation of the Revised Recommendation concerning Technical and Technical concerning Vocational Education (25 C/28).

ITEM 7.3 - FIRST REPORTS BY MEMBER STATES ON THE IMPLEMENTATION OF THE RECOMMENDATION CONCERNING EDUCATION FOR INTERNATIONAL UNDERSTANDING, CO-OPERATION AND PEACE AND EDUCATION RELATING TO HUMAN RIGHTS AND FUNDAMENTAL FREEDOMS

(44) The Commission discussed item 7.3 of the agenda and recommended that the General Conference adopt the resolution proposed by the

Executive Board (25 C/30 and 25 C/30 Add.) (25 C/Resolution 26).

ITEM 7.4 - DRAFT CONVENTION ON TECHNICAL AND VOCATIONAL EDUCATION

(45) The Commission recommended that the General Conference adopt the Draft Convention for Technical and Vocational Education (25 C/31. Annex I).

ITEM 7.7 - DESIRABILITY OF ADOPTING AN INTERNATIONAL CONVENTION ON THE RECOGNITION OF STUDIES, DEGREES AND DIPLOMAS IN HIGHER EDUCATION

(46) The Commission examined item 7.7 (25 C/34) and recommended that the General Conference adopt a resolution to the effect that: (1) the recognition of studies, degrees and diplomas be regulated at the international level

(the proposal was <u>adopted</u> by 22 votes to 12, with 8 abstentions);
(2) the method adopted should be an international convention (the proposal was <u>adopted</u> by 20 votes to 10, with 11 abstentions);

20 votes to 10, with 11 abstentions);
(3) the Director-General be invited to prepare, following the procedure laid out in Article 10 of the Rules of Procedure, a final draft of a convention to be submitted to the General Conference at its twenty-sixth session (1991) (the proposal was adopted by 21 votes to 13, with 9 abstentions) (25 C/Resolution 1.24).

The Commission therefore suggested the following procedure: a meeting of experts would prepare a draft convention, which should be submitted to Member States for their observations 14 months before the next session of the General Conference; those observations would then be incorporated in the draft, and a final report would be sent to Member States with a final draft of the convention seven months before the next session of the General Conference.

ITEM 6.10 - PROPOSED AMENDMENT TO THE STATUTES OF THE INTERNATIONAL FUND FOR THE DEVELOPMENT OF PHYSICAL EDUCATION AND SPORT

(47) Commission II examined document 25 C/81 and proposed that Article 5, paragraph 2, of the proposed statutes be modified to read as follows: 'The members of the Governing Board shall be appointed for a term of office of

four years, which may be renewed once. The Chairperson of the Intergovernmental Committee shall be the Chairperson of the Governing Board ex officio'. The proposed amendment was transmitted to the Legal Committee for further action.

ITEMS 2.1 AND 4.5 - DISCUSSION UNIT 3 -PROGRAMME I.3: PROMOTING AND SUPPORTING EDUCATIONAL DEVELOPMENT

(48) During its twelfth to fifteenth ngs Commission II examined Unit 3, meetings Programme I.3: Promoting and supporting educational development, and items 6.7 and 7.2. Fifty delegates and representatives of three non-governmental organizations and two liberation movements took the floor.

MEDIUM-TERM PLAN (1990-1995)

Resolution concerning the Medium-Term Plan

(49) The Commission recommended that the General Conference adopt paragraph 22(c) of the resolution proposed for Major Programme Area I (25 C/4, Annex I), as amended by the Commission. The proposals made in 25 C/DR.6 (submitted by USSR) regarding this paragraph were withdrawn.

Text of the Medium-Term Plan

(50) The Commission recommended that the General Conference approve paragraphs 101 to 118 of document 25 C/4, incorporating the modifications proposed by the Executive Board (131 EX/Decision 4.1) to paragraphs 106, 111 and 113, the modifications proposed by the Executive Board and the suggestions proposed by the Executive Board and the suggestions proposed by the Director-General for the title of the programme and for paragraph 108A and the following amendment to paragraph 118 proposed in 25 C/4/DR.5 (submitted by France): for 'building up ... clearing-house on education', read 'strengthening, in conjunction with IBE, the function of information clearing-house function of information clearing-house on education, ...'.

The recommendation was unanimously approved by the General Conference at its twentyninth plenary meeting, on 10 November 1989.

PROGRAMME AND BUDGET FOR 1990-1991

Resolution concerning the Programme and Budget

(51) The Commission recommended that the General Conference adopt paragraph 2(c) of the proposed resolution on Major Programme Area I proposed resolution on Major Programme Area I (para. 01002) as amended by the Commission following the discussion on 25 C/DRs 75, 86 Rev., 135, 201, 240 and 261 (submitted, respectively, by France; USSR and German Democratic Republic; Congo; Federal Republic of Germany; Denmark, Norway, Finland, Sweden, Iceland and Hungary; and German Democratic Republic) (25 C/Resolution 1.1).

(52) The Commission recommended that the General Conference adopt the resolution proposed

General Conference adopt the resolution proposed in document 25 C/77, Annex I, including the budgetary allocation of US \$4,587,800 referred to in the first operative paragraph of the resolution proposed in document 25 C/5 (para. 01402). Draft resolution 25 C/DR.204, submitted by Federal Republic of Germany, was withdrawn (25 C/Resolution 1.2).

(53) The Commission recommended that the ral Conference adopt resolution 1.3 General

(para. 01502) (25 C/Resolution 1.3).

(54) As regards the Unesco Institute for Education, Hamburg, the Commission recommended that the General Conference adopt the draft resolution in paragraph 01601, as proposed in 25 C/DR.200 (submitted by Federal Republic of Germany) and as amended by the Commission (25 C/Resolution 1.4) (25 C/Resolution 1.4).

Other resolutions

(55) The Commission recommended that the General Conference adopt 25 C/DR.241 (submitted by France, Bulgaria, Mauritania, Egypt, Spain, Nicaragua, Kuwait, India, Malaysia, Norway and Sri Lanka), as amended by the Commission (25 C/Resolution 1.8).

(56) The Commission recommended that the General Conference adopt 25 C/DR.231 (submitted by Switzerland), as amended by the Commission (25 C/Resolution 1.10).

(57) The Commission recommended that the General Conference adopt 25 C/DR.233 (submitted by Hungary), as amended by the Commission (25 C/Resolution 1.25).

(58) The Commission recommended that the General Conference adopt 25 C/DR.285 (submitted by USSR), as amended by the Commission (25 C/Resolution 1.26).

(59) The Commission recommended that the General Conference adopt 25 C/DR.234 (submitted by Yugoslavia, Algeria and Senegal), as amended by the Commission (25 C/Resolution 1.11).

(60) The Commission recommended that the General Conference adopt 25 C/DR.81 Rev. (submitted by USSR and German Democratic Republic), as amended by the Commission (25 C/Resolution 1.27).

Work plan

(61) The Commission considered 12 draft resolutions relating to the work plan for Programme I.3.

(62) Nine were withdrawn in the light of Director-General's notes: 25 C/DR.3 the Director-General's notes: 25 C/DR.3 (Czechoslovakia); 25 C/DR.37 (Venezuela); 25 C/DR.47 (Venezuela); 25 C/DR.68 (Venezuela

and Colombia); 25 C/DR.111 (Venezuela); 25 C/DR.112 (Venezuela); 25 C/DR.113 (Venezuela); 25 C/DR.212 (Hungary); and 25 C/DR.248 (Kuwait, Haiti, United Arab Emirates, Yemen, Morocco, China, Tunisia, Bahrain and Cuba).

(63) The Commission recommended approval of 25 C/DR.2, submitted by Czechoslovakia, entailing budgetary expenditure of US \$35,000 over the budget in document 25 C/5 (i.e. the budget without reinforcement). provided that the

budget without reinforcement), provided that the expenditure could be financed through use of the amount agreed upon for budgetary reinforcement or any other additional resources included by the General Conference in the provisional budget ceiling.

(64)transmitted Commission 25 C/DR.257 (submitted by Italy) with its comments to Commissions IV and V for further consideration. It will be reflected to the extent that it has implications for Major Programme Area I, in the work plan, as indicated in the Director-General's note.

(65) The Commission approved 25 C/DR.250 (submitted by Yugoslavia), as amended by itself, and transmitted it to Commission III for further consideration and action.

(66) The Commission recommended that the General Conference take note of the work plan for Programme I.3 (paras. 01302-01350) and of the Executive Board's recommendations concerning the Draft Programme and Budget for 1990-1991, on the understanding that it would be modified in the light of the resolutions and amendments approved by the Commission, the Commission's debate and the reply given by the representative of the Director-General.

(67) The Commission recommended that the General Conference take note of the work plan for the International Bureau of Education (paras. 01403-01409), on the understanding that it would be adjusted to the provisions of the Medium-Term Plan and taking into consideration the following paragraph from 25 C/DR.75, submitted by France: (ii) to amend the paragraphs of the work plan for the Draft Programme and Budget for 1990-1991 concerning IBE to take account of all the points made in the resolution proposed by the IBE Council and include, in particular, the provisions relating to the information clearing bouse function

mation clearing-house function.
(68) The Commission recommended that the General Conference take note of the work plan of the International Institute for Educational Planning (paras. 01503-01513), on the under-

standing that it would be adjusted to the provisions of the Medium-Term Plan.

(69) The Commission recommended that the General Conference take note of the work plan of the Unesco Institute for Education, Hamburg (paras. 01602-01609), on the understanding that it would be adjusted to the provisions of the Medium-Term Plan.

<u>Appropriation</u>

(70) The Commission recommended that the General Conference take note of the budgetary provision of US \$5,249,900 (para. 01301) for Programme I.3, it being understood that the figure was subject to alteration in accordance with adjustments resulting from the decisions taken by the General Conference on the provisional budget ceiling and by the joint meeting of the Administrative Commission and the five Programme Commissions.

ITEM 6.7 - PROPOSED AMENDMENTS TO THE STATUTES OF THE INTERNATIONAL BUREAU OF EDUCATION

(71) After considering item 6.7 and document 25 C/LEG/1 and Corr. the Commission recommended that the General Conference amend the Statutes of the International Bureau of Education as proposed in document 25 C/21, amended by document 25 C/LEG/1 and Corr., and

further amended by the Commission: three new subparagraphs are added to Article II.1; a sentence is added to Article II.2; a new paragraph 5 is added to Article IV; Articles VII.3 and VII.3bis are deleted.

ITEM 7.2 - FOURTH REPORT BY THE JOINT ILO/UNESCO COMMITTEE OF EXPERTS ON THE APPLICATION OF THE RECOMMENDATION CONCERNING THE STATUS OF TEACHERS

(72) The Commission recommended that the General Conference adopt the resolution proposed in document 25 C/29 Add., paragraph 15, as amended by the Commission (para. 7 was approved by consensus, and para. 8 by 28 votes to 6, with 6 abstentions) (25 C/Resolution 1.23).

MAJOR PROGRAMME AREA I: EDUCATION AND THE FUTURE MOBILIZING PROJECT 1: COMBATING ILLITERACY

(73) The Commission recommended that the General Conference adopt the proposed resolution concerning Major Programme Area I (25 C/4, Annex I, paras. 1–23), as amended by the Commission following discussion on 25 C/4/DR.6 submitted by USSR, and transmitted its approval of the proposed resolution concerning the mobilizing projects (25 C/4, Annex I, paras. 1-5) to Commission V.

(74) The Commission recommended that the General Conference approve the Draft Medium-Term General Conference approve the Draft Medium-Term Plan (25 C/4) for Major Programme Area I (paras. 41-118), as amended by the Commission, and for Mobilizing Project 1: Combating illiteracy, paragraphs 501 to 521, as proposed in document 25 C/4, Annex II, Part I.

(75) The Commission recommended that the General Conference adopt the preambular paragraph to resolution I.1 (para. 01002), operative paragraph 1 and a new constitute paragraph 2 to

paragraph 1 and a new operative paragraph 2, to be inserted between the existing operative paragraphs 1 and 2, as proposed in 25 C/DR.86 Rev. (submitted by USSR), as amended by the Commission.

(76) The Commission recommended that the Conference adopt resolution I.1 General (para. 01002) as amended by the Commission (25 C/Resolution 1.1).

(77) The Commission recommended that the General Conference take note of the work plans for Major Programme Area I, including Mobilizing Project 1, as amended by it, the work plans for Co-operation for Development and the Partici-pation Programme under Major Programme Area I (paras. 01701-01804) and the recommendations of the Executive Board on the Draft Programme and Budget for 1990-1991, on the understanding that further modifications might be decided by the joint meeting of the Administrative Commission and the five Programme Commissions.

(78) The Commission recommended that the General Conference approve an appropriation of US \$70,338,300 (para. 01001) for Major Programme Area I, it being understood that the figure was subject to alteration in accordance with adjustments resulting from the decisions taken by the General Conference on the provisional budget ceiling and by the joint meeting of the Adminis-trative Commission and the five Programme Commissions.

(79) The Commission recommended that the General Conference take note of the following

(7) The Commission did not endorse the

(7) The Commission did not endorse the amendment proposed in 25 C/4/DR.14 (Ukrainian Soviet Socialist Republic) but took note of the Director-General's comments.

PROGRAMME AND BUDGET FOR 1990-1991

Resolution concerning the Programme and Budget

(8) The Commission recommended that the General Conference adopt paragraph 2(a) of resolution 2.1 contained in paragraph 02002 of document 25 C/5, as amended by 25 C/DR.92 (Ukrainian Soviet Socialist Republic) in paragraph 2(a)(iii) and 25 C/DR.219 (Uganda) as regards the amendment to paragraph 2(a)(i) (25 C/Resolution 2.1).

(9) As regards 25 C/DRs 21 (Morocco. Belgium and Poland) and 193 (German Democratic Republic), the amendments proposed to subparagraphs 2(a)(ii) and 2(a)(iii) of paragraph 02002 of document 25 C/5 were not endorsed by the Commission; nor was the amendment to subparagraph 2(a)(ii) proposed in 25 C/DR.219.

(10) The Commission recommended that the General Conference take note of 25 C/DRs 67 (Venezuela), 83 (Ghana), 87 (Yugoslavia), 91 (USSR), 93 (Philippines), 115 (New Zealand,

Australia, Indonesia, Papua New Guinea, Philippines, Republic of Korea and Thailand), 120 (Philippines), 121 (Venezuela), 125 (Yugoslavia and Italy), 148 (USSR and German Democratic Republic), 220 (Uganda), 250 (Yugoslavia), 292 (China and Morocco), 295 (Bulgaria) and 296 (Côte d'Ivoire), which had no budgetary implications and did not require any modifications and did not require any modifications. implications and did not require any modification of the text proposed in document 25 C/5, and of the Director-General's notes about them, and invite the Director-General to take those draft resolutions into account in the implementation of the biennial programme.

(11)The Commission also recommended that the General Conference take note of 25 C/DR.94 (USSR), as modified by its sponsor in its statement, that is with the first three operative paragraphs deleted. Paragraph 4 thus became operative paragraph 1, to be followed by paragraph 2 of the Director-General's note, rephrased to read as follows: '2. Recommends that

the Director-General co-operate with the appro-priate bodies of the United Nations system and with ... Unesco's role in this field.', and deleting the last sentence.

(12) Concerning 25 C/DR.131 (Bulgaria and German Democratic Republic), the sponsor of the resolution stated that it was withdrawing the mention of 'financial assistance' in the resolution and was requesting only moral support. The Commission recommended therefore that the General Conference take note of this draft resol-ution as amended, on the understanding that it would have no financial implications.

(13) Concerning 25 C/DR.192 (USSR), the Commission recommended that the General Conference take note of it as amended during the debate, that is with operative paragraphs 3 and 4 deleted, the word <u>financial</u> in paragraph 5 replaced by <u>consultative</u> and the words <u>in Stockholm</u> on page 3, line 1, deleted, on the understanding that it would have no financial implications

implications.

(14) Similarly, as regards 25 C/DR.193 (German Democratic Republic and India), since the sponsor deleted operative paragraphs 1 and 2 during its oral statement and expressed its agreement with the Director-General's note the Commission recommended that the General Conference take note of that draft resolution, as amended, and of the Director-General's observations, on the understanding that it would have no financial implications.

(15) One of the sponsors of 25 C/DR.318 (Cuba, Angola, Bulgaria, Nicaragua, Peru, Suriname and Syrian Arab Republic) expressed its agreement with the Director-General's observations in paragraphs 1 and 2 of his note. The Commission recommended therefore that the General Conference take note of this draft

resolution, on the understanding that it would

have no budgetary implications.

(16) The Commission recommended that the General Conference take note of 25 C/DR.92 (Ukrainian Soviet Socialist Republic) and of the Director-General's note and invite the Director-General to take that draft resolution into account when finalizing the Approved Programme and Budget for 1990-1991.
(17) The Commission recommended that the

General Conference take note of 25 C/DR.97 (Egypt) and of the Director-General's observations, on the understanding that the work plan would be modified accordingly and would take into account the debate that took place in Com-

mission III on this subject.

(18) The Commission recommended that the General Conference take note of the part of 25 C/DR.144 (People's Republic of the Congo) that sought to modify paragraph 02103, as amended in the Director-General's note, and that it invite the Director-General to take it into account when preparing the text of the Approved Programme and Budget. The Commission took note of the Director-General's remarks concerning the

proposed amendment to paragraph 02114.

roposed amendment to paragraph U2114.

(19) With regard to 25 C/DR.265 (Islamic Republic of Iran) and 25 C/DR.266 (Islamic Republic of Iran, German Democratic Republic, Byelorussian Soviet Socialist Republic), the Commission recommended that the General Conference invite the Member States to consider the possibility of holding a national information technology day (on 6 September or any other dates technology day (on 6 September or any other date convenient to them) in order to stress the importance of information technology as an integral part of economic and social development and to inform the Director-General of the action they intended to take to give effect to that recommendation; and that the General Conference request the Director-General, in the light of the observations of the Member States, to report to it at its twenty-sixth session on the desirability of formally instituting a world information-technology day.

(20) The Commission recommended to the General Conference that the following draft resolutions be examined, if requests were made, under the Participation Programme for 1990-1991 in accordance with current procedures: 25 C/DR.9 (Czechoslovakia), 25 C/DR.19 (Czechoslovakia), 25 C/DR.19 (Czechoslovakia), 25 C/DR.20 (Czechoslovakia) 25 C/DR.19 (Czechoslovakia), 25 C/DR.20 (Czechoslovakia), 25 C/DR.67 (Venezuela), 25 C/DR.74 (Venezuela), 25 C/DR.121 (Venezuela), 25 C/DR.218 (Kenya), 25 C/DR.291 (China, Australia, Indonesia, Malaysia and Thailand) and 25 C/DR.327 (Nigeria). The sponsor of 25 C/DR.218 had expressed agreement with the Director-General's observations, it being understood that limited assistance could be provided under the Participation Programme.)

(21) The Commission recommended to the General Conference that 25 C/DR.21 (Morocco, Belgium and Poland), 25 C/DR.44 (Ukrainian Soviet Socialist Republic) and 25 C/DR.293 (Mongolia) also be considered under the Participation Programme if requests were made, note being taken of the support expressed for the activities in question by certain Member States.

(22) Having considered 25 C/DR.14 and

(22) Having considered 25 C/DR.14 and 25 C/DR.286 the Commission recommended that the General Conference take note of the Director-General's undertaking to increase his efforts, with the assistance of the Member States concerned, to muster increased extra-budgetary funds to strengthen the proposed activities.
(23) In response to the request of the Chairman, and observing that it was materially impossible for the Commission to examine the transfer of allocations requested in 25 C/DR.45 (France, Finland, Bulgaria, Burkina, Cameroon, Costa Rica, Kuwait, Peru, Senegal and Tunisia), the sponsor of that draft resolution agreed to withdraw it. On behalf of the co-signatories, he requested that the Commission inform the General Conference of the very broad support given to 25 C/DR.45 and recommend it to take steps to see that mathematics was given priority in receiving budgetary reinforcement from the 1992-1993 biennium.

(24) The Commission also took note of the withdrawal of 25 C/DR.85 (Union of Soviet

Socialist Republics).

(25) The Commission recommended that the General Conference take note of 25 C/DR.70 (Union of Soviet Socialist Republics), as amended during the debate, while inviting the Director-General to provide moral support for the organization of a scientific seminar to take stock of studies on wood and other plant materials, and to defer the question of establishing an international expert council until the twenty-sixth session of the

Conference.

During the discussion, 77 delegates representatives of eight non-governmental organizations took the floor.

(54) Forty-six delegates, including four representing non-governmental organizations, took part in the discussion on Unit 16 and item 5.7, and 37 delegates, some representing non-governmental organizations, took part in the discussion on Unit 17.

(65) Draft resolutions 25 C/DRs 16, 170, 175, 182, 257 and 330 (submitted respectively by Czechoslovakia, Nigeria, Nigeria, Nigeria, Italy and Burkina) were withdrawn in the light of the Director-General's note.

(66) Note was taken of 25 C/DR.179 (submitted by Nigeria), changing the title of Programme VII.2 to read 'Human rights and contribution to the elimination of apartheid and all other forms of discrimination' and the title of Subprogramme VII.2.2 to read 'Contribution to the elimination of apartheid and all other forms of discrimination'.

(67) Draft resolution 25 C/DR.187 (submitted by Nigeria) was noted, it being understood that the work plan would be amended

accordingly.

(68) The Commission recommended that the General Conference take note of 25 C/DR.183 The Commission recommended that the (submitted by Nigeria) and amend the title of the Special Project (paras. 07227-07234) to read 'Contribution to the elimination of apartheid: towards an apartheid-free world'.

(69) Similarly, the Commission mended that the General Conference take note of 25 C/DR.308, together with the note by the Director-General, it being understood that they would be taken into account during programme

execution.

(70) The Commission recommended that the General Conference take note of the work plan for Major Programme Area VII (paras. 07102-07234), as amended by 25 C/DRs 179, 187 and 183.

Appropriation

(71) The Commission recommended that the General Conference approve an appropriation of US \$6,502,100 for Major Programme Area VII (para. 07001), it being understood that the figure was subject to alteration in accordance with adjustments resulting from the decisions taken by the General Conference on the pro-visional budget ceiling and by the joint meeting of the Administrative Commission and the five Programme Commissions.

(72) The Commission also recommended that the General Conference note the budgetary provisions for Programmes VII.1 and VII.2 in paragraphs 07101 and 07201 respectively, and for the

Participation Programme (para. 07306).

(73) Regarding 25 C/DR.6 (submitted by Finland) and 25 C/DR.84 (submitted by Monaco) and taking into account the corresponding notes by the Director-General, the Commission recom-mended that the General Conference approve the proposals to: (i) strengthen the implementation of the 1974 Recommendation, in particular the preparation of an integrated action plan, and the activities concerning information and documentation on human rights, in particular the development of a computerized data base of human rights teaching materials (US \$70,000); (ii) organize an international symposium on the consequences of scientific and technological progress, including genetic engineering, for respect for fundamental human rights, in particular the rights of the child (US \$40,000).

III. Report of the Joint Meeting of the Programme and Administrative Commissions¹

ITEM 4.12 - ADOPTION OF THE APPROPRIATION RESOLUTION FOR 1990-1991

(1) The joint meeting was held on the afternoon of 14 November 1989 under the chairafternoon of 14 November 1989 under the chairmanship of Mr G.-H. Dumont (Belgium), Chairman of the Administrative Commission, with the following five Vice-Chairmen: Mr S. Kaempf (German Democratic Republic), Chairman of Commission I; Mr V. Ordoñez (Philippines), Chairman of Commission II; Mr D. Bensari (Morocco), Chairman of Commission III; Mr A. Wagner de Reyna 'Peru), Chairman of Commission IV; Mr B. A. Orott (Kenya), Chairman of Commission V.

Mr B.A. Ogot (Kenya), Chairman of Commission V.
(2) The Chairman presented document
25 C/PRG/ADM/1 to the joint meeting. He referred
to the Working Group of Chairmen of the Programme Commissions and the Administrative Commission, chaired by the President of the General Conference and attended by the Presidents of the Regional Groups, which had recommended by consensus that only Solution I, presented in document 25 C/PRG/ADM/I, Annex I, be considered for adoption by the joint meeting. Solution I implies the approval of a total appropriation of plies the approval of a total appropriation of US \$380,948,000, it being understood that no extra funds will be available for budgetary reinforcement and draft resolutions submitted by Member States and that an amount of US \$9,116,000 will have to be absorbed within the budget during the 1990-1991 biennium.

(3) The Working Group also recommended for adoption by the General Conference the following introductory statement to the Appropriation Resolution for 1990-1991:

INTRODUCTORY STATEMENT

The General Conference recognizes the priority character of the draft resolutions submitted by Member States and adopted by the competent Programme Commissions and acknowledges the urgency of activities for which budgetary reinforcement is proposed in the Draft Programme and Budget for 1990–1991 but for which no financing is at present available.

(ii) The General Conference

Director-General to keep these priority and urgent activities in mind during the execution of the programme in the next biennium, giving

full support, and using any savings that may become available, for their implementation.

(iii) The General Conference emphasizes, this context, the Administrative Commission's resolution (on item 4.4), adopted by the plenary, concerning, in particular:

reduction of the duration of the sessions of the General Conference and the Executive Board.

modernization of Unesco's working methods, which will entail reduction of administrative

expenses and staff costs, being understood that savings so achieved will be used for priority and urgent activities and those programmes which were singled out in the Administrative Commission's resolution.

(iv) The General Conference reiterates its invitation to Member States to make voluntary contributions to priority activities in the programme for 1990-1991, as recommended by the Administrative Commission.

(4) The joint meeting agreed with the introductory statement and recommended by consensus that the General Conference adopt the Appropriation Resolution for 1990-1991 as in Annex I of document 25 C/PRG/ADM/1

(25 C/Resolution 17).

(5) Subsequently, three delegates took the floor and stated that their governments had accepted the principle of budgetary reinforcewas of crucial importance for which Unesco's forthcoming programme, and regretted that such reinforcement had not yet been approved. On the other hand, four delegates expressed their countries' reservations on the budget ceiling recommended for adoption, which implied increased contributions for The President requested governments. delegates who had made the above statements to reiterate them in plenary meeting and invited any other delegate wishing to express himself or herself on the same subject also to make a statement in plenary meeting.

The General Conference took note of this report at its thirty-third plenary meeting, on 16 November 1989.

FIRST REPORT

PROPOSED AMENDMENTS TO THE STATUTES OF THE INTERNATIONAL BUREAU OF EDUCATION

Item 6.7 of the agenda (25 C/21)

Committee examined The document 25 C/21, containing proposed amendments to the Statutes of IBE. The Director of IBE introduced the proposed amendments. Ten delegates took part in the discussion.

(2) The Committee approved, with one minor change (underlined below), the proposed amendment to paragraph (a) of Article II.1. It decided to present the amendment in the form of a new paragraph (b) and to change accordingly the lettering of the paragraphs which follow. The paragraph approved reads as follows:

'(b) to assist in the <u>dissemination</u> implementation of the recommendations adopted by

the International Conference on Education'. 2

(3) The Committee also approved the addition to Article II.1 of a new paragraph (f) (paragraph (e) proposed in document 25 C/21)

with modifications underlined as follows:

'(f) to provide technical assistance for the organization of training programmes, workshops, seminars, and retraining and further training courses for those in charge of national, subregional or regional research, documentation and information centres in the field education'.

(4) The Committee also proposed the addition to Article II.1 of a further paragraph

worded as follows:

the training (g) to promote specializing in research in education and in the management of documentation centres'.

(5) The Committee approved without change the proposed amendment to Article II.2, namely,

the addition of the following:

'The resources allocated for the operation of the Bureau shall consist of the budget approved by the General Conference of Unesco and of gifts, bequests, subventions and voluntary contributions received in accordance with the Financial Regulations of Unesco'.

The Committee decided to set up a working group to prepare a new form of words for the proposed new paragraph 5 to be added to Article IV, relating in particular to the extension of the terms of office of the members of the Bureau of the IBE Council for the period running from the end of the ordinary session of the General Conference, this being the end of

the General Conference, this being the end of the term of office of part of the membership of the Council, until the election of a new Bureau. The working group drafted the following paragraph, which the Committee approved:

'5. The Council shall elect its Bureau comprising a President and five Vice-Presidents, nationals of the six regional groups. The President of the Council shall preside over the Bureau. The Council shall renew its Bureau at Bureau. <u>The Council shall renew its Bureau at</u> its first session following the ordinary session of the General Conference at which the Council has been partially renewed. The members of the Bureau shall be eligible for re-election, provided the terms of office of the Member States of the Council which they represent are renewed by the General Conference, but they shall not hold office for more than two consecutive terms'.2

(7) At the close of the discussion of this amendment, the Committee expressed the view that it was essential for the session of the IBE Council responsible for electing its new Bureau to be held as soon as possible after the ordinary session of the General Conference at which

the Council was partially renewed.

(8) One member of the Committee voiced his reservations concerning this paragraph and his support for the amendment as proposed in document 25 C/21, with the exception of the sen-

tence stating that 'the President of the Council shall preside over the Bureau', this provision

being in his view superfluous. He explained that the original paragraph merely applied the principle of the permanence of office, so that those who held office would continue to exercise it until they had been replaced.

until they had been replaced.

(9) The Committee agreed to the deletion of Article VII.3, which had no further raîson d'être, and of Article VIIbis, which was a

transitional provision, and also recommended that the phrase 'Subject to what is stated in paragraph 3 below' occurring in Article VII.1 be deleted.

 On the recommendation of Commission II this proposal was adopted by the General Conference (25 C/Resolution 1.2.1).

SECOND REPORT

STUDY ON THE PRIVILEGES AND IMMUNITIES OF PERSONNEL RECRUITED UNDER THE PARTICIPATION PROGRAMME

Item 6.6 of the agenda (25 C/27)

(1) The Legal Committee, at its second meeting, held on 19 October 1989, examined item 6.6 of the agenda. At the twenty-fourth session of the General Conference the delegation of Japan submitted an amendment (24 C/DR.209) to the draft resolution concerning the Participation Programme, which contained, as such resolutions usually do and as does the one at the present session, several provisions pertaining to privileges and immunities of personnel recruited under the Participation Programme. Acting on the basis of a report of the Legal Committee, the General Conference at its twenty-fourth session invited the Director-General to carry out a study on the question, to be submitted to the Executive Board with a view to the presentation of a report to the current session of the General Conference.

Statement by the representative of Japan

(2) At the invitation of the Chairman of the Committee, the delegate of Japan recalled the draft amendment that his country had presented to the General Conference at its twenty-fourth session. After stating the importance that his government attached to the Participation Programme in the framework of Unesco's activities he drew attention to the difficulties his government faced in agreeing to grant the privileges and immunities mentioned in subparagraphs 9(e) and 9(f) of the usual resolution concerning the Programme, and to the fact that these privileges and immunities went beyond those provided for in the Convention on the Privileges and Immunities of the Specialized Agencies. The granting of additional privileges and immunities raised serious problems for Japan in relation to its domestic law as it would require approval by the Japanese Parliament, in line with the procedure adopted for approval of the aforementioned Convention. His government therefore reiterated its position, as previously expressed at the twenty-fourth session of the General Conference.

General discussion

(3) The representative of the Director-General explained the practice of the Organization in that regard.

(4) Various questions were raised in the ensuing discussion, among which were the following:

whether the biennial resolution of the General Conference should always be applied by the Member States as a condition of the Organization's participation, or whether the Director-General could negotiate the conditions of such participation;

whether an appropriate resolution would be necessary for the Director-General to be empowered to negotiate with Member States in regard to those privileges and immunities that go beyond those provided for in the Convention and, in that case, whether it would not be necessary to establish a set legal framework for such negotiations;

since the Convention provided (in Article X, section 39) for the conclusion of supplementary agreements between the Organization and Member States for the purpose <u>inter alia</u> of extending the privileges and immunities provided for therein, whether it would not be appropriate to envisage the conclusion of such supplementary agreements.

(5) In concluding its debate, the Committee recommended alteration of the usual wording of subparagraph 9(f) of the draft resolution in view of its imperative character and to insert therein guidelines that the Director-General would take into due account in negotiations with Member States. The text, as adopted by the Committee, reads as follows:

Director-General would take into due account in negotiations with Member States. The text, as adopted by the Committee, reads as follows:

'(f) it shall grant to personnel recruited under the Participation Programme who are officials of Unesco the privileges and immunities set out in Articles VI and VII of the Convention on the Privileges and Immunities of the Specialized Agencies; it shall grant to personnel recruited under the Participation Programme who are not officials of Unesco the privileges and immunities provided for in paragraph 3 of Annex IV to the above-mentioned Convention. It is understood that additional privileges and immunities can be granted in supplementary agreements concluded with the Director-General. No restriction should be imposed upon the rights of entry, sojourn and departure of the persons mentioned in the present subparagraph'.

(6) The Committee considered that the term 'personnel' used in the text applied not only to Unesco experts but also to other categories of personnel recruited outside the country concerned, such as freelance interpreters.

The General Conference took note of this report at its twenty-fifth plenary meeting, on 7 November 1989.

THIRD REPORT

AMENDMENT TO ARTICLE IX.3 OF THE CONSTITUTION AND TO ARTICLES 6.7, 7.3, 7.6, 9.1 AND 13.2 OF THE FINANCIAL REGULATIONS

Item 10.8 of the agenda (25 C/54 and Add.)

(1) At the invitation of the Chairman, the Comptroller introduced document 25 C/54 and Add. to the Committee. On the proposal of the Chairman it was agreed to discuss the proposals point by point.

<u>Proposed amendment to Article IX.3 of the Constitution</u>

- (2) It was noted that the Director-General's proposals were based on decision 5.1.2 taken by the Executive Board at its 130th session and, bearing in mind Rule 103 of the Rules of Procedure of the General Conference, that it had been circulated to Member States in circular letter CL/3172 dated 14 April 1989 more than six months in advance of the General Conference.
- (3) The Committee noted that letters had been received from three Member States in answer to the circular letter of the Director-General. Two of these letters, one from the Federal Republic of Germany and one from Venezuela, suggested modifications to the Director-General's text. After a debate in which several members of the Committee took part, the Committee unanimously agreed to propose that in the first line of the Director-General's text the word 'receive' should be replaced by the word 'accept'.

Proposed amendment to Financial Regulation 6.7

- (4) The Committee took note of the proposed amendment specifying that the Executive Board could make 'appropriate recommendations' on Financial Regulations established by the Director-General for Trust Funds, Reserve or Special Accounts. It noted that the existing Financial Regulations required only that such Financial Regulations be reported to the Executive Board.
- (5) Three members of the Committee wished that the attention of the Administrative

Commission of the General Conference be drawn to the proposed change. In their opinion, the change had political rather than legal dimensions, involving as it did an alteration in the existing division of responsibilities between the Executive Board and the Director-General. These three members did not consider that the proposed change, especially the word 'recommendations' contained therein, expressed clearly the extent of the Executive Board's capacity to intervene in the matter of special Financial Regulations for Trust Funds, Reserve and Special Accounts.

Proposed amendment to Financial Regulation 7.3

(6) The Committee recommended the acceptance of the proposed amendment, subject to the substitution of 'and' in place of 'or' in the fifth line of the text, as suggested by the Federal Republic of Germany, in the text proposed by the Director-General (25 C/54 Add.).

(7) The Committee recommended that the Director-General's proposed amendments be approved.

(8) The Committee recommended that the General Conference adopt two draft resolutions instead of one as provided for in document 25 C/54, since amendments to the Constitution needed to be adopted by a two-thirds majority whereas amendments to the Financial Regulations required only a simple majority.²

- 1. The General Conference took note of this report at its twenty-fifth plenary meeting, on 7 November 1989.
- These draft resolutions were adopted by the General Conference (25 C/Resolutions 29.4 and 35.1).

FOURTH REPORT 1

MODIFICATION OF THE STATUTES OF THE INTERGOVERNMENTAL COUNCIL FOR THE GENERAL INFORMATION PROGRAMME

<u>Item 6.11 of the agenda</u> (25 C/101)

- (1) The Legal Committee examined an amendment proposed to Article 4.1 of the Statutes of the Intergovernmental Council for the General Information Programme (PGI), the purpose of which was to widen the scope of the Council's mandate to include the following functions:
- 'Reviewing related information activities of Unesco and making recommendations for their co-ordination'.
- (2) The Committee felt that although the proposal raised certain problems of a legal
- nature it involved essentially a question of substance that did not come within its competence and should be examined in a programme commission.
- (3) The attention of the commission concerned should be drawn to the expression 'related information activities' featuring in

the text of the proposed amendment, it being considered somewhat imprecise and in need of clarification. Moreover, the commission's attention should also be drawn to the fact that the amendment did not specify the addressee of the Council's recommendations.

(4) After having obtained the advice of Commission I on the substance, the committee proposed to it the following text to replace that appearing in document 25 C/101:

'(f) reviewing the other information activities of Unesco and making recommendations for a better co-ordination of the said activities'.

The present (f) would become (g).

1. On the recommendation of Commission I this proposal was adopted by the General Conference (25 C/Resolution 15.1.1).

FIFTH REPORT

AMENDMENT OF RULES 6 and 67B OF THE RULES OF PROCEDURE OF THE GENERAL CONFERENCE AND OF ARTICLE 7B OF THE REGULATIONS FOR THE GENERAL CLASSIFICATION OF VARIOUS CATEGORIES OF MEETINGS CONVENED BY UNESCO

- (1) The purpose of the proposed amendments was, in the light of Resolution 43/177 of the General Assembly of the United Nations, to replace in the rules and regulations of the Organization the designation 'Palestine Liberation Organization recognized by the League of Arab States', by the designation 'Palestine'.
- (2) The Committee put forward a draft resolution to the General Conference. 2
- The General Conference took note of this report at its twenty-fifth plenary meeting, on 7 November 1989.
- 2. The draft resolution was adopted by the General Conference (25 C/Resolution 29.5).

SIXTH REPORT¹

PROPOSED AMENDMENT TO ARTICLE VII(3) OF THE STATUTES OF THE INTERNATIONAL CO-ORDINATING COUNCIL OF THE PROGRAMME OF MAN AND THE BIOSPHERE (MAB)

Item 6.12 of the agenda (25 C/88)

- (1) The Legal Committee examined an amendment proposed to Article VII(3) of the Statutes of the International Co-ordinating Council of the Programme of Man and the Biosphere (MAB), the purpose of which was to include in the relevant text a reference to the International Social Science Council among the international organizations mentioned therein as having the right to take part in meetings of the Co-ordinating Council of MAB and its subsidiary organs.
- (2) This proposal not appearing to pose any problem from the legal standpoint, the Committee recommended that the General Conference adopt a draft resolution on the subject.²
- The General Conference took note of this report at its thirtieth plenary meeting, on 14 November 1989.
- The draft resolution was adopted by the General Conference (25 C/Resolution 2.4).

SEVENTH REPORT 1

PROPOSED AMENDMENT TO ARTICLE VI, PARAGRAPH 2, OF THE CONSTITUTION

(1) The Legal Committee examined an amendment proposed to Article VI, paragraph 2, of the Constitution, concerning the number of terms of office for which the Director-General could be elected.

Presentation of the proposed amendment

(2) The representative of Australia reminded the Committee that it was his country

and Canada that had initiated the draft amendment at the twenty-fourth session of the General Conference. The basic idea behind the proposal was to ensure a necessary rotation, from both the intellectual and geographical

points of view, of persons who could be called upon to assume high responsibilities within the organizations of the United Nations system and that two terms of office were adequate for such purpose. It was a question of principle and was in no way directed at any given person or persons.

General discussion

(3) In the light of the information provided by the Secretariat on the terms of office of the heads of the secretariat of the other organizations of the United Nations system, various views were expressed on the proposal. One member, referring to the preamble of 24 C/Resolution 31.5, considered that the Secretariat should have carried out consultations with its counterparts of the other organizations, with a view to establishing a common position on the question.

(4) The representative of the Director-General pointed out that the Secretariat did not have such a mandate, and that each organization of the system was autonomous and had its own rules, which could at times differ from those of its sister organizations for passess of its sister organizations. its sister organizations for reasons of its own.

(5) Another opinion was that the Legal Committee could not appropriately give its views on a limitation of the Director-General's term of office, since such a question was not a legal one. The Committee should therefore limit its role to examining whether the draft amendment was acceptable from the formal and procedural standpoint. It was up to the General Conference itself to decide on the substantive issue involved therein.

(6) Several members were of the opinion, however, that, while this opinion was correct per se, nothing need prevent the Committee from expressing its views on the substantive issue.

(7) Several members of the Committee considered that the question of limiting the number of terms of office of the Director-General was closely linked to the need to uphold the principle of equal access for the nationals of all countries to posts of responsibility within the international organizations of the United Nations system, and that an effort to harmonize the rules in that area covering all the Specialized Agencies was essential in order to reduce the imbalance in the distribution of

posts between different geographical regions.
(8) The Legal Committee drew the attention of the General Conference to the value that would be gained if all United Nations bodies adopted a comparable view on the question of the number of terms of office of the Chief Administrative Officer of the Organization.

(9) The Legal Committee recalled that in accordance with Article XIII, paragraph 1, of the Constitution, proposed amendments to the latter had to be approved by a two-thirds majority vote of Member States at the General Conference. It considered that the present amendment did not involve new obligations for Member States and could take effect upon its

adoption by the General Conference.
(10) The Committee put forward a draft resolution to the General Conference for possible adoption.

The draft resolution was adopted by the General Conference (25 C/Resolution 29.3).

EIGHTH REPORT

PROPOSED AMENDMENT TO ARTICLE II, PARAGRAPH 2, OF THE CONSTITUTION

Item 6.9 of the agenda (25 C/104, 25 C/104 Add. and 25 C/104 Add.2)

(1) The Legal Committee examined an amendment proposed to Article II, paragraph 2, submitted by Australia and New Zealand.

(2) The purpose of the proposal, supported by Algeria, Kuwait, Lebanon, Libyan Arab Jamahiriya and Tunisia, but opposed by Federal Republic of Germany, Syrian Arab Republic and Rwanda, was to reduce the majority vote required for admission to Unesco of States that are not members of the United Nations from a two-thirds to a simple majority vote. The proposal was considered admissible in regard to Article XIII of the Constitution and Article 103 of the Rules of Procedure of the General Conference.

Presentation of the proposed amendment

representative of Australia The reminded the Committee, that, two years before, Australia and New Zealand had proposed an amendment the aim of which was to extend the right to become members of Unesco to all members of any Specialized Agency of the United Nations system. The Legal Committee, at the twenty-fourth session of the General Conference, was of the opinion that it was not desirable to amend the present provision of the Constitution, among the reasons advanced being that it was not desirable for the right to membership of Unesco to depend on the rules of other organizations.

The Committee felt, nevertheless, that a proposed amendment to the Constitution modifying the majority vote for admission to a simple majority instead of a two-thirds majority could be submitted to the General Conference at its twenty-fifth session, in order to facilitate the admission to Unesco of States not members of the United Nations. Australia and New Zealand had therefore taken the initiative of presenting the present draft amendment, which they felt would encourage new States to request membership of Unesco. However, in the meantime, two new Member States had been admitted to the Organization at the current session by acclamation under the existing rule. In view there-fore of the reticence shown by certain Member States and in order to favour the obtaining of a consensus in the matter, Australia and New Zealand would see no objection to the question being postponed and put on the agenda for the next session of the General Conference.

General discussion

(4) At the Chairman's invitation, the Secretariat drew the attention of the Committee

to information concerning the rules and practice other Specialized Agencies of the United Nations system with regard to the vote required for admission of a State that is not a member of the United Nations.

(5) Several members emphasized the need to permit States that had no interest in joining the United Nations, a political organization, to benefit from the advantages that membership of Unesco could procure them in the fields of education, science, culture and information, universality and the rapprochement of 'peoples' being among its basic aims. The observer of Palestine supported that argument and emphasized the relevance of the proposed amendment that had been submitted.

(6) On the other hand, several members held the view that there was no need, at the present time, to amend the present text of

Article II, paragraph 2.

(7) At all events, it was evident that the general feeling was that the question under discussion needed more reflection and had not yet reached a stage enabling a consensus to be obtained in the matter. The Committee therefore decided to submit a draft resolution to the General Conference for adoption.

NINTH REPORT

PROPOSED AMENDMENTS TO ARTICLE II, PARAGRAPH 6, AND ARTICLE IX OF THE CONSTITUTION

Items 6.1 and 6.3 of the agenda (25 C/22 and 25 C/25)

The Legal Committee examined, at the

same time, proposed amendments to Article II, paragraph 6, and Article IX of the Constitution.

(2) The purpose of the first proposed amendment was to make the effective date of withdrawal of a Member State coincide with the end of a financial period, and to provide for prior notification by a withdrawing member of at

least one year.

(3) The purpose of the second proposed amendment was to provide for the insertion in the Constitution of a paragraph stipulating that the Organization's financial period was two consecutive calendar years, beginning with an even-numbered year, and that Member States' financial contributions would be payable for the whole of the current financial period.

(4) The representative of Australia reminded the Committee that, following the withdrawal of the United States of America from the Organization, the Executive Board, at its 124th session, had invited the Director-General to prepare a report on the harmonization of the constitutional and statutory texts of the Organization, having regard to the modifications already made to the Constitution by the General Conference at its seventh session with respect to the biennial nature of its sessions and at its eighth session as regards the withdrawal of Member States.

(5) The Director-General had therefore presented a report (125 EX/29 Rev.) to the Executive Board at its 125th session. Following examination of that report the Board had come to the conclusion that the most appropriate measure would be to modify Article II.6 of the Constitution in such a way as to remove any possible ambiguity as to its meaning with respect to the financial obligations of a Member State withdrawing from the Organization in the

middle of a financial period.

(6) It was in this context that Australia and Canada had submitted to the General Conference at its twenty-fourth session a proposed amendment to that end.

(7) The Legal Committee, at that session, had recommended that the General Conference adopt the text appearing in paragraph 2 of document 25 C/22.

(8) As a logical corollary to their proposed amendment Australia and Canada had also submitted to the General Conference the proposed amendment to Article IX of the Constitution appearing in the annex to document 25 C/24.

(9) Examination of these two proposed amendments had been postponed by the General Conference at its twenty-fourth session to the

present session.

(10) Following a lengthy exchange of views the Legal Committee set up a working group to examine the matter and, on the basis of the consensus reached in the working group, put forward to the General Conference a draft resolution for possible adoption.

The draft resolution was adopted by the General Conference (25 C/Resolution 29.1).

The General Conference took note of this report at its thirtieth plenary meeting, on 14 November 1989.

The draft resolution was adopted by the General Conference (25 C/Resolution 29.2).

TENTH REPORT

CONSIDERATION OF THE CONSTITUTIONAL AND STATUTORY TEXTS FROM THE POINT OF VIEW OF FORM AND LANGUAGE

Item 6.4 of the agenda (25 C/25)

Amendments to the Rules of Procedure of the General Conference require only a simple majority, in accordance with Rule 107 of the Rules of Procedure. Amendments to the Financial Regulations likewise

require only a simple majority.

(4) The Legal Committee put forward to the General Conference a draft resolution for possible adoption 2

possible adoption.

Article IV.8(c)

The General Conference may nevertheless permit such a Member State to vote, if it is satisfied that failure to pay is due to conditions beyond the control of the Member State.

Article IV.11

The General Conference shall set up special and technical committees and such other subsidiary organs as may be necessary for its purposes.

 Similarly, 'body' should be replaced by 'organ(s)' in the following Rules of Procedure of the General Conference: 13.2, 21, 25.1, 25.3, 26, 30.2, 30.3, 36.1(b), 42, 46, 47, 49.1, 50, 61, 62.2, 65, 67, 67A, 67B, 68, 69.2, 70.2, 78.4, 79.1 and 79.2.

Article V.1

The Executive Board shall be elected by the General Conference from among the delegates appointed by the Member States and shall consist of 51 members each of whom shall represent the Government of the <u>Member</u> State of which he is a national. The President of the General Conference shall sit ...

Article V.4(a)

In the event of the death or resignation of a member of the Executive Board, his replacement for the remainder of his term shall be appointed by the Executive Board on the nomination of the Government of the <u>Member</u> State that the former member of the Board represented.

RULES OF PROCEDURE OF THE GENERAL CONFERENCE

Rule 1.1

The General Conference shall meet in ordinary session every two years.

Rules 4 and 5.2

4. In the event of circumstances developing which, in the opinion of the Executive Board, render it undesirable to hold the General Conference at the place fixed at the previous session, the Executive Board may, after consultation with Member States and if a majority of them concur, convene the General Conference elsewhere.

5.2. Extraordinary sessions shall be held at the Headquarters of the Organization, unless the Executive Board finds it necessary to convene

the **General Conference** elsewhere.

Rule 6.2

The United Nations and $\underline{\text{the}}$ Specialized Agencies of the United Nations shall be notified of the convening of any session of the General Conference and invited by the Director-General to send representatives.

Rule 6.3

Appropriate intergovernmental organizations shall be notified <u>of the convening of any</u> session of the <u>General Conference</u> and invited by the Director-General to send observers.

Rule 6.5

Executive Board shall before each session of the General Conference include in the appropriate list the African liberation movements recognized by the <u>Organization of African Unity</u> which are to be invited to send observers to that session. The Director-General shall notify the liberation movements which appear on this list of the convening of the session and shall invite them to send observers.

Rule 6.7

International non-governmental or semi-governmental organizations approved for consultative arrangements shall also be notifed of the convening of any session of the General Conference and invited by the Director-General to send observers.

Rule 10(c)

Items proposed by the United Nations in conformity with Article \underline{III} of the Agreement concluded between the two Organizations.

Rule 11.4

After the period of six weeks mentioned in paragraph 1, no new items can be included in the agenda, unless they are included in accordance with the procedure laid down by Rules 14 and 36, paragraph 1(c).

Rule 13.2

The General Conference, or any committee, commission or other subsidiary organ of the General Conference, may request the advice of the Executive Board on any item on the agenda. The body making such request shall postpone any

The body making such request shall postpone any action on the item in question until such time as, in its opinion, the Executive Board shall have had the opportunity to consider the request.

The adjective 'other' should also be added immediately before 'subsidiary organs' in the following Rules: 21, 25.1, 25.3, 26, 30.1, 30.2, 36.1(b), 42, 46, 47.3, 48, 49.1, 50, 61, 62.3, 65, 67, 67A, 67B, 68, 69.2, 70.2, 78.4, 79.1 and 79.2.

Rule 14.2

New items of an important and urgent character may be added to the agenda by approval of a two-thirds majority of the members present and voting; but such new items shall be referred to the General Committee of the Conference for its report, in accordance with Rule 36, paragraph l(c), before the vote is taken. The discussion of any new item so added to the agenda shall, at the request of any Member State or Associate Member, be deferred for a period not exceeding seven days after its inclusion in the agenda.

Rules 22.1 and 22.2

22.1 The credentials of delegates and alternate $\underline{\text{delegates}}$ shall be issued by the Head of the State, the Head of the Government or the Minister of Foreign Affairs. 22.2 The credentials

of delegates and alternate <u>delegates</u> of Associate Members shall be issued by the competent authorities.

Rule 28.3

It shall also examine and report on the credentials of observers designated by international non-governmental or semi-governmental organizations admitted to the Conference in accordance with Rule 6, paragraph $\underline{7}$, and Rule 7.

Rule 30.1

The Nominations Committee, after receiving a report from the Executive Board, and without any obligation to accept its recommendations, shall determine and submit to the General Conference the <u>list</u> of nominations for the posts of President and of the Vice-Presidents of the

General Conference. It shall submit to the General Conference proposals for the composition of committees, commissions and other subsidiary organs of the Conference on which not all Member States are represented.

Rule 32.1(a)

The Committee shall consider: (a) Proposals for the amendment of the Constitution and of the present Rules.

Rule 36.1(a)

The functions of the General Committee are: (a) To fix the hour, the date and the agenda of plenary meetings of the Conference.

Rule 36.2

In carrying out the above-mentioned functions, the General Committee shall not discuss the substance of any item except in so far as this bears upon the question whether <u>it</u> should recommend the inclusion of new items in the

Rule 66 (Title)

Specialized Agencies and other intergovernmental organizations.

Rule 67A

Liberation movements recognized by the

Organization of African Unity.
Observers from African liberation movements recognized by the <u>Organization of African Unity</u> may make oral or written statements in plenary meetings and in meetings of committees, commissions and other subsidiary organs, with the consent of the presiding officer.

Rule 87.2

All other elections and decisions relating to individuals shall be voted on by secret ballot whenever five or more Members shall so request or if the President so decides.

FINANCIAL REGULATIONS

Articles 3.4; 3.5; 5.8

3.4 The budget estimates shall be transmitted to all Member States and Associate Members so as to reach them at least three months prior to the opening of the ordinary session of the General Conference.

3.5 The Director-General shall, prior to the opening of the <u>ordinary</u> session of the General Conference, submit the estimates Executive Board for examination.

5.8 The Director-General shall submit to the ordinary session of the General Conference a report on the collection of contributions and advances to the Working Capital Fund.

RULES OF PROCEDURE CONCERNING RECOMMENDATIONS TO MEMBER STATES AND INTERNATIONAL CONVENTIONS COVERED BY THE TERMS OF ARTICLE IV, PARAGRAPH 4, OF THE CONSTITUTION

Article 2

The General Conference shall make no decision on the desirability or on the substance of any proposal for the regulation of a particular question on an international basis by the adoption of an international convention or of a recommendation, unless the proposal has been specifically placed on the provisional

agenda of the Conference in accordance with the present Rules of Procedure.

Article 10.2

The Director-General's preliminary report shall reach Member States at least 14 months before the opening of the session of the General Conference. Member States shall forward their comments and observations on the preliminary report, to reach the Director-General at least ten months before the opening of the session mentioned in the preceding sentence.

II. AMENDMENTS NOT SUPPORTED BY THE LEGAL COMMITTEE

Considering the amendments proposed in document 25 C/25 to the following texts unnecessary, the Legal Committee decided to disregard them.

(a) Constitution of the United Nations Educational, Scientific and Cultural Organization:

Article IV.2; Article V.7: Article IX.2: Article XII.

(b) Rules of Procedure of the General Conference: Rule 6.5: second proposed amendment;

III. PROPOSED AMENDMENTS TO BE CONSIDERED AT A FUTURE SESSION OF THE GENERAL CONFERENCE

Considering that the following amendments raised questions of substance rather than of form, the Legal Committee did not feel it could take any decision regarding them and decided to request the Director-General to submit, if he considers it necessary, formal proposals for amendments to the General

Conference at its twenty-sixth session:

(a) Constitution of the United Educational, Scientific and Organization: Article IV.6; Article Nations Cultural VI.3(a);

Article VI.6.

(b) Rights and obligations of Associate Members: resolution 41.2 adopted by the General of Associate Conference at its sixth session.

(c) Rules of Procedure of Conference: Rule 78.4. the General

(d) Financial Regulations: Article 6.7.

2. The Legal Committee considered that it would be appropriate for the Director-General to propose to the General Conference at its twenty-sixth session an amendment to the last sentence of Rule 13.2 of the Rules of Procedure, to the effect that any action should be postponed until such time as, in the opinion of the Executive Board <u>itself</u>, it has had the opportunity to consider the matter concerned (a deadline might perhaps be set).

- 3. The Legal Committee also considered that it would be appropriate for the Director-General to propose to the General Conference at its twenty-sixth session an amendment to Rules 23 and 28.3 of the Rules of Procedure concerning the question of the credentials of the national liberation movements recognized by the Organ-ization of African Unity and of Palestine, referred to under Rule 6, paragraphs 5 and 6, and Rules 67A and 67B of the Rules of Procedure of the General Conference.
- Lastly, the Legal Committee invited the Director-General to consider conducting an overall review, from the point of view of form, of the Rules of Procedure concerning recommendations to Member States and international conventions covered by the terms of Article IV, paragraph 4, of the Constitution.

ELEVENTH REPORT

PROPOSED AMENDMENT TO THE STATUTES OF THE INTERNATIONAL FUND FOR THE DEVELOPMENT OF PHYSICAL EDUCATION AND SPORT (FIDEPS)

Item 6.10 of the agenda (25 C/81)

(1) The Legal Committee examined item 6.10 of the agenda, concerning the proposed amendment to the Statutes of the International Fund for the Development of Physical Education and Sport.

(2) This item had been subjected to a preliminary substantive examination by Commission II, which had proposed that Article 5, paragraph 2, be amended as follows: 'The members of the Governing Board shall be appointed for a term of office of four years, which may be renewed once. The Chairperson of the Inter-governmental Committee for Physical Education and Sport shall be Chairperson of the Governing Board ex officio'.

- (3) The Legal Committee considered the proposed amendments to the Statutes of the Fund, article by article, including the amendment proposed by Commission II. It decided to submit to the General Conference the text of the revised Statutes annexed to this report.
- (4) Consequently, the General Conference might, if it deemed it desirable, adopt the draft resolution submitted to it.²
