The Executive Board,

- 1. <u>Having examined</u> the preliminary report prepared by the Working Group relating to the in-depth study on the organization and methods of work of UNESCO, as a member of the United Nations system, in a changing world (137 EX/SP/4 & Add. & Corr.),
- 2. <u>Thanks</u> the Special Committee and its Working Group for this preliminary analysis of a difficult and complex topic of such importance for the future role of the Organization;
- 3. <u>Recalls</u> that the Executive Board recommended that 'the role of UNESCO in the United Nations system and in a changing world' be one of the subjects on which heads of delegations would be invited to focus their statements in the general policy debate at the twenty-sixth session of the General Conference;
- 4. <u>Considers</u> that the examination of this topic should continue as a matter of priority, taking into consideration the views of Member States expressed during the general policy debate as well as other relevant decisions taken by the General Conference at its twenty-sixth session;
- 5. <u>Requests</u> the Special Committee, in the light of the debates at this session, of any subsequent debates and of any decisions that may be taken by the General Conference at its twenty-sixth session, to recommend to it appropriate ways of continuing the work of reflection by the Special Committee on the in-depth study on the organization and methods of work of UNESCO, as a member of the United Nations system, in a changing world, and to report to it at its 139th session.

3.4 <u>Report by the Special Committee's Working Group on</u> <u>Decentralization concerning the continuation of its work</u> (137 EX/30)

The Executive Board,

1. <u>Having heard</u> the oral report of the Working Group of the Special Committee on Decentralization concerning the

progress of its studies designed to ascertain 'what pattern of decentralization would best serve the specificities of each region and subregion in the context of existing financial constraints', a report requested by the Board at its 136th session (136 EX/Decision 3.3, para. 10),

- 2. <u>Takes note</u> of the progress made by the Secretariat in devising a methodology for the creation of coherent and compatible regional data bases that can be used to prepare profiles of the different regions taking into account the work carried out in each one of them by UNESCO, including programmes and activities promoted and undertaken within the region funded from both regular and extra-budgetary resources, and the level of co-operation between UNESCO and other organizations of the United Nations system, regional governmental and non-governmental organizations, National Commissions for co-operation with UNESCO and the specialized networks dealing with UNESCO's fields of competence;
- Considers that in order to establish the pattern of 3. decentralization referred to in paragraph 1 above, such profiles should be compiled for all regions in which UNESCO operates, and in-depth evaluations should likewise be carried out, region by region, of each and every UNESCO field office, as provided for under paragraph 9 of Section II of the set of recommendations adopted by the Board at its 136th session; these evaluations should be carried out in conjunction with the host country and the countries of the region/subregion concerned, as well as with National Commissions and funding organizations, and costs resulting should indicate the different from possible regrouping (136 EX/Decision 3.3);
- 4. Recommends to the Director-General that work be continued the data bases and regional profiles that on the Secretariat is promoting as a vital working tool and that, in addition, the in-depth evaluations referred to in paragraph 3 above be carried out within a reasonable period of not more than two years; these evaluations, together with the regional profiles, will enable the Director-General, inter alia, to consult with the Member States of the corresponding regional groups, and to formulate the pattern and structure of field offices and activities best suited to the region/subregion concerned; this work should be completed in time to be reflected in the next Medium-Term Plan.

- 4. <u>Strongly deplores</u> the continued subjection of the occupied Holy City to modifications, alterations, changes and transformations of a demographic and environmental nature, all of which are doing irreparable damage to the equilibrium of this site, which is also one of the world's most beautiful urban landscapes;
- 5. <u>Deplores</u> the fact that, contrary to historical and archaeological truth, a Jewish religious presentation is given, according to the indications contained in the Director-General's report, of monuments belonging to the Roman, Crusader and Arab heritage of the City of Jerusalem, and more specifically of the underground edifices discovered or exposed to view in the course of the excavation of the tunnel along the West Wall of the Haram al-Sharif;

#### ANNEX

STATUTES OF THE UNESCO PRIZE FOR THE PROMOTION OF THE ARTS

### PURPOSES

1. The UNESCO Prize for the Promotion of the Arts (hereinafter called 'the Prize') shall be awarded, in accordance with the ideals of Mr Kaii Higashiyama, in recognition of outstanding creative achievements by young artists, or groups of artists, in the field of the visual arts (painting, sculpture and graphics) and that of the performing arts, and to encourage their further development as artists.

#### PERIODICITY

2. The Prize shall be awarded to five laureates (or groups of laureates) in the above-mentioned fields every two years by the Director-General of UNESCO. For the three prizes in the visual arts, the award ceremony shall be held on the World Day for Cultural Development. The two prizes in the performing arts shall be awarded within the framework of international or regional cultural events (festivals, competitions, etc.) at the discretion of the Director-General.

#### THE PRIZE

3. Each of the prizes shall consist of a financial award of approximately US \$20,000, the exact sum to be decided each time on the basis of the amount made available in advance to UNESCO from interest accruing from the Higashiyama Fund set up and managed by the National Federation of UNESCO Associations in Japan (hereinafter called 'NFUAJ'). To this end the Director-General of UNESCO has established a Trust Fund to receive such interest payments. Any unspent balance of the Trust Fund shall be carried forward from one financial period to the next.

#### SELECTION OF PRIZE-WINNERS

4. The prize-winners shall be selected by an international jury, composed as indicated in Article 5. In the case of the two prizes to be awarded in the field of the performing arts, the Director-General may decide to award them within the context of international or regional cultural events as indicated in Article 2, in which case the task of selecting the prize-winner shall be entrusted to the jury already set up for the event.

#### JURY

5. The Jury shall consist of seven members from different parts of the world who shall be appointed for a term of two years. Five of these members shall be eminent specialists in the fields described in Article 1, appointed by the Director-General of UNESCO to serve in their personal capacity; one member shall represent NFUAJ and one shall represent the Director-General. The Jury shall adopt its Rules of Procedure. The Director-General shall designate a member of the Secretariat to serve as Secretary to the Jury. The administrative costs of the selection process and of the prize-giving ceremony shall be met entirely from the funds provided to UNESCO by NFUAJ.

6. Candidates for the Prize may be proposed to the Director-General by governments of Member States or Associate Members, in consultation with their National Commissions, by recognized schools and institutions for the arts, and by intergovernmental and non-governmental organizations, each of which may nominate one candidate for each award.

7. Nominations for the Prize shall be accompanied by a biographical statement for each candidate, or group of candidates) and shall include a detailed description and photographic

illustration of the work for which the candidature is being presented. The deadline for submission of nominations and supporting documentation to the Director-General shall be 1 November of the year preceding the award of the Prize. In the case of prizes to be awarded in the context of an international or regional cultural event, the UNESCO Prize shall be advertised in advance in a manner to be determined between UNESCO and the organizers of the event.

#### DURATION

8. The Prize, which is created within the framework of the World Decade for Cultural Development (1988-1997), is established for an unlimited duration. If NFUAJ and UNESCO should decide to discontinue awarding the Prize, any unspent balance of the Trust Fund shall be returned to the Federation, after deduction of any expenses remaining unpaid at the time of the discontinuation of the Prize.

- 4. <u>Concerned</u> about the grave and continuing environmental dangers to human beings and the biosphere in Kuwait and in the Gulf region that have resulted from the burning of Kuwaiti oil wells by the occupying forces, and the dumping of crude oil in the Gulf,
- 5. <u>Considering the urgent need felt by the Government of</u> Kuwait to reorient the education system, and strengthen its links with the world of work, by training an adequate number of professionals and technicians in UNESCO's fields of competence,

- Having. studied document 137 EX/28, submitted by the Director-General, concerning the Secretariat's action in the light of the findings of the mission carried out in Kuwait by his personal representative in implementation of 135 EX/Decisions 8.4,
