INTRODUCTION

United Nations Educational, Scientific and Cultural Organization (UNESCO) was founded on November 16, 1945. UNESCO's mission is to contribute to the building of a culture of peace, the eradication of poverty, sustainable development and intercultural dialogue through education, the sciences, culture, communication and information.

With the Headquarters in Paris (France) UNESCO has a network of regional, cluster and country offices, specialized institutes and centres to work with its 195 Member States and 9 Associate Members* at global, regional and country levels

The UNESCO Office in Moscow was opened in 1994 to strengthen cooperation with the Russian Federation. In 2002, as a result of decentralization the mandate of the UNESCO Moscow office was expanded technically to full spectrum of UNESCO's sectoral activities as well as geographically to work with five countries: Armenia, Azerbaijan, Belarus, Republic of Moldova and Russian Federation.* It is the Organization's only cluster office based in Europe and North America







The Bolshoi/UNESCO Project



The Bolshoi Theatre (CC) Alexey Andreyev

Building on its long-rooted traditions of excellence in performing arts, the Bolshoi Theatre became renowned as one of the most highly esteemed centres of excellence for the arts of ballet and opera in the world. The Bolshoi/UNESCO Flagship Project was launched in 1993 on the initiative of the Russian Government. The project's main goal was to provide international assistance to the restoration and modernization of the Bolshoi Theatre.

After a series of consultations, a Master Plan for the Bolshoi was developed for a period of ten years. It covered the renovation of the old building and the construction of a new theatre. The latter,

located next door, enabled the Bolshoi to continue performing while the old building was under renovation. UNESCO offered technical advice on both conceptual and practical issues.

The involvement of Russian and international organizations in the restoration and reconstruction of the Bolshoi's main building gave a decisive impulse to the project in 1998. In the following year, a world-wide campaign started to collect funds for the Bolshoi. To initiate and endorse new actions within the project, a Steering Committee was created under the Chairmanship of Ms. Alexandra Vovolini—Laskaridis, a sponsor of arts.

UNESCO proclaimed March 28, 2000, the Day of Solidarity with the Bolshoi. On that day the Theatre celebrated its 224th anniversary. Many theatres from all over the world responded to the appeal made by the UNESCO Director-General and the Bolshoi's Art Director to support the reconstruction of the Bolshoi. The money collected by the performances in honour of the Bolshoi were credited to the project accounts. In 2001 a charity photo exhibition "Forever Bolshoi" opened in Moscow, constituting an important step in the fundraising campaign.

The UNESCO Moscow Office provided consulting services on the reconstruction project and fundraising campaign. In 2003

independent international experts contracted by UNESCO visited the Bolshoi and provided recommendations on its modernization. In the same year, the UNESCO Moscow Office together with the division of Cultural Heritage and the Bolshoi Theatre held an international conference on the restoration and reconstruction of the Bolshoi. The meeting gathered experts in architecture, conservation and scenography to examine and discuss the proposals for the modernization of the Bolshoi, as well as the experts' reports. One of the conference recommendations was to establish an International Advisory Board for the entire period of restoration of the Bolshoi's main building.

The Hermitage/UNESCO project

Launched in 1993, the Hermitage/UNESCO is an on-going, multifaceted, cooperative project of UNESCO and the State Hermitage Museum in St. Petersburg (Russia). Over the years, several initiatives were undertaken in the areas of museum management, restoration and renovation, conservation and visitor services. These included upgrading the museum's financial accounting system, establishing the museum's international fundraising operations and expanding the network of its international friends, training the museum staff in computerization of the museum's collections, and initiating an international project to preserve 620 Rembrandt prints in the Hermitage collection.

The Hermitage/UNESCO Project worked closely with the museum on several restoration projects. With the assistance of the Flemish Government, the Rubens and Snyders Rooms were restored. A new entrance for the museum was created through the Great Courtyard of the Winter Palace from the Palace Square. With the support from the Dutch government, the restoration of the key element of the new entrance — the porte cochere (vestibule) of the Winter Palace — was completed in 2002. Danish experts assisted in the restoration of the Great Courtyard and its fountain. The new entrance was officially opened to the public in May 2003.

Under the auspices of UNESCO, the Hermitage International Advisory Board was established in 1994. It is comprised of world renowned museum directors and experts who provide consultation on a wide range of issues.



The second phase of the project was focused on expertise sharing with the museums in CIS countries. The first museum management workshop for experts from the leading museums of the cluster countries took place at the Hermitage in 2005 ("The Museum Practices in the 21st Century"). As a follow-up of

the Hermitage/UNESCO partnership project the Interregional seminar on the use of museum resources in the field of artistic education entitled "Problems and Prospects of Arts Education in the XXI Century. Museum Resources" took place at the Hermitage in 2007.



Towards a Culture of Peace

The UNESCO Moscow Office in close cooperation with the Commission of the Russian Federation for UNESCO was actively engaged in the implementation of the National Pilot Project "Culture of Peace in Russia: The Year 2000" and promoted the values of peace and dialogue which are at the heart of UNESCO's mission.

The project received wide support from both governmental and non-governmental organizations as well as from youth movements. Among other events, a Week for the Culture of Peace was conducted in more than 1,400 schools of Moscow. Another highlight of the year — an appeal by the crew of the Mir Orbital Station, on behalf of public organizations in Russia involved in the movement for a culture of peace, to the world's leaders to join the Manifesto 2000 to support Culture of Peace and Non-Violence and the Century without Wars. Altogether, more than 120 thousand people signed the Manifesto 2000.



The International Year for the Culture of Peace was marked by another important event — the Interregional Conference "A Dialogue of Women in Dagestan and Azerbaijan". The conference organized by the Derbent Centre for Social and Psychological Rehabilitation and Culture of Peace was supported by the UNESCO Moscow Office and the Open Society Institute. The conference discussions focused on relationships between the peoples of Dagestan and Azerbaijan and the role of women as peacemakers in the Caucasus.

The pilot project ended in March 2001 with a nationwide Conference "Culture of Peace in Russia: Results and Prospects (From a UNESCO Project to a National Programme)". The conference participants discussed various aspects of the project implementation, training of experts in peacemaking and conflict management, and suggested effective mechanisms for achieving tangible results at community level. This UNESCO supported project evolved into a Federal Programme on Tolerance and Prevention of Extremism in the Russian Society. The Culture of Peace Institute established in 1999 in Kazan (Russia) became one of the first educational site in the world that specialized in the training of peace promoters.

Since 1999, a Russian-language website provided updated information on the subject within the framework of the Internet-based project "Culture of Peace News Network". In April 2000, the UNESCO Moscow Office hosted a number of training sessions for Culture of Peace News Network moderators. Students of Moscow universities were joined for the training by their peers from Dagestan, Volgograd, and St. Petersburg. Participants — young reporters and moderators, representatives of the UNESCO Associated Schools Project, public organizations and professional journalists — discussed the establishment and expansion of the Culture of Peace News Network that acquainted Internet users with culture of peace media products.

Joint UNESCO and Russian Federation Project "Restoration and Development of the Education System of the Chechen Republic"

In 2000, the Director-General of UNESCO. Koïchiro Matsuura, and the President of the Russian Federation, Vladimir Putin, agreed on cooperation between UNESCO and Russia. Assistance in recovery and development of the education system of the Chechen Republic was one of the main priorities of this cooperation. In 2002, on the initiative of UNESCO and with support of the Ministry of Education and Science of the Russian Federation, the Assessment Report "Education in the Chechen Republic – Conditions, Problems, Perspectives of Restoration and Development' was prepared to identify the qualitative and quantitative characteristics of the Chechen education system. The Report provided a framework for necessary and realistic directions for recovery and development of the education system in the Republic in short, medium, and long-term perspectives.

Following the mission of experts from UNESCO and the Russian Federation, including those from the Chechen Republic, a project document containing proposals on the implementation of four interlinked components was developed:

(1) First component – professional development of the staff of the Chechen Ministry of Education and Science, local education authorities and educational institutions (implemented with the financial support of the Government of Japan);

- (2) Second component institutional support to the Chechen Institute for Teacher Retraining (implemented with the financial support of the Government of Norway);
- (3) Third component introduction of information and communication technologies in educational process (implemented with the support of the Government of South Korea which provided computers):

(4) Fourth component – capacity building for integrated psychological, pedagogical and medical and social rehabilitation of school children and education personnel. The financial resources were received jointly with the World Health Organisation through the Trust Fund for Human Security.

For several years the UNESCO's Programme "Children in Need" had been supporting psycho-social rehabilitation of the Chechen children.

Major Project Results

- ▶ 355 education managers and teachers of the Chechen Republic updated their knowledge of the modern education legal framework received training in management, licensing and attestation of educational institutions and other issues:
- ▶ Specialists of the Chechen Institute for Teacher Retraining and teachers of the Chechen schools (altogether over 70 people) upgraded their qualification in school curriculum modernization, content and methods of teaching and organization of methodological and research activities of teachers;

- More than 100 pedagogues-psychologists and specialists in the field of psychosocial rehabilitation of the Chechen Republic were trained in the delivery of psychological and pedagogical support, specific techniques of psychological, pedagogical and correctional work with schoolchildren and their families, methods of emergency psychological interventions;
- More than 200 Chechen children received psychological and pedagogical assistance at a psychosocial rehabilitation camp and other programmes implemented in the Chechen Republic;
- ▶ Altogether over 70 methodological guidelines and recommendations for educators and three textbooks for schoolchildren, including a textbook in the Chechen language, were developed and published;
- ▶ 92 units of computer and office equipment were delivered to the schools of Grozny for introduction of the state-of-the-art information and communication technologies in school education;
- ▶ The Psychological, Pedagogical, Medical and Social Rehabilitation Center was established, equipped, and opened in Grozny.

Indigenous Peoples: fostering access to quality education, information and knowledge

Education for All Goals and Millennium Development Goals have special focus on ensuring access to quality primary education for all children, including those, who live in remote areas. In 2006–2007 the UNESCO Moscow Office in close cooperation with the Ministry of Education of the Republic of Sakha (Yakutia) successfully implemented the project "Promoting Literacy of Indigenous School Children through Capacity Building for the System of Community Education of Nomadic Peoples of North of the Republic of Sakha (Yakutia)".

The overall goal of the project was to increase the number of children receiving basic education that has a focus on preservation of indigenous peoples' cultures. The project contributed to the capacity building for education authorities and nomadic school staff, modernization and improvement of curriculum and textbooks in conformity with the local context, incorporation of modern and efficient approaches and methods in teaching practice, strengthening international cooperation in the field of education, especially in the circumpolar zone. Nine pilot nomadic (mobile) schools participated in the project and created a network of best practice schools for expanding this model over the Republic of Sakha (Yakutia). The established Centre of Nomadic Schools Development elaborated teaching and learning materials and training guidelines, integrating traditional knowledge of indigenous peoples of the North and using different models of community school. In summer 2008, the new law "On nomadic schools in the Republic of Sakha (Yakutia)" came into effect and determined the legal status of nomadic schools which sustained the project results.

To contribute to the promotion and use of multilingualism and universal access to cyberspace, the Office developed two Community Multimedia Centres (CMC) for the local communities of Yugan Khanty and Forest Nency in the Khanty—Mansy Autonomous District — Yugra (Russia). The CMCs seek to enhance ICT access to the cultural riches of the indigenous peoples of Russian regions and integrate local communities into the world community of the Internet users. The CMCs present the ways of life of indigenous peoples of the Russian Federation to the global community via modern ICTs

The project provided training and support to local communities to enable their participation in self documenting processes and development of community archives. The Bear Festival and Master-Apprentice programme became the first local traditions that were documented by the Khanty community Yaoun Yakh in Ugut.

Another project on the promotion of multilingualism – the International Conference "Linguistic and Cultural Diversity in Cyberspace" – brought in 2008 to Yakutsk (Republic Sakha (Yakutia) Russia) over 100 participants from 15 countries. They represented educational institutions, libraries as well as ICT sector and business communities and gathered to share experiences in the fields of legislation, IT and education which promote multilingualism in cyberspace.

In 2007 in continuation of the efforts for promoting cultural diversity and safeguarding intangible cultural heritage of indigenous peoples the UNESCO Moscow Office supported a project to develop and launch a multilingual Internet portal "Kuyaar — Observatory of Cultural Diversity, Traditions and Folk Art of Peoples of the Republic of Sakha (Yakutia)". The project aimed at safeguarding and rejuvenating cultural heritage of the Republic of Sakha (Yakutia) and integrating it into the global culture through public awareness raising.

The Great Volga River Route Project: "Uniting the Seas (Baltic, Black and Caspian Seas) for World Heritage Education for Sustainable Development with Support of Information Communication Technologies (ICTs)"

Uniting 16 countries situated along the Great Volga River Route, the Baltic, Black and Caspian Seas, this cross-cutting and intersectoral project aimed to link young people and mobilize the youth from various countries for exploration of the cultural and natural heritage in support of sustainable development.

During four years (2004–2007), the project facilitated exploration and development of effective ways of using information and communication technologies to improve the quality of education, and supported best practice sharing in education for sustainable development and world heritage. The project contributed to the UN Decade for Education for Sustainable Development (2005–2014) and promote the dialogue between young people and scholars.

UNESCO Associated Schools in 16 countries (Azerbaijan, Bulgaria, Estonia, Finland, Georgia, Germany, Latvia, Lithuania, Iran, Kazakhstan, Poland, Romania, Russian Federation, Sweden, Turkey and Ukraine) participated in this project.

A bilingual English—Russian Web portal was created to present the project interactive map and activities, materials produced by students, and innovative e-modules for teachers and students. It also served for communication and experience sharing purposes.

One of the highlights of the project was the International Forum "Along the Great Volga River Route: Youth Sail to Explore the World

Heritage, Sustainable Development and ICTs" held on a cruise ship "Georgy Chicherin" in May 2006 (Russia). For the first time, the forum brought together 60 participants from all 16 countries that participated in the project. The event was jointly organized by the UNESCO Associated Schools Project Network and the UNESCO World Heritage Centre with the participation of the UNESCO Moscow Office and the Russian ASPnet.

"Living Volga" Programme

In 2006 the UNESCO Moscow Office and Coca-Cola HBC Eurasia joined efforts to foster better understanding and appreciation of biodiversity resources of Volga water and wetlands ecosystems and the principles of sustainable development among local authorities and communities.

Three main action lines of "The Living Volga" programme were identified as follows:

- 1) raising public awareness about the value of the Lower Volga water and wetlands systems;
- 2) drawing attention of the local authorities and industries to environmental problems of water and wetlands ecosystems and increasing their contribution to the sustainable development of the Volga basin,
- 3) producing and disseminating relevant education and information materials.

The programme supported a number of workshops and roundtables, production of booklets and promotional materials, development of action plans and training modules. Ecological competitions were held among school and university students. A working group "The Union for Conservation of the Lower Volga Heritage" was created.

The programme was implemented in close cooperation with the Russian Man and Biosphere (MAB) Committee and the Russian biosphere reserves to ensure full coherence of the programme activities with the MAB Programme. The programme also envisaged effective collaboration with the International Hydrological Programme (IHP) and all key actors in this area, including international organizations such as UNDP, UNEP, GEF, Wetlands International.

To raise public awareness about the great value of the Lower Volga wetlands two kits, an educational and an informational, were developed by specialists from environmental and nature protection organizations based on ecological and educational experience of nature reserves. A desk game "Voyage along the Volga River" was developed in 2013 to enhance environmental awareness of young people about the water resources and the Volga ecosystems. A new web-site http://www.living-volga. ru was created for disseminating the programme materials, networking and cooperation.

Thanks to "The Living Volga" programme, May 20 was inscribed in the international ecological calendar as the annual Volga Day with the purpose to raise public awareness about the challenges of conservation of the Volga River ecosystem and sustainable use of its resources. The Volga Day was first commemorated in 2008 in Nizhny Novgorod, and in 2009 it was marked in Astrakhan, Kazan, Nizhny Novgorod and Volgograd where it gained its followers and partners, who initiated the celebration.

Since 2010, the UNESCO Moscow Office focused the programme activities on scientific meetings: several seminars were organized in Nizhny Novgorod, Astrakhan and Volzhsko-Kamsky biosphere reserve.

Promoting Bioethics in CIS

In line with the UNESCO Programme "Assisting Bioethics Committees" (ABC), the Office supported the establishment of National Committees on Bioethics and contributed to the reinforcement of country capacities in the area of ethics education. By the end of 2007, National Committees on Bioethics were established in all cluster countries. Since 2008, activities focused on the networking and capacity building of the Committees. The Congress "Bioethics and Human Rights" held in 2008 in Kazan (Russia) initiated the creation of the Regional Network of National Bioethics Committees

The UNESCO Ethics Education Programme (EEP) set a framework for dissemination of the information concerning the 2005 Universal Declaration on Bioethics and Human Rights. This programme is mapping existing ethics teaching curricula in the UNESCO Member States to make them available through the Global Ethics Observatory (GEObs). In order to promote the quality of ethics

teaching, UNESCO regularly organizes meetings with ethics teaching experts and conducts the Ethics Teacher Training Course, targeting, in particular, a younger generation of university teachers.

With the support of the UNESCO Moscow office, representatives of the newly established Network of the National Bioethics Committees of CIS countries were actively involved in the above mentioned activities. Their participation in the International Ombudsman Conference "Bioethics, Human Rights and New Technologies: legal and ethical aspects of reproductive health and family planning" (Azerbaijan, 2009) provided Azerbaijani experts in bioethics an opportunity to build capacity. The UNESCO Ethics Teacher Training Course (Belarus, 2008) was used to train young ethics teachers from different countries. The Sub-regional meeting of experts in bioethics teaching (Republic of Moldova, 2009) made a significant contribution to strengthening cooperation in the field of bioethics education in CIS countries. The Regional Seminar "Bioethics Education in Armenian Universities: Problems and Perspectives"

(Armenia, 2010) emphasized the importance and necessity of teaching bioethics and provided an impetus to the development of educational programs in bioethics, specialist training and public awareness raising initiatives and the promotion of the ideas and values of bioethics and human rights in the cluster countries. The 18th (ordinary) Session of the International Bioethics Committee of UNESCO (Azerbaijan, 2011), which was held at the invitation of the Government of Azerbaijan, became an excellent

opportunity for the leading experts in bioethics to share experiences and analyse new ethical challenges in the field of bioethics in the region.

In 2008 the UNESCO's Bioethics Core Curriculum aimed to introduce the principles of the Universal Declaration on Bioethics and Human Rights to university students was published in Russian. Its pilot testing was conducted in the Lomonosov Moscow State University (Russia), Kazan State Medical University (Russia), International Sakharov Environmental University (Belarus), Yerevan State Medical University (Armenia) and Baku State University (Azerbaijan).

In 2006, the project "Bioethics and Media" started to sensitize the public and introduce bioethical issues into the agenda of the mass media of the sub-region's countries. Over a period of seven years several round tables, workshops and seminars focusing on bioethics issues in the mass media were held for journalists in the cluster countries: Russia, 2006–2007; Armenia, 2008; Lithuania,

2009; Belarus, Azerbaijan, Republic of Moldova, 2011. As part of the project, a cross-regional network of journalists interested in the promotion of bioethics in the media was set up. Several handbooks on problems of bioethics in the mass media were published in Russian and English to provide recommendations for journalists on how to cover sensitive bioethical issues.

In 2011, the application of advanced communication and information technologies made the ongoing journalist training different from the one carried out in the previous years — journalists from different countries got an opportunity to study the bioethics course online. The integrated training programme on bioethics for distance education (e-learning) was elaborated in Russian and English by the Office in close cooperation with the UNESCO Institute for Information Technologies in Education and leading specialists from CIS countries, members of the Regional Network of National Bioethics Committees.

Long-term cooperation within the framework of the Inter-Parliamentary Assembly of CIS (IPACIS) and UNESCO facilitated the development of several normative documents for the regional countries. In 2010 IPACIS adopted normative and methodological recommendations for harmonization of medical education in the region within UNESCO Bioethics Core Curriculum, in 2012 – "Declaration on Ethical Principles of Science Activity". Both documents were elaborated by a group of UNESCO experts with the support of the UNESCO Moscow Office and the Permanent Commission of IPACIS on Science and Education.

"Running a Museum" – UNESCO/ICOM training for museum professionals in the CIS

Museum specialists from all CIS countries (Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Republic of Moldova, Russian Federation, Tajikistan, Ukraine and Uzbekistan) participated in the trainings implemented in the framework of two extra-budgetary projects: "A Series of Regional and National Capacity Building Trainings for CIS Countries in Museum Management based on UNESCO/ICOM Museum Studies Training Package" (2008–2010) and "Running a Museum — XXI Century: Thematic Regional Capacity Building UNESCO/ICOM Trainings and Expert Meetings for CIS Countries" (2011–2014) developed by the culture desk of the UNESO Moscow Office and supported by the Intergovernmental

Foundation for Educational, Scientific and Cultural Cooperation (IFESCCO). The project sought to promote international partnerships and strengthened social, economic and educational roles of museums for sustainable development, with a special emphasis on museum development in the context of sustainable tourism development and intercultural dialogue.

Within the project "A Series of Regional and National Capacity Building Trainings for CIS Countries in Museum Management based on UNESCO/ICOM Museum Studies Training Package" (2008–2010) national capacities for the legal protection of movable cultural property were strengthened and the capacity of museum professionals in museum management and collection conservation was increased. More than 200 museum professionals from nine CIS Member States were trained to conduct national trainings in their respective countries. A booklet and a DVD "Running a Museum — XXI century" were published. The training sessions were

conducted in close cooperation with the ministries of culture and national museums of the cluster countries. A network of museum partnerships was created as a result of the project.

Capacities of more than 300 experts in museum management from Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Republic of Moldova, Russian Federation, Tajikistan, Ukraine and Uzbekistan were strengthened through supporting their participation in the series of regional thematic and UNESCO/ICOM museum trainings and expert meetings organized under the UNESCO/IFESCCO long-term project "Running a Museum – XXI Century: Thematic Regional Capacity Building UNESCO/ICOM Trainings and Expert Meetings for CIS Countries" (2011–2014) based on the UNESCO/ICOM Museum Studies Training Package.

The project facilitated the inclusion of culture in the development policies to foster the culture of peace and non-violence through

development of museum partnerships and improvement of museum policies. Apart from increasing social, economic and educational roles of museums, their role in sustainable tourism was strengthened. Efforts to support the sustainability and development of museums in CIS countries were made with a focus on professional capacities in conservation and public programming. Cooperation with major professional institutions reinforced.

Reinforcing Arts Education for Cultural Creativity and Sustaining the Diversity of Cultural Expressions

Aiming to assist the cluster countries in the development of national policies and strategies in the field of protection and promotion of the diversity of cultural expressions the UNESCO Moscow Office implemented the project "Arts Education in CIS Countries: Building Creative Capacities for XXI Century" (2009–2014) which was included into the UNESCO's additional programme entitled "Sustainable Development of Arts Education to Promote the Diversity of Cultural Expressions". The objective of the UNESCO's programme was to acknowledge the value of arts education in promoting creativity and innovation, cultural diversity and in giving equal learning opportunities to children and adolescents living in marginalized areas.

The activities within the UNESCO/IFESCCO project were carried out by the UNESCO Moscow Office in partnership with UNESCO offices in Almaty and Tashkent and UNESCO Headquarters (Section of Museums and Creativity) in close cooperation with cultural and educational governmental institutions, including the

Ministries of Culture, the Ministries of Education, state universities and institutions of culture and arts as well as non-governmental organizations working in this field in CIS countries.

The existing systems of arts education, current programmes and development trends were studied in all CIS countries and analytical reports were prepared for each country. The reports included recommendations which allowed to assess the current state and challenges of arts education development and set strategic goals for its further development.

The project activities were implemented by expert communities of CIS countries with consideration of international experience and UNESCO's basic documents in this field.

Professional partnerships and networking for the capacity building in the field of arts education and education through arts, focusing on implementation of the "Seoul Agenda: Goals for the Development of Arts Education" (adopted at the 2nd World Conference on Arts Education in May 2010) and the Road Map for Arts Education (adopted at the 1st World Conference on

Arts Education in 2006, Lisbon) were strengthened through the conduction of two expert meetings.

As a result of the project, a bilingual Russian—English information resource — "Observatory on Arts Education in CIS Countries" — was created and launched. This Observatory is a multilevel informational resource, which provides access to the basic international documents about arts education and education through art and documents regulating the activities in the field of arts education and other related documents and information

During the project implementation, several publications were prepared, produced and distributed in partnership with the Moscow State University of Culture and Arts and the National Institute for Education of the Ministry of Education of the Republic of Belarus. These included a policy brief "Strategic Guidelines for the Development of Arts Education in the CIS Countries" and a comparative analytical review "Arts Education in CIS Countries" with a presentational DVD. These materials are available online at the websites of the Observatory of Arts Education in the CIS Countries and the LINESCO Moscow Office

Safeguarding of the Intangible Cultural Heritage

The UNESCO Moscow Office assists cluster countries in developing measures to promote the principles of the Convention for the Safeguarding of the Intangible Cultural Heritage (UNESCO, 2003). Particular attention is given to the safeguarding of intangible heritage through the use of modern information and communication technologies, its promotion and transmission to the young generation.

To strengthen intergenerational transmission of intangible cultural heritage and enhance cultural diversity, a long-term project "Safeguarding of the Armenian Duduk Music as a Masterpiece of the Oral and Intangible Cultural Heritage of Humanity" was initiated in 2006. The project included master classes, competitions for duduk players and concerts, launching of a website on the Armenian duduk music, and publication of a practical manual for playing duduk.

The Azerbaijani Mugham was proclaimed a masterpiece of the Oral and Intangible Heritage of the Humanity in 2005. For the purposes of inventorying the Mugham performances, a special website — "Atlas of the Traditional Music of Azerbaijan" — was created. It contains information on the genres of folk arts as well as examples of regional Mugham performances.

World folklore is an important constituent of the intangible heritage. To promote access to the rich intangible heritage of the cluster countries, the Office, among other activities, supported the production of a DVD "Belarusian Folk Dances", featuring examples of traditional folk dances performed by local residents from different ethnographic regions of Belarus; a CD "Musical Folklore of Romanians outside Romania", containing more than 2000 pieces from folklore collections edited at different times in Romania and the Republic of Moldova; a DVD "Cultural Heritage of the Shor People" with two heroic sagas of indigenous Shor people of Siberia.

Developing Independent and Pluralistic Mass Media

Free, independent and pluralistic communication, as well as universal access to information are important cornerstones of inclusive societies. The UNESCO Moscow Office provided substantial support to train journalists in the cluster countries on the topics of independent journalism in post-conflict situations, scientific journalism, reporting on issues related to Millennium Development Goals, writing about climate change, sustainable development, and HIV and AIDS. Several activities helped media workers to improve ethical and professional standards and develop media accountability systems based on the principles of self-regulation. Within UNESCO's International Programme for Communication Development a number of media capacity building projects were implemented in the cluster countries.

To strengthen the culture of tolerance and understanding among young journalists, the Office supported a media forum for young journalists "Dialogue of Cultures" since 2006. The unique format of the project, developed by Eurasia Media Centre and the State Hermitage Museum, provided possibilities for intercultural exchange, dialogue and promotion of peace.

To celebrate World Press Freedom Day and raise awareness on freedom of expression, the Office supported various activities in the cluster countries. A highlight of these events is the international photo and television contest to celebrate World Press Freedom Day, held annually in Moscow, Russia. As part of the contest, photographers and media specialists from CIS and Eastern European countries meet to discuss their views on the freedom of press and the freedom of expression in their respective countries.

Over the years the contest has grown in both prestige and number of participants. In 2010 more than 500 journalists submitted their photo and video reports to the contest which received a larger media coverage.

Fostering access to Documentary Heritage

Various activities of the UNESCO Moscow Office were geared towards strengthening libraries and archives as the key actors in knowledge dissemination among the public at large and specialized groups. Within the framework of the UNESCO Master plan "Modernization of the Russian State Library", continuous support was provided to the library. The Russian State Library features 43 million volumes in 367 languages and is among the largest libraries of the world. The provided assistance focused on the restoration of the library buildings, management restructuring, and improving information management.

UNESCO's Programme "Memory of the World" aims at protecting and disseminating world's inheritance of books and works of art, history and science. As of December 2013, the Memory of the World Register included 293 entries — archive and library collections as well as manuscripts. One of the entries included in the Memory of



the World Register is held in Armenia, three – in Azerbaijan, one – in Belarus and eleven entries are held in archives and libraries of Russia

Virtual reconstruction of the Radziwill's archive and library catalogue has kick-started digitization of documentary heritage in Belarus. In 2009 with the assistance of the UNESCO Moscow Office and cooperation between archivists and librarians of Belarus, Lithuania, Poland, Russia, Ukraine and Finland, the Nesvizh Radziwill Archive and Library Collection, one of the largest in Central and Eastern Europe, was added to UNESCO's Memory of the World Register.

To enhance access to documentary heritage and contribute to its preservation using ICT, collections of valuable documents from libraries and museums of Armenia, Azerbaijan, Belarus, Republic of Moldova and Russia were reproduced on CD and DVD and online catalogues of library resources were created. Activities focusing on the preservation of documentary heritage assisted cluster countries in deepening their appreciation for the roots of their national identity and regional cultural interdependency.

Education for health, HIV prevention and youth participation

Over a decade, the UNESCO Moscow Office has been working to achieve Education for All by promoting the health of every individual within the school community. Good polices and practice have been promoted to create healthy and inclusive learning environments for all members of the school community, foster youth participation in healthy lifestyle promotion and

strengthen education sector responses to HIV epidemic. Since 2009, the UNESCO Moscow office provides technical support to CIS countries through EDUCAIDS, the UNESCO led global initiative on education and HIV and AIDS.

Strategic information generated through assessment of situation related to HIV prevention education in Russia (2007), and in ten CIS countries (2011 and 2013) prompted decisions and actions to improve the quality and expand the scale of prevention education programmes. National concepts for HIV prevention education developed with UNESCO's support in Russia (2005) and Belarus (2007) set a framework and basic approaches for learners' awareness raising about HIV. Formation of enabling environment in educational institutions for learners and teachers living with or affected by HIV was the aim of targeted interventions in 5 countries in 2011–2012

and resulted with the adoption of comprehensive national policies on HIV in education sector in Belarus, Kyrgyzstan, Russian Federation, Tajikistan and Ukraine.

In Ukraine, to facilitate delivery of "Basics of Health" obligatory subject in primary school new textbooks were developed for Grades 1-3 in cooperation with the UNESCO Moscow Office. About 1 million pupils will use these textbooks in Ukrainian schools every year.

To provide synergies between formal and non-formal education on HIV prevention, UNESCO worked with NGOs to enhance their capacities to reach out young people from key populations and use the Internet and social media to raise young people's awareness about sexual and reproductive health and rights and reduce stigma and discrimination against people living with HIV.

To ease acceptance and reinforce delivery of school-based HIV prevention and health education, UNESCO and PSYCHOLOGIES


magazine developed and widely promoted resources for parents' sensitization about the benefits and approaches of such education: a special section "TEEN's Territory" in the magazine's printed version and website. Thanks to cooperation with AMWAY Charity Fund "Responsible for the Future" over 140,000 readers of the magazine received a free "Guide for Parents of Adolescents" in 2013. The "Guide" is available online.








"Delivering as One", launched in 2007 in eight pilot countries around the world, has become one of the core principles of the UNECO Moscow Office programming. Though non-resident in four of the five cluster countries, the Office ensured UNESCO's participation in UN Country Team processes across the cluster including development of the United Nations Development Assistance Frameworks (UNDAF). The implementation of joint projects and UNESCO-supported activities was carried out in a coordinated fashion.

Within the UNDAF for Armenia for 2005–2009 and in close cooperation with the Government of the country and other UN agencies, the Office developed its first UNESCO Country Programming Document (UCPD), which was signed by UNESCO and the Government of Armenia on March 20, 2008. UCPDs have

been also developed for Azerbaijan, Belarus, the Republic of Moldova. Since 2010 the Office actively participated in the process of elaboration of UNDAF in these four cluster countries.

Major thematic priorities proposed by UNESCO for the UNDAF for Armenia in 2010–2014 include strengthening technical and vocational education and training (TVET), enhancing national environmental policies, providing better access to information for women and marginalized, developing capacity of regional media and the Human Rights Defender's Office, and facilitating confidence building and dialogue.

In Azerbaijan, the UNESCO Moscow Office works in line with the priorities established in the UCPD for the Republic of Azerbaijan for 2011–2013 and the objectives set in the country's UNDAF

for 2011–2015 in such areas as science policy, cultural tourism, media development, universal access to effective HIV prevention and treatment, early childhood care and education, use of ICT in education and support to human rights institutions.

In the UCPD for Belarus for 2010–2012 and the country's UNDAF for 2011–2015 the Office's work was focused on the following areas: technical and vocational education and training, education for sustainable development, education in the field of environmental ethics and bioethics, improvement of environmental protection, promotion of cultural diversity and intercultural dialogue, media development and preservation of documentary heritage.

UNESCO's cooperation with the Republic of Moldova was guided by the UCPD for 2009–2011 and the national priorities as established in the country UNDAF for 2007–2012. Having completed all the activities planned under the current UCPD and UNDAF, to safeguard intangible cultural heritage, to develop arts education and museum network, to enhance capacities of media workers and educators, the UNESCO Moscow Office was actively working with national and UN partners on the elaboration of the new United Nations Partnership Frameworks (UNPF) for 2013–2017, which addresses the key priorities identified in the new National Development Strategy. The Office's work focuses on the development of new policies and piloting innovative approaches in the field of education, science and culture and the implementation of international conventions with a broader objective to promote the sustainable development of the Republic of Moldova.

In all the cluster countries, the UNESCO Moscow Office participates in Joint UN Team on HIV and in cooperation with other UNAIDS co-sponsors works towards achievement of the goals of the UNAIDS Strategy and Outcome Framework 2011–2015. UNESCO promotes comprehensive national education

sector responses to the HIV epidemic and mobilizes cultural, social science, civil society and media resources to halt the spread of HIV among young people and key populations at higher risk of infection. Engaging people living with HIV, promoting gender sensitive and culturally appropriate responses and fighting stigma and discrimination are at the heart of UNESCO's HIV-related programming in the cluster countries.

To effectively support these national priorities, UNESCO is collaborating with governmental organizations of the cluster countries, academia, civil society and other UN agencies.

In all projects and activities realised in the cluster countries the Office applies a gender equality perspective, promoting UNESCO Gender Equality Priority and Gender Mainstreaming Strategy.

In 2013, when all UNESCO commitments within first UCPD for the four cluster countries were implemented, the UNESCO Moscow Office in close cooperation with the National Commissions for UNESCO elaborated and published new UCPD for 2014–2017. New UCPD are based on the analysis of the current situation, national priorities in the fields of education, sciences, culture and communication and information, the experience gained in the countries and the current countries' UNDAF.




