1. *Having* examined document ICDS/2CP/Doc.13,

 3. *Elects* Mr Sergei Nered (Belarus), Mr Daniel Jacobovitch (Argentina), Mr Jiang Zhixue (China), Ms Lina Fassi (Morocco) as Vice-Chairpersons of the Conference of Parties.

The Conference of Parties,

1. *Having* examined document ICDS/3CP/Doc.2,
 2. *Adopts* the agenda and timetable included in the above-mentioned document.

RESOLUTION 3CP/3

The Conference of Parties,

1. *Having* examined document ICDS/3CP/Doc.3,
2. *Welcomes* the initiatives undertaken by the Secretariat to promote the International Convention against Doping in Sport and to increase the number of States Parties to the Convention,
3. *Expresses* its gratitude to all of the intergovernmental organizations and the World Anti-Doping Agency (WADA), which have provided valuable support to the International Convention against Doping in Sport,
4. *Strongly encourages* all Member States of UNESCO that have not yet done so to become States Parties to the International Convention against Doping in Sport,

5. *Requests* the Secretariat to continue to enhance existing arrangements as well as to develop new partnerships to promote the International Convention against Doping in Sport, and in particular anti-doping education initiatives,
 6. *Calls upon* the representatives of WADA and relevant regional intergovernmental organizations and/or sport organizations to promote the International Convention against Doping in Sport within their respective regions particularly through existing initiatives and regional meetings and conferences.

RESOLUTION 3CP/4

The Conference of Parties,

1. *Expresses* its gratitude to the World Anti-Doping Agency for its comprehensive report.

RESOLUTION 3CP/5

The Conference of Parties,

1. *Having examined* document ICDS/3CP/Doc.4,
 2. *Acknowledges* that the 2012 Prohibited List International Standard has been prepared by the World Anti-Doping Agency (WADA) in accordance with the guidelines for the annual review and consequent publication of the Prohibited List, involving the circulation of a draft Prohibited List and consultation with government and sports movement stakeholders, as outlined in the World Anti-Doping Code,
 3. *Recognizes* that the elimination of doping in sport is dependent upon harmonization of anti-doping standards and their application by the sports movement and competent national authorities,
 4. *Approves* the amendment of Annex I of the International Convention against Doping in Sport in order to incorporate the changes made by WADA, from the 2011 Prohibited List International Standard to the 2012 Prohibited List International Standard.

RESOLUTION 3CP/6.1

The Conference of Parties,

1. *Having examined* document ICDS/3CP/Doc.5,
2. *Expresses* its gratitude to the States Parties that have made financial contributions to the Fund for the Elimination of Doping in Sport,

3. *Notes with satisfaction* the financial status of the Fund for the Elimination of Doping in Sport.

RESOLUTION 3CP/6.2

The Conference of Parties,

1. *Having examined* document ICDS/3CP/Doc.6,
 2. *Notes with satisfaction* the unprecedented number of applications submitted to the Fund for the Elimination of Doping in Sport and the large number of projects approved in the 2010-2011 biennium,
 3. *Expresses* its gratitude to the Approval Committee for their work in the allocation of the Fund for the Elimination of Doping in Sport, as well as to the Secretariat for their efficiency in administering the Fund and supporting States Parties in the development of applications.

RESOLUTION 3CP/6.3

The Conference of Parties,

1. *Having examined* documents ICDS/3CP/Doc.6 and ICDS/3CP/Doc.7,
2. *Takes note* of the recommendations made by the Approval Committee regarding the principles and procedures governing the allocation of the Fund for the Elimination of Doping in Sport,
3. *Agrees* that the principles and procedures governing the administration of the Fund, as determined by the Conference of Parties in Resolutions 1CP/7 and 2CP/4.3, shall be amended as follows:

...

- The disbursement of the amounts approved for the States Parties submitting applications to the Fund for the Elimination of Doping in Sport can only be made for States Parties that have submitted national reports as required under Article 31 of the Convention.
- Applications shall have five compulsory prerequisites. States Parties in submitting the applications must agree:

...

(iii bis) to ensure that the amounts allocated to hospitality as direct costs in each project shall not exceed 10% of the total financial contribution provided by UNESCO,

4. *Approves* the use of the Fund for the Elimination of Doping in Sport for the establishment of a P1/2 Post, for the 2012-2013 biennium, to administer the

Fund and to support the implementation of the International Convention against Doping in Sport, it being understood that this decision be reviewed at the fourth session of the Conference of Parties,

5. *Requests* the Secretariat to revise the *Handbook: Fund for the Elimination of Doping in Sport* to incorporate the decisions taken above.

RESOLUTION 3CP/6.4

The Conference of Parties,

1. *Elects* France / Canada¹, the Russian Federation, Barbados, New Zealand / Australia², Côte d'Ivoire and Kuwait to the Approval Committee.

¹ The States Parties of Group I agreed that France will represent them on the Approval Committee from the end of the third session of the Conference of Parties for one year, and that Canada will represent them in the second year until the conclusion of the fourth session of the Conference of Parties.

² The States Parties of Group IV agreed that New Zealand will represent them on the Approval Committee from the end of the third session of the Conference of Parties for one year, and that Australia will represent them in the second year until the conclusion of the fourth session of the Conference of Parties.
