 - In December 2014, the National Commission has agreed to reimburse the unspent funds of US\$ 6,000 for the project **N° 6651423002UKR** "Creating the model of ecological network of Marine Protected Area of the Crimean Peninsula and its integration into national and Pan-European ecological network." implemented under the Participation Programme 2012-2013. **These funds were not transferred to UNESCO's account to date.**

- 2008-2009: the approved requests were not financed due to the country's failure to present financial reports of the previous biennium.
