- 5. <u>Further decides</u> to place consideration of this matter under the title "Draft UNESCO declaration on cultural diversity" on the agenda of its 162nd session with a view to the adoption of a recommendation to the General Conference, and on the provisional agenda of the 31st session of the General Conference.

Recalling the provisions of the Fourth Geneva Convention of 1949 and its Additional Protocols, of the Convention for the Protection of Cultural Property in the Event of Armed Conflict (The Hague, 1954) and its Protocol, and of the Convention for the Protection of the World Cultural and Natural Heritage (1972), the inscription of the Old City of Jerusalem on the World Heritage List and on the List of World Heritage in Danger, and the relevant United Nations Security Council and General Assembly resolutions and decisions on the status of Jerusalem,
- 3. <u>Takes note</u> of document 161 EX/13 and Addenda concerning Jerusalem and the implementation of 160 EX/Decision 3.5.1 and of the exchanges of correspondence between the Director-General of UNESCO and the Director General of the Ministry of Foreign Affairs of Israel;
- 4. <u>Concerned</u> at the measures which continue to impede the free access of Palestinians to Jerusalem,
- 5. <u>Condemns</u> the excessive use of force and the acts of violence which began on 28 September 2000 on the esplanade of al-Saram ash-Sharîf, itself part of a site inscribed in the World Heritage List, and which have led to heavy losses;
- 6. <u>Endorses</u> the Director-General's remarks on this issue in document 161 EX/INF.16;
- 7. <u>Takes note</u> of the conclusions of the Mitchell Commission and of the Egypto-Jordanian initiative, as measures intended to help restore calm and build confidence between the two parties;

- 8. <u>Renews its request</u> to the Israeli authorities to implement the resolutions and decisions of UNESCO relating to Jerusalem;
- 9. <u>Thanks</u> the States, organizations, institutions and individuals that have made financial contributions to the Special Account for the Safeguarding of the Cultural Heritage of the City of Jerusalem, and in particular the Kingdom of Saudi Arabia for its generous contribution;
- 10. <u>Thanks</u> the Director-General for his praiseworthy and unceasing efforts for the preservation of the cultural and historic property of the Old City of Jerusalem, and <u>invites</u> him to continue his efforts to safeguard the overall balance of the site, and to endeavour to ensure the application by the occupying power of all decisions and resolutions concerning Jerusalem and relating to cultural, architectural, historical and demographic aspects and to the restoration work;
- 11. Reiterates its regret that the Israeli authorities are continuing to obstruct the mission to Jerusalem with which Professor Oleg Grabar was entrusted, and that as a result of this obstruction he has not been able to submit his report to the Executive Board at its 161st session;
- 12. <u>Invites</u> the Director-General to continue his efforts with a view to securing the implementation by the Israeli authorities of 30 C/Resolution 28 and enabling Professor Grabar to carry out his mission and to submit his report at the 162nd session;
- 13. <u>Stresses the need</u> for the Israeli authorities to take all necessary measures to facilitate the satisfactory accomplishment of this mission;
- 14. <u>Requests</u> governmental and non-governmental organizations and institutions to observe UNESCO General Conference resolutions and Executive Board decisions relating to Jerusalem, and not to allow any measures to be taken which contravene them;
- 15. Decides to include this item in the agenda of its 162nd session.

- 5. Once again launches an urgent appeal to Member States and to public and private donors to strengthen their action to safeguard, revitalize and promote examples of the heritage proclaimed by UNESCO masterpieces of the oral and intangible heritage of humanity, in particular by means of extrabudgetary resources and the creation of prizes;
- 6. <u>Takes note</u> of the interim report on the progress made in processing the candidatures relating to the proclamation and the action plan for the safeguarding, protection and promotion of cultural spaces or forms of cultural expression of the oral and intangible heritage of humanity;
- 7. <u>Approves</u> the draft general rules governing the award of prizes for safeguarding, protecting and promoting cultural spaces or forms of popular or traditional expression proclaimed by UNESCO as "Masterpieces of the Oral and Intangible Heritage of Humanity", set out in the annex to this decision;
- 8. <u>Invites</u> the Director-General to carry out a study with a view to the establishment of consolidated administrative and financial procedures for the implementation of the project concerning the "Proclamation of Masterpieces of the Oral and Intangible Heritage of Humanity" and to submit the study to it for approval at its 162nd session;
- 9. <u>Also invites</u> the Director-General to study the question of extending the database on cultural spaces and forms of expression of the oral and intangible heritage of humanity and of setting up for that purpose an audio/video library, safeguarding the recordings of all candidatures presented for the competition without exception;
- 10. <u>Further invites</u> Member States to consider as appropriate the establishment of national organs for the protection of the intangible heritage, composed of artists, creative workers and any other actors involved at local level.

General rules governing the award of prizes for safeguarding, protecting and promoting cultural spaces or forms of popular or traditional cultural expression proclaimed by UNESCO as "Masterpieces of the Oral and Intangible Heritage of Humanity"

1. PURPOSE

These prizes form part of a set of measures designed to contribute to the safeguarding, protecting and promoting of the oral and intangible heritage. Their purpose is to encourage individuals, groups, institutions and organizations to safeguard, protect and promote those cultural spaces or forms of popular or traditional expression proclaimed by UNESCO as "Masterpieces of the Oral and Intangible Heritage of Humanity".

2. OFFICIAL NAME OF EACH PRIZE

Each prize shall be given an official name, to be settled by mutual agreement between the donor and the Director-General.

3. PRIZES

The prizes, the amounts of which will be fixed by the donors, may be awarded every two years, in relation with the "Proclamation by UNESCO of Masterpieces of the Oral and Intangible Heritage". The amount of a prize not awarded in a particular year may be awarded in one of the four years immediately following the year in question, as an additional prize.

4. ELIGIBILITY

The prizes are open to individuals, groups, institutions and organizations which are mentioned in the candidature files for the Proclamation of Masterpieces of the Oral and Intangible Heritage as responsible entities for the implementation of the action plan aiming at safeguarding those masterpieces.

5. SELECTION OF PRIZEWINNERS

The prizewinner(s) shall be selected by the Director-General on the recommendation of an international jury.

6. JURY

The jury shall consist of five to twelve members of different nationalities appointed by the Director-General for a period of two years on the basis of the criteria established under paragraph 4 of the Regulations relating to the Proclamation by UNESCO of Masterpieces of the Oral and Intangible Heritage of Humanity (155 EX/Decision 3.5.5). The jury will be chaired by the President of the International Jury for the Proclamation of Masterpieces of the Oral and Intangible Heritage.

7. PROCEDURE FOR THE AWARD OF PRIZES

The names of the winners of the prizes will be announced during a special ceremony to be held at the time of the sessions of the General Conference.

8. DURATION FOR THE AWARD OF PRIZES

Each prize is created for an indeterminate period. Should a donor or UNESCO decide to stop awarding the prize, the amounts remaining in the prize account shall be returned to the donor, after deduction of all charges outstanding at the time when the prize is terminated.

- 7. <u>Recommends</u> the General Conference to take a decision to continue action aimed at advancing the preparation of a new international standard-setting instrument for the safeguarding of the intangible cultural heritage.

- 3. Recalling 155 EX/Decision 9.6 inviting the Member States, the institutions of the United Nations system, other intergovernmental organizations and the non-governmental organizations to celebrate the International Year for the Culture of Peace in the year 2000,
- 4. <u>Takes note with appreciation</u> of the global mobilization achieved by UNESCO during the International Year for the Culture of Peace, including by Member States, intergovernmental organizations, civil society and a large number of individuals who committed themselves to follow the principles of a culture of peace in their daily lives;
- 5. <u>Commends</u> the Director-General for the breadth and effectiveness of all activities undertaken:
- 6. <u>Notes</u> that UNESCO has been designated by the United Nations General Assembly in resolution 55/47 as the lead agency for the International Decade for a Culture of Peace and Non-Violence for the Children of the World;
- 7. <u>Invites</u> the Member States and all partners of UNESCO to continue and further deepen their commitment to a culture of peace during the International Decade for a Culture of Peace and Non-Violence for the Children of the World (2001-2010):
- 8. <u>Encourages</u> the Director-General to continue his coordination and mobilization action to promote a culture of peace, in cooperation with the United Nations.

- 5. <u>Appeals</u> to Member States to ratify or accede to the UNESCO Convention against Discrimination in Education;
- 6. Requests the Director-General to ensure adequate UNESCO participation in the World Conference and its working groups and a visible and significant UNESCO contribution to the Conference and to continue to cooperate closely in this regard with the Office of the United Nations High Commissioner for Human Rights; also requests the Director-General to ensure adequate UNESCO participation in the 9th Summit of la Francophonie (27-29 October 2001);
- 7. <u>Invites</u> the Director-General to contribute to the implementation of the decisions and recommendations to be adopted by the above-mentioned World Conference.

- 1. <u>Having examined</u> the Draft Medium-Term Strategy for 2002-2007 (31 C/4),
- 2. <u>Noting</u> that this document was prepared in conformity with 160 EX/Decision 5.1 and draws on the results of a vast and transparent consultation process with Member States, National Commissions, international and regional organizations and other stakeholders,
- 3. <u>Conscious</u> that this Strategy is an integral part and the programmatic pillar of the reform process of the Organization and that it complements the administrative and structural reforms already launched,
- 4. <u>Expresses its appreciation</u> to the Director-General for the innovative approach and presentation of the Strategy and <u>expresses its conviction</u> that it lays a solid foundation for the urgently required programmatic re-orientation and renewal of the Organization;
- 5. <u>Underlines</u> the importance of the unifying theme for the Strategy "UNESCO contributing to peace and human development in an era of globalization through education, the sciences, culture and communication" and <u>expresses its wish</u> that the linkages between the unifying theme and the various activities proposed be more explicitly articulated throughout the document;
- 6. <u>Welcomes</u> the clear progress in the presentation of the document, in particular its clarity and focus, which sets forth the general policies of the Organization, its mission, strategic objectives and related strategies in each of its fields of competence;
- 7. <u>Appreciates</u> the clear structure of the Strategy, built around a set of well-defined strategic and sub-strategic objectives and two cross-cutting themes to be pursued during 2002-2007;
- 8. <u>Underlines</u> that the two cross-cutting themes "Eradication of poverty, especially extreme poverty" and "The contribution of information and

- communication technologies to the development of education, science and culture and the construction of a knowledge society" must be intrinsic to all of UNESCO's programmes;
- 9. <u>Expresses its wish</u> that the Strategy be presented in such a way that the central role of the two cross-cutting themes for the entirety of the Organization's activities becomes more apparent;
- 10. <u>Takes note</u> of the valuable contributions made during the Executive Board's thematic debate on "The new information and communication technologies for the development of education, science and culture" and during the debate held at the 161st session on "eradication of poverty, especially extreme poverty";
- 11. <u>Acknowledges</u> the Director-General's analysis of the new and ongoing challenges to UNESCO in the present global environment and <u>underlines</u> the need to relate the various strategic objectives more explicitly to this overarching analysis;
- 12. <u>Welcomes</u> the results-based approach adopted for the formulation of expected outcomes related to each of the strategic objectives and sub-objectives and to the activities envisaged under the cross-cutting themes;
- 13. <u>Recognizes</u> that UNESCO's activities are oriented along three main thrusts, as set out in paragraph 26 of document 31 C/4;
- 14. <u>Endorses</u> the Director-General's observation that UNESCO must continue to make strategic choices, based on its mandate and a dynamic analysis of its comparative advantage and of emerging challenges;
- 15. <u>Affirms</u> that the urgent needs of excluded and vulnerable groups and the most disadvantaged regions and countries should be more explicitly addressed in all programmes of UNESCO;
- 16. <u>Appreciates</u> the efforts made towards the mainstreaming of priority areas, such as Africa, the least developed countries (LDCs), women and youth throughout the document;
- 17. <u>Emphasizes</u> the need to develop, in close collaboration with all stakeholders and drawing on UNESCO's field network, regional and subregional strategies immediately following the adoption of document 31 C/4 by the General Conference;
- 18. <u>Welcomes</u> the commitment by the Director-General that in implementing its activities UNESCO will actively pursue partnerships, where appropriate;
- 19. <u>Expresses its desire</u> that all partnership relations be clearly identified in a context map, identifying, as appropriate, for each programme and strategic objective the partners to be associated and their respective roles and contributions;
- 20. <u>Being acutely aware</u> that the implementation of the Strategy will depend on the availability and mobilization of resources, <u>recognizes</u> that the application of all resources should be firmly targeted on the strategic objectives;

21. <u>Transmits</u> hereby to the General Conference the Draft Medium-Term Strategy for 2002-2007 (31 C/4) together with the following recommendations:

The global setting (paras. 1-24)

- 22. To highlight more clearly throughout the document the unifying theme of the Strategy and to make more explicit its relation with the two cross-cutting themes and with the strategic objectives;
- 23. To spell out more clearly the linkages between the two cross-cutting themes and the sectoral objectives throughout the document;

<u>UNESCO's mission</u> (paras. 25-36)

- 24. To emphasize more clearly the relation between the three main strategic thrusts and the contemporary challenges and opportunities described in the part on the global setting;
- 25. To reformulate paragraph 36 on the basis of the provisions of the UNESCO Constitution, in particular Article VII thereof, and the Charter of National Commissions as well as other relevant resolutions by the General Conference;
- 26. To include the Associated Schools among the partners mentioned in paragraph 36;

Providing the means (paras. 37-47)

- 27. To include an explicit human resources policy and strategy for the Organization which will support the full implementation of the strategic objectives;
- 28. To amend the box after paragraph 47 by making reference to the cross-cutting themes immediately following the unifying theme;

Education (paras. 48-77)

- 29. To articulate more clearly the contribution of education to the eradication of poverty, through both formal and non-formal settings;
- 30. To refer, within the framework of the follow-up to the Dakar World Education Forum, to the need to encourage the development of literacy in all its dimensions, including basic skills and functional literacy, on the basis of the concept of lifelong learning and utilizing local languages;
- 31. To highlight in paragraph 56 the need for additional resources to implement all Education for All (EFA) commitments;
- 32. To expand in paragraph 58 on the needs of the E-9 countries and to continue to accord high priority to the E-9 Initiative, keeping in view the fact that two thirds of the world's illiterates are found in the E-9 countries;
- 33. To include reference to the EFA observatory, currently in paragraph 58, in a new subsequent paragraph;

- 34. To make more specific references, throughout the entire section dealing with education, to the recommendations of the International Commission on Education for the Twenty-First Century (Delors report), considering UNESCO's function as a laboratory of ideas and a source of policy advice and development for Member States;
- 35. To emphasize the importance of teacher training and retraining for all levels and forms of education, including the use of information and communication technologies and modern methods of distance and open learning, as a means of building an enabling environment in the context of the knowledge society;
- 36. To place greater emphasis on promoting the use of local languages in education as a pillar for identity and dialogue and the teaching of additional languages utilizing modern methods as a means of promoting better understanding, tolerance, diversity and peace and as a vehicle for empowering individuals in the twenty-first century; and to develop urgently a UNESCO strategy in this regard;
- 37. To reformulate the text pertaining to strategic objective 2 on a holistic basis and to include:
 - (a) values and civic education, especially for human rights and democracy;
 - (b) the reform of curricula, taking into account sociocultural needs and promoting regional and subregional networks;
 - (c) support by UNESCO of Member States' initiatives to carry out bilateral or multilateral revision of textbooks, particularly textbooks on history and civic education;
 - (d) the measurement and monitoring of learner achievements;
 - (e) the structure, method and content of education systems;
 - *(f) the improvement of human and material resources;*
 - (g) preventive education;
 - (h) school networking through the Associated Schools Project;
- 38. To emphasize more clearly the central role of comprehensive preventive education in combating the HIV/AIDS pandemic, including educational, scientific, communication, cultural, social and human rights dimensions; and further to underline the importance of both non-formal and formal approaches in that regard;
- 39. To make reference to Latin America and the Caribbean in the box following paragraph 70;
- 40. To formulate, jointly with the International Labour Organization and other willing agencies, an international long-term programme for the development of technical and vocational education and training, including teacher training and alternative delivery mechanisms;

- 41. To include in paragraphs 69 and 71 the need to promote science-based "disaster preparedness" in the strategy for environmental and science education and to cross-reference it to paragraph 101;
- 42. To express more clearly the need for UNESCO's education institutes and centres to contribute, in a coherent and complementary manner, to the achievement of the objectives and sub-objectives of the education strategy and, to that end, to develop focused and concentrated programmes, to adopt results-oriented approaches and to enhance visibility and outreach;

Sciences (paras. 78-118)

- 43. To give more prominence to the need for people-centred sustainable development in all areas of the strategy for the sciences;
- 44. To attach importance throughout the strategy for the sciences to the role and importance of local and traditional knowledge, as agreed at the World Conference on Science;
- 45. To refer in paragraphs 28 and 81 to the "new commitment for science", as defined by the results of the World Conference on Science, instead of a "new social contract between science and society";
- 46. To reflect in paragraphs 85 and 111 the need for enhanced cooperation between the natural and the social and human sciences and to give more emphasis to issues pertaining to the ethics of science and technology, the formulation and development of science and technology policies in Member States and the capacity-building, including in research and science and technology management, and their interrelationships;
- 47. To include in paragraph 92 and in the box on The Oceans (related to paragraph 33(d)) a reference to the follow-up of the Pan African Conference on Sustainable Integrated Coastal Management (PACSICOM) to the effect that IOC will concentrate in Africa a significant portion of its field activities, especially in the development of marine data and information networks and integrated coastal management;
- 48. To reinforce synergies between UNESCO's intergovernmental and international science programmes and those of ICSU in line with the recommendations of the World Conference on Science;
- 49. To add at the end of paragraph 101 that, in developing strategies for enhancing human security, UNESCO shall also address the impact of and preparedness for technological and other man-made disasters;
- 50. To include reference in paragraph 102 to the need for increased involvement of qualified and experienced scientists from developing countries in the execution and implementation of the Global Renewable Energy Education and Training Programme;
- 51. To replace the first and second sentences of paragraph 103 with the following text:

- "UNESCO will continue to give priority to network research on social transformations, that is different ways in which globalizing forces affect local communities and national societies with diverse historical experiences, economic and social patterns, political institutions and cultures. Such research shall focus, in principle, on the themes recommended by Member States for the second phase of the MOST Programme (2002-2009). Likewise, priority will be given to the follow-up ...";
- 52. To insert a new paragraph following paragraph 103 emphasizing the need to provide policy advice on poverty in all its dimensions and specificities, including migration, drugs, urban violence and exclusion, in line with the strategy for the cross-cutting theme on eradication of poverty, especially extreme poverty, and to provide for pertinent extension mechanisms;
- 53. To increase attention to inter-agency cooperation in the field of water resource management in paragraphs 104 and 105;
- 54. To insert a new sentence, to become the fifth sentence of paragraph 104: "Equally, special attention shall be given to water resources management in arid and semi-arid zones.";
- 55. To rephrase the last sentence in paragraph 104 as follows: "UNESCO shall also endeavour to provide an enhanced understanding of vulnerabilities and causes of water conflicts and to develop cooperative approaches and tools to assist in preventing or reducing them through successful water resource management.";
- 56. To include in paragraph 112 reference to the "culture of maintenance" and its relevance for sustainable development, focusing on its intersectoral aspects;
- 57. To make specific reference, following paragraph 113, to the development of programmes on basic sciences, such as mathematics, physics, chemistry and biology;
- 58. To emphasize in paragraph 114 the need to increase the dissemination of scientific and technological information and to facilitate access to scientifically relevant data as a vehicle for contributing to scientific and economic progress;

Culture (paras. 119-148)

- 59. To reflect more clearly, in the section on culture, the report of the World Commission on Culture and Development and the conclusions of the Stockholm Conference and the resulting dynamics including, inter alia, the formation of a network and round tables of ministers of culture, the drafting of a declaration on cultural diversity and the development of a plan of action to ensure implementation and follow-up;
- 60. To reflect more explicitly in paragraph 123 not only the need for a more balanced and representative World Heritage List, but also for closer linkages between the strategies for the world's tangible and intangible heritage shared by humanity as a whole;

- 61. To continue to define more precisely the concept of intangible heritage in the elaboration of a normative instrument and to provide clearer guidance for UNESCO's ongoing programmes and activities in this area;
- 62. To include under expected outcomes of strategic objective 7 a reference to increased participation of Member States in the protection of underwater heritage through broad accession to the new normative instrument, and enhanced knowledge of civil society through programming for capacity-building at the regional and international levels;
- 63. To pay more attention to the pivotal role of language in the definition of cultural identity and, in particular, to endangered languages and the study, learning and translation thereof as a key element for the promotion of the intangible heritage, cultural diversity and linguistic pluralism;
- 64. To change the wording of strategic objective 8 to read: "Safeguarding cultural diversity and encouraging dialogue among cultures and civilizations";
- 65. To attach more emphasis to UNESCO's contribution to the recognition, promotion and application of cultural rights, as defined in existing international human rights instruments;
- 66. To replace the second expected outcome following paragraph 131 with the following text: "Development of programmes aimed at fostering shared values";
- 67. To delete the box on the Global Alliance for Cultural Diversity and instead to provide a revised description of the Global Alliance in paragraph 141, including a clearer reference to the exploratory and evolutionary nature of the initiative at its present stage; and, within the context of the full articulation of the initiative to give emphasis to its ethical implications, the need to safeguard in its eventual implementation the very principle it is designed to uphold, the contribution it may make to the eradication of poverty through the promotion of cultural industries in developing countries and the need to ensure effective cooperation in concert with other competent United Nations organizations;

Communication and information (paras. 149-172)

- 68. To place emphasis on the need to strengthen cooperation and complementarity of the Information for All Programme and the International Programme for the Development of Communication (IPDC);
- 69. To articulate in more detail UNESCO's envisaged contribution and role in the preparations and follow-up to the World Summit on the Information Society, scheduled for 2003;
- 70. To place more emphasis on the importance of training in information and communication technologies through formal and informal means, at local, national and regional levels, with a view to facilitating access to learning, to boost capacity-building, to help eradicate poverty, to support economic development and to reduce the digital divide;

71. To support and promote the traditional media which play a fundamental role in developing countries, especially as regards the consolidation of the freedom of expression and of pluralism;

<u>Strategy for cross-cutting theme: Eradication of poverty, especially extreme poverty</u> (paras. 173-196)

and

<u>Strategy for cross-cutting theme: The contribution of information and communication technologies to the development of education, science and culture and the construction of a knowledge society (paras. 197-215)</u>

- 72. To stress that the cross-cutting themes must be integrated fully by all programmes and that their linkages must be highlighted;
- 73. To welcome and endorse the strategy and focus provided in the strategy for the eradication of poverty, especially extreme poverty, which should enable UNESCO to contribute constructively in its areas of competence to the implementation of the United Nations Millennium Declaration and especially its central goal of halving extreme poverty by the year 2015;
- 74. To welcome and endorse the strategy for the contribution of information and communication technologies to the development of education, science and culture and the construction of a knowledge society; and to emphasize that it will be required to develop further the strategic positioning and specific orientation of UNESCO, especially in preparation for the World Summit on the Information Society, scheduled for 2003, and other international initiatives.

- 1. Having examined the Draft Medium-Term Strategy for 2002-2007 (31 C/4),
- 2. <u>Requests</u> the Director-General to prepare a proposed resolution for the approval of this Medium-Term Strategy by the General Conference together with the recommendations of the Executive Board.

- 4. <u>Notes with satisfaction</u> the progress achieved in the presentation, readability and results-orientation of document 31 C/5 and the innovation adopted regarding a series of interdisciplinary and intersectoral projects as a contribution to the two cross-cutting themes of the Medium-Term Strategy;
- 5. <u>Commends</u> the Director-General on his success in preserving the amount of resources for programme activities from the regular budget at US \$112,989,500;
- 6. <u>Welcomes</u> the concentration and focus inherent in document 31 C/5 accomplished by the Director-General by selecting both a principal priority and a set of other priorities for each major programme;
- 7. <u>Emphasizes</u> the need to identify for each programme, subprogramme and main line of action the relationship to the principal priorities and the other priorities and <u>invites</u> the Director-General to prepare relevant information documents for each of the programme commissions of the General Conference at its 31st session;
- 8. <u>Further welcomes</u> the measures already taken to promote interdisciplinary approaches in programme activities and intersectoral cooperation in the Secretariat and <u>invites</u> the Director-General to strengthen further such cooperation, as appropriate;
- 9. <u>Underlines</u> that the two cross-cutting themes "Eradication of poverty, especially extreme poverty" and "The contribution of information and communication technologies to the development of education, science and culture and the construction of a knowledge society" must be intrinsic to all of UNESCO's activities and that they must permeate all UNESCO's action;
- 10. <u>Concurs</u> with the substantial rate of decentralization of programme activities proposed by the Director-General and <u>emphasizes</u> that this will be an important factor for enhancing the role, impact and visibility of UNESCO;
- 11. <u>Underlines</u> the need to formulate speedily regional and subregional strategies for each major programme, with provisions for interdisciplinary approaches, so as to translate the priorities into operational reality;
- 12. <u>Emphasizes</u> the critical importance of capacity-building as a modality in all programme activities of UNESCO;
- 13. <u>Expresses its satisfaction</u> that document 31 C/5 identifies clearly for each main line of action the various partners to be engaged in the process of implementation;
- 14. <u>Recommends</u> that Member States submit a draft resolution at the forthcoming session of the General Assembly of the United Nations in September 2001 for the proclamation of a United Nations Year for the common cultural heritage;
- 15. <u>Transmits</u> hereby to the General Conference the Draft Programme and Budget for 2002-2003 (31 C/5) together with the following recommendations:

- 19. To amend the formulation of paragraph 01006 by placing more emphasis on the role to be played by educational policies in poverty reduction strategies and on the need to reduce illiteracy as envisaged in the Dakar Framework;
- 20. To create, under Subprogramme I.1.1 (Coordinating the Follow-up of the Dakar Framework for Action) a new main line of action on "EFA activities in the E-9 countries", to be inserted in paragraph 01112 after main line of action 2 (National and regional education strategies and EFA action plans), the contents of which are to be redrafted to reflect the transfer of the E-9 related activities to a new main line of action, it being understood that the creation of the new main line of action will entail no increase in the overall budget of the programme;
- 21. To reflect in paragraph 01121 and in paragraph 01122 the need to develop all dimensions of literacy (e.g. functional literacy, computer literacy) and their contribution to lifelong learning and to the fulfilment of basic needs;
- 22. To amend the draft resolution contained in paragraph 01210 relating to Subprogramme I.2.1 (Towards a new approach to quality education) by adding in paragraph (a)(i) after the words "quality education" the new words "as outlined in the Delors report" and by replacing the last part of paragraph (a)(i) beginning with "in particular through education..." with the words "with a clear focus on human rights education, the reform of curricula and textbook revision and the Associated Schools Project (ASP)";
- 23. To amend the narrative in paragraph 01210 related to Subprogramme I.2.1 (Towards a new approach to quality education) by reflecting the amendment in paragraph 19 as well as the need for an agreed-upon framework of action, encompassing other dimensions of quality education, including the measurement and monitoring of outcomes; the improvement in the structures, methods and contents of education systems and delivery systems;

- 3. <u>Invites</u> the Director-General to take the necessary measures to ensure the implementation of proposals contained therein, including measures to ensure an appropriate survey of the conservation status of the collection and to develop a comprehensive disaster preparedness and response plan;

4. <u>Further invites</u> the Director-General to call upon the Member States of the Organization and relevant institutions and organizations to contribute to the maintenance and conservation of the works of art in the care of UNESCO.

- 2. <u>Considers</u> that the "purposes" specified in such Financial Regulations should relate to objectives defined in the Programme and Budget;
- 3. <u>Approves</u> the standard model text for the Financial Regulations of Special Accounts as annexed to the present decision;
- 4. <u>Requests</u> the Director-General to apply the standard model text to the Financial Regulations of all Special Accounts that are not related to institutes or similar bodies;
- 5. <u>Invites</u> the Director-General to report to it for its consideration and recommendation on any deviation from the standard model text when reporting such Financial Regulations;
- 6. <u>Further invites</u> the Director-General to provide to it a list of closed special accounts to be included in his financial report which accompanies the audited financial statements.

Annex

Financial regulations of Special Accounts that are not related to institutes or similar bodies

Article 1 – Creation of a Special Account

- 1.1 In accordance with Article 6, paragraph 6, of the Financial Regulations of UNESCO, there is hereby created a Special Account for [name of Special Account], hereafter referred to as the Special Account.
- 1.2 The following regulations shall govern the operation of the Special Account.

Article 2 – Financial period

The financial period shall correspond to that of UNESCO.

Article 3 – Purpose

[description of purpose]

Article 4 – Income

The income of the Special Account shall consist of:

- (a) voluntary contributions from States, international agencies and organizations, as well as other entities;
- (b) such amounts provided from the regular budget of the Organization as might be determined by the General Conference;
- (c) such subventions, endowments, gifts and bequests as are allocated to it for purposes consistent with the object of the Special Account;
- (d) miscellaneous income, including any interest earned on the investments referred to in Article 7 below.

Article 5 – Expenditure

The Special Account shall be debited with the expenditure relating to its purpose as described in Article 3 above, including administrative expenses specifically relating to it.

Article 6 – Accounts

- 6.1 The UNESCO Comptroller shall maintain such accounting records as are necessary.
- 6.2 Any unused balance at the end of a financial period shall be carried forward to the following financial period.
- 6.3 The accounts of the Special Account shall be presented for audit to the External Auditor of UNESCO, together with the other accounts of the Organization.
- 6.4 Contributions in kind shall be recorded outside the Special Account.

Article 7 – Investments

- 7.1 The Director-General may make short-term investments of sums standing to the credit of the Special Account.
- 7.2 Interest earned on these investments shall be credited to the Special Account.

Article 8 – Closure of the Special Account

The Director-General shall decide upon the closure of the Special Account at such time as he deems that its operation is no longer necessary and inform the Executive Board accordingly.

Article 9 - General provision

Unless otherwise provided in these Regulations, the Special Account shall be administered in accordance with the Financial Regulations of UNESCO.

- 1. <u>Having considered</u> the report of the Director-General on the United Nations Millennium Declaration: Outcome and follow-up (161 EX/37),
- 2. Recognizing the high significance of the Declaration adopted by the United Nations Millennium Summit (New York, 6-8 September 2000), which clearly identifies the major global priorities and which offers the United Nations system a framework for common action to address these priorities,
- 3. <u>Convinced</u> that UNESCO has an active role to play and an important contribution to make in implementing paragraphs of the Declaration, particularly in priority areas within its fields of competence,
- 4. <u>Resolved</u> to ensure that UNESCO's future Medium-Term Strategies and Programme and Budgets contribute to the United Nations system-wide coordinated efforts to implement the Declaration,
- 5. <u>Welcomes</u> the United Nations Millennium Declaration adopted by the historic Millennium Summit of the United Nations;
- 6. <u>Requests</u> the Director-General to ensure that UNESCO plays, within the Administrative Committee on Coordination and other inter-agency arrangements, an active and central role in implementing the Declaration, in the framework of priorities and targets within its mandate;
- 7. <u>Invites</u> the Director-General to step up his approaches to funding organizations of the United Nations system and other funding organizations with a view to obtaining financial resources for activities by UNESCO geared to the implementation of the Millennium Declaration;
- 8. <u>Further invites</u> the Director-General to keep it regularly informed on all his approaches and action for the implementation of the Declaration and, in particular, on the Secretary-General's "road map" of implementation and follow-up.

The Executive Board,

- 1. <u>Recalling United Nations General Assembly resolution 55/196 proclaiming the year 2003 as the International Year of Freshwater,</u>
- 2. <u>Fully aware</u> of the critical importance of the water resources problem and the need for an international campaign to raise awareness leading to concerted action at all levels.
- 3. <u>Noting with satisfaction</u> that water resources and ecosystems are a principal priority in document 31 C/4 (Draft),
- 4. <u>Welcomes and supports</u> the General Assembly initiative to proclaim the year 2003 as the International Year of Freshwater;
- 5. <u>Calls upon</u> Member States, NGOs, and civil society organizations and the private sector to provide voluntary resources for the activities of the Year at local, national and regional levels and to enable UNESCO to play its role actively in the preparation and celebration of the Year;
- 6. Requests the Director-General to ensure that UNESCO plays a pivotal role, and actively contributes to the joint United Nations system efforts within the Subcommittee on Water Resources of the Administrative Committee on Coordination with regard to the preparations for the Year;
- 7. <u>Acknowledges</u> the Director-General's preliminary proposals concerning UNESCO's programme of activities for the Year and <u>requests</u> him to finalize the programme and to report to the Board at its 164th session in 2002 on the preparations for the Year.

- 4. <u>Decides</u>, on the basis of the information contained in the aforementioned document, to initiate the procedure for the renewal of statutory relations with these organizations and to continue examination thereof at its next session, on

the basis of additional information concerning the contribution of these NGOs to documents 31 C/4 and 31 C/5;

- 5. <u>Approves</u> the draft cooperation agreements with the International Association of Educating Cities (IAEC) and the Organization of World Heritage Cities (OWHC) contained in Annex III to document 161 EX/38 and <u>invites</u> the Director-General to sign them;

The Executive Board,

- 1. Having examined document 161 EX/39,
- 2. <u>Recommends</u> that the General Conference adopt the following resolution:

The General Conference,

Having examined the sexennial report submitted to it by the Executive Board on the contribution made to UNESCO's activities by non-governmental organizations from 1995 to 2000, in pursuance of Section V.3 of the *Directives concerning UNESCO's relations with non-governmental organizations* adopted at its 28th session (28 C/Resolution 13.42, 1995),

Reaffirming that the participation of non-governmental organizations in UNESCO's task is an ideal means for the Organization of associating civil society with its mission and its actions,

1. *Considers* that such cooperation, based on Article XI of the Constitution of the Organization and governed by the aforementioned Directives, has been reflected in a wide-ranging consultation of the National Commissions and

- the NGO community worldwide, of the NGO-UNESCO Liaison Committee, and of all Secretariat services at and away from Headquarters, which have contributed extensively to this evaluation and reflection exercise through a constructive dialogue;
- 2. *Stresses* the importance of strengthening cooperation and developing partnership with the different sectors of civil society in the implementation of the Medium-Term Strategy for 2002-2007 and in the pursuit of the reform process undertaken by the Organization;
- 3. *Reaffirms* the fundamental objectives of the Directives, in particular the revitalization and diversification of partnerships and the strengthening of operational cooperation for the benefit of the developing countries and countries in transition;
- 4. *Recommends* to the Executive Board that it:
 - (a) ensure that the implementation of the Directives continues to proceed in a spirit of openness towards civil society, especially in parts of the world where it is still isolated or weak;
 - (b) endeavour to clarify certain outstanding questions relating in particular to the financial and material arrangements for cooperation with the NGOs;
 - (c) invite its Committee on International Non-Governmental Organizations to develop its intellectual reflection, to pursue the dialogue with the NGOs as a whole and the Secretariat, and for that purpose to continue to improve its working methods;
 - (d) to request the aforesaid Committee to continue its work with the aim of operationalizing the recommendations of the General Conference in this regard;
- 5. *Recommends* to the Director-General, with respect to programme preparation, that he:
 - (a) encourage the active participation of all NGOs maintaining official relations with UNESCO in sessions of the General Conference and in conferences on specialized subjects;
 - (b) continue to encourage the participation of the NGOs maintaining official relations with UNESCO in major UNESCO and United Nations conferences and their follow-up, side by side with other stakeholders, and the collective expression of the views of NGOs at international conferences organized under the auspices of the Organization;
 - (c) develop bilateral consultations, formal and informal, between the Secretariat and the NGOs, both at and away from Headquarters, particularly concerning the preparation of the Organization's biennial draft programme and budget, and make sure that their contributions are actually taken into account;

- 6. *Recommends* to the Director-General, with respect to programme execution, that he:
 - (a) strengthen cooperation with the NGOs and the coordination and follow-up role of the Secretariat by appointing, in each programme sector and preferably within the Executive Office of the Assistant Director-General, a focal point for coordination with the NGOs in the fields of activity of the sector concerned that does not entail additional financial resources:
 - (b) ensure, in connection with the new information and management systems for the programme and budget, the introduction of rational and uniform procedures, familiar to all users, which will enable a rigorous and transparent evaluation to be carried out of financial exchanges with the NGOs;
 - (c) develop communication activities (guide, database, Internet site);
- 7. Terminates the Special NGO Support Programme, established by 27 C/Resolution 13.141 as a specific form of financial cooperation with NGOs;
- 8. *Recommends*, with respect to geographical extension and openness to regional and national NGOs:
 - (a) To Member States and their National Commissions, that they:
 - (i) strengthen their cooperation with the national branches of NGOs maintaining official relations with UNESCO and consider the possibility of involving them more systematically in the work of National Commissions and their programme committees;
 - (ii) inventory organizations or national coalitions which are representative and active in the Organization's fields of competence;
 - (iii) associate national NGOs in the consultations which they carry out for the preparation of their contributions to the draft programmes of the Organization and ensure that they include in their priority requests to the Participation Programme projects emanating from NGOs or NGO coalitions which are active and representative in the Organization's fields of competence;
 - raise the quality of their contributions in the Organization's fields of competence by considering the inclusion of experts proposed by the NGOs in their delegations to specialized meetings;
 - (b) To the Director-General, that he:
 - strengthen the field units' role of promotion, stimulation and coordination in the development of cooperation at the regional and

national levels, and appoint, in each regional office and if possible in each cluster office, a focal point for coordination with the NGOs;

- (c) To NGOs maintaining official relations with UNESCO, that they:
 - (i) tirelessly pursue their efforts to extend their geographical range and ensure a better geographical balance among the members of their governing bodies;
 - (ii) align their activities as far as possible on the priority thrusts of UNESCO's programme;
 - (iii) continue their efforts to make their national and local branches known to the National Commissions and keep the latter as well-informed as possible about their activities;
- 9. Decides to amend Section II, paragraph 4.1(b) (advantages enjoyed by organizations maintaining operational relations with UNESCO) and Section III (Collective consultations), paragraphs 1.1 (International conference) and 1.3.1 (Standing Committee) of the Directives concerning UNESCO's relations with non-governmental organizations as follows:

Section II

4.1(b):

"in accordance with the provisions of Article IV, paragraph 14, of the Constitution, the Executive Board may invite them to be represented as observers at specified plenary meetings of the Conference and meetings of its commissions". [Remainder of text unchanged]

Section III

1.1 International conference

"International non-governmental organizations maintaining *official* relations (formal or operational relations) with UNESCO may, with the approval of the Director-General" [Remainder of text unchanged]

1.3.1 NGO-UNESCO Liaison Committee

- 3. <u>Noting</u> that, in the vast majority of cases, the evaluators were chosen from among those proposed or approved by National Commissions for UNESCO, as well as from NGOs with official status with UNESCO.
- 4. <u>Expressing its general appreciation</u> of the evaluation work carried out, especially with regard to the pertinence of the findings and recommendations based essentially on the expertise of the external evaluators in their respective fields of specialization and their international experience,
- 5. <u>Regretting</u>, that largely due to lack of time and resources, the evaluators were not able to include more detailed analysis of the effectiveness and substantive impact of the activities reviewed,
- 6. <u>Taking note</u> of the recommendations made by the evaluators as well as of the observations of the Director-General thereon,
- 7. Requests the Director-General to:
 - (a) pursue the work on the introduction of results-based programme management tools and processes that would facilitate future programme evaluations:
 - (b) ensure a more geographic and gender-balanced composition of external evaluation teams;
 - (c) as appropriate, complement external evaluations by audits, including risk management reviews;
 - (d) ensure that resources provided for individual evaluations are adequate for their completion;
 - (e) publish the terms of reference of evaluations on the UNESCO website;
 - (f) make available to it the reports of evaluations when they are completed;
 - (g) examine the general lessons for UNESCO as a whole to be learned from individual evaluations or groups of evaluations;
 - (h) encourage the undertaking of evaluations related to systems of operations as well as programmes;
 - (i) ensure that data collection systems are adequate for cost-effectiveness analysis;
 - (j) include assessment of inputs in all future evaluations and undertake follow-up impact studies for recent evaluations in which impact has not been covered;
- 8. <u>Invites</u> the Director-General to implement measures envisaged by him as a follow-up to the recommendations made by the evaluators;

9. <u>Also invites</u> the Director-General to report to it on progress made in the follow-up to the evaluations.

Recalling, moreover, the decision that it took, at its 157th session, following the discussions held on the visibility of UNESCO, inviting the Director-General to "establish a group of experts with the task of looking into the functioning of the public information of UNESCO" (157 EX/Decision 10.4),
- 4. <u>Having examined</u> the communication and information strategy as proposed by the Director-General in document 161 EX/43,
- 5. <u>Thanks</u> the Group of Experts for its contribution and for the recommendations that it addressed to the Director-General, which are annexed to document 161 EX/43;
- 6. <u>Welcomes</u> the decisions taken by the Director-General, in the months after he took office, in order to give effect to the above-mentioned recommendations, which led to the establishment of a Bureau of Public Information (BPI) and to the formulation of a communication strategy project;
- 7. <u>Notes with satisfaction</u> that communication is recognized as an important tool for the implementation of the Organization's objectives and programmes;
- 8. <u>Emphasizes</u> the crucial role of the field offices in enhancing UNESCO's visibility and the need to create adequate capacity in these offices for this purpose;
- 9. <u>Stresses</u> the need to increase the visibility of UNESCO both in public opinion and vis-à-vis its existing and potential partners and <u>urges</u> Member States of the Organization and their National Commissions to cooperate closely with the Secretariat in this respect;

- 10. <u>Approves</u> the main lines of the communication and information strategy as proposed by the Director-General in document 161 EX/43;
- 11. <u>Invites</u> the Director-General to present to the Executive Board, at its 164th session, a comprehensive and detailed proposal for the implementation of a communication and public information strategy, as contained in document 161 EX/43, for possible approval;
- 12. <u>Further invites</u> the Director-General to review whether it is possible to make the UNESCO *Courier* more viable and cost-effective within the proposed budget and to continue his efforts to identify potential sources of sponsorship for the *Courier*, and ways to widen its readership especially among youth in different languages, taking into account the views expressed during the debates of its 161st session and to report thereon at its 162nd session.

- 3. <u>Greatly concerned</u> at the critical situation facing the Palestinian Territories, which gravely prejudices Palestinian children's right to education because of the sealing off of these territories which hampers the Palestinian education system,
- 4. <u>Highly appreciative</u> of the efforts of the international community to halt the violence and safeguard the peace process, which is seriously threatened by these tragic events,
- 5. <u>Urgently appeals</u> to the Israeli authorities to facilitate safe access of Palestinian children to their schools and to allow the functioning of educational establishments;
- 6. Expresses the urgent need for the Palestino-Israeli peace negotiations to be resumed so that a just and comprehensive peace is speedily brought about in accordance with the United Nations resolutions, to which UNESCO adheres, particularly Security Council resolutions 242, 338 and 1322, based on withdrawal from the occupied Arab territories and the principle of land for peace;
- 7. <u>Expresses its profound regret</u> that the third phase of the UNESCO Programme for Palestine (UPP) has been delayed because of the present situation;
- 8. <u>Expresses its gratitude</u> to the States, organizations, foundations and representatives of the private sector that have contributed to the implementation of the UNESCO Programme for Palestine (UPP);

- 9. <u>Appeals</u> to sponsors to contribute generously to financing the reconstruction of the Palestinian education system;
- 10. <u>Warmly thanks</u> the Director-General for his efforts to ensure the implementation of 30 C/Resolution 54 and 160 EX/Decision 9.1;
- 11. <u>Expresses its support</u> for the Director-General's initiative concerning the revision of Israeli and Palestinian textbooks, and <u>invites</u> him to contact the parties concerned and submit his proposals in this respect to it at its 164th session;
- 12. Expresses the hope that the Arab-Israeli peace negotiations will be resumed and that a just and comprehensive peace will be speedily brought about in accordance with the United Nations resolutions, to which UNESCO adheres, particularly Security Council resolutions 242 and 338, based on withdrawal from the occupied Arab territories and the principle of land for peace;

13. Invites the Director-General:

- (a) to carry out, in cooperation with international organizations, an overall evaluation of the new needs of the Palestinian educational institutions and to submit the findings of that evaluation to it at its 162nd session;
- (b) to continue financial assistance for Palestinian students to pursue their studies;

14. Invites the Director-General:

- (a) to continue the efforts he is making vis-à-vis the Israeli authorities with a view to preserving the human and social fabric and safeguarding the Arab cultural identity of the occupied Syrian Golan, in accordance with the relevant resolutions adopted in this regard;
- (b) to continue his efforts vis-à-vis the Israeli authorities so that they cease imposing Israeli curricula on the students of the occupied Syrian Golan, to offer more grants to those students and to provide special assistance to the educational institutions of the Golan;
- 15. Reiterates all its previous decisions relating to the occupied Syrian Golan;
- 16. <u>Decides</u> to include this item in the agenda of its 162nd session.
