INVITATIONS TO THE INTERNATIONAL CONFERENCE OF STATES FOR THE REVISION OF THE 1981 REGIONAL CONVENTION ON THE RECOGNITION OF STUDIES, CERTIFICATES, DIPLOMAS, DEGREES AND OTHER ACADEMIC QUALIFICATIONS IN HIGHER EDUCATION IN THE AFRICAN STATES

# Summary

Pursuant to the "Regulations for the general classification of the various categories of meetings convened by UNESCO", and in accordance with 36 C/Resolution 14, the Director-General submits to the Board proposals concerning invitations to the International Conference of States to examine and adopt amendments to the 1981 Regional Convention on the Recognition of Studies, Certificates, Diplomas, Degrees and other Academic Qualifications in Higher Education in the African States to be held in Addis Ababa, Ethiopia, in spring 2014.

Any financial and administrative implications related to the present document will be covered by extrabudgetary financial contributions and programme and budget of document 37 C/5.

Action expected by the Executive Board: proposed decision in paragraph 11.

- 1. In accordance with 36 C/Resolution 14, by which the General Conference requested the Director-General to convene an international conference of States (category I) with a view to examine and adopt amendments to the 1981 Regional Convention on the Recognition of Studies, Certificates, Diplomas, Degrees and other Academic Qualifications in Higher Education in the African States, the Director-General submits to the Executive Board proposals concerning invitations to that international conference. This conference of States (category I) is to be hosted by the Government of Ethiopia and to be held in Addis Ababa, Ethiopia, in spring 2014.
- 2. While UNESCO continued to make efforts to organize this Conference throughout the 2012-2013 biennium, due to the shortage of financial resources and uncertainty of a host State, the International Conference of States for the Africa region was not convened in 2013. The Organization received recently confirmation of the Ethiopian Government's formal acceptance to

host the Conference in Addis Ababa. UNESCO also received commitment from the Government of the People's Republic of China for a financial contribution of US \$250,000 towards the Conference. In addition, the Government of the Kingdom of Norway has given indication of their strong support, and confirmation of their financial contribution is expected shortly.

#### **CATEGORY OF THE CONFERENCE**

3. Pursuant to the regulations for the general classification of the various categories of meetings convened by UNESCO, this Conference falls within the category of "international conference of states" (category I) and the heads of delegation will therefore represent their governments.

#### **PARTICIPANTS**

4. In accordance with the Regulations as they relate to category I meetings, invitations to the Conference are decided on by the Executive Board.

## Member States and Associate Members (Art. 11.1 and 11.2 of the Regulations)

- 5. Under Article 11, paragraph 1, the General Conference, or the Executive Board authorized by it, shall decide on the Member States and Associate Members whose governments are to be invited.
- 6. In accordance with the above-mentioned article, the Director-General proposes that all Member States in UNESCO's Africa region be invited to participate, with the right to vote. In addition, the Director-General proposes that the State Parties to the Convention be invited to participate, with the right to vote.
- 7. Under Article 11, paragraph 2, Member States and Associate Members of UNESCO not invited under paragraph 5 may send observers to the Conference.

# International organizations (Arts. 11.3 and 11.4)

- 8. The Director-General reminds the Board that under Article 11, paragraph 3, the following organizations of the United Nations system, with which UNESCO has concluded mutual representation agreements, may send representatives to the Conference:

- 9. Under Article 11, paragraph 4, the Board may decide that the following shall be invited to send observers to the meeting: (a) organizations of the United Nations system with which UNESCO has not concluded mutual representation agreements; (b) other intergovernmental

organizations; and (c) international non-governmental organizations, in accordance with the Directives concerning UNESCO's relations with international non-governmental organizations.

- 10. The Director-General proposes that the Executive Board invite the following organizations, foundations and institutions to send observers to the Conference:

#### **Proposed decision**

11. In the light of the foregoing, the Executive Board may wish to adopt the following decision:

The Executive Board,

- Recalling 36 C/Resolution 14, by which the General Conference authorized the Executive Board and the Director-General to take appropriate measures for the organization of the International Conference of States to examine and adopt amendments to the 1981 Regional Convention on the Recognition of Studies, Certificates, Diplomas, Degrees and other Academic Qualifications in Higher Education in the African States,
- 2. Having examined document 193 EX/8,

#### 3. <u>Decides</u>:

- (a) that invitations to participate in the International Conference of States to examine and adopt amendments to the 1981 Regional Convention on the Recognition of Studies, Certificates, Diplomas, Degrees and other Academic Qualifications in Higher Education in the African States will be sent to all Member States in the Africa region, as well as to the States Parties to the Convention in accordance with paragraph 5 of document 193 EX/8;
- (b) that invitations to send observers to the Conference will be sent to Member States and Associate Members of UNESCO not invited under paragraph 5 of document 193 EX/8;
- (c) that invitations to send observers to the Conference will be sent to the organizations of the United Nations system with which UNESCO has concluded mutual representation agreements and which are listed in paragraph 7 of document 193 EX/8;
- (d) that invitations to send observers to the Conference will be sent to the organizations, foundations and institutions listed in paragraphs 8 and 9 of document 193 EX/8;
- 4. <u>Authorizes</u> the Director-General to send out any other invitations she may deem useful for advancing the work of the Conference, notifying the Executive Board thereof.
