THE IMPLEMENTATION OF THE STRATEGY ON UNESCO'S STANDARD-SETTING INSTRUMENTS IN THE FIELD OF EDUCATION

SUMMARY

Pursuant to 197 EX/Dec. 20(VIII), the Director-General informs the Executive Board of the measures envisaged for the implementation of the UNESCO Strategy on standard-setting instruments in the field of education which was presented to the Executive Board in document 197 EX/20 Part VIII.

This document is composed of two parts: the first part highlights the specific actions to be undertaken, in the format of a roadmap including a provisional timetable to guarantee the implementation of this Strategy; and the second part presents detailed information on the financial, personnel and procedural aspects for the development of the Global Observatory on the right to education.



I. Strategy on UNESCO's standard-setting instruments: Overview

1. A Strategy on UNESCO's standard-setting instruments in the field of education covering the period 2015-2016 was presented to the 197th session of UNESCO's Executive Board in 2015 (197 EX/20 Part VIII). The Strategy aims at improving the visibility, application and monitoring of normative instruments, as well as ratification of conventions, enhancing cooperation, supporting capacity-building and making better use of normative instruments as key tools in the framework of the implementation of the Education 2030 agenda and the sustainable development agenda.

2. The objective is to mainstream the normative work, reinforce explicit linkages between the various activities carried out by the Education Sector and its different standard-setting instruments, and finally, fostering synergies.

- (1) **Visibility**: Inspire countries and enhance advocacy on normative action, improve communication and raise awareness through more focused information-sharing
- (2) **Implementation**: Strengthen technical support to Member States, capacity-building and resource mobilization
- (3) **Monitoring**: Reinforce existing mechanisms and foster synergies between stakeholders to efficiently serve Member States in their implementation process
- (4) **Cooperation**: Establish and strengthen channels promoting knowledge-sharing, peerlearning and collaboration for a more effective implementation by Member states
- (5) **Ratification**: Identify and assess difficulties and challenges faced by Member States and offer tailored assistance

II. Implementing the Strategy on UNESCO's standard-setting instruments: a roadmap

3. Following the request by the Executive Board (197 EX/Decision 20 (VIII)), this document highlights the specific actions proposed in the Strategy and corresponding activities including the costing, timeline and procedural aspects.

4. The table below provides a **detailed overview** of the specific actions to take and corresponding activities that will be carried out in the framework of the strategy in order to achieve the specific objectives under each area of work, while highlighting the distinction between the "core elements" and the activities conditioned by additional resources including the minimum estimate for resource mobilization. A tentative timeline is also provided to better understand the various stages of each activity and the pathways.

III. Observatory on the right to education: detailed information on the financial, personnel and procedural aspects of its development

5. A major component of the UNESCO Strategy on standard-setting instruments in the field of education is the development of a global Observatory on the Right to education by upgrading the current Database on the right to education,² launched in September 2014. With a view to ensuring an overall consistency between the proposed activities, each component of the Strategy will be implemented, as far as possible, through the future Observatory. The Observatory will be designed to be a worldwide unique research tool on the right to education, providing comprehensive presorted analysed information, in order to further raise awareness, advocate, provide assistance, monitor and ultimately improve the quality of education. The Observatory has three key missions:

- (1) Information-sharing to upgrade the existing Database on the right to education. It aims at expanding and enriching the existing platform. There will be two levels of action: refine the tools of the current Database by creating new functionalities and encourage Member States to share relevant information; and creating new tools such as adding the dimension of justiciability of the right education.
- (2) Analysis and prospective to consider and evaluate the progress, target the relevant issues and foresee possible recommendations. There will be three levels of action: new tools instigating the analysis of the information such as an interactive timeline tracking process; in depth case studies; analysis of relevant topic for discussion identified; and encourage expert consultations and workshops notably at regional level.
- (3) Forum for technical assistance to provide an accessible platform for legal and technical consultations for Member States as well as for legal and policy frameworks' reviews. There will be two levels of action: build experience-sharing through online dialogues and reviews; and provide assistance through an online secure private chat.

6. The technical developments for the Observatory would be: indexing and metadata; direct and further linkage to other resources; a multi-information chronological timeline; an online platform to upload documents; mobilization of regional and field offices and a shared access to some of the Observatory administrative tools; an online secured platform including a private chat.

7. Resources would be needed. In terms of human resources: two full-time staff (Mission 1; Mission 2 and Mission 3); one consultant (Mission 1 on Information-sharing); one documentarist (Mission 1 on information sharing); punctual research teams (Mission 2 and Mission 3). Some \$150,000 per year (\$900k or the six-year period) would be required.

First Observatory's Mission – INFORMATION-SHARING Strengthen the current Database's scope, impact and visibility

8. Based on the current Database, this first mission aims at expanding and enriching the platform by developing a broad spectrum of instruments offering a comprehensive and exhaustive picture of the Member States implementation status. There will be <u>two levels of action</u>:

- (1) **Enrich the tools of the current Database**: creating new functionalities to enrich the current platform and its search functions and expanding the current content of the Database; and
- (2) **Create new tools**: upgrading the platform by creating additional dimensions that require not only significant developments, but also important research and analysis work.

9. The Observatory will centralise information relating to the implementation of the right to education by Member States as well as challenges faced by them, of the UNESCO's education-related standard-setting instruments. Such data will for instance include additional national reports submitted to the United Nations and state of implementation of the right to education at national level. Relevant excerpts of recommendations by United Nations Special Rapporteurs, in particular the United Nations Special Rapporteur on the right to education and United Nations human rights bodies will also be included or strengthened. The availability of key resources – and notably national reports – will significantly encourage governments to apply the principles of responsibility and transparency, and to submit reports of good quality that can be harnessed by the Secretariat. Through this virtuous circle, the monitoring of the standard-setting instruments will be significantly improved.

10. The future Observatory will be instrumental in mobilising around the issue of ratification. Moreover, Member States will be encouraged to share relevant information on the implementation of the standard-setting instruments on a **spontaneous basis**; such an ongoing monitoring process will provide the Secretariat with more **up-to-date and relevant information** to share publicly. This will constitute very valuable sharing of information, as Member States themselves will be informed of promising practices adopted by other countries. The Observatory will thus offer a sustained basis for regional and international cooperation.

11. In addition to the regular updating of current information provided, the content of the database will be enriched and further developed. It is envisioned that in addition to information related to the legal and policy framework, **factual information** on the **effective implementation** of the right to education will be added for each country. This will enable measuring the status of the right to education in practice and provide comprehensive information and material on the level of implementation of the right to education at country level *in law* and *in fact*. In addition, other existing information could be developed such as the United Nations standards setting instruments status of ratification which could include the reservations made by the Member States. In a complementary way, statistical data will be made available online for each country, making full use of UNESCO's Institute for Statistics (UIS).

12. Moreover, **justiciability** dimension of the right to education will be developed by offering access to a databank of case laws under country profiles. In concrete terms, each country profile will include a specific part on case laws adopted at national level as well as a legal analysis of the decisions. This could appear in a list of case law with a brief reminder of the facts, the Court arguments and its decision and below a small commentary of the case law in light of the applicable legal standards. Also, when several case laws about the right to education or related to it exist in a given Member State, a comparison could be made between the different decisions in order to inform on the evolution of the jurisprudence. Also, doctrinal commentaries could be added to the analysis as well as other inputs from regional courts.

13. Indexing the documents uploaded onto the library though their related metadata is to be envisaged. This development will make it be possible to perform thematic searches on the documents contained in the library (which at the moment is not available). Such interactive and detailed search functions will make an added value to the Database. It is also envisioned that direct linkages are established between the country profiles and the Library in order for users to have direct access to primary source material (national texts) while consulting the summaries on the implementation of the right to education at country level. In addition, further linkages will be established with other resources (such as new tools developed by UIS). In this regard, university research tools on public international law or human rights law could be mobilized to include UNESCO instruments in their own databases as well as used as resources in the Observatory.

14. In terms of content, **interactive consultations** could be organised once a year to collect feedback and updates from Member States. Moreover, Member states should be encouraged to provide relevant information on implementation of the standard-setting instruments on **spontaneous basis**; such an ongoing monitoring process would provide the Secretariat with more

important information to elaborate **analytical reviews**. Direct **linkages between country profiles and the library** will be established so that users may be able to access every document available on the country. The interactive consultation could take the form of an online platform where Member States are able to upload documents relevant to the implementation of the right to education and updates on information.

Second Observatory's Mission – ANALYSIS and PROSPECTIVE Assess the information, track progress and foresee solutions

15. The second mission aims to consider and evaluate the information, track progress, target relevant issues and foreseeing possible recommendations. There will be three levels of action:

- (1) Incorporation of new tools instigating the analysis of the information;
- (2) Identifying relevant topics for discussion and/or regulation; and
- (3) Encourage expert consultations and workshops

16. Through its function of legal and policy watch, the platform will incorporate new significant functionalities and tools, such as a **timeline tracking progress** for each country, highlighting the adoption of legal texts, relevant provisions and educational policies as well as measures taken in terms of concrete implementation. It will also bring the **historic perspective** necessary to assess the state of implementation and the evolution of the situation in countries. A compilation of **recent court laws** will also be added to the platform to see how concretely the right to education is implemented, guaranteed and enforced at the country level. The timeline will also cover the justiciability dimension.

17. Based on the information collected, **in-depth analyses** on the implementation of standard setting instruments regarding the right to education will be conducted and published in a dedicated space in the Observatory; a space will be thus created **under each profile (analysis by country)** and also **through a thematic approach (analysis by themes) or regional approaches (analysis of trends by regions)** for **analytical reports** on the status of the implementation of the right to education. This will provide strong support material and elements for the elaboration, by Member states, of reports on the state of the implementation of education-related standard setting instruments. On the basis of this analysis, it will be possible to **identify emerging themes** on the right to education and standard-setting instruments that may need new or **further regulation** in the future.

18. UNESCO will also convey **expert consultations and workshops** – at the regional level – that will contribute to identifying those **emerging trends** and formulating relevant recommendations based on **case studies** undertaken under the Observatory. This could also involve discussions about issues member States can encounter in implementing the standard-setting instruments in order for the Secretariat to directly take them into account and use one of the Database functionalities to answer them. This could take the form of a tab called "Implementing the standard-setting instruments" listing the issues encountered by the States followed by answers for each of these issues using other member States example of good practices. The compendiums of practical examples of good practices published by the Secretariat could for instance be used to address those issues.

19. The **chronological timeline** will be included in the platform under each country profile to give an overview of the progress achieved by Member States. In addition, a specific **space** under country profiles will be created to host the analytical reports as well as new tool that will enable to undertake an advanced research also on the analytical reports by countries, themes and regions. This new tool could take the form of a search by word which enables the user to look for a specific

area of the right to education in a country constitutional, legislative or policy framework as well as the relevant related official text contained in the library and relevant case law.

Third Observatory's Mission – FORUM for TECHNICAL ASSISTANCE: Experience-Sharing and Assistance

20. The third mission aims at providing a platform for legal and technical consultations for the Member States, on a spontaneous basis. There will be two levels of action:

- (1) Build experience-sharing among Member States (through interactive consultations); and
- (2) Provide assistance to Member States for reviewing and/or developing legal and policy framework through online private platform

21. The Observatory will be instrumental in supporting Member States and providing them with **technical assistance**. Dedicated **access** for Member States will be created on the platform, and will enable them to participate in an **interactive way**. The Observatory will host the *Guidelines for reviewing national legal and policy frameworks regarding the right to education (*currently undergoing pilot-testing).

22. Based on recommendations and the outcomes of the review process, UNESCO will be able to provide further assistance to Member States to develop their legal frameworks. Specific **recommendations** will be formulated to help countries and to engage in a **constructive dialogue** to strengthen the implementation of the standard-setting instruments in the field of education at the national level.

23. It is also envisioned that **technical assistance and support** be provided through this process through **close cooperation between Headquarters, regional and field offices and national authorities**. This could be put in place through an online private chat where Member States and relevant authorities would be able to send to the Secretariat (Headquarters and field offices) enquiries in relation to the difficulties they may have in implementing UNESCO standard-setting instrument or legal issues regarding the right to education.

24. The functionalities of the existing Database will be further improved to facilitate the interaction, such as RSS feeds or more elaborated and user-friendly tools such as an online chat. Specific spaces will be dedicated to Member States for this purpose accessible on every page of the Observatory through a quick link – e.g. "technical support on the right to education".
