Report on the implementation of the current Programme and Budget (C/5), together with the results achieved in the previous biennium (C/3)

Content of the report

1. Recalling recommendation 13 of 33 C/Resolution 92, and 33 C/Resolution 78, in which the General Conference requested the Executive Board to report to it at each session on the implementation of the current Programme and Budget (C/5), together with the results achieved in the previous biennium (C/3),

- 2. <u>Further recalling</u> 34 C/Resolution 89 inviting the Executive Board to have a wider and more strategic assessment of the performance of the programmes, including the EX/4 document, by expressing its views progressively during the biennium through explicit decisions on the performance of individual programmes at the main-line-of-action level,
- 3. Having examined document 184 EX/4 Draft 36 C/3,
- 4. Notes the progress achieved as identified in document 184 EX/4 Draft 36 C/3:
 - under Major Programme I (Education), especially towards achieving the Education for All goals, developing holistic education policies that integrate cross-cutting themes, and expanding provision of education beyond formal primary schooling through advocacy, high-level world conferences and active engagement in countrylevel coordination processes;
 - under Major Programme II (Natural Sciences), especially towards addressing adaptation to global climate change under the intergovernmental and international scientific programmes (IHP, IOC, MAB, IGCP, IBSP) and the revision of science, technology and innovation policy in many countries, notably in Africa;
 - under Major Programme III (Social and Human Sciences), especially towards fostering policy responses to mitigate the negative social consequences of the financial crisis, and raising awareness of issues relating to the ethics of science, in particular human cloning and international governance and the principle of social responsibility and health;
 - under Major Programme IV (Culture), especially towards integrating culture into national development strategies, and translating cultural diversity principles into policies for development processes;
 - under Major Programme V (Communication and Information), especially towards raising awareness of freedom of expression as a basic human right, the recognition of free and independent pluralistic media, as well as universal access to knowledge and information as important factors in the achievement of sustainable development and commitment to supporting Member States through policy advice and capacitybuilding, including the conservation of archives included in the Memory of the World Register;
 - under the global priority Addressing the needs of Africa, especially towards supporting the implementation of the Plan of Action for the Second Decade of Education for Africa (2006-2015) and the development of capacity in the areas of literacy and all levels of education, the review of science policies in 17 countries, fostering an enabling policy environment for youth participation in policy development, strengthening national capacities for the management and conservation of World Heritage properties, and increased mobilization for the development of media and infostructures;
 - under the global priority Promoting gender equality, especially towards increasing learning opportunities for women, improving gender-sensitivity in reading material, including in media reporting, and broader participation of women in decision-making processes, especially at the community level, and increasing use of the gender-lens perspective in needs assessments;
- Invites the Director-General to address the challenges identified under each major programme, in particular those that are cross-sectoral such as: United Nations Delivering as One and joint United Nations programming at the country level,

intersectoral platforms, including with regard to UNESCO's contribution to the Mauritius Strategy for Small Island Developing States, implementation of conventions, capacity development at the national level, further integration of a human-rights based approach into all UNESCO activities, further strengthening of ongoing efforts to combat racism and racial discrimination, and the need to better capitalize on and publicize UNESCO's expertise;

- 6. <u>Also invites</u> the Director-General to take stock of the lessons learned, in particular with regard to impact, cost-effectiveness and sustainability, and to apply the most relevant elements to the activities of the entire Organization;
- 7. <u>Further invites</u> the Director-General, in preparation for the next Draft Programme and Budget (36 C/5), to take into account the lessons that may be learned from analysis of the information provided in document 184 EX/4 Draft 36 C/3 and of the detailed information presented online, and to make good use of the complementary empirical evidence provided in the evaluations of the strategic programme objectives;

Format of the report

- 8. Recalling 34 C/Resolution 89, 176 EX/Decision 29, and Part II of document 179 EX/4 Draft 35 C/3 (*Rev. in English only*),
- 9. <u>Reiterating</u> its commitment to results-based management (RBM) as a vital tool for evidence-based strategic decision-making by the governing bodies,
- 10. <u>Underlining</u> the contribution expected from the C/3 document in terms of accountability for results and financial and administrative transparency, and as a tool for the planning process of future programme cycles,
- 11. Recognizing that document 184 EX/4 Draft 36 C/3 builds on the continued efforts to strengthen reporting on the performance of the programme in response to 34 C/Resolution 89,
- 12. Noting that, while the report focuses on main developments in the delivery of major programmes, detailed information concerning results achieved by all major programmes and under all other chapters (including central services) can be obtained from the UNESCO website, as well as complementary information on the results achieved with regard the participation of UNESCO field offices in United Nations common country programming processes,
- 13. <u>Welcomes</u> the enhanced commitment to presenting illustrative achievements and challenges for the two global priorities, *Addressing the needs of Africa* and *Promoting gender equality*, as well as for intersectoral platforms and each of UNESCO's five functions;
- 14. <u>Notes</u> with appreciation the improvements resulting from ongoing training in the overall RBM practice identified by the Internal Oversight Service (IOS), in particular in the preparation of the C/5 document and the identification and achievement of expected results relating to the core functions;
- Also welcomes Part II of document 184 EX/4 Draft 36 C/3 containing findings and conclusions of IOS that are crucial for the reinforcement of results-based monitoring and reporting;

- 16. <u>Stresses</u>, however, that limited progress has been achieved in addressing some of the shortfalls identified by IOS in document 35 C/3, and that action needs to be taken to address the following key challenges that hamper programming, results-based monitoring and reporting:
 - (a) excessive output-based programming and reporting (instead of outcome-based);
 - (b) weak use of formal monitoring systems and data collection tools;
 - (c) lack of monitoring data from beneficiaries to assess quality and usefulness;
 - (d) absence of baselines and benchmarks for some expected results;
 - (e) lack of appropriate indicators for qualitative interventions such as capacity- and policy-development related expected results;
- 17. <u>Invites</u> the Director-General to:
 - find means to overcome the challenges relating to results-based management identified in paragraphs 78 to 87 of document 184 EX/4 Draft 36 C/3 and to report to the Executive Board at its 186th session on her intentions and on the measures taken to implement the recommendations of IOS in order to enhance monitoring reporting for the next C/3 document (37 C/3);
 - make greater and more targeted efforts to ensure that quality outcome indicators as well as baselines and benchmarks are used throughout the process of drafting C/5 documents in order to support more qualitative outcome-based reporting in future C/3 documents;
 - present in the EX/4 and C/3 documents evidence-based analyses of the extent to which expected results have been achieved and have contributed towards the achievement of the biennial sectoral priorities and the strategic objectives in the Medium-Term Strategy, and how efficiently and effectively financial and human resources have been used:
 - pursue efforts to provide easier access to SISTER 2, and to hold appropriate training sessions for the Permanent Delegations on a regular basis;
- 18. <u>Further invites</u> the Director-General to present comprehensive analytical EX/4 reports each year at its spring session, and to present more concise reports at its autumn session.

The United Nations International Year of Youth (2010) and the UNESCO Strategy on African Youth developed by the Social and Human Sciences Sector

- 1. <u>Having examined</u> document 184 EX/4 containing the report by the Director-General on the implementation of the Programme and Budget, under Major Programme III,
- 2. <u>Considering</u> United Nations General Assembly resolution 64/134 "Proclamation of 2010 as the International Year of Youth: Dialogue and Mutual Understanding", bringing youth to the forefront of the global agenda,

- 3. <u>Convinced</u> that Africa's greatest resource is its youthful population, and that through the active and full participation of African youth, Africans can surmount the difficulties that lie ahead,
- 4. <u>Taking into account</u> the African Youth Charter of the African Union inviting every Member State to develop a comprehensive and coherent youth policy,
- 5. Recalling the Declaration of Ouagadougou adopted by the First UNESCO African Youth Forum (Burkina Faso, 24-28 September 2007), in which UNESCO was entrusted with encouraging, supporting, following and developing action by and for youth,
- 6. <u>Noting</u> that, in the context of the United Nations proclamation of 2010 as the International Year of Youth: Dialogue and Mutual Understanding, no concrete activity has yet been planned in the Africa region,
- 7. <u>Welcoming</u> efforts made by the UNESCO Social and Human Sciences Sector in the development of the UNESCO Strategy on African Youth, in close collaboration with African Member States.
- 8. <u>Acknowledging</u> the wide consultative process involving various partners, including the African Union, the African Development Bank, regional economic communities, regional intergovernmental organizations, African youth organizations, academia and the United Nations system in the development of the Strategy,
- 9. <u>Further recalling</u> the importance given to youth, and in particular African youth, under Major Programme III and Priority Africa in the Programme and Budget for 2010-2011 (35 C/5 Approved),
- 10. Requests the Director-General to reflect in her preliminary proposals for the Draft Programme and Budget for 2012.2013 (36 C/5) the UNESCO Strategy on African Youth;
- 11. <u>Invites</u> the Director-General to report to it at its 185th session on the planned implementation of the UNESCO Strategy on African Youth, and on activities planned for the celebration of the United Nations International Year of Youth (2010).

- 3. Requests the Director-General to present a thorough report on possible scenarios for alignment of programme cycles, including the programmatic and managerial implications for UNESCO, at its 185th session in connection with the Board's discussions on decentralization;

- 3. <u>Takes note</u> of the information included therein as well as of the proposed work plan to improve the geographical balance in the staff of the Secretariat (2010-2015);
- 4. <u>Notes</u> the slow implementation of the specific measures aimed at improving geographical representation, in particular for non-represented and under-represented Member States;
- 5. <u>Notes with appreciation</u> the Director-General's commitment to reinforcing the Young Professionals programme as one means among others to improve geographical representation in the Secretariat;
- 6. <u>Invites</u> the Director-General to present, as soon as possible, an information note on the geographical representation of the ten Young Professionals for the 2010-2011 biennium;
- 7. Urges the Director-General to implement the proposed work plan;
- 8. <u>Also invites</u> the Director-General to present to it at its 185th session an information note on:
 - (a) the progress made in the implementation of the specific measures and of the work plan;
 - (b) the situation of geographical representation, by country, in the staff of the Secretariat.

Progress in the implementation of the fundraising strategy for the South-South Cooperation Programme/Fund for Education

The Executive Board,

1. Recalling 33 C/Resolution 7, 174 EX/Decision 9, 175 EX/Decision 4 (III), 176 EX/Decision 5 (II), 179 EX/Decision 29 and 181 EX/Decision 54 regarding the establishment of the South-South Cooperation Programme/Fund for Education, the status of the South-South Cooperation Programme/Fund for Education, and

- development of a fundraising strategy for the South-South Cooperation Programme/Fund for Education,
- 2. <u>Further recalling</u> 182 EX/Decision 5 (III), in which the Director-General was requested to present a progress report on the implementation of the fundraising strategy at the 184th session of the Executive Board.
- Thanks the Director-General for submitting a progress report on the implementation of the fundraising strategy, and <u>notes with satisfaction</u> the commitment of the Director-General, reiterated at the information meeting of the Executive Board on 4 February 2010, to proactively strengthen the Programme/Fund, including by promoting it at all major international events;
- 4. <u>Notes</u> that the Director-General has emphasized the strengthening of South-South cooperation and triangular North-South-South cooperation in the activities of all major programmes in refining the work plans for document 35 C/5 Approved and in the preparation of the 36 C/5 work plans and the 35 C/5 and 36 C/5 complementary additional programme;
- 5. <u>Welcomes</u> the organization by the Steering Committee of the South-South Cooperation Programme/Fund for Education of the Round Table on South-South Cooperation/Funding in Education: Opportunities and Challenges at UNESCO Headquarters on 17 December 2009, held in conjunction with the United Nations Day for South-South Cooperation celebrated for the first time at UNESCO, and as part of the implementation of the fundraising strategy;
- 6. <u>Notes with satisfaction</u> the circulation as an information document of the Executive Board the summary report of the Round Table on South-South Cooperation/Funding in Education: Opportunities and Challenges;
- 7. <u>Notes with great concern</u> that ongoing pilot projects for the different regions cannot be sustained without funding either from the regular budget or from extrabudgetary contributions, and from new donors;
- 8. <u>Welcomes</u> the steps initiated by the Secretariat to implement the fundraising strategy, including letters written by the Director-General to potential donors to further mobilize funding for the South-South Cooperation Programme/Fund for Education;
- 9. <u>Expresses satisfaction</u> at the Director-General's commitment to seek funding for the Asia-Pacific pilot project through the complementary additional programme, and <u>requests</u> the Director-General to consider doing the same for other regional projects;
- Notes with deep regret that despite education for all (EFA) being a priority goal for UNESCO, only developing countries have to date contributed to the Programme/Fund, and <u>calls upon</u> all Member States to strengthen their support for South-South cooperation;
- 11. <u>Strongly urges</u> development partners to strengthen their support for South-South cooperation and for triangular North-South-South cooperation by making contributions to the Programme/Fund;
- 12. <u>Thanks</u> the Director-General for her commitment to the Programme/Fund, and <u>welcomes</u> her intention to earmark 0.5% of regular programme resources under the major programmes for the funding of South-South cooperation projects in all of UNESCO's fields of competence;

- Invites the Director-General to further strengthen the implementation of the fundraising 13. strategy, including through the active sensitization of other United Nations programmes such as the United Nations Development Programme (UNDP), as well as, inter alia, the World Bank, Asian Development Bank, Inter-American Development Bank and African Development Bank, and other donors:
- Further invites the Director-General to report to it at its 185th session on the progress achieved in mobilizing new funds through the implementation of the fundraising strategy, and to present a detailed report on the progress of implementation of the pilot projects.

- 1. Having examined document 184 EX/5 (IV) and Add.,
- 2. Recalling document 182 EX/5 (V),
- 3. Recalling 176 EX/Special Plenary Meeting/Decision, 177 EX/Decision 20, and 179 EX/Decisions 9 and 52,
- Further recalling Decisions 31 COM 7A.18, 32 COM 7A.18 and 33 COM 7A. 18 adopted by the World Heritage Committee at its 31st (Christchurch, 2007), 32nd (Quebec City, 2008) and 33rd (Seville, 2009) sessions respectively,
- 5. Also recalling the relevant provisions on the protection of cultural heritage including: the four Geneva Conventions (1949), the relevant provisions of the 1907 Hague Regulations on Land Warfare, the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954, the Convention for the Protection of the World Cultural and Natural Heritage of 1972, the inscription of the Old City of Jerusalem and its Walls at the request of Jordan on the World Heritage List (1981) and on the List of World Heritage in Danger (1982), and the recommendations, resolutions and decisions of UNESCO.
- 6. Deeply regretting in this regard, the postponement of the follow-up meeting of experts which was scheduled on 12 November 2008, as called for in Decision 33 COM 7A.18 adopted by the World Heritage Committee in Seville and reiterated in UNESCO Executive Board 182 EX/Decision 5 (II), as well as of the planned visit of Jordanian technical experts to the Mughrabi Ascent site on 27 July 2009, and requested visits of 17 December 2009 and 9 March 2010 due to the repeated denial of access by Israeli authorities, to Jordanian technical experts to the Mughrabi Ascent site, to enable them to conduct the required measurements to finalize the Jordanian Design in accordance with the World Heritage Committee decision (33 COM 7A.18) adopted in Seville and reiterated in UNESCO Executive Board 182 EX/Decision 5 (II),
- 10. <u>Recognizing</u> the deep concerns regarding the decision taken by the Jerusalem District Planning and Construction Commission on the town planning scheme for the Mughrabi Ascent,
- 11. Requests that, despite the decision mentioned in paragraph 10, the process for the design of the Mughrabi Ascent be inclusive of all parties concerned, in accordance with obligations and duties of such parties as stipulated in the content of previous World Heritage Committee decisions;
- 12. Reaffirms in this regard that no measures, unilateral or otherwise, should be taken which will affect the authenticity and integrity of the site, in accordance with the Convention for the Protection of the World Cultural and Natural Heritage of 1972 and the relevant provisions on the protection of cultural heritage of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954;
- 13. <u>Notes</u> the request made by the World Heritage Committee at its 33rd session in Decision 33 COM 7A.18 and <u>asks</u>, in this regard, that the Israeli authorities *resume cooperation* with all concerned parties, in particular with Jordanian and Wagf experts:

- 3. <u>Also recalling</u> General Conference and Executive Board decisions regarding the appointment of a permanent representative of the Director-General of UNESCO on the issue of Jerusalem,
- 4. <u>Affirming</u> that nothing in the present decision, which is aimed at the safeguarding of the Cultural Heritage of East Jerusalem, shall in any way affect the relevant United Nations resolutions and decisions, in particular the relevant Security Council resolutions on the legal status of Jerusalem,

- 9. <u>Invites</u> the Israeli authorities to facilitate the work of the expert(s) in conformity with its adherence to UNESCO decisions and conventions;
- 10. Also invites Member States to provide the necessary assistance to finance the work of the expert(s) from extrabudgetary resources:

- 6. Invites the Director-General, pursuant to 35 C/Resolution 108 to:

- (a) capitalize on the Decade's achievements and mobilize all programme sectors for the Organization's consolidated, coherent, targeted and innovative action in this field, duly taking the current world context and Member States' expectations into account;
- (b) maintain the culture of peace as one of the overarching objectives in the next C/4 document:
- (c) include in her preliminary proposals regarding the Draft Programme and Budget for 2012-2013 to be submitted to the Executive Board at its 185th session a draft programme of action for the culture of peace, including coherent targeted intersectoral and interdisciplinary activities, taking into account the present global context and new challenges.

- 4. <u>Conscious</u> of the necessity of reducing running costs without adversely affecting the work of the governing bodies,
- 5. <u>Welcomes</u> the measures already taken by the Chairperson;
- 6. <u>Decides</u> to improve its working methods in order to reduce costs, notably those relating to overtime, adhering to the following quality imperatives:
 - (a) provision of relevant working documents:
 - (i) timely provision of concise and analytical documents containing full relevant information to allow quality decision-making;
 - (ii) respect of statutory deadlines for issuing the documents;
 - (iii) improving and streamlining the distribution of documents;
 - (iv) good-quality translation, also exploring the use of high-quality translation outsourcing services, where possible at more competitive rates;
 - (b) organization of work:
 - (i) rational thematic grouping of items wherever possible, without preventing the introduction of draft decisions on any agenda item/sub-item by Members of the Board;
 - (ii) sunset clauses for follow-up reporting, in accordance with General Conference resolutions and Executive Board decisions concerning the need to continue or discontinue reporting on particular items;
 - (iii) more rational scheduling of side events outside of meeting hours;
 - (iv) increased use of seconded staff members, and reduction in the number of supernumerary contracts;

Aware that more than 30 years have passed since the Executive Board adopted 104 EX/Decision 3.3, and that in the light of the development and achievements within the United Nations system for the protection and promotion of human rights, it would be timely to review and improve the effectiveness of the implementation of 104 EX/Decision 3.3 in order to achieve greater efficiency and visibility in UNESCO's action,

 - (b) it shall have at least two working days before the autumn session of the Executive Board, to evaluate the different proposals included in the written contributions from Member States (182 EX/30 and 184 EX/19 Part I), and those resulting from the debate of the Committee on Conventions and Recommendations at the 184th session, as well as the comparative study of the Secretariat (184 EX/19 Part II), with a view to presenting a comprehensive proposal in this regard to the Executive Board at its 185th session;

- (c) it shall consider, with particular attention, all the concerns expressed by members of the Committee regarding the working methods, practices and modalities of the Committee:
- (d) it shall conduct its business under the Rules of Procedure of the Executive Board;
- (e) it shall meet in conjunction with the next session of the Executive Board.
- 7. <u>Also decides</u> to grant the Committee on Conventions and Recommendations, at its 185th session, two additional working days for this purpose, with a view to considering the ad hoc working group's proposals and adopting decisions in due course, and requests the Director-General to identify funding for that purpose.

Guidelines for the preparation of reports by Member States on the application of the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (184 EX/25; 184 EX/39)

- 1. <u>Bearing in mind</u> Member States' obligations under Article VIII of UNESCO's Constitution and Article 17 of the Rules of Procedure concerning recommendations to Member States and international conventions covered by the terms of Article IV, paragraph 4, of the Constitution,
- 2. Recalling 177 EX/Decision 35, in which (Part I) a specific multi-stage procedure was adopted for the monitoring of the implementation of UNESCO conventions and recommendations for which no specific institutional mechanism is provided, and (Part II) framework guidelines were adopted,
- 3. <u>Having examined</u> document 184 EX/25 and the report of the Committee on Conventions and Recommendations thereon (184 EX/39),
- 4. <u>Approves</u> the guidelines drawn up for the preparation of reports by Member States on the application of the Convention on the Means of Prohibiting and Preventing the Illicit

Import, Export and Transfer of Ownership of Cultural Property (1970) as amended and contained in the Annex to this decision;

- 5. Requests the Director-General to request Member States to submit to UNESCO, within a period of six months, reports on the implementation of the 1970 Convention;
- 6. <u>Further requests</u> the Director-General to submit to it, at its 187th session, a summary of the reports received from Member States on the measures taken in regard to the implementation of the 1970 Convention, with a view to transmitting the summary, together with the Board's comments, to the General Conference at its 36th session, and to establishing and providing access to a database containing the information thus obtained.

ANNEX

Guidelines for the preparation of reports by Member States on the application of the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property

As far as practicable, it is recommended that Member States address all of the points contained in these guidelines. In its contribution, however, a State may disregard any aspects on which no information is available. Lastly, even though some points are framed as questions, the document should be be regarded more as a guide than as a questionnaire.

I. INFORMATION ON THE IMPLEMENTATION OF THE UNESCO CONVENTION OF 1970 (with reference to its provisions)

1. Ratification of the Convention

- (a) Has the Convention already been ratified?
- (b) If not, please indicate, where applicable:
 - the stage of the ratification process reached by the State concerned (close to ratification, under way, actively under preparation, not considering ratification in the short, medium or long term);
 - obstacles or difficulties encountered in completing the ratification process (whether legal, political or practical) and the means of overcoming them;
 - the extent to which UNESCO can assist in completing the process?

2. Implementation of the Convention in national legislation and in the organization of relevant services

- (a) Give the references of the principal national regulations adopted in order to implement the 1970 Convention.
- (b) A definition of "cultural property" which is in accordance with the definition set forth in the 1970 Convention is important in order to increase the effectiveness of international cooperation. State what definition is used in the national laws of the country concerned.
- (c) Have specialized services been established in order to prevent or combat trafficking and ensure international cooperation for the protection of cultural heritage? Within the Heritage Department? In other government departments (police, customs)?
- (d) Describe briefly the administrative coordination of the activities of these specialized services, especially with the police and customs authorities.

(e) Are working meetings held to enable police officers, customs officials and ministerial representatives to meet and coordinate their activities?

3. Inventories and identification

- (b) State how precise the definition is, at the national level, of "cultural property" as referred to in international conventions (see above I.2(b)). State whether "national treasures" are identified in an official, tentative or exhaustive list.
- (c) To what extent is the Object ID standard used? Is the standard geared to the needs of the State concerned?
- (d) Do museums have anti-theft systems and provide training to museum staff, and have specific measures been adopted for libraries, archival and manuscript repositories, and any specialized units established to monitor them?

4. Archaeological excavations

- (a) Describe briefly the basic principles of the regulations in force in the country governing archaeological excavations and the monitoring of excavations.
- (b) Is there a recurrent problem of clandestine archaeological excavations? If so, what are the reasons for it and when did it begin? What steps have been taken to combat this scourge?

5. Monitoring of the export and import of cultural property

- (a) Give an estimate of the scale of the illicit export or import of cultural property. Are up-to-date statistics compiled on the theft of cultural property?

- (c) What are the main rules (administrative and legal) for monitoring the export and import of cultural property (existence of an export certificate, public information about the rules in force)? What categories of cultural property are covered by the rules?
- (d) Do the rules provide for the restitution of illicitly imported cultural property?
- (e) What are the main obstacles encountered in securing the restitution of illicitly exported cultural property? What is the nature of the obstacles (administrative, legal or political) and why do they arise (legal loopholes, reticence of importing countries, lack of international cooperation, etc.)?
- (f) If the country has succeeded in securing the restitution of a stolen cultural object, describe the circumstances and state whether that involved legal proceedings, arbitration or some alternative form of dispute resolution.

6. Regulations governing trade in and acquisition, ownership and transfer of cultural property

- (a) Give a brief description of the cultural property market in the country (financial volume of the market, number and turnover of auction houses, including via the Internet).
- (b) What are the main rules governing trade in cultural property? Are monitoring measures in place for such trade (maintenance of a police register), in particular through the Internet (for example, reference to the basic measures proposed by UNESCO, INTERPOL and ICOM)?

- (c) Do measures exist to control the acquisition of cultural property (for example, mechanisms to prevent museums and similar institutions from acquiring cultural property which has been exported illegally from another State)?
- (d) Specify the existing legal system concerning ownership of cultural property:
 - is the principle of inalienability applied to cultural objects in national collections and to objects from heritage sites ?
 - what is the status of cultural objects not yet discovered, of cultural objects found by chance, and of archaeological artefacts found during legal or illegal excavations?
- (e) Are there special rules governing the transfer of title deeds in respect of cultural property? If so, please summarize them.

7. Bilateral agreements

- (a) List the bilateral agreements concluded with other countries on the import, export and return of cultural property, and comment briefly on the effects of such agreements.
- (b) What conditions are set by the importing country with regard to the admissibility of requests for restitution from a country of origin?
- (c) Apart from such agreements, is there administrative assistance or any other type of cooperation with neighbouring countries, particularly in respect of police and customs services?

II. CODE OF ETHICS, AWARENESS RAISING AND EDUCATION

1. Ethical standards

Are the UNESCO International Code of Ethics for Dealers in Cultural Property and that of ICOM for museums known to the professionals concerned (in particular, curators, antique dealers, merchants and collectors)? How is their observance checked?

(e) Does cooperation exist with the United Nations Office on Drugs and Crime (UNODC)?

2. Customs

- 6. <u>Congratulates</u> the Director-General on UNESCO's rapid and timely response to the catastrophe, and <u>thanks</u> her for the initiatives that she has already taken, in particular UNESCO's participation in the needs evaluation undertaken jointly with United Nations organizations in Haiti, the identification of assistance priorities, as reflected in the three UNESCO projects included in the United Nations Flash Appeal for Haiti, and the mobilization of financial resources in support of the Organization's post-catastrophe action in Haiti;
- 7. <u>Congratulates and thanks</u> the Latin America and the Caribbean group (GRULAC) and the Africa group for the initiatives taken to contribute to the aid provided to Haiti through the Participation Programme;
- 8. <u>Thanks</u> the Member States for their generous contributions to the UNESCO projects included in the United Nations Flash Appeal for Haiti, and <u>urges</u> Member States and international governmental and non-governmental organizations to continue their aid in this regard by means of extrabudgetary funding;
- 9. <u>Invites</u> the Director-General to strengthen relations in the areas of UNESCO's competence with the NGOs present in the field for the purpose of the reconstruction and development of Haiti;
- 10. <u>Acknowledging</u> the key role that the various UNESCO sectors must play in the reconstruction of Haiti and the consolidation of its sustainable development, <u>invites</u> the Director-General, in coordination with other United Nations agencies, to develop a medium- and long-term cooperation strategy to be discussed and approved by the Executive Board, and to ensure its funding from the regular budget and from extrabudgetary resources, in particular:
 - (a) in all fields and all levels of education and scientific research, while taking into account the priorities of the Haitian Government;

- (b) in the field of the exact and natural sciences, harnessing space, terrestrial and oceanographic research and surveillance systems of the UNESCO Intergovernmental Oceanographic Commission (IOC), International Hydrological Programme (IHP), and the Man and the Biosphere (MAB) Programme;
- (c) for the protection and safeguarding of the tangible and intangible cultural heritage, including cultural industries;
- (d) for access to information and knowledge using the media and information and communication technologies (ICTs);
- 11. <u>Also invites</u> the Director-General, in collaboration with the Haitian Government, to provide the UNESCO Office in Haiti with the qualified human resources necessary for the smooth execution of UNESCO projects;
- Further invites the Director-General to present to the Executive Board at its 185th session a report on the progress of UNESCO's action and the monitoring of each project;
- 13. <u>Approves</u> the establishment of the International Coordination Committee for the Safeguarding of Haitian Cultural Heritage and the Statutes of the International Coordination Committee, as annexed to this decision, with the provision that the total administrative expenditure for the initial period should not exceed \$50,000, to be met from the UNESCO regular budget line of \$400,000 under the section relating to post-conflict, post-disaster (PCPD) activities;

ANNEX

Statutes of the International Coordination Committee for the Safeguarding of Haitian Cultural Heritage

Article 1

The International Coordination Committee for the Safeguarding of Haitian Cultural Heritage (hereinafter referred to as "the Committee") is hereby established.

Article 2

The Committee, in cooperation with specialized Haitian bodies, shall advise UNESCO's Director-General – who shall inform the Haitian authorities, Member States and other partners – on measures to improve and reinforce international cooperation for the safeguarding of Haiti's cultural heritage, and more specifically on:

- (a) a policy framework for immediate and long-term heritage protection and the definition of priorities and practical standards in accordance with the funds and technical assistance available or forthcoming in the near future;
- (b) concrete programmes and international assistance of the highest international standards;
- (c) the progress of the various activities in support of the safeguarding of Haitian cultural heritage, in order to coordinate international communication efforts;
- (d) the progress of the various activities in support of the safeguarding of built heritage, whether or not such heritage has been inscribed on the World Heritage List;

- (e) the exchange of knowledge relating to cultural objects, cultural and natural sites, museums, intangible heritage, art, creativity and cultural traditions throughout the country;
- (f) the identification of the funds available from donor countries and other partners in order to ensure their proper coordination, as well as the identification of possible supplementary funding and technical assistance for the safeguarding of Haitian cultural heritage;
- (g) the identification of secured shelters (safe havens) for temporary storage, and the preservation of the cultural objects at risk;
- (h) the provision of assistance to the Haitian authorities in implementing or elaborating the necessary legislative measures to protect, safeguard, and promote Haitian culture and in preparing nominations of potential sites for inscription on the World Heritage List or of potential elements for inscription on the Representative List of the Intangible Cultural Heritage of Humanity and the List of Intangible Cultural Heritage in Need of Urgent Safeguarding;
- (i) the provision of assistance to the Haitian authorities in implementing or formulating the necessary legislative measures to protect and safeguard the outstanding universal value of the National History Park Citadel, Sans Souci, Ramiers for which it was inscribed on the World Heritage List.

Article 3

- The Committee shall be composed of ten members, experts who shall be appointed in their personal capacities by the Director-General from a list of experts submitted by Member States, intergovernmental and non-governmental organizations, foundations and other institutions that contribute to the safeguarding and promotion of Haitian culture. At least three members shall be Haitian.
- 2. The normal term of office of members of the Committee shall be two years. This term is renewable. In the event of the resignation, incapacity or death of a member of the Committee, the Director-General shall appoint a replacement for the remainder of his or her term.
- In addition to the members of the Committee, and the observers mentioned in Article 8, the Director-General may invite to sessions of the Committee, as non-voting participants, the following:
 - (a) persons who by reason of their special knowledge and experience can assist the Committee in its work;
 - (b) representatives of funding or aid agencies that are active in Haiti in the relevant areas of cultural heritage and which, in the opinion of the Director-General, have experience that can contribute to the work of the Committee:
 - (c) representatives of non-governmental international organizations, funding agencies and regional and Haitian organizations which may be involved in the activities implemented in Haiti in the relevant areas of cultural heritage, in accordance with the Directives concerning UNESCO's relations with non-governmental organizations.

Article 4

- 1. The Chairperson of the Committee shall be appointed by the Director-General for a period of two years. The Committee shall elect its Vice-Chairpersons and Rapporteur for the same period.
- 2. The Chairperson, Vice-Chairpersons and Rapporteur shall form the Bureau of the Committee. They shall be eligible for further terms of office, and in any event shall remain in office until the election or appointment of the new members of the Bureau.
- 3. The Director-General shall convene the Bureau and shall be represented at its meetings.

4. In the interval between sessions of the Committee, the Bureau shall ensure the execution of tasks entrusted to it by the Committee.

Article 5

- The Director-General shall designate members of the UNESCO Secretariat to represent him or her on the Committee and the Bureau without the right to vote.
- 2. The secretariat of the Committee shall be provided by the UNESCO Secretariat.

Article 6

The Director-General shall convene sessions of the Committee, meetings of the Bureau, or small working meetings on certain aspects of the activities of the Committee as and when she deems it necessary.

Article 7

The travel and subsistence expenses of Committee members and of persons referred to in Article 3, subparagraph 3(a), in connection with the work of the Committee, may be borne by UNESCO in accordance with the relevant rules and regulations of the Organization.

Article 8

- Member States and Associate Members of UNESCO may send observers to sessions of the Committee.
- The United Nations and other organizations of the United Nations system with which UNESCO
 has concluded mutual representation agreements may send representatives to sessions of the
 Committee.
- The Director-General may extend invitations to send observers to sessions of the Committee, to:
 - (a) organizations of the United Nations system with which UNESCO has not concluded mutual representation agreements;
 - (b) intergovernmental organizations and international non-governmental organizations in accordance with the Directives concerning UNESCO's relations with non-governmental organizations;

Article 9

- 1. At its first session, the Committee shall adopt its Rules of Procedure which shall be submitted to the Director-General for approval. They must not be in contradiction with the present Statutes.
- 2. Each member of the Committee shall have one vote.
- 3. The agenda of the sessions of the Committee shall be drawn up by the Director-General.
- 4. After each session and at least once a year, the Committee shall present a report on its work and recommendations to the Director-General. The Director-General shall inform the Executive Board of the results of the work of the Committee.

Article 10

These Statutes may be amended by the Executive Board, on its own initiative or following proposals by the Director-General.

Article 11

The Committee's mandate may be terminated by decision of the Director-General after consultation with the Executive Board.

- 3. <u>Underlining</u> that all children, young people and adults have the human right to an education that meets their basic learning needs in the best and fullest sense of the term, in conformity with the World Declaration on Education for All (Jomtien 1990), the conclusions of the World Education Forum (Dakar 2000), the Universal Declaration of Human Rights, and the Convention on the Rights of the Child,
- 4. <u>Taking note of the conclusions and recommendations of the forty-eighth session of the International Conference on Education on the theme of "Inclusive Education: the Way of the Future".</u>
- Noting that the Addis Ababa Declaration recommended that national governments ensure that their educational policies and strategic planning, linked to a broader development framework, include all children, youth and adults, regardless of age, nationality, race, gender, ethnicity, disability, religion, social status and other markers of disadvantage,
- 6. <u>Recognizing</u> that the Dakar Framework for Action states that progress in meeting the basic learning needs of all will depend ultimately on the actions taken within individual countries,
- 7. <u>Also recognizing</u> that when countries face challenges in achieving education for all (EFA) goals, notably in rural, remote and disadvantaged areas, local communities/ organizations often develop their own initiatives,
- 8. <u>Emphasizing</u> that the development of quality education systems is essential to achieving the six EFA goals and other related internationally agreed development goals, in particular Millennium Development Goal 2, which seeks to ensure that, by 2015, children everywhere, boys and girls alike, are able to complete a full course of primary schooling,
- 9. <u>Taking note</u> of UNESCO's support for national efforts to achieve these goals, including, *inter alia*, through the preparation of UNESCO's National Education Support Strategies (UNESS) as well as through existing multilateral initiatives and mechanisms,
- Acknowledging the important role played by some non-formal education initiatives, such as community centres for learning, civil society organizations, and various religious educational institutions in supplementing governmental efforts to achieve the EFA goals,
- Recognizes the efforts of the Member States of UNESCO to mainstream these nonformal education initiatives so as to develop modern and quality education as a key tool for lifelong learning and sustainable development;
- 12. <u>Recommends</u> that these non-formal education initiatives be open to women and girls and do not discriminate against any student on account of religion, in order to ensure the free dissemination of knowledge;

- 13. <u>Taking into consideration</u> the Mid-Term Review of EFA carried out by Member States in cooperation with UNESCO, <u>invites</u> the Director-General, when requested by Member States concerned, to include in their UNESCO National Education Support Strategies (UNESS):
 - recommendations on how to develop and strengthen their education system in order to provide basic education opportunities to marginalized groups, *inter alia*, by bringing the non-formal education initiatives up to the same standards as their formal education system;
 - (b) guidance on the development of curricula, textbooks, teacher education programmes and the use of ICTs which may enhance access to education, notably in rural, remote and disadvantaged areas;
 - (c) advice regarding the development of quality early childhood care and development programmes for pre-school children;
 - (d) development of networks to share best practices;
- 14. <u>Also invites</u> the Director-General to report to the Executive Board on any concrete measures taken to assist Member States to improve the ability of their education systems to reach marginalized groups, by linking UNESCO's National Education Support Strategy (UNESS) documents closely to the formulation of programme deliverables of United Nations Development Assistance Frameworks (UNDAFs).

- 1. Having examined document 184 EX/37 and Add.,
- 2. Recalling resolutions and decisions of UNESCO on the protection of the cultural heritage in the occupied Arab territories, as well as the provisions of the four Geneva Conventions (1949), the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954) and the related Protocols and the Convention for the Protection of the World Cultural and Natural Heritage (1972),
- Also recalling the Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970),
- 4. <u>Affirming</u> that nothing in the present decision, which aims at the safeguarding of the cultural heritage located in the occupied Arab territories, shall in any way affect the relevant United Nations resolutions and decisions, in particular the relevant Security Council resolutions,
- 5. <u>Sharing</u> the concern expressed by the Director-General regarding the announcement made by the Israeli authorities that two sites, namely al-Haram al-Ibrahimi/Tomb of the Patriarchs in the city of al-Khalil/Hebron and the Mosque of Bilāl bin Rābāh (Tomb of Rachel), in Bethlehem, both located in the occupied Palestinian territories, are to be included in the Israeli national heritage list,
- 6. <u>Sharing as well</u> the conviction affirmed by the international community that the two sites are of religious significance for Judaism, Christianity and Islam,
- 7. Reaffirms that the two sites are an integral part of the occupied Palestinian territories and that any unilateral action by the Israeli authorities is to be considered a violation of international law, the UNESCO conventions and the United Nations and Security Council resolutions;
- 8. Regrets the Israeli authorities' decision to include the two sites on its national heritage list;
- 9. Urges the Israeli authorities to abide by international law and the relevant international conventions and decisions;
- Also urges the Israeli authorities to remove the two sites from its national heritage list;
- 11. <u>Thanks</u> the Director-General for her commitment to strengthening UNESCO's financial and technical assistance to the Palestinian educational and cultural institutions in compliance with the UNESCO General Conference resolution at its 35th session;

After the publication of the draft decision, the following Board Members added their signatures: Bangladesh, Congo, Democratic Republic of the Congo, Niger and Zimbabwe.

12. <u>Invites</u> the Director-General to submit to it a follow-up report at its 185th session and <u>decides</u> to include this item on the agenda of the 185th session of the Executive Board.
