

These more than 150 associations of the whole regions of Spain are represented by this non-profit-organization, FEAF, which have dedicated its work, effort and time to preservation and safeguard of the customs and traditions in Spain, specially traditional apparel, music and dance. FEAF is developing an "Overall Plan" to put the basic lines to continue working about the Traditional Culture, which had a suitable place in the field of the Culture. FEAF is developing actions in different areas to defend and to safeguard the I.C.H., knowing Conventions and Recommendations of UNESCO and taking part in a Not of Law Proposition for the Protection and Promotion of the Traditional Dance in 2010 or in the Draft of Law of the I.C.H. in Spain in 2011.

The Overall Plan of FEAF have been presented in several forum, National and International Congresses (CID, IOV) with a great wellcome. Following the line of the "Overall Plan" that FEAF is developing for several years, it has been marked several aims to protect and to safeguard the Cultural Immaterial Heritage in different areas of intervention, such as ANALYSIS, INVESTIGATION, SPREADING, FORMATION the CATALOGUING AND SAFEGUARD. All these areas form part of the same project from different ways, but that try to fulfill the same aims. UNESCO marked and mark the main lines to safeguard our Cultural Immaterial Heritage, because of it FEAF develops a project that tries to make fulfill these aims marked for Europe in Europe, with the jointed colaboration of several partners of different countries of the EU, knowing that it is necessary to follow the same way in the same direction., ... The development and teaching of the Methodology of Traditional Dance and Methodology and cataloguing of Intangible Cultural Heritage is a great support to this project, but it is neccessary to teach and work with researchers and students directly to can use and develope them

Federación Española de Agrupaciones de Folclore – F.E.A.F.



F.E.A.F. has been working for more than 30 years in the field of the Safeguarding of the Intangible Cultural Heritage, specially in Traditional Music and Dance, though the majority of associations that formed it have been safeguarding the Intangible Cultural Heritage (ICH) for decades in the development of their Etnographic Work.

F.E.A.F. has increased and improved its structure in last years, incorporating new members and creating a solid base, beating 150 associations and a great number of agreements with Regional Federations, contributors, expert, scientits and other organizations related with ICH to develop activities with common interests.

The work and the effort of countless people are recompensed, in a side because it recovers the cultural pluralism of different regions, and in other side because it becomes a entity with recognized preetige in Spain and abroad our borders in the field of the ICH. This work was realized is a indicator that everyone, every association, every member of F.E.A.F. has to carry on working, studying, cataloguing, recovering, spreading and disclosing our Culture.

F.E.A.F. is recognized as <u>Public Utility Entity</u> by the Government of Spain, as <u>member of IOV</u> (International Organization of Folk Art) and <u>member of CID of UNESCO</u> (International Dance Council), F.E.A.F. is incorporated in the en la <u>Commission of Following of the National Plan of Safeguarding of the Intangible Cultural Heritage of Spain in 2014 into the Ministry of Culture of Spain, in addition to realize contributions for the drafting and approval of the <u>No-Law Proposition in Defense of the Traitional Music and Dance</u> (SEE ANNEX number 1: Proposicion No de Ley 2010) approved in 2010, as well as the presentation of amendments in the development of the <u>Law of Intangile Cultural Heritage</u> aproved in 2015 (SEE ANNEX number 2: Ley de Patrimonio Cultural Inmaterial)</u>

UNESCO considers that the importance of the Intangible Cultural Heritage (I.C.H.) derives in the important fact of the Diversity of Cultures and the Guarantee of a sustainable Development of them. UNESCO <u>recognizes that colectives, grups and individuals take a important role</u> in the production, safeguard, maintenance and recreation of the I.C.H., which help to the enrichment of the cultural diversity and the human creativity, then F.E.A.F., as entity that incorporate a great number of associations related with it, is one of

the link organizations with carriers of the I.C.H. (SEE ANNEX number 3: Socios de F.E.A.F.).

Convention of Paris in 2003 speaks about the transmission process of the knowledge and this Convention is complementary to 2005, which is concerned to the protection and promotion of the diversity of these Cultural Expressions, that are spreading and sharing by main cultural activities and services. This fact is something that <u>F.E.A.F.</u> is making from desde multiple festivals, workshops, courses or schools of Traditional Music and Dance into their associations (SEE ANNEXS numbers 4 and 5: Actividades de agrupaciones de F.E.A.F.).

F.E.A.F. follow contributions that UNESCO remarks with the obligation of cataloguign the I.C.H., including, of course, Traditional Music and Dance, as is indicated in Convention of 2003: "uses, representations, expressions, knowleges and techniques, alongside instruments, objects, artifacts and cultural spaces that are inherents— that communities, groups and, in some cases, individual recognize as part and parcel of its Cultural Heritage. This Intangible Cultural Heritage, that is transmitted generation by generation, is recreated constantly by communities and groups in function of their environment, their interaction with nature and their history, infusing a identity feeling, continuity and contributing, as well as promoving the respect of the cultural diversity and human creativity" (UNESCO 2003); therefore F.E.A.F. is developing a Project, into the National Plan of Intangible Cultural Heritage about "Old dances of the región of Montehermoso, The Festival of Negritos of Montehermoso - Cáceres and Old dances of the region of Siberia Extremeña - Extremadura" (SEE ANNEX number 6: CONTRATO DE SERVICIOS del Instituto de Patrimonio Cultural de España, I.P.C.E.); and a project into the call of competitive grants of Cultural Industries of Ministry of Culture, about "Los caminos de arrieros" "Old ways of carriers" (SEE ANNEX number 7: Proyecto de arrieros FEAF).

Keep in mind that actions and activities realized by F.E.A.F. take part of <u>an Overall Project</u> whose objective is to include different fields and intervention áreas as: <u>analysis</u>, <u>research</u>, <u>cataloguing</u>, <u>education or formation</u>, therefore these activities are no separated actions, but as parts of a same idea that is looking for a common objective: <u>Defense and Safeguarding of our Intangible Cultural Heritage</u>.

FEAF is front of an important and necessary Project that try to get warnings and suggestions of UNESCO in the Convention in París, knowing that is a work that associations have been developing for decades so altruistic, but it has to be **coordinated**,

<u>organized and supported</u>, above all it is defined a international and national regulation (Plan Nacional de Salvaguarda del Patrimonio Inmaterial y Ley de Patrimonio Inmaterial).

OVERALL PLAN OF TRADITIONAL MUSIC AND DANCE: PRIORITIES

- a) To value the importance of the Music and Dance of oral tradition and the entities and people that help to promote the respect and other actions infavour of the same one.
- b) To realize an analysis about the currente situation in Spain, promoving meetings of specialists to advance in a scientific research of this área of the culture.
- c) To create differents university degrees about Traditional Music and Dance to the study and specialization of the several áreas of them.
- d) To give support to the incorporation of activities related with Traditional Dance and the knowledge of the folclore in schools and going to the University the career of Folclore, including the speciality of Etnochoreology, what means to integrate it n the formal formation from the infancy.
- e) To elaborate a catalogue of Music and Dance of Oral Tradition of the whole country, realized by a group of specialists to create a record and a Access of this catalogue across the technologies, having a Center of Documentation of traditional Music and Dance to file every traditional musics and dances, knowing that there is a lot of different formats and contents, for what is necessary a study about the evolution of traditional dances.
- f) To estimulate the work of speciallists, amateur groups, professional artists, scenic industry, programmers and show creators to intensify the presence of folclore in stages and meetings out of our borders.
- g) To be aware in TV and other media about the importance of this área of the culture to dedícate time and informatives programms
- h) To establish measures to avoid that any creator can take possesion of a popular music or dance, realizing changes in the law.
- i) To promote measures that allow to coordinate the action of differents staments of the country and the UE.

INTERVENTION AREAS OF THE OVERALL PLAN OF TRADITIONAL MUSIC AND DANCE OF F.E.A.F.:

ANALYSIS AND ACTION:

In this Plan, FEAF try to value, analyze and look for solutions to problems that envolve the world of the Traditional Culture in general, and Traditional Music and Dance particulary, that nowadays depends, as is said in the No Law Aproach, to the effort and work of no profit associations which defense to preserve our Culture.

SPREADING:

Developed activities in this area try to go near to the people because Traditional Culture born in people and is property of people, This fact have to be in our concience and have to bring to all generations and audiences.

SUMMARY AND SAFEGUARD:

The real posibility of lost of the Inmaterial Culture Heritage has to be vigilada in this moment when advances play to favour and against of it. To favour because it offers media to preserve it in new formats and in better conditions, and against because new ages make that the origin of our Culture, our character, our custom could lose.

RESEARCH:

Several areas of previous points of this Overall Plan offer <u>different lines to research and</u> <u>study the world of the Traditional Music and Dance</u>. Specially to catalogue Traditional Music and Dance, research and educational Plan, the posibilities of the Traditional Culture in the chilhood education....

FORMATION:

Need of offer formation to our teachers has been in several forum, in the same way that our associations try it, but to can offer a good learn, adecuated objectives, methodologies, etc, we have to offer a academic formation to our teachers and we try it with the first Title of Specialist in Traditional Dance, that pretends to be completed with differents actions in the educational way, as the first Certification of Specialist in Traditional Dance and Experimental Educational Plan. A great example of our purpose is the creation of the first certification related with Traditional Dance in Spain to complete different actions in the educational field (Experimental Plan) and in the formative field (extension of the specialized academic formation).
