At the beginning of 2012, I would like to extend my best wishes for health, success and happiness to you and yours.

As you know, UNESCO is currently experiencing financial difficulties. This concerns us all, and I know I can count on the support of National Commissions to continue the good work that we have jointly done thus far. We have already received encouraging words of support from many of you over the past months. This is further evidence of your commitment. As with the Director-General, I am convinced that together we can overcome the current difficulties.

In this regard, I am pleased to announce that an information meeting for Permanent Delegates, to be chaired by the Director-General, will be held on 26 January 2012. The purpose of this meeting is to inform Member States of the current budgetary situation of UNESCO, the reform process, and the implementation of the 36 C/5.

I would also like to note that we keep you regularly informed of the latest developments on the Organization's website (http://www.unesco.int), especially designed for Member States and National Commissions. In particular, we will continue updating data on the current financial situation, UNESCO reforms, as well as the Emergency Multi-Donor Fund.

As announced, "the National Commission News" has been recently added to the above-mentioned website. As such, we are pleased to inform you that your contributions are already online. We invite you to send us your information regularlyso that we may publish it on-line.

Participation Programme for 2012-2013

In the December 2011Monthly Newsletter I mentioned that new guidelines were prepared to improve the operation of the Participation Programme. I hope you have received the <u>Circular Letter</u> of the Director-General (CL/3985) on the Programme. The deadline for submitting your requests is 28 February 2012. Projects for 2012-2013 should be implemented before 31 December 2013, and the financial reports should be submitted by 30 April 2014 at the latest.

Launching the 40th Anniversary Celebration of the World Cultural and Natural Heritage Convention (1972)

Forty years after the adoption of the Convention Concerning the Protection of the World Cultural and Natural Heritage, 936 properties of outstanding universal value (725 cultural, 183 natural and 28 mixed properties) in 153 States Parties have been listed on the World Heritage List. To date 188 States Parties have ratified the Convention, which makes the Convention the most widely recognized for heritage protection.

In 2012, the 40th anniversary of the Convention will be held under the theme "World Heritage and Sustainable Development: the Role of Local Communities." This will be an opportunity to reflect on the importance of World Heritage and its implications to the lives of communities in the era of globalization and in light of economic, social and environmental upheavals.

The opening ceremony of the 40th anniversary of the Convention will take place at UNESCO Headquarters on 30 January. Throughout the ceremony, a tracing of the history of the Convention, from the context of its creation to the diversity of sites inscribed on the World Heritage List will be made. On this occasion, an acoustic concert by UNESCO Goodwill Ambassador Herbie Hancock will also be organized.

Launch of the 4th edition of the World Water Development Report (WWDR4)

The 4th edition of the World Water Development Report (WWDR4) "Managing Water under Uncertainty and Risk" will be launched on 12 March in Marseille (France) by Ms Irina Bokova, UNESCO Director-General and Mr Michel Jarraud, Chair of UN-Water.

Hosted and led by UNESCO, the United Nations World Water Assessment Programme (WWAP) coordinates the work of 28 UN-Water members and partners in the WWDR. It provides a comprehensive assessment of the state, use and management of the world's fresh water resources.

UNESCO's Division of Public Information (ERI) is preparing a range of materials to promote this new report. Your National Commissions are invited to contribute to organize launch events for the WWDR4 in your respective countries either on 12th March, or close to that date, with your respective UN-Water colleagues.
