**on the occasion of the Information Meeting “Follow up of the situation in
the Autonomous Republic of Crimea (Ukraine)”**

UNESCO, 2 June 2015

Excellencies,

Ladies and Gentlemen,

Thank you for attending this Information Meeting.

This is part of the implementation of the Decision adopted by Member States at the 196th session of the UNESCO Executive Board on “Follow up of the Situation in the Autonomous Republic of Crimea (Ukraine).”

As you know, this is the third Decision taken by the UNESCO Executive Board on “Follow up of the Situation in the Autonomous Republic of Crimea (Ukraine),” starting in 2014 -- this highlights, I believe, the continuing engagement of the Organisation on this important question.

In all of this, UNESCO has been and remains guided by the United Nations General Assembly Resolution of 27 March, 2014, on “Territorial Integrity of Ukraine,” which “affirms its commitment to the sovereignty, political independence, unity and territorial integrity of Ukraine within its internationally recognized borders.”

The most recent Decision of the UNESCO Executive Board requests me, as Director-General, to “organise, prior to the Executive Board’s 197th session, an information meeting to provide Member States with updates on the situation in Crimea in the fields of UNESCO’s competences.”

In this respect, the Decision called on me to invite to this information meeting representatives of international organisations and non-governmental organisations.

Guided by these lines, I consulted with the Ambassador and Permanent Delegate of Ukraine to UNESCO, to exchange views on taking the Decision forward.

On this basis, I invited the following organisations to inform on developments in Crimea (Ukraine) -- given their relevance to UNESCO's fields of competence and drawing on existing partnership relations with UNESCO:

- The United Nations Office of the High Commissioner for Human Rights;
- The Office of the Commissioner for Human Rights, Council of Europe;
- The Representative on Freedom of the Media of the Organisation for Security and Cooperation in Europe;
- The International Council on Monuments and Sites;
- Amnesty International (Official Partner of UNESCO, Associate Status).
