Analysis of replies of the questionnaire



- The Questionnaire was addressed to Member States, Associated Members, UN Agencies, IGOs and NGOs on 18 April 2016 (Circular letter CL/4152)
- It is designed to solicit views on future
   programme orientations, building on
   Organizations past achievements and taking
   into recent developments at global level, in
   particular Agenda 2030, to inform preparation
   of Draft 39 C/5
- 121 replies: 117 Member States and 4
   Associated Members (109 replies for 37 C/5)
- Member States and Associated Members replies and the Analysis are available on BSP Website

## Regional consultations of representatives of Member States and Associate Members:

- a new mechanism introduced at the 38th session of the General Conference
- foreseen as e-discussion where feasible (38 C/7 Annex III)
- discussions and preparations ongoing (awaiting list of moderators and rapporteurs)
- some technical and logistical challenges;
   maybe a need for face-to-face meetings



#### **Sub-regional consultations with NatComs:**

- a new mechanism (38 GC)
- foreseen as e-discussion online
- technical and logistical challenges
- will take place at the interregional meeting of the National Commissions (one day, 15 June 2016), with presence of several FO Directors and Heads

#### Some **milestones** in the process:

- Conducted an **initial mapping** on UNESCO's contribution to supporting Member States in implementing the SDGs (38 C/7) for the 38th session of the General Conference
- **38 C/5** aligned to show direct and indirect link to several of the 17 SDGs
- Strategic Results Report (SRR, April 2016): a significant step in the discussion on the strategic positioning of UNESCO's programmes
- Questionnaire and consultations





With "step-bystep" approach to the Structured Financing Dialogue



- A "step-by-step" approach and a "mutual learning process" between the Member States and the Secretariat, taking into account UNESCO's specificity (199 EX/Decision 5.II.F)
- Preparatory work is being undertaken in informal consultations of Member States...
- ... with the development of an "a transitional integrated budget framework presentation": a simulation of typical budget tables, based on 38 C/5 figures, is being developed
- Some typical questions at this stage:
  - ✓ What resources should we integrate? (assessed and voluntary, etc.)
  - ✓ How should we categorize the funds under the integrated budget framework? (specified, flexible...)
  - ✓ Is there any area of activities that is integrated in the framework but should be left outside the future "dialogue" for funds raising? (e.g.: equivalent to "emergency event" and "polio" in WHO)





With **adjustments** in some areas:

- **Budgeting techniques and accounting** (e.g., standard cost calculation, constant dollar mechanism, cost recovery policy)
- Programming (e.g. adjustments to RBB tool)
- **Human resources** (e.g., what posts to be included etc.)
- **Reflection on the 39 C/5 presentation** (ensuring comparability with the 38 C/5, and continuing to present useful information -- post details, decentralization, etc.)
- Transparency Portal

A full summary on these issues will be provided to the Executive Board at the **200th session** as part of the 39 C/5 Preliminary Proposals.
