The coming year will be marked by important events for us, notably the next session of the General Conference in autumn. The 4<sup>th</sup> Interregional Meeting of National Commissions will also take place in the margins of that session of the General Conference at the UNESCO Headquarters.

Let me now share with you the outcomes of two recent events in the field of culture.

16 new elements have been added to the UNESCO List of Intangible Cultural Heritage, following the decisions adopted by the eleventh session of the intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage, held from 28 November to 2 December 2016 in Addis Ababa, Ethiopia. The Representative List of the Intangible Cultural Heritage of Humanity, now numbering a total of 366 items, shows the diversity of this heritage and raises awareness about its importance. Another important event was the tenth session of the Intergovernmental Committee for the Protection and Promotion of the Diversity of Cultural Expressions, held from 12 to 15 December 2016 at UNESCO Headquarters. The Committee examined, among others, how to enable greater access to digital technologies and adopted the draft Operational Guidelines on the implementation of the Convention in the digital environment, which aim to encourage new policies and measures based on principles of openness and access. ## 15 January 2017 – deadline for submission of the Celebration of anniversaries with which UNESCO will be associated in 2018-2019

The National Commissions are invited to inform the Secretariat of the commemoration(s) with which their countries would like UNESCO to be associated during the 2018-2019 biennium, in accordance with the revised criteria and procedures relating to the Celebration of Anniversaries, adopted by the Executive Board through 195 EX/Decision 25.

Each Member State may submit **two requests** for the celebration of anniversaries in association with UNESCO and preferably, one of these relating to gender equality.

In addition, Member States who have anniversaries approved by the 38<sup>th</sup> session of the General Conference (check here the List of anniversaries to be celebrated in 2016-2017 in association with UNESCO) are kindly reminded that they are responsible for the implementation of the activities relating to the celebration of anniversaries and must submit to the Director-General, on completion of the project, a detailed activity report on the results achieved and their usefulness to the Member State(s) and UNESCO. No new anniversary proposals will be considered until the Member State concerned has provided all of the requisite activity reports.

## 28 February - 3 March 2017 – African Regional Conference on Humanities, Bamako, Mali

In preparation of the World Humanities Conference (Liège, Belgium, 6-12 August 2017), the Government of Mali will host an African Conference on Humanities on the theme "Languages, Cultures, History and Territories" in Bamako, from 28 February to 3 March 2017.

Launched on 5 December 2016 at UNESCO Headquarters during a highlevel panel on "Targeting Heritage: in search of new paradigms – save heritage through dialogue", the new publication *Military Manual on Protection of Cultural Property* is intended to be used by all governments to enhance the capacity of their military to address the new challenges of protecting cultural property in times of conflict. This publication is the firstof-its kind training tool published by UNESCO with the support of the International Institute of Humanitarian Law (Sanremo, Italy) and funded by the Republic of Azerbaijan. - UNESCO, in collaboration with the Joint United Nations Programme on HIV/AIDS (UNAIDS) Inter-Agency Task Team (IATT) on Education and School Health and UN Women, launched a publication Global Guidance on Addressing School-related Gender-based Violence following recommendations by the Global Working Group to End School-Related Gender-Based Violence. This publication provides key information to governments, policy-makers, teachers, practitioners and civil society who wish to take concrete action against school-related gender-based violence (SRGBV). It introduces approaches, methodologies, tools and resources that have shown positive results in preventing and responding to SRGBV. The publication is available in English under this link.
- Human rights and encryption, the eighth title in the UNESCO series on Internet Freedom, was launched at the 11th Internet Governance Forum in Guadalajara, Mexico, held from 6 to 9 December 2016. This study addresses the relevance of encryption to human rights in the media and communications field and offers policy recommendations for state practice and other stakeholders.
