Vision



- Based on the Maastricht Declaration (2002) GENE works towards the day when all people in Europe will have what we believe to be a right: access to quality Global Education.
- We do this through sharing Policy Learning.
- Clear benchmark Universalising, rightsbased approach

Mechanisms

Roundtables - sustained policy learning;

Peer Reviews — affirming best practice,
recognising routes for increasing, improving;

Support for national structures and strategies;
Policy Research — cross-cutting, common issues

Strengthening funding mechanisms

Policy learning....



- Need for clear, overarching vision that is based on international agreement and national realities;
- Clear conceptual foundation and a term (Global Education) that is all-embracing but non-prescriptive;
 - Policy learning is not uni-directional;
- Integration into education systems is not a goal, cannot be achieved by targeting

Policy learning....



.....from outside education systems, but the involvement of other Ministries (MFA, E.Env) helps;

- the professional and personal learning involvement of policymakers is key;

What works?



- Ownership by MOE, coupled with national support by MFA, MEnV, etc, works.
- Peer learning, international affirmation and peer engagement, also works.
- A common vision works but common visions cannot be prescribed or promulgated
- A combination of top down and bottom up works.
- Accompanying national initiatives works.
