I. Activities

1. Education/ Training/ Research

All the activities realized by the UNESCO Chair in 2009 had the following target groups and geographical coverage:

Target groups: undergraduate, graduate and postgraduate students, academics.

Geographical coverage: national, Africa (Ethiopia, Ghana, Nigeria, Sudan), Arab States (Palestine, Egypt), Asia and the Pacific (China, India, Indonesia, Malaysia, Mongolia, Philippines, Vietnam), Europe and North America (Czech Republic, Latvia, Slovak Republic, Poland, Turkey, Ukraine, Austria, Canada, Greece, Netherlands, Switzerland, USA), Latin America and the Caribbean (Argentina, Bolivia, Brazil, Chile, Columbia, Costa Rica, Cuba, Ecuador, El Salvador, Guatemala, Honduras, Mexico, Nicaragua, Panama, Peru).

Duration: January-June 2009

Research

In 2009, the UNESCO Chair conducted the following research projects:

• Indicators for Education for Sustainable Development (ESD)

Duration: April 2008 – August 2010

Objectives: to develop a set of indicators on ESD to enable gathering information regarding the development of ESD activities and the conditions under which ESD is practiced.

• Evaluation of Measures of the National Action Plan and awarded projects within the UN-Decade on ESD in Germany (TRANS300)

Duration: September 2007 – January 2010

Objectives: to analyse possible contributions of the UN DESD in Germany, focusing on measures and projects and their potential for distributing, anchoring and stabilising ESD in the long run.

• Educational Institutions and Sustainable Consumption - BINK (German: Bildungsinstitutionen und Nachhaltiger Konsum)

Duration: June 2008 – May 2011

Objectives: discuss on how educational institutions can become places in which youths and young adults are offered a chance to reflect their own patterns of consumption and to try out sustainable consumer behaviour and raise awareness on sustainable consumption (food, mobility,energy).

• Geoinformatics breaking new ground - Development of a study program "Environmental communication and nature protection" for students of Geoinformatics at Czech Technical University in Prague

Duration: January 2008 – December 2010

Objectives: Development and testing of a project-oriented contribution to the Master course curriculum and realization of study trips for Czech participants to Germany in order to initiate expertise in communication methodologies with regard to nature protection. In the long run, this new field of activity shall be tailored to fit into already existing courses at Czech TU in Prague as a new area of specialisation or as a module of continuing education.

• Teaching Sustainability in Higher Education

Duration: January 2009 – December 2011

In cooperation with: Universidad Técnica del Norte (Ibarra, Ecuador)

Objectives: developing and evaluating a 1-year teacher-training, aiming at the integration of sustainability in the Higher Education Curriculum, focusing on interdisciplinary didactical approaches and methods. As a long-term goal the Universidad Técnica del Norte strives for a Master "Sustainability".

II. Outcomes

At the regional level, the activities of the UNESCO Chair helped to realize aspects of sustainable development in different realms and on varying levels within its own university.

In teaching and learning, the focus is to foster inter- and transdisciplinary education and research in order to counterbalance disciplinary approaches which are equally needed to achieve sustainability. These challenges are primarily achieved through the "Leuphana Bachelor programme" and Leuphana's Master's program in Sustainability Sciences.

At the national level, the UNESCO Chair has been influencing national and international policy on higher education for sustainable development. As a member of the German working group on higher education of the UN Decade Education for Sustainable Development (ESD), the Chair continuously works on the inclusion of sustainability as a paradigm for higher education in Germany – especially in preparing a memorandum on "Sustainability and Higher Education", adopted by German UNESCO Commission and scheduled to be co-published together with the German Rectors' Conference (HRK) in 2010.

At the European level, the UNESCO Chair was one of the drivers that helped to re-establish the COPERNICUS Alliance as a NGO under German law in 2009. This European network aims to exchange and enhance knowledge on Education for Sustainable Development between European higher education and student organizations that work for sustainable development and to promote Higher Education for Sustainable Development in European Policy (http://www.copernicus-alliance.net/).

Finally, since its inauguration in 2005, the UNESCO Chair has been active to stimulate international debate about the meaning of sustainability as a paradigm for higher education institutions, particularly through international conferences.

III. Development prospects

- To acquire and carry out new projects which target sustainable development issues at universities to allow scientific research and transfer of knowledge in regard to sustainable development.
- To follow up the project proposal for highlighting the context of higher education within the context of biodiversity and current nature conservancy strategies that was submitted to the German Federal Agency for Nature Conservation (BfN) in the summer 2009.
- To follow up the application on "Sustainable Higher Education: Future-oriented design of university teaching and learning against the backdrop of sustainable development" submitted to the German Academic Exchange Service (DAAD) in July 2009.
- To introduce sustainable development at all the University levels (structural and cultural), following the "Agenda 21 and the University of Lüneburg" project (1999-2001) and the "Sustainable University" project (2004-2008).
- To take a pro-active role in the development of national and international policy on education for sustainable development: at the national level, to continue to pinpoint directions of the working group on higher education for sustainable development under the auspices of the German Round Table of the UN Decade; at the international level, to continue, in collaboration with other European partner universities, to revitalize the COPERNICUS Campus Network.
- To strengthen international cooperation on higher education for sustainable development through networking and exchange, in order to enhance the recognition of sustainability as an essential paradigm for higher education institutions worldwide. In this regard, closer cooperation with other ESD-related UNESCO Chairs (e.g. in the Netherlands, UK and Sweden) is essential. As a consequence, these considerations are supposed to have a vital influence of the design of the forthcoming 4th International Conference on Higher Education for Sustainable Development, scheduled for 2011.
