**Final Statement: Drafting process** 

## 1. Preparation of the first draft

The draft Statement has been prepared by the EFA Steering Committee and the UNESCO Secretariat in advance of the GEM, informed by findings of the 2012 EFA Global Monitoring Report and regional EFA reports, and recommendations from regional EFA meetings (Africa, October 2012; Arab States, October 2012); the Asia and the Pacific High-Level Expert Meeting on Post-2015 (May 2012); the Sixth Meeting of the Collective Consultation of Non-Governmental Organisations on EFA (October 2012) and the Ninth E-9 Ministerial Review Meeting (November 2012).

The first draft Statement integrates input from all stakeholders, collected by the EFA Steering Committee<sup>1</sup> who carried out consultations among their regions and constituencies during the month of November.

The draft Statement will be discussed by the Senior Officials' Meeting, revised by the Drafting Group accordingly, and discussed and adopted at the High-Level Ministerial Meeting.

## 2. Drafting Group

The EFA Steering Committee as the Drafting Group will work on 21 and 22 November to finalise the Statement. The working language of the Drafting Group is English.

## 3. The first draft

The draft Statement will be distributed to the Senior Officials' Meeting participants in the morning of 21 November 2012.

The draft Statement will be discussed by the Senior Officials' Meeting on 21 November during Session 5. Participants are asked to provide recommendations on (i) the overall structure, tone and content of the document and (ii) any key themes missing or to be removed from the

document. Specific proposals for reformulation or adding/deleting text should be provided in writing to the Secretariat or to members of the Drafting Group by 18.00 on 21 November.

The Drafting Group will meet **on 21 November at 19.30** to finalise the document for adoption by the High-Level Ministerial Meeting.

## 4. The draft document to be presented to the High-Level Ministerial Meeting

The revised draft Final Statement will be distributed to all meeting participants in English and French on 22 November around midday, and presented by the Chair of the Drafting Group to the High-Level Ministerial Meeting on 22 November at 17.15 (Session 7).

The High-Level Ministerial Meeting will discuss and adopt the Final Statement during the same session.

The final document will be disseminated to participants in English and French on Friday 23 November by 12.00. The Final Statement will subsequently also be translated into Arabic, Chinese, Russian and Spanish.
