Biofutura is a non-governmental organization, formed by 15 professionals with high social and environmental commitment, and we got around 300 volunteers. The organization has two locations in Mexico, the headquarters is located in the State of Hidalgo (in the center of Mexico), and the other based in the north of Mexico, in the State of Chihuahua.

Our work is related to the preservation, protection, dissemination and preservation of intangible cultural heritage, we have more than five years of experience, within the recent activities related to the topic are the following:

1. Conservation and diffusion of Xantolo (Day of the Dead in Mexico) in the Huasteca of Hidalgo, through a previous justification study of the problem of cultural loss and workshops with Freirean pedagogical approach to the conservation of the Huasteca culture, and the creation and dissemination of Xantolo in the Huasteca supporting the festival the first days of November in 2014.
2. Rescue biocultural heritage of the Nahua, the jaguar as intangible cultural heritage, tecuani, lord of animals and mountain heart at the Huasteca, this activity was linked to the preservation, protection, measurement and transmission of social uses, rituals that have a direct relationship between the divine figure of the jaguar in the indigenous community. This incredible work ended with the reintegration of the jaguar in the carnival called nahnuatilli.
3. Rescue of the handcrafted embroidery called "pepenado" as ancestral heritage of indigenous Otomi-Tepehua Sierra. This activity is developing with Otomi and Tepehuas people because the embroidery pepenado is in danger of disappearing. We performed this activities with the elderly people in workshops with the young to rescue this activity.
4. Creation of the indigenous young group to rescue the biocultural heritage of the Tarahumaras, this activity is in process, and aims to rescue the biocultural heritage of the Tarahumara region in Chihuahua state focusing on the black bear worldview.
5. Rescue to the dance of the first corn and the raccoon in Nahua community, this activity focused on measures to preservation of this ritual in Oceloco and Yahualica communities in the state of Hidalgo through the valorization of this ritual through the workshops of intangible biocultural heritage.

Our efforts to protect intangible cultural heritage are specializes in issues related to the practices, representations, expressions, knowledge and techniques together with the instruments, objects, artefacts and cultural spaces that have a relationship with nature (intangible biocultural heritage), for that reason we establishing alliances between communities and indigenous peoples to safeguarding the biocultural heritage.

So in all our activities, we always drive with the utmost respect, for this reasons in the communities where we do the safeguarding of intangible cultural heritage, the people believe, learn and work with us, one of the problems that we have encountered is the great plurality of languages that exists in Mexico, so in our organization we have different translators to help us to understand more and work together for the cultural heritage that gives identity as a social group and is part of a recognized national and international human right..
