1. OPENING OF THE MEETING

The fifty-fifth annual meeting of the Bureau of the Intergovernmental Council of the International Programme for the Development of Communication (IPDC) was organized at UNESCO Headquarters in Paris from 22 to 24 March 2011. The meeting was opened by Mr Jānis Kārklīņš, representative of the Director-General of UNESCO, and chaired by Mr Raghu Menon (India), Chairman of the IPDC Intergovernmental Council. The eight members of the Bureau – Egypt, India, Namibia (Rep.of), Russian Federation, Senegal, Thailand, Venezuela and United States of America - were all represented at the meeting. Mr Mamadou Koumé from Senegal acted as Rapporteur.

The UNESCO Advisers for Communication and Information based in the field offices were invited to present the project proposals under their responsibility.

**2. OPENING REMARKS BY J. KĀRKLIŅŠ,
Assistant Director-General for Communication and Information,
UNESCO.**

Mr Jānis Kārklīņš highlighted in his opening remarks that the total amount of contributions to the IPDC, which is the only multilateral forum in the UN system designed to mobilize the international

1. OUVERTURE DE LA SESSION

La cinquante-cinquième réunion annuelle du Bureau du Conseil intergouvernemental du Programme international pour le développement de la communication (PIDC) s'est tenue au siège de l'UNESCO à Paris du 22 au 24 mars 2011. M. Jānis Kārklīņš, représentant de la Directrice générale de l'UNESCO, a ouvert la réunion, qui a été présidée par M. Raghu Menon (Inde), Président du conseil intergouvernemental du PIDC. Les huit membres du Bureau – l'Égypte, les États-Unis d'Amérique, l'Inde, la Namibie (Rép. de), la Fédération de Russie, le Sénégal, la Thaïlande et le Venezuela - étaient tous représentés à la réunion. M. Mamadou Koumé, du Sénégal, en était le Rapporteur.

Les Conseillers régionaux de l'UNESCO pour la Communication et l'Information étaient invités à présenter les propositions de projets sous leur responsabilité.

**2. OBSERVATIONS PRÉLIMINAIRES PAR J. KĀRKLIŅŠ,
Sous-Directeur général pour la Communication et l'information,
UNESCO.**

M. Jānis Kārklīņš a souligné dans ses observations préliminaires que la somme totale des contributions au PIDC, qui est le seul forum multilatéral du système onusien dont le but est de mobiliser la

community to support media development, had reached in 2010 its highest level in the decade – almost 2,5 million USD –, a sign of the growing confidence of donors in the Programme. He drew attention to IPDC's strategic approach to media development, spelling out the Programme's key priorities – (i) promotion of freedom of expression and media pluralism; (ii) community media development; and (iii) human resource development.

He went on to report on the progress made within the framework of the three recent special initiatives launched by IPDC: firstly, the development and application of a set of Media Development Indicators to assess national media landscapes; secondly, monitoring the safety of journalists and addressing the impunity of those who commit crimes against them; and thirdly, developing centres of excellence in journalism education in Africa. For the representative of the Director-General, supporting the training of journalists in Africa should contribute to improving practices among the profession.

Mr Kārkliņš ended by acknowledging all of the donors that had contributed to the Programme in the last year, namely: India, Switzerland, Spain, the United States of America, Denmark, Finland, Norway, Andorra, Sweden, France and Israel.

3. REPORT BY R. MENON, Chairperson of the International Programme for the Development of Communication

After providing an overview of the various missions that had been carried out in the last year to promote the IPDC among donors, Mr Menon went on to remind the Bureau members of project selection procedures and of the criteria to be used for assessing project proposals. He underlined that the quality of the project and the credibility of the submitter are the most important factors, while others include the contribution of the projects to the three priorities of the IPDC, the justification of budget in relation to the project activities

Il a attiré l'attention des délégués sur l'approche stratégique du PIDC vis-à-vis du développement des médias, énonçant les priorités clés du Programme – (i) la promotion de la liberté d'expression et du pluralisme des médias; (ii) le développement des médias communautaires; et (iii) le développement des ressources humaines.

Il a ensuite informé des progrès qui avaient été réalisés dans le cadre des trois initiatives spéciales lancées par le PIDC: tout d'abord, le développement et la mise en application des indicateurs de développement des médias (IDM) pour évaluer le secteur des médias dans différents pays; ensuite, le suivi de la sécurité des journalistes et comment combattre l'impunité de ceux qui commettent des crimes à leur encontre; et enfin, le développement de centres d'excellence dans la formation au journalisme en Afrique. Pour le représentant du Directeur général, l'encouragement à la formation des journalistes en Afrique est de nature à contribuer à une bonne pratique du métier.

M. Kārkliņš a terminé son intervention en remerciant tous les donateurs qui avaient contribué au Programme l'an passé, à savoir: l'Inde, la Suisse, l'Espagne, les États-Unis d'Amérique, le Danemark, la Finlande, la Norvège, Andorre, la Suède, la France et Israël.

3. RAPPORT PAR R. MENON, Président du Programme international pour le développement de la Communication

Après avoir évoqué les différentes missions qui avaient été effectuées au cours de l'année écoulée pour promouvoir le PIDC parmi les donateurs, M. Menon a rappelé aux membres du Bureau les procédures de sélection des projets ainsi que les critères à prendre en compte pour leur évaluation. Il a précisé que la qualité du projet et la crédibilité de l'organisation qui le soumet étaient les facteurs les plus importants; parmi les autres, il a mentionné la contribution des projets aux trois priorités du PIDC, un budget justifié par rapport aux activités

He also made reference to the Decision taken by the IPDC Bureau at its 53rd meeting in 2009 to allocate up to US\$ 100,000 from the Special Account for projects aimed at applying UNESCO's Media Development Indicators (with a maximum of US\$ 15,000 per country).</p> <p>He ended by drawing the delegates' attention to the expanding opportunities for developing free, independent and pluralistic media, particularly within the context of the recent events in the Arab region, and invited the Bureau to identify the most deserving projects, i.e. those that will have the strongest impact on improving the situation of the media in the countries in which assistance is being sought.</p>	<p>et résultats escomptés du projet, la contribution du bénéficiaire et enfin, la viabilité du projet. <p>4. IPDC BUDGET 2011 AND DECISIONS ON PROJECTS</p> <p>In line with its mandate, the Bureau examined the 109 new media development projects submitted to it this year. The Bureau decided to approve 93 projects for a total amount of US\$ 2,315,780. Thirty-nine of these projects will be implemented in Africa, twenty-two in the Asia-Pacific region, eighteen in Latin America and the Caribbean, twelve in the Arab region and two in Europe. All will be financed from the IPDC Special Account - the Programme's common funding pool – except one, a Funds-in-Trust (FIT) project supported by Belgium aimed at assessing national media landscapes in the MENA region using the Media Development Indicators (US\$ 176,280).</p> <p>The budgetary allocations decided on by the Bureau can be spelled out as follows:</p>	<p>4. Le Bureau a décidé d'approuver 93 projets pour un montant total de 2,315,780 dollars. Parmi ces projets, trente-neuf seront mis en œuvre en Afrique, vingt-deux en Asie-Pacifique, dix-huit en Amérique latine et les Caraïbes, douze dans la région arabe et deux en Europe. 5. DECISION ON THE EVALUATION OF IPDC PROJECTS

The IPDC Bureau approved a Decision increasing the funds allocated from the IPDC Special Account for evaluation activities in order to enable the IPDC Secretariat to reinforce the evaluation of IPDC projects and ensure adequate follow-up. The biennial allocation will thus increase from US\$25 000 (53rd IPDC Bureau meeting, March 2009) to US\$ 40 000 in view of financing the missions of independent evaluators to complete at least 12 evaluation reports on terminated projects per biennium.
