Background: Following a proposal by the Government of the People's Republic of China to establish an International Research and Training Centre for Science and Technology Strategy in Beijing, as a category 2 centre under the auspices of UNESCO, a field mission was undertaken to evaluate the feasibility of establishing the proposed centre.

Purpose: Following 185 EX/Decision 16, Part II, the present document contains a draft resolution recommended by the Executive Board for the approval of the establishment of the Centre. For reference, document 185 EX/16, Part II describes the proposal and analyses the feasibility of the Centre, and provides the scientific and institutional rationale behind the Chinese Government proposal in conformity with document 35 C/22 and Corr. relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 35 C/Resolution 103.

- 1. The Executive Board, at its 185th session, considered document 185 EX/16 Part II on the proposed establishment of an International Research and Training Centre for Science and Technology Strategy in Beijing, as a category 2 centre under the auspices of UNESCO. Having examined document 185 EX/16 Part II which describes the proposal and analyses the feasibility of the centre in accordance with the guidelines contained in document 35 C/22 and Corr. relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 35 C/Resolution 103, the Executive Board welcomed the proposal to place the centre under the auspices of UNESCO. The Executive Board subsequently recommended (185 EX/Decision 16, Part II) that the General Conference, at its 36th session, approve the proposal to grant to the said centre the status of a category 2 centre under the auspices of UNESCO and that it authorize the Director-General to sign an agreement with the Chinese Government concerning the establishment and operation of the centre.

Background: In response to a proposal by the Portuguese Republic for the establishment of an International Centre for Advanced Training of Scientists from Portuguese-Speaking Countries in Areas of Basic Sciences in Lisbon as a category 2 centre under the auspices of UNESCO, consultation was held with the Portuguese Ministry of Science, Technology and Higher Education and Ministry of Foreign Affairs, and a mission to Portugal was undertaken to evaluate the feasibility of the proposed Centre.

Purpose: Following 185 EX/Decision 16, Part III, the present document contains a draft resolution recommended by the Executive Board for the approval of the granting to the Centre the status of a category 2 centre under UNESCO's auspices. Background: In pursuance of a proposal from the Government of Slovenia for the establishment of a category 2 centre under the auspices of UNESCO by transforming the Institute of Information Science in Maribor as IZUM-Regional Centre for Library Information Systems and Current Research Information Systems, the Executive Board at its 187th session welcomed such a proposal and recommended the General Conference to approve it, at its 36th session, and to authorize the Director-General to sign the Agreement between UNESCO and the Government of the Slovenia contained in the Annex to document 187 EX/14, Part V.

Purpose: Following 187 EX/Decision 14, Part V, the present document contains a draft resolution for the General Conference recommended by the Executive Board for the approval of the establishment in Slovenia of the above-described centre. For reference, document 187 EX/1, Part V, describes the proposal, analyses the feasibility of the centre, which is in conformity with documents 35 C/22 and Corr. relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 35 C/Resolution 103, and contains, as an annex, the Draft Agreement between UNESCO and the Government of Slovenia.

- 1. The Executive Board, at its 187th session, considered item 14 on the proposed establishment in Slovenia of a category 2 centre under the auspices of UNESCO by transforming the Institute of Information Science in Maribor as IZUM-Regional Centre for Library Information Systems and Current Research Information Systems. Having examined document 187 EX/14, Part V, which describes the proposal and analyses the feasibility of the centre in accordance with the guidelines contained in document 35 C/22 and Corr. relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 35 C/Resolution 103, the Executive Board welcomed the proposal to place this centre under UNESCO's auspices. Background: In response to a proposal by the Government of Sudan to establish on its territory a regional centre on capacity development and research in water harvesting as a category 2 centre placed under the auspices of UNESCO, the Intergovernmental Council of the International Hydrological Programme (IHP) at its 19th session adopted Resolution XIX-6 in July 2010 welcoming the establishment of the proposed centre and requesting UNESCO's assistance in preparing the necessary documentation to be submitted to UNESCO's governing bodies. A UNESCO mission, hosted by the Government of Sudan was undertaken in February 2011 in order to assess the feasibility of establishing the proposed centre.

Purpose: Following 187 EX/Decision 14, Part VI, the present document contains a draft resolution recommended by the Executive Board for the approval of the granting to the centre of the status of a category 2 centre under UNESCO's auspices. Document 187 EX/14, Part VI describes the proposal and reviews the prerequisites for the establishment of the centre, and provides the scientific and institutional rationale behind the proposal of Sudan in conformity with document 35 C/22 and Corr. relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 35 C/Resolution 103.

- 1. The Executive Board, at its 187th session, considered document 187 EX/14, Part VI on the proposed establishment of a Regional Centre on Capacity Development and Research in Water Harvesting, under the auspices of UNESCO. Having examined document 187 EX/14, Part VI which describes the proposal and analyses the feasibility of the centre in accordance with the guidelines contained in document 35 C/22 and Corr. relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 35 C/Resolution 103, the Executive Board welcomed the proposal to place this centre under UNESCO's auspices. The Executive Board subsequently recommended (187 EX/Decision 14, Part VI) that the General Conference, at its 36th session, approve the proposal to grant to the said centre the status of a category 2 centre under the auspices of UNESCO and that it authorize the Director-General to sign an agreement with the Government of Sudan concerning the establishment and operation of the centre.

For reference, document 187 EX/14 Part VIII describes the proposal and analyses the feasibility of the centre, in accordance with the integrated comprehensive strategy approved by the General Conference in 35 C/Resolution 103.

Background: In response to a proposal by the Government of Serbia to establish on its territory a centre for water for sustainable development and adaptation to climate change as a category 2 centre under the auspices of UNESCO, the 46th session of the Bureau of the Intergovernmental Council of the International Hydrological Programme (IHP) endorsed the proposed centre for presentation to the 20th session of the Intergovernmental Council of IHP in the Summer of 2012. In line with the deep interest expressed by the Government of Serbia to expedite the establishment of the centre, the feasibility study process has been initiated through a successful mission to Serbia, which took place from 20 to 22 July 2011 and collected the needed information. The feasibility study will be completed by the Secretariat following the 20th session of the IHP Intergovernmental Council.

Purpose: Following 187 EX/Decision 14, Part VIII, the present document contains a draft resolution recommended by the Executive Board for the implementation of a procedure that would allow for expediting the processing of the centre. Document 187 EX/Decision 14 Part IX and Corr. contains a procedure proposed by the Natural Sciences Sector, with the agreement of the Government of Serbia that will gain one year in the overall process. Relying on paragraph A.1.5 of the integrated comprehensive strategy (35 C/22 Annex), the procedure requires that the General Conference at its 36th session delegate to the 190th session of the Executive Board, that would follow the 20th session of the IHP Council, the authorization to decide, on behalf of the General Conference, concerning the designation of the proposed centre as a category 2 centre, and that the General Conference, at its 36th session also authorizes the Director-General to sign the corresponding agreement in the case of a favorable decision by the 190th session of the Executive Board. The proposed process would have the advantage of providing the opportunity for the proposed centre to be approved in the autumn of 2012 instead of at the 37th session of the General Conference in the autumn of 2013.

- The Executive Board, at its 187th session, considered document 187 EX/14 Part IX and Corr. on the proposed establishment of a Centre for Water for Sustainable Development and Adaptation to Climate Change, under the auspices of UNESCO. Having examined document 187 EX/14 Part IX and Corr., which describes the procedure proposed by the Natural Sciences Sector and agreed upon with the Government of Serbia to expedite the establishment of the proposed centre in accordance with the guidelines contained in document 35 C/22 and Corr. and in paragraph A.1.5 in the same document relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 35 C/Resolution 103, the Executive Board welcomed the proposed procedure to expedite the processing of the proposal from the Government of Serbia. The Executive Board subsequently recommended (187 EX/Decision 14, Part VIII.) that the General Conference, at its 36th session, authorizes the Executive Board, at its 190th session to decide, on its behalf, on the request of designating the "Water for Sustainable Development and Adaptation to Climate Change" at the Jaroslav Černi Institute for the Development of Water Resources in Serbia as a category 2 centre under the auspices of UNESCO, and that it further authorizes the Director-General to sign the corresponding agreement with the Government of Serbia concerning the establishment of the centre in the case of a favorable decision.
- 2. In view of the above, the General Conference may consider the following draft resolution:

- 1. Recalling 35 C/Resolution 103 and 187 EX/Decision 14, Part VIII,
- Further recalling paragraph A.1.5 in document 35 C/22, stating that in certain cases, the General Conference may authorize the Executive Board to decide on its behalf in designating a category 2 institute or centre,
- Taking note of the endorsement thereof by the forty-sixth session of the Bureau of the Intergovernmental Council of the International Hydrological Programme of UNESCO in June 2011 leading to the comprehensive review by the 20th session of the IHP Council in 2012,

Authorizes the Executive Board of UNESCO at its 190th session to decide, on its behalf, the request of designating the "Water for Sustainable Development and Adaptation to Climate Change" at the Jaroslav Černi Institute for the Development of Water Resources in Serbia as a category 2 centre under the auspices of UNESCO which is to be done in conformity with document 35 C/22 and Corr. relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (categories 1 and 2) as approved by the General Conference in 35 C/Resolution 103 and recommended by the Executive Board at its 187th session (187 EX/Decision 14, Part VIII);
- 6. <u>Authorizes</u> the Director-General to sign an Agreement concerning the establishment of the Water for Sustainable Development and Adaptation to Climate Change in Serbia as a centre under the auspices of UNESCO (category 2) in the case of a favorable decision by the 190th session of the Executive Board of UNESCO.
