DEMOCRATIC CONSTITUENT CONGRESS

THE CONSERVATION, PROTECTION AND PROMOTION OF THE ARCHAEOLOGICAL HERITAGE OF SIPAN IS DECLARED OF NATIONAL INTEREST

LAW Nº 26282

THE PRESIDENT OF THE REPUBLIC

WHEREAS:

The Democratic Constituent Congress has passed the following Law:

THE DEMOCRATIC CONSTITUENT CONGRESS has passed the following Law:

Article 1º.- To declare of national interest the conservation, protection and promotion of the Archaeological Heritage of Sipán, exclusive owner of the State, located in the annex of the same name, district of Zaña, province of Chiclayo in the North-Eastern Region of Marañón.

Article 2º.- To declare the Archaeological Complex of Sipán as Intangible Archaeological Reserve including a monumental and central minimum area of 31.5 hectares and other surrounding testimonies, whose specific boundaries shall be established by the National Institute of Culture (INC).

Any interference with plots in possession of or owned by individuals must be resolved in terms of expropriation as established by the Law.

Article 3º.- By the appropriate legal and/or diplomatic means, the State shall stipulate the recuperation of the cultural property of the archaeological reserve, which could have been acquired illegally in the country or abroad.

Article 4º.- Enrique Brunning National Museum of Lambayeque of the INC is the responsible body for this Archeological Reserve.

Article 5th.- The legal provisions opposing to this Law are amended or repealed.

Article 6th.- This Law will come into effect the day following its publication in *El Peruano* Official Gazette.

Let the President of the Republic be notified for the enactment of the Law.
