<u>Item 3 of the Agenda</u>: Nominations to be examined by the World Heritage Committee in 2003: Status of Nominations received by the World Heritage Centre

SUMMARY

This document presents a list of nominations submitted by States Parties to be examined by the World Heritage Committee in 2003. The list includes <u>all</u> nominations received by the World Heritage Centre up until the time of preparation of this document.

This document also outlines the procedure applied by the Centre to determine whether a nomination is "full and complete" as requested by the 24th and 25th sessions of the Committee (Cairns, December 2000 and Helsinki, December 2001).

Results

Applying the Committee's decision in Cairns (December 2000) that only one new nomination could be submitted by a State Party with properties already inscribed on the World Heritage List, the total number of new "full and complete" nominations to be transmitted to the Advisory Bodies for evaluation and examination by the Committee in 2003, was **seven**. **Two** extensions were also transmitted for evaluation. **Nineteen** nominations, **two** extensions and **one** deferred nomination lacking minor pieces of supplementary information, were determined "almost complete." Under paragraph 65 of the *Operational Guidelines*, additional information may be requested after examination by the Advisory Bodies. Rather than submit only 7 new nominations to the Committee for review in 2003, paragraph 65 has been interpreted as an opportunity to request the supplementary information necessary to make the 19 "almost complete" nominations "full and complete".

Action required:

The 25th session of the Committee agreed that if more than 30 complete nominations were received by the Centre by 1 February 2002 the matter would be referred to the April 2002 Bureau for guidance. Since this is not the case, this document is presented to the Bureau for information only.

The Bureau may wish to,

- (i) reflect on the overall conclusions presented in this document;
- (ii) make recommendations to the 26th session of the World Heritage Committee concerning the selection of nominations to be examined by the Committee in 2003 and,
- (iii) make recommendations to the 26th session of the World Heritage Committee to establish a priority system to limit the number of nominations to be examined by the Committee in 2004.

Procedure applied by the World Heritage Centre to determine whether a nomination is "full and complete"

In total, **57** nominations were received by 1 February 2002. These included **50** new nominations submitted by 34 States Parties, **6** nominations for extensions and **1** nomination deferred from an earlier session of the Committee. **Seven** States Parties submitted a total of **15** nominations to be set aside for consideration by future sessions of the Committee. In the majority of cases, these States Parties have indicated a priority order in which nominations should be examined in successive years. This priority order is indicated in the list following.

Of the 57 nominations received by 1 February 2002, <u>35 were new nominations submitted for consideration by the Committee in 2003</u>. Of these, the World Heritage Centre determined that:

- 7 nominations were "full and complete" (designated with an "F" in the list),
- 19 nominations were "almost complete" (designated by an "A"); and
- 9 nominations were "incomplete" ("I").

These terms were defined as follows:

A nomination was considered to be **''full and complete''** if all information requested by the World Heritage Committee in the Nomination Format was submitted in the required number of copies by 1 February 2002.

A nomination was determined to be "almost complete" if the missing information could be supplied without modification to the nomination text. For example, if the only missing elements were a map or slides, or there were an insufficient number of copies, the nomination was considered "almost complete".

If the nomination required textual changes (for instance, if no justification was provided, or sections of the nomination were omitted), the nomination was considered **"incomplete"**.

Results

As noted above, only seven new nominations were determined to be "full and complete," in addition to **two** extensions. Under paragraph 65 of the *Operational Guidelines*, additional information may be requested after examination by the Advisory Bodies. **Nineteen** nominations, **two** extensions, and **one** deferred nomination lacking minor pieces of supplementary information were determined "almost complete." Rather than submit only 7 new nominations to the Committee for review in 2003, paragraph 65 has been interpreted as an opportunity to request the supplementary information necessary to make the nomination "full and complete".

At the time of the preparation of this document, the Centre was writing to all the States Parties who had submitted nominations to advise them of the status of their nominations. On 5 March 2002 the Centre will have transmitted the 7 "full and complete" nominations and 19 "almost complete" nominations to the Advisory Bodies for their evaluation, in addition to the four extensions, and one deferred nomination.

Overall conclusions:

Compared to previous years, the list of nominations demonstrates an increase in the number of States Parties nominating sites (34 States). Five States Parties with no World Heritage properties submitted a total of seven nominations. Overall, a wider variety of types of properties have been nominated. Furthermore, the need to determine whether a nomination is "full and complete" has given the World Heritage Centre an opportunity to review its technical registration procedures and to ensure more rigour and objectivity to the process on a global basis.

The results presented in this document demonstrate that the use of the criterion "full and complete" by itself has been sufficient to implement the decision of the 24th session of the Committee (Cairns, 2000) to examine in 2003 no more than 30 new nominations. Additional selection criteria were therefore not required.
