## Main responsibilities

Under the overall authority of the Director-General and under the supervision of the Assistant Director-General for the Intergovernmental Oceanographic Commission (ADG/IOC), the incumbent will assist with the implementation of technical activitie at the IOC Marine Policy and Regional Coordination Section within the context of the Project on Knowledge, Assessment, and Management for AQUAtic Biodiversity and Ecosystem Services aCROSS EU policies (AQUACROSS Project – H2020) (www.aquacross.eu);

The incumbent will specifically:

(i) Contribute to implementation of the IOC/MPR activities to H2020 Project AQUACROSS in order to assist the project coordinator and the Regional Observatory for Environment

- and Sustainable Development (OREDD) of the Regional Direction of Environment for Tanger-Tetuan-AlHoceima (Morocco) to provide valuable inputs to the project.
- (ii) Contribute to the implementation of the AQUACROSS pilot case study at the Intercontinental Biosphere Reserve of the Mediterranean Andalusia (Spain) – Morocco and specifically the finalization of the storytelling application within the OREDD in French and Arabic.
- (iii) Contribute to the compilation and analysis of data and information from different national sources in Morocco for the ORFDD.
- (iv) Contribute to enhance the collaboration with relevant public and private stakeholders at the Intercontinental Biosphere Reserve of the Mediterranean: Andalusia (Spain) Morocco.
- (v) Contribute to the development of multilingual web-based multimedia products and training materials in French and Arabic.
- (vi) Contribute to events, meeting reports, scientific papers and the regular reporting of activities to the head of the MPR Section, and the Project Coordinator of AQUACROSS at IOC-UNESCO.

## **Required qualifications**

<u>Education:</u> Advanced university degree (master level or higher) in environmental sciences, information systems and decision support tools.

<u>Work experience</u>: Preferably 3-5 years of working experience on regional and transnational biodiversity, habitats and water policies in connection with environmental information systems. Experience on modelling processes with GIS and Web GIS tools will be an asset.

# Skills and competences:

- Excellent research, analytical and problem solving ability, including taking part in the resolution of issues and in the application of good judgement.
- Very good inter-personal skills and ability to maintain effective partnerships and working relations within a multi-cultural environment; ability to work collaboratively as part of a team to achieve organisational goals.
- Ability to plan own work and manage conflicting priorities; work under pressure.

- Ability to write and speak clearly and effectively, including the ability to draft reports in a concise style and communicate complex scientific information to a broader audience – via visual, written and verbal modes.
- Languages: Very Good knowledge of spoken and written French and Arabic. Knowledge of Spanish and English will be an asset.
- Specific knowledge on databases and information products, the Environmental Information Systems of Morocco (OREDD) and the Information Systems of Spain / Environmental Information Network of Andalusia (REDIAM).

## **Desirable qualifications:**

<u>Education</u>: The consultant should hold a degree in marine/coastal resources management, geography, environmental sciences, biological sciences, geological sciences or equivalent combined with the use of information/data management tools.

<u>Work experience:</u> Practical familiarity with Moroccan, European and transnational water and land policies and their associated environmental information systems and decision support tools.

#### **Duration:**

The Consultant is appointed 3 months (including a probationary period of 1 month) from 1 September to 30 November 2018. The contract is not renewable. The appointment is non-career and does not carry any expectancy of renewal or conversion to another contract. Medical health care is not provided.
