Questions

Rights

The respect of human rights and fundamental freedoms as proclaimed in the Universal Declaration of Human Rights, including the right to freedom of opinion and expression, as well as the right to privacy; The same human rights, responsibilities and obligations applied in the physical world should also apply in the digital world.

Openness

The right to seek, impart and receive information forms part of the freedom of expression as a human right, and is linked to other rights such as the right to education, gender equality, right to privacy, right to take part in cultural life and freedom of assembly and association. It is the global and open nature of the Internet that facilitates opportunities to evolve. This also requires widespread cooperation among different stakeholders such as governments, civil society, the private sector and citizens at large. Participation, privacy and safety are closely interrelated with freedom of expression. A modern and broad concept of security, based on international law and with a clear human rights perspective should focus on the security of the individual. A lack of human security on the Internet affects the opportunities of individuals to exercise their rights and to participate politically, economically and socially in society. The Swedish Media Council is a government agency whose primary task is to promote the empowering of minors as conscious media users and to protect them from harmful media influences. The Media Council gathers relevant research and disseminates information on media development, media effects and media use regarding children and young people. Every second year they publish a report (loosely translated to "Kids and media") looking into, among other things, the Internet use of children and young people through several indicators.
