## **Division of Freedom of Expression and Media Development (CI/FEM)**

**The Division of Freedom of Expression and Media Development (CI/FEM) implements activities that promote the free flow of information.**

The main tasks include sensitizing governments, public institutions and civil society on freedom of expression and media development, online and offline, including through the celebration of World Press Freedom Day. Notably, the Division assists UNESCO's Member States in developing standards and legal instruments for press freedom and freedom of information in accordance with internationally recognized standards, and monitors the state of the safety of journalists, including impunity as regards violence against journalists.

The Division is also responsible for mobilizing international support for the International Programme for the Development of Communication (IPDC) and, in this context, for assisting UNESCO's Member States in the development of free, independent and pluralistic media, in line with the Media Development Indicators (MDI) and Internet Universality Indicators.

It is responsible for setting standards for journalism education and for supporting the role of media in fostering inclusive dialogue, especially in conflict-sensitive situations.

Moreover, the Division works in fostering media pluralism, particularly by promoting community media and fostering media and information literacy.
