**ARTICLES OF REGULATIONS OF ARCHEOLOGICAL RESEARCH  
APPROVED BY EXECUTIVE ORDER N° 004-2000-ED ARE AMENDED**

**EXECUTIVE ORDER N° 012-2006-ED**

Lima, April 20, 2006

In view of the Official Letter N° 036-2006-INC/DN issued by the Director of the National Institute of Culture (INC)

WHEREAS:

Pursuant to the Regulations of Organization and Duties of the INC, approved by Executive Order N° 017-2003-ED, the INC has the following duties: *To formulate and execute policies, strategies and objects of the State for the cultural development, such as the identification and registration, research, defense, conservation, preservation, promotion, diffusion and value of the Cultural Heritage of the Nation*”;

The Regulations of Archeological Research was approved by Executive Order Resolution N° 004-2000-ED dated January 24, 2000;

The Office of the Comptroller General of the Republic, by Recommendation N° 04 of Report N° 254-2005-CG/EA - Special Exam to the INC - in the frame of the Agreements signed between the INC, the Company Bohic Ruz Explorer SAC and Convento de Santo Domingo, indicates that the incumbent of the INC must establish a mechanism, which allows the entity to be sure that the projects presented before its representative have the necessary financing as well as the corresponding guarantees for incidental damages, in general compliance with the relevant regulations requirements;

In that sense, it is convenient to amend the Regulations of Archeological Research in order to meet with the Recommendation given by the Office of the Comptroller General of the Republic;

As provided for by Legislative Decree N° 560, Law Decree N° 25762, as amended by Law N° 26510 and Law N° 28296.

IT IS ORDERED:

**Article 1°.-** To include clause d) and c) in Articles 36° and 50° respectively of the Regulations of Archeological Research, approved by Executive Order N° 004-2000-ED dated January 24, 2000.

“Article 36°.- (...)

d) Letter of commitment signed by the applicants, assuming responsibility for any incidental damages caused during the execution of the project.”

“Article 50°.- (...)

d) Letter of Commitment signed by the applicants, assuming responsibility for any incidental damages caused during the execution of the project.”

**Article 2°.-** To amend the first paragraph of Articles 41° and 56° of the Regulations of Archeological Research, approved by Executive Order N° 004-2000-ED dated January 24, 2000 as appropriate, which shall read as follows:

“Article 41°.- The following must be indicated, together with the corresponding financing supporting documents, regarding the material and financial resources: (...)”

“Article 56°.- The following must be indicated, together with the corresponding financing supporting documents, regarding the material and financial resources: (...)”
