PRESIDENT OF THE REPUBLIC

WHEREAS

THE CONGRESS OF THE REPUBLIC has passed the following law:

LAW AMENDING ARTICLE 82° OF THE CODE OF CIVIL PROCEDURE ABOUT SPONSORSHIP OF DIFFUSE INTERESTS

Article 1°.- It amends Article 82° of the Code of Civil Procedure.

Be amended Article 82° of the Code of Civil Procedure as follows:

"Article 82°.- Sponsorship of diffuse interests.- A diffuse interest is that, which ownership corresponds to an undetermined group of people regarding assets of inestimable value such as the environment, the cultural or historical heritage, or the consumer's assets.

The Government Attorney General's Office, the Regional and Local Governments and the Rural and/or Native Communities, in which jurisdiction a damage to the environment or the cultural heritage was caused, and non-profit associations or institutions legitimated according to the law or the Judge's opinion, made by resolution duly grounded, can promote or take part in this process.

The Rural Patrols, who prove legal capacity, have the same right than the Rural or Native Communities, where these do not exist or have not appeared before trial.

If processes related to the defense of the environment or cultural assets or valuables are promoted without the intervention of the above-mentioned Local Governments; the Judge must include them in capacity of required joint litigants in compliance with Articles 93° to 95°.

In these cases, a synthesis of the claim shall be published in "El Peruano" Official Gazette and other, where the judicial notices of the corresponding judicial district are published. The regulations about subjective accumulation of claims are applied to the processes about diffuse interests where they may be relevant.

If the sentence is not appealed, this shall be passed for consultation to the Court of Appeals. The final judgment, which declares the claim founded, shall be binding also to the people who have not participated in the process.

The indemnity established in the sentence must be given to the District or Provincial Councils, which might have taken part in the process, in order to use it for repairing the damage caused or the environment conservation of its circumscription."

Article 2°.- Be annulled legal provisions.

Be annulled all the legal provisions against this law.

Let it be notified to the President of the Republic to be enacted.
