**IN EXERCISE** of the powers conferred by section 14 of the Town and Country Planning Act, 1992 the Minister makes the following Order:-

**TOWN AND COUNTRY PLANNING (ZONED AREA DECLARATION)  
(PORT ELIZABETH - BEQUIA) ORDER, 1994.**

1. **Citation:** This Order may be cited as the Town and Country Planning (Zoned Area Declaration) (Port Elizabeth - Bequia) Order, 1994 and shall come into effect on the 15th day of September, 1994.

2. **Declaration:** (1) In accordance with section 14 of the Town and Country Planning Act the portions of land in Port Elizabeth, Bequia more particularly described in the Schedule hereto are declared zoned areas as OPEN SPACE for public recreational use and assembly.

(2) The following land uses are strictly prohibited -

- (a) retail activities including the vending of vegetables, fruits, souvenirs, clothing, fish and meat products, and dry goods;
- (b) the preparation and sale of food, drinks and snacks except at designated sites upon the issuance of prior written non-transferable permit for a period of twelve months by the Physical Planning and Development Board, and subject to such conditions as the Board may think fit and in conformity with other laws;
- (c) organized sporting activities and games except with prior written permission from the Physical Planning and Development Board which shall be for a period not exceeding seven days;

(d) the deposit of garbage generated from ships, boats or from any other area outside of the zone defined in the Schedule hereto;

(3) A map of Port Elizabeth, delineating the zoned areas referred to in this Order is available for inspection by members of the public during normal working hours from the 23rd day of August, 1994 and thereafter for a period of six weeks at the following places -

- (a) Revenue Office, Port Elizabeth < Bequia;
- (b) Bequia District Council, Port Elizabeth, Bequia;
- (c) Port Elizabeth Police Station, Bequia;
- (d) Tourism Information Centre, Port Elizabeth, Bequia;
- (e) Central Planning Division, Administrative Centre, Kingstown;
- (f) Registry, Kingstown.

**SCHEDULE -**

**(Paragraph 3 (1), (2) (d) )**

**ZONED AREA**

(a) **ALL THAT** area bounded -

- EAST:** by Front Street;
- NORTH:** by the Port Elizabeth Jetty and Tourism Information Centre;
- WEST:** by the sea;
- SOUTH:** by access road on footpath leading to the Old Fig Tree and including the footpath and all public lands adjoining the said footpath in a southerly direction proceeding as far as the southern boundary of the property known as "The Crab Hole".

(b) **ALL THAT** public area bounded -

- EAST:** by Front Street;
- NORTH:** by the headland;
- SOUTH:** by the Harbour Centre;
- WEST:** by the Sea."
