## ACT NO.20 OF 1999 I ASSENT

AN ACT to make provisions for the Incorporation of SVG CREATE in the State of Saint Vincent and the Grenadines.

[ 28th December, 1999 ]

BE IT ENACTED by the Queen's Most Excellent Majesty by and with the advice and consent of the House of Assembly of Saint Vincent and the Grenadines and by the authority of the same, as follows:-

This Act may be cited as the SVG CREATE Incorporation Act 1999.

Short title

- NZIMBU BROWNE, SUSAN MURPHY, VONNIE ROUDETTE, MARGARET ROACHE, YVONNE BIBBY, BARTHOLOMEW QUAMMIE, TOPSY TONEY HUGGINS, CAROL PAYNE, JAMAAL ROSE Executive Committee Members and their successors in office, shall be the TRUSTEES and are hereby created a body corporate by the name of SVG CREATE hereinafter referred to as "the GROUP" which shall have perpetual succession and a common seal and power to sue and be sued.
- The said body corporate shall have the power to acquire and dispose or otherwise deal with all movable and immovable property personal or real now or hereafter vested therein and to borrow, raise or secure payment of money in such manner as may be thought fit provided that the body corporate shall be duly constituted for all the purposes of this Act, and empowered to do all things in accordance with this section.

Power to acquire property

On any vacancy occurring in the said body corporate by reason of death, absence from Saint Vincent and the Grenadines or incapacity to act of any of its members, the TRUSTEES may from time to time appoint any suitable person to fill such vacancy and the person so appointed shall

have the same powers as if he had been named a member of Section 2 of this Act.

## Property held for Group

- 5. All property vested or hereafter acquired by the said body corporate shall be held by the said body corporate for the use and benefit of the GROUP.
- 6. All property movable and immovable of whatever kind heretofore bequeathed or devised by will or otherwise given to the GROUP shall be deemed to be vested in the said body corporated.

Savings

7. Nothing in this Act shall affect or be deemed to affect the rights of Her Majesty, Her heirs or Successors or any bodies politic or corporate or any other persons except such as may be mentioned or referred to in this Act and those claiming by, through, from or under them.
