As the Erigae Foundation recognizes the problems that rise in the interaction between ethnic and socially diverse groups as well as with their environments, and that these have been deeply affected by national and international political and economical policies, it has directed its efforts in opening various lines of research in order to offer analysis and solutions that may strengthen their cultural identities and practices. Based on this general objective, the Foundation has defined as its main mission the research of changes that may introduce a balance within the relations between communities and individuals and their environments, from a long duration perspective and an interdisciplinary orientation. As its main strategy it understands research as a tool for development, for dialogue and transfer of knowledge and as a means to mediate in the integration of the public, academic and community spheres. To pursue these main purposes the Foundation has proposed 5 strategic objectives:

- Promote integral processes oriented to the solution of cultural, social and ecological interaction problems, through the formation of students and community members and in joining the community and academic spheres.
- Promote and advance scientific and technological research, especially in the archaeological, architectural, biological, geographical, historical and social areas.
- Provide advice and cooperation in scientific or technological research advanced or promoted by other persons or entities.
- Disseminate and manage knowledge on cultural heritage, in its different aspects, through written publications, databases, audio or visual media, exhibitions and lectures open to the public.
- Provide advice and cooperation for the maintenance, preservation, conservation, management and safeguarding of the intangible and tangible cultural heritage in its archaeological, architectural, ecological, historical and social aspects.

Specifically, the Foundation has developed a framework for working towards the safeguarding of cultural practices and identities and it is expected to contribute with the processes of identification, documentation, research, protection and enhancement of these as intangible heritage. Similarly, the efforts to promote solutions to the abovementioned problems and the scientific and technological research in various areas have been expanded to examine them from the issue of intangible heritage, serving also to support its preservation.

Since 1991, the Eriagaie Foundation has opened several lines of work that involve what is now defined as Intangible Heritage. These lines of work are based on a main strategy: regard research as a tool for development, for dialogue and transfer of knowledge, and as an instrument to mediate between the official, academic and community spheres. Three of Eriagaie's lines of work stand out as directly involved with cultural practices and identities, and the research projects carried out within these lines look forward to their identification, documentation, analysis, protection and enhancement and as a means to strengthen the communities and their confrontation with the problems from the national and international political and economical policies introduced by globalisation.

#### 1. Culture, environment and community development

This line of work was established since 1991 and focuses on traditional communities that consider human beings as part of nature, through cultural signifiers that remind them of their obligations with the environment. However, recent colonization, forced migration, the reduction of natural areas, the weakening of cultural traditions and the introduction of capitalist consumption have had impact on these communities, their practices and their local resources.

Eriagaie has pursued the recovery of native knowledge in favour of environment management, by means of an interdisciplinary and action-participation perspective that has promoted the development of natural resources for the benefit of the communities. This has been done in collaboration with other NGO's such as Tropenbos and Gaia, by which COAMA (the interinstitutional organization created for this purpose) was granted The Right Livelihood Award in 1999, for the work done with indigenous communities of the Amazonian basin.

#### 2. Museums, tourism and general public

Eriagaie considers tourism and museums as a means to enhance those manifestations that communities consider representative of their identities and practices. Eriagaie is interested in analysing how these cultural spaces may generate confronting narratives, and pursues solutions to conflicts related with whom and how their representation are assumed by locals, foreigners, experts or official employees and from diverse political, religious or economic perspectives. Particularly, it looks forward to promote local initiatives of museum and tourism projects that may benefit the communities involved.

Since 2005, the Foundation in association with Terra Firme (another national NGO), and the ministry of culture have supported the creation of several museums and tourist routes with the participation of local official entities as well as with the creation of community NGO's.

#### 3. MIA Cultural Heritage Observatory (MIA: Tangible, Intangible and Archaeological)

This line was created after the 2003 Convention of ICH, with the purpose of monitoring its implementation in Colombia and analysing its impact on the discourse of tangible heritage as well. Two main trends of work arise within this line: critical analysis of public policies and official action plans regarding ICH and the need to establish methodologies and channels of communication that permit an active participation and interaction between official entities, the academic institutions and the communities. In the latter case, one of the main tools that have been developed are the focal working groups composed by representative members of these three spheres, in which each one is intended to generate recommendations and/or solutions for specific subjects of discussion and further action with ICH, such as a conceptual framework and working methodologies for the inventory and elaboration of safeguarding plans, the alternatives for communities in the matter of intellectual property and collective rights, and the impact of cultural tourism in the weakening of cultural identities and practices.

The most recent scenario of discussion and interaction has been the "Seminar and Workshop on ICH: Management, Participation and Action" organized by Eriagae and held in April of 2009. Conceived as a space for theoretical debate, interdisciplinary analysis and working methodologies, this seminar counted with the participation of Colombian and foreign researchers who presented their case studies and perspectives, intertwined with the experience of managers, official employees and members of local organizations in the identification and understanding of problems and challenges faced by them in the formulation of public policies and action plans relating to ICH, its implementation and impact on the local and regional contexts.

#### Eriagae Foundation's personnel directly involved with ICH

Monika Therrien, Anthropologist, Project Director of Eriagae, Director of the Master's program in Cultural Heritage and Territory (Universidad Javeriana), founder of the Observatory and advisor of the ministry of culture. Develops and supervises all the lines of work, as well as the Lab and Communication sections of the Foundation.

Germán Ferro, Anthropologist, Senior Member of Eriagae, Professor of the Master's program in Cultural Heritage and Territory, develops several projects in the Foundation's lines of work 1 and 2 in the Andean region of Colombia.

Carlos del Cairo and Catalina García, Anthropologists, Junior Members of Eriagae, develop the projects of lines 2 and 3 in the Colombian Caribbean coast.

Mónica Hernández, Anthropologist, Junior Member of Eriagae, develops projects in the line 3 in Palenque de San Basilio.

Alvaro Santoyo, Anthropologist, Associate Researcher of Eriagae and the Instituto Colombiano de Antropología, cofounder of the Observatory, develops projects in the lines 1 and 3 in the Colombian Amazonian basin.

11 students and community members that have been enrolled in the Youth Research Program of the Foundation, supported by Colciencias, Colombia's government agency for scientific and technological research.

In general, Eriagae's ample experience has given way for members to act as advisors of the ministry of culture in the development of the legal and normative issues regarding ICH, as well as in the development of inventory strategies and tools used for documenting manifestations and cultural practices. As well, it has offered critical reflections on policies regarding the development and implementation of Safeguarding Plans and the participation of communities in the process. Also, it is a space that looks

forward to activate the involvement of young participants (at present we count with a group of 11 members), from the academic and community spheres as a means to widen the interest in participating and reproducing the enhancement and safeguarding of ICH.

Erigaie's recent activities and the relevant experience in safeguarding intangible cultural heritage

1. Culture, environment and community development

Since 1991 Erigaie has proposed several projects in this line of work in the Amazonian basin and since 2008 new ones have been proposed for other areas of the country. These new research projects have been directed to the Andean region, specifically the Huila area, deeply affected by political struggle and illegal drug trafficking, which have altered traditional knowledge, mainly in peasant communities. An ongoing project funded by Colciencias and in association with the ministry of culture, Los Andes University and the local communities, pursues the study of these peasant communities traditional knowledge of plants (medical, nutritional and symbolic uses) in domestic environments, as a means to promote the revitalization of their cultural practices and a better quality of life.

This same framework has been applied at Bogotá, in association with the Instituto Distrital de Patrimonio Cultural, and at present the acquired knowledge has been enhanced by public lectures and pedagogical tours with local inhabitants.

2. Museum, tourism and general public

Since 2004, an inventory process of the manifestations of the central Andean area of Huila, intensely affected by political violence, has resulted in the awareness of the diverse practices regarding traditional foodways and agricultural knowledge, oral traditions, rituals and festivities, as well as their enhancement by different means, such as web pages, pedagogical routes and communitarian tourism programs.

Since 2005, with the aid of Erigaie and the support of the local government, a museum of funerary ritual practices was created at a central Andean town where corpses are naturally mummified. The community actively participates in exploring the meanings of death, remembrance and permanence of loved ones and with their narratives, donations and communitarian management of the museum enhance their local identity through this singular experience.

Since 2006, in the Colombian Caribbean coast single mothers and fishermen created two local NGO's with the aid of Erigaie and the ministry of culture, in order to preserve the traditional knowledge of their maritime culture. Through the rescue and inventory of different objects associated with their ancient and present cultural practices, in a collaborative research program these members and the researchers from Erigaie have recorded from the local inhabitants the oral histories related to their cultural practices and have materialized their results in an open space maritime culture museum, with the support of Colombia's National Museum.

Also in association with the ministry of culture, the Erigaie Foundation is developing the research and curatorial exhibition of Colombia's representative cultural manifestations to be presented in the year 2011 at the Folklife Festival organized by the Smithsonian Institution in Wash. D.C. For this presentation, the Colombian government has relied on the conceptual framework proposed by the Foundation, The Nature of Colombian Culture: Eco-systems and Intangible Cultural Heritage Routes, based on the importance of the relation of traditional cultural practices and the preservation of the environment.

Colombia's participation will include the traditional foodways, games, handcraft production of objects and musical instruments, body performance (in dance, music, tattooing, customs), and ecological management of the environment of five specific Colombian eco-systems.

### 3. Cultural Heritage Observatory

Since 2006, Eriagae and the Colombian Institute of Anthropology are conducting a research project on the analysis of the elaboration of Palenque de San Basilio's (included in UNESCO's Intangible Heritage list) and of the Nukak Maku's (included in the ICH national list) Safeguarding Plans. Palenque de San Basilio's is an afrodescendant community of little or no recognition in the local and national context, and the identification of a human group known as Nukak Maku, refers to a number of nomadic indigenous groups whose language and forms of settlement are unknown for a large part of the country's population. These circumstances constitute very interesting case studies, as they have retarded the process of elaborating safeguarding plans, due to the different problems that surround them, from political struggles for recognition of Palenque as a black independent community, or the rapid loss of the Nukak cultural practices and identity. As a result, the analysis of cases as those mentioned are oriented to the formulation of recommendations for the ministry of culture in the further implementation of their safeguarding plans

The Eriagae Foundation projects constitute a diverse example of the problems and methodological challenges that the Colombian government and the communities have to confront in the development of ICH policies and actions. The monitoring of these processes by the researchers of Eriagae pursues an adequate adaptation of the Convention and its legal principles to the country's numerous and diverse manifestations and the communities that practice them.

In developing projects for the protection of cultural heritage, the Foundation has supported the creation of local NGOs "ALCAESPO" and "Buceadores de la historia de los cañones (Divers of the history of the cannons)" made up of mothers who are heads of families and groups of fishermen from the island of Tierra Bomba, for the local management of the maritime resources of the island. Through the signing of agreements with these organizations, the Foundation ensures cooperation between the institutional, the local and the academic sectors for the implementation of initiatives for the study, protection and dissemination of the Intangible Cultural Heritage in coastal areas and islands.

The development of joint projects with the Terra Firme NGO, formed by researchers supported by the Eriagae Foundation, has allowed the generation of opportunities for dissemination of the projects related to the Intangible Cultural Heritage at national and

international levels, by young researchers and professionals working in the field.

The development of the Seminar on Intangible Heritage "management, participation and action" held in April, 2009, was conceived as a space for theoretical debate, analysis and work methodologies on the Intangible Cultural Heritage. This is done with the participation of Colombian and foreign researchers who presented their case studies and perspectives from which they have been addressed. Additionally, in four days were presented experiences of managers, public officials and leaders of organizations to identify and understand local contexts and the problems and challenges faced in the formulation of public policies and action plans relating to cultural heritage and its implementation and impact on local and regional authorities.

Through the implementation of valuation and empowerment methodologies of local cultural resources it has been possible to involve communities from some municipalities of the Department of Huila, as watchers and managers of the material and intangible heritage.

The MIA (Material, Intangible and Archaeological) Cultural Heritage Observatory, has been formed as a line of research devoted to the study of the discursive construction of heritage and the production of relevant knowledge to act as a consultative body in the formulation of public policies related to the indicated topic.





## ACTA No. 24

En la ciudad de Bogotá, en la sede de la Fundación Erigaie, Cra. 7 No. 150-01 Ofc. 2, a las 1:00 p.m. del 14 de noviembre del año 2.003, en sesión extraordinaria, se reunió la Junta de la Fundación Erigaie, previa convocatoria efectuada por Luisa Fernanda Herrera, Presidente de la Junta, de conformidad con los estatutos y la ley. El orden del día propuesto fue el siguiente:

1. Verificación del quórum.
  2. Lectura y aprobación del Orden del Día.
  3. Reforma de los Estatutos.
  4. Presentación y elección de nuevos integrantes de la Junta Directiva.
  5. Renuncia del Presidente y miembros de la Junta.
  6. Elección del Presidente y miembros de la Junta.
  7. Elección del Representante Legal Suplente.
  8. Aprobación del Acta de la reunión.

1. **Verificación del Quórum:** El quórum se verifica con el siguiente resultado: 3 miembros hábiles asistentes y uno ausente, para un total de 4 miembros (75%), del total de la Fundación Erigaie. Habiendo quórum deliberatorio, la Presidente, Sra. Luisa Fernanda Herrera, declara abierta la Junta extraordinaria.
  2. **Lectura y aprobación del Orden del Día:** Se da lectura al Orden del día, el cual se aprueba sin modificaciones.
  3. **Reforma de los Estatutos:** Se propone reformar el artículo 2 del Título I, el cual fue aprobado por unanimidad. A continuación se da lectura al nuevo texto de los Estatutos, así :

### FUNDACION ERIGAIE ESTATUTOS TITULO I

#### *Denominación, Domicilio y Objeto*

**Artículo 1o.** Con el nombre de FUNDACION ERIGAIE se instituye una universalidad de bienes, sin ánimo de lucro, de duración indefinida y con domicilio en Bogotá.

**Artículo 2º.** La Fundación tendrá como objeto:

- a) Contribuir a la solución de los problemas del entorno cultural, social y ecológico del país, mediante el impulso a procesos de formación integral en el ámbito estudiantil, académico y comunitario.
- b) Promover y adelantar investigaciones científicas y tecnológicas, especialmente en las áreas arqueológica, arquitectónica, biológica, geográfica, histórica y social.
- c) Prestar asesoría y cooperación en investigaciones científicas o tecnológicas adelantadas o promovidas por otras personas o entidades.
- d) Divulgar y administrar el conocimiento sobre el patrimonio cultural, en sus aspectos arqueológico, arquitectónico, ecológico, histórico y social, mediante publicaciones escritas, bases de datos, medios visuales o auditivos, exposiciones y conferencias abiertas al público.
- e) Prestar asesoría y cooperación para el mantenimiento, conservación, restauración, consolidación, administración y custodia del patrimonio cultural en sus aspectos arqueológico, arquitectónico, ecológico y natural, histórico y social.

## TITULO II

### *Capacidad y Patrimonio*

**Artículo 3º.** La FUNDACION tendrá capacidad para adquirir derechos y contraer obligaciones y podrá celebrar toda clase de contratos directamente subordinados al cumplimiento de su objeto, con arreglo a las disposiciones legales vigentes.

**Artículo 4º.** Serán bienes de la FUNDACION: a) el aporte entregado por los fundadores; b) los frutos de sus bienes o de la prestación de sus servicios; c) las donaciones inter vivos; d) las asignaciones testamentarias que se le otorguen y acepte, y e) auxilios provenientes de entidades públicas y privadas, nacionales o extranjeras.

## TITULO III

### *Administración*

**Artículo 5º.** Son órganos de esta FUNDACION:

- a) La Junta
- b) El Comité, Científico
- c) Revisor Fiscal

**Artículo 6º.** La FUNDACION será administrada por una Junta, inicialmente integrada por los fundadores.

En caso de ausencia temporal, cada integrante de la Junta designará un suplente, designación que será aprobada por la Junta. En caso de fallecimiento,

incapacidad legal, ausencia definitiva o renuncia de un integrante, la Junta podrá nombrar un nuevo miembro.

**Artículo 7º.** El número de personas que integran la Junta podrá aumentarse en la medida de sus necesidades, y serán aceptados por unanimidad de los integrantes de la Junta, entre los candidatos que sean presentados para su consideración.

**Artículo 8º.** La Junta se reunirá en Bogotá, en el sitio y la fecha indicados por cualquiera de los integrantes que efectúe la convocatoria. La Junta, por común acuerdo de todos los miembros, podrá reunirse fuera de Bogotá.

**Artículo 9º.** Constituirá quórum para deliberar, la presencia de la mitad más uno de los integrantes de la Junta.

**Artículo 10º.** Las decisiones de la Junta se adoptarán por unanimidad de votos de sus integrantes, y en ausencia de alguno de los miembros, y de su suplente, se adoptarán por unanimidad de los asistentes.

**Artículo 11º.** La Junta será presidida por quien ella designe en cada sesión. De los acuerdos, decisiones, votaciones y demás actos de la Junta, así como del resumen de las deliberaciones, la lista de asistentes, la forma de convocatoria y el respectivo orden del día, se dejará testimonio en acta que deberá firmar el Presidente, y el secretario de la sesión, una vez aprobada. Las actas se asentaran en orden cronológico en libro foliado, rubricado por el respectivo Secretario de la Junta.

**Artículo 12º.** Son funciones de la Junta:

- a) Velar por el cumplimiento de los fines de la FUNDACION, estableciendo su política general.
- b) Decidir sobre los asuntos puestos a su consideración.
- c) Dirigir su administración, vigilar sus bienes, contabilidad y correspondencia, y cumplir y hacer cumplir los estatutos y reglamentos.
- d) Dictar resoluciones y cualesquiera otros reglamentos internos.
- e) aprobar el ingreso al Comité Científico de las personas que lo soliciten o le sean propuestas, y decidir sobre el retiro de los integrantes del Comité ya sea por solicitud de los mismos, o por determinación de la Junta.
- f) Aprobar el ingreso a la Junta de las personas que lo soliciten o le sean propuestas.
- g) Delegar la representación de la FUNDACION en personas extrañas a la Junta.

h) Reformar los Estatutos sin contrariar la esencia o características propias de la FUNDACION.

i) La Junta podrá contar con un grupo de asesores, quienes tendrán prioridad para labores de consultorías u otras que la Junta considere convenientes.

**Artículo 13º. Representación Legal**

La Fundación será representada por cualesquiera dos miembros de la junta, quienes deberán actuar conjuntamente y sin limitación alguna.

Esta representación podrá ser delegada en otra persona escogida de común acuerdo por la Junta, quien actuará como Representante Legal Suplente en los casos de ausencia permanente o temporal del principal

**Artículo 14º. Funciones del Comité Científico:**

a) Evaluar los proyectos y resultados de investigaciones puestas a su consideración por la Junta.

b) Someter a consideración de la Junta nuevos campos de acción en las áreas de interés para la FUNDACION.

c) Sugerir la asesoría de personas extrañas a la FUNDACION.

**TITULO IV**

***Disposiciones Varias***

**Artículo 15º.** La contabilidad será llevada conforme a la ley, en libros debidamente registrados.

**Artículo 16º.** La FUNDACION tendrá un revisor fiscal quien durará en el cargo por periodo de un (1) año, podrá ser reelegido indefinidamente y removido en cualquier tiempo.

**Artículo 17º. Son funciones del Revisor Fiscal:**

a) Examinar todas las operaciones, inventarios, balances, actas, libros, correspondencia, comprobantes, y en general, las cuentas de la FUNDACION.

b) Efectuar el arqueo de caja.

c) Efectuar la comprobación de todos los valores y los que la FUNDACION tuviere en custodia.

d) Autorizar con su firma, si los encuentra conformes, los balances de la FUNDACION.

- e) Cerciorarse de que las operaciones que se ejecuten por cuenta de la FUNDACION están conformes con los estatutos, las decisiones de la Junta y las disposiciones legales.
- f) Dar a la Junta cuenta oportuna de las irregularidades que observe en los actos de la FUNDACION; y
- g) Las demás que, si fueren compatibles con las indicadas antes, le señale la Junta.

## TITULO V

### *Terminación y Liquidación*

Artículo 18º. La FUNDACION terminará por cualquier causa que hiciere imposible el cumplimiento de sus fines, a juicio unánime de la Junta.

Artículo 19º. Llegado el caso de disolución, se procederá a la liquidación y adjudicación del patrimonio, de acuerdo con la ley. Harán la liquidación la persona o personas a quienes la Junta designe.

Artículo 20º. Durante todo el periodo de liquidación funcionará la Junta, y ejercerá á todas las funciones compatibles con el estado de liquidación, especialmente las de nombrar y remover libremente al liquidador o liquidadores y contratar con ellos el precio de sus servicios, si fuere el caso.

Artículo 21º. La Junta exigirá la cuenta de su administración a los liquidadores o a cualquier persona que hubiere manejado o manejare intereses de la FUNDACION. Examinará también el desempeño de las labores del fiscal. A la Junta corresponde examinar toda cuenta relativa a la liquidación, glosarla, fenercerla, exigir eventuales responsabilidades judiciales por medio de apoderados, y resolver cuándo se liquida, en definitiva, la FUNDACION.




Turbay y Emilio Ferrero presentan su renuncia a la Junta de la FUNDACION ERIGAIE.



8. Aprobación del Acta de la reunión: La Junta aprobó por unanimidad la presente Acta.




