

DECREE by which several legal provisions are amended.

Published in the Official Gazette of the Federation on January 23rd, 1998

SOLE ARTICLE.- Articles 20 and 32, section I are hereby amended and section I BIS of article 47 of the Mexican Foreign Service Law is added; articles 4, section I, 117, 161, first paragraph and 173, second paragraph are hereby amended and article 148 BIS is added to the chapter titled "On Recruitment", as well as a section F) to section II of article 170 of the Law of the Mexican Army and Air Force; article 57 is hereby amended and a section E) is added to section I in article 105 of the Law of the Mexican Navy; article 4, section I of the Military Justice Code is hereby amended, article 5 BIS is added to the Law of the Military Service; articles 106 and 108 of the Law of the Federation's Judiciary Power are hereby amended; 4, first paragraph of the Law of the Federation's Fiscal Tribunal; 9, section I of the Law for the Treatment of Common Delinquent Minors in the Federal District and in all of the Republic on Federal Matters; 20, section a), 22 and 23 in both their sections I of the Law of the Republic's General Attorney's Office; 19, 34 and 35 in their sections I of the Law of the General Justice Bureau for the Federal District; 76, 91, 103, 114 and 120 in their sections a) of the Electoral Institutions and Procedures Federal code; 22 and 50 in their corresponding first paragraph of the Navigation Law; 7, first paragraph and a second paragraph is added, articles 38 and 40, first paragraph of the Civil Aviation Law are hereby amended; 189, 216 and 612, section I of the Federal Labor Law; 267 of the Social Security Law; 156, section I and 166 second paragraph of the Law of the Institute for State Workers' Social Security and Services; 28, first paragraph, 50 section IV and section III of article 51 of the Law of the Social Security Institute for the Mexican Armed Forces is hereby derogated; articles 21, section I of the State Agencies Federal Law, 51 of the Regulatory Law of the Constitution's Article 27 dealing with nuclear matter are hereby amended; 9, section I of the Human Rights National Commission Law; 8, section I of the Federal Law for Public Brokerage; **6, second paragraph of the Law of the National Institute for Anthropology and History**; 32, sections I to III of the Foreign Investment Law; 14, section I, of the General Law establishing the Coordination Tenets for the National Public Security System; 5th., section I of the Law of the Energy Regulating Commission; 10, section I and 14, section I of the Law for the Savings System towards Retirement; 12, section I of the Law for Agrarian Courts; 39, section I of the Law of the Bank of Mexico; 26, section I, of the Economic Competence Federal Act; 121, section I of the State Workers' Federal Law, Regulating Section "B" of the Constitution's Article 123; and 15, section I and last paragraph of the Law of the National Banking and Securities Commission, to read as follows:

TRANSITORY ARTICLE

SOLE.- This Decree shall enter into force on March 20th, 1998.
