LORS DE LA 63^E REUNION DU BUREAU DU
CONSEIL INTERGOUVERNEMENTAL DU PROGRAMME INTERNATIONAL
POUR LE DEVELOPPEMENT DE LA COMMUNICATION (PIDC)**

Décision concernant la visibilité et la levée de fonds pour les projets

Le Bureau, ayant discuté des documents, décide de :

- Continuer à plaider activement auprès des gouvernements, du secteur privé et de la société civile pour financer le PIDC selon l'une de ses modalités établies: compte spécial du PIDC (contributions volontaires ou contributions à des projets spécifiques), fond-en-dépôt, contributions symboliques et/ou détachement de personnel. Et de demander au Secrétariat de développer une stratégie afin d'approcher le secteur privé et la société civile, conformément à la stratégie de levée de fonds de l'UNESCO.
- Demander au Secrétariat d'inclure un point permanent à l'ordre du jour dans les réunions statutaires afin que les membres du Conseil envisagent de rendre compte de leurs efforts pour collecter des fonds pour le PIDC et de toute autre bonne pratique visant à accroître la visibilité du programme au niveau national.

Décision quant à la préparation de la 32^e réunion du Conseil du PIDC

a) Gouvernance et méthodes de travail du PIDC.

Le Bureau, ayant considéré le besoin pour une meilleure préparation pour la 32^e réunion du Conseil ;

1. Rappelant le document CI-18/COUNCIL-31/8 REV et ses annexes qui incluaient des recommandations de la 62^e réunion du Bureau du PIDC à la 31^e session du Conseil du PIDC pour considération et adoption ;
2. Prend note que le 31^e Conseil du PIDC n'a pas prit de décisions concernant le point de l'ordre du jour 13 « Suivi des recommandations sur la gouvernance, les procédures et les méthodes de travail ;
3. Prend également note avec satisfaction du travail positif qui a été accompli par la Présidente du PIDC, les membres du Conseil du PIDC et par le Secrétariat, ce qui a permis la mise en œuvre de certaines recommandations pour le Conseil et le Bureau du PIDC ;
4. Prend également note de la proposition introduite par le GRULAC afin d'amender les Statuts et règles de procédure du PIDC ;
5. Encourage davantage d'efforts afin de mettre en œuvre les recommandations de gouvernances pertinentes, en lien avec les décisions de la 39^e Conférence générale sur la gouvernance, ses procédures et méthodes, et invite tous les membres du Conseil du PIDC à s'engager dans des consultations informelles ouvertes et transparentes au sujet de la proposition introduite par le GRULAC, pour sa finalisation et présentations lors de la 32^e session du Conseil du PIDC en 2020.
