- 5. The chairperson informed that, as per habitual practice, the distribution of seats and candidates among Group V(a) and Group V(b) will be provided in the next revised list of candidates (document 39 C/NOM/INF.1): Group V(a) 8 vacant seats; and Group V(b) 3 vacant seats.
- 6. Concerning agenda **items 14.2 to 14.16 Elections** Headquarters Committee, Legal Committee, and other **subsidiary organs of the General Conference**, examination and accurate follow-up by Member States of the status of candidatures, contained in document 40 C/NOM/INF.2 (status as of Tuesday 12 November 2019 at 10 a.m.) were held.

The Chairperson reminded the delegates that the ballot will be held on Thursday 21 November 2019, from 10 a.m. to 1 p.m. in Room IV, during the 6th meeting of Nominations Committee, and the expiration of admissibility of candidatures for this election was at 10 a.m. on Tuesday 19 November 2019.
