The Chairperson reminded the delegates that the election of Members of the Executive Board would take place on Wednesday, 20 November 2019 from 9 a.m. to 1 p.m. in Room V and that the expiration of admissibility of candidatures for this election was at 9:00 a.m. on Monday 18 November 2019 (according to the Rules of Procedure of the General Conference, Appendix 2, Rule 4).</li> <li>It was noted that document 40 C/NOM/INF.1 contains an updated provisional list of candidates which has been communicated to the Secretariat by 14 November at 10 a.m. This document details the list of countries as candidates of Group V(a) and Group V(b) and the number of seats for these two groups.
