The Convention on the Protection and Promotion of the Diversity of Cultural Expressions of UNESCO, was ratified by Mexico on July 5, 2006. This Quadrennial Report on mediated efforts to protect and promote the diversity of cultural expressions, including the actions taken by the different areas and programs of the Directorate General of Popular Culture National of Council for Culture and the Arts, and by the institutes comprising the National Movement for Cultural Diversity of Mexico, and two civil society organizations: Writers in Indigenous Languages and U40 International Program "Cultural Diversity 2030".

In Mexico, the coordination of cultural policies should be promoted and is implemented since 1988, date of creation, by the National Council for Culture and the Arts (CONACULTA). Together with the Council, the National Institute of Fine Arts and the National Institute of Anthropology and History maintains a leading role in the protection, promotion and preservation of heritage and research and cultural education.

Through the National Program for Culture 2007-2012, recognizes the responsibility of the State in the preservation of archaeological heritage, historical, artistic, immaterial (traditions, festivities, food, rituals, languages, music, craftsmanship, knowledge and practices concerning nature and the universe) in art education in the stimulus to the creation and promotion of arts and culture.

The actions taken to protect and promote expressions of cultural diversity, prior to the creation of the Convention, placed Mexico as one of the countries with the richness of its cultural diversity, promotes, disseminates, encourages and safeguards, the main expressions of their cultural heritage in each of the peoples cultural regions and sectors of Mexican society. This strengthens the local identity, regional, state and national population.

Making a diachronic in the implementation of cultural policies that stimulate and promote the cultural diversity of the country, with full respect for their cultural expressions and manifestations, its forms of organization, worldview and self-management, it is recognized that efforts are still limited, that resources are scarce at the extent and richness of cultural potential of the popular sectors, indigenous and diverse sectors of the national society.

Facing the future tasks in pursuit of a Mexican society that promotes respect and intercultural dialogue, remains in effect the vision of the Department of Popular Culture: a country of cultural relations based on dialogue, the value of the diversity of their communities and the strengthening of their cultural heritage, a country that recognizes and fully respects the cultural and ethnic differences of its members. A country that works for discrimination disappears.

#### a) What are the main objective(s) of policy or measure? When was it introduced?

In Mexico, the coordination of cultural policies should be promoted and is implemented since 1988, date of creation, by the National Council for Culture and the Arts (CONACULTA). Thus, from the last decade of the twentieth century, the work and direction of cultural policy of the country have been defined by the Mexican government, through CONACULTA. In this period of country life, awareness of nature and the profound significance of national cultural heritage, the value and role of intellectual and artistic creation, has been led by artists, artists, intellectuals, institutions and civil society. The work of CONACULTA was then the point of convergence and coordination of efforts from various institutional and social fields to promote the cultural development of the Mexican nation, whose composition is multicultural and diverse. Together with the Council, the National Institute of Fine Arts and the National Institute of Anthropology and History continue to have a role in the protection, promotion and preservation of heritage and research and cultural education.

The National Program for Culture 2007-2012, is the product of a broad process of reflection within the National Council for Culture and the Arts and coordinating bodies, held in May 2007 with the artistic communities, intellectuals, academics, members of civil society and promoters of culture who participated in an open dialogue with the ministries, institutions and culture of state boards of all states. Through the National Program for Culture 2007-2012, recognizes the responsibility of the State in the preservation of archaeological heritage, historical, artistic, immaterial (traditions, festivities, food, rituals, languages, music, craftsmanship, knowledge and practices concerning nature and the universe) in art education in the stimulus to the creation and promotion of arts and culture. Cultural policy instrumented in recent years has focused on contributing to the understanding of the cultural industries and the production and promotion of arts and culture offer conditions and potentials for economic development of municipalities, states and regions of the country as a whole.

The overall objectives of the National Culture are:

- 1. Promote equal access and enjoyment of culture.
- 2. Provide spaces, cultural goods and services of quality.
- 3. Encourage expressions of cultural diversity as a basis for union and social coexistence.
- 4. Expand the contribution or development of culture and social welfare.
- 5. Promote an action cultural participation and national responsibility.

The axes of the cultural policy defined by the program are:

- 1. Heritage and Cultural Diversity
- 2. Cultural infrastructure
- 3. National and international cultural promotion

#### b) How has it been implemented?

The Directorate General of Popular Culture (DGCP) of National Council for Culture and the Arts, along with other institutions, participates in the following Areas of cultural policy:

- 1. Heritage and Cultural Diversity
- 3. National and international cultural promotion
- 4. Public incentives for the creation and sponsorship
- 5. Training and research in anthropology, history, culture and art.

It aims to promote the preservation and dissemination of popular demonstrations, urban, rural and indigenous communities. Its mission is to contribute to the creation of social and institutional conditions that facilitate intercultural dialogue respectful and harmonious, which expresses all the richness and cultural diversity of our country. The vision that underlies his work is of a country of cultural relations based on dialogue, the value of the diversity of their communities and the strengthening of their cultural heritage, a country that recognizes and fully respects the cultural and ethnic differences of its members. A country that works for discrimination disappears.

The DGCP has over 30 years of promoting the study, preservation, dissemination and development of popular and indigenous cultures of Mexico, through design, implementation and development of several programs. The Languages and Indigenous Literature Program promoted the strengthening of Indigenous languages of the peoples and the revaluation of indigenous literature. The National Gastronomy Program, the recovery of traditional knowledge of indigenous cuisine and urban and rural communities, and the National Folk Music Program, the appreciation of traditional music. Currently, promotes the following programs:

The Folk Art Program through the Project to Strengthen Cultural Heritage at Risk, developed registration procedures and safeguards with creators, cultural players and carriers. Make an inventory of the traditional skills of artisans and folk artists, supporting since 2001, over 100 artisan groups through annual fairs and exhibitions.

Comprehensive Development Program of the Cultures of Indigenous Peoples and Communities (PRODICI), designed to strengthen traditional artistic creation of indigenous peoples. These have been aimed at identifying expressions at risk, disseminate literary traditions in different languages, systematize the aesthetic visions and artistic heritage to revitalize the community.

The Regional Cultural Development Programs (Huasteca, Isthmus, Maya, Sotavento, Tierra Caliente and Yoreme), have focused on strengthening traditional cultures, including music and various expressions of dance and dance of our people.

The Program of Support for Municipal and Community Cultures (PACMYC), from 1989, through an annual call nationwide, provides resources for projects of their own culture, in coordination with the State Institute of Culture. By funding projects that support people in the communities in which they operate, the PAMCYC helps protect and promote the diversity of cultural expressions, while stimulating respect and appreciation for cultural diversity nationally.

Regional Units, State and Popular Culture Offices in coordination with the State Culture instances, instrumented Development Programs created by the DGCP to implement the axes of the country's cultural policy for that country.

Regional Units are strategically located in major centers of cultural development and cultural areas, which cover areas where they settle the main indigenous people of the country, in establishing the relationships between them, the "mestizo" population and society in general.

The staff of the Regional Units is comprised of developers, researchers and experts in the fields of cultural heritage, tangible and intangible, which perform their work in managing and promoting the diverse cultural expressions of communities and cultural regions of the country, which strengthens their identity. Some of the celebrations that promote regional units annually between the communities are: Diversity Day, International Day of Indigenous Peoples, Day of the Dead, Day International Mother Language, Day International Women, among others.

a) What are the main objective(s) of policy or measure? When was it introduced?				
The Directorate General of Popular Culture in the context of interagency coordination began in 2001 with other federal institutions, designed, promoted and executed a National Campaign for Cultural Diversity of Mexico from 2005, on the occasion of World Day for				

Cultural Diversity for Dialogue and Development. The campaign was in effect until 2009, after which, the institutions that promoted it, formed the National Movement for Cultural Diversity in Mexico (2010 to date).

The objective of the Movement is: To ensure that Mexican society recognizes and values the cultural diversity that characterizes each of the individuals, communities and peoples that make up our country, promoting intercultural dialogue as a basis for addressing discrimination, marginalization, exclusion and social inequalities.

#### b) How has it been implemented?

Consistent with the National Development Plan 2007-2012, the Movement acting on behalf of freedom and human dignity and recognizes and respects pluralism, committing the government of the Republic to pay special attention to policies that affect the fields justice, health, education and cultural development, to consider spaces of action central to the vitality of society.

#### c) What challenges have been identified in the implementation of this measure?

The institutions and agencies involved in the Movement publicly commit to work in carrying out actions that seek to bring to the table of national debate issues that mean risks to cultural diversity (the homogenization of cultures, environmental issues and the violation of individual rights and collective).

In addition to activities to protect and promote the diversity of cultural expressions which together make the institutions of the Movement for Cultural Diversity, each of them has made the following substantive.

General Coordination of Intercultural and Bilingual Education (CGEIB)

Produce and distribute educational materials is one of the strategies through which the General Coordination of Intercultural and Bilingual Education (CGEIB) of the Secretariat of Public Education (SEP) is promoting the intercultural approach to education in the national education system and the society in general. The publication of books and teaching materials bilingual (Spanish-national indigenous language) contributes to the preservation and revitalization of the national indigenous languages and cultures of these peoples. These materials are distributed free to teachers, school sites, libraries, cultural centers, and support the visibility and reevaluation of the contributions of these peoples to national and world culture.

Center for Research and Higher Studies in Social Anthropology (CIESAS)

The work of CIESAS on the issue of diversity of cultural expressions, is condensed in conducting research projects (completed or in progress), publication of articles and other products as well as participation in events as an organizer or co- organizer. The products generated by CIESAS in this period are: the publication of 3 books, the preparation of 20 articles or chapters in books, participation in 10 national and 2 international events, 2 collaborative programs, and research projects completed 4 and 3 current projects, as well as

organizing 11 events in coordination with other academic and research institutions.

National Commission for the Development of Indigenous Peoples (CDI)

Program Promotion and Development of Indigenous Cultures (PROFODECI) was created in 2004, and rescues the positive experiences of work achieved by the Fund for Indigenous Culture (1991-2003). Its objective: To contribute and promote the cultural processes that affect creativity, empowerment and cultural preservation of indigenous peoples and communities, based on the recognition and respect for cultural diversity, equity and responsibility, and in the needs and situation framed in contemporary society.

National Council to Prevent Discrimination (CONAPRED)

It is the agency responsible for monitoring compliance with Federal Law to Prevent and Eliminate Discrimination (LFPED), which prohibits discriminatory practices. The Constitution of the United Mexican States in 2001 reformed its first article to prohibit all forms of discrimination that is intended to nullify or impair the rights and freedoms of individuals. Following the reform in 2003 created the Federal Law to Prevent and Eliminate Discrimination, which states that discrimination also prevent the exercise of rights, gate access to opportunities. This law includes the obligation of the State to implement and promote compensatory measures to achieve equal opportunities for all people. So far, 17 state agencies have gradually created local anti-discrimination laws.

Attorney General of the DF (PGJDF)

In Mexico, Mexico City is the first city, in collaboration with civil society organizations, academic institutions and specialized human rights organizations, realizes his plan of action. The Human Rights Program of the Federal District (PDHDF), is created with the ambition of becoming an issuer of lines of actions that seek to transform public policies that hinder the enjoyment of human rights and to consolidate good practice. The commitments relate to the Attorney General of the Federal District are mainly on the rights of access to justice, to due process, the integrity, liberty and security of person.

National Pedagogic University (UPN)

The UPN has a population of about 300 Indian students, most of them studying for a Bachelor of Indian Education (LEI). Students LEI in the various activities organized annually for the university community more visible in their languages and cultures, as the day of the mother tongue, the day of cultural diversity and the celebration of Day of the Dead. Also, to promote activities to attend a different gender of inclusive perspectives.

The UPN has consistently promoted the presentation of different cultural and linguistic expressions of indigenous peoples in forums, events and spaces for the university community recognizes, values and enjoyment of cultural and linguistic diversity, with broad participation of indigenous students.

University Program Mexico Multicultural Nation-(PUMC / UNAM)

The PUMC / UNAM was established on December 2, 2004, as an agency of the Coordination of Humanities, National Autonomous University of Mexico, for research and higher education, dissemination and inter-cultural management and specializes in issues relating to cultural diversity, multiculturalism, interculturalism and its heritage in contemporary societies.

#### a) What are the main objective(s) of policy or measure? When was it introduced?

The National Council for Culture and Arts with the Directorate General of International Affairs, which in coordination with the Ministry of Education and the Ministry of Foreign Affairs, promote the implementation of agreements and cooperation agreements with other countries in the field Education, Culture and Sport. Through meetings of joint committees are reviewed regularly these cooperation agreements, their results and set new work commitments, involving all federal and institutional bodies associated with the actions of cooperation in education, culture and sports. In recent years, issues of cultural heritage, tangible and intangible, and the various expressions of art and culture, have established joint arrangements for collaboration between cultural agencies from Mexico and other countries that have strengthened the bonds of friendship and cultural cooperation between them.

Writers in Indigenous Languages, was established as Civil Association in the city of Texcoco, on November 26, 1993, Land of the Nahuatl poet and ruler Nezahualcoyotl. Its objectives are:

- Promote the development and diffusion of the literature or contemporary to tongues and in Spanish of Mexico.
- Articulate the different experiences (personal, community and institutional) that contribute to the development and flourishing of languages indigenous of Mexico, as to the recording of knowledge and expertise of our people.
- Encourage participation of Language Writers Indigenous in local, regional, national and international.

The languages are represented in the Association are: Campeche: Maya, Chiapas: Chol, Mocho, Tojolabal, Tzeltal, Tsotsil, Zoque, Federal District: Nahuatl, State of Mexico: Hñähñu (Otomi), Mazahua, Nahuatl, Guerrero: Me'pha (Tlapaneca), Nahuatl, San Luis Potosi: Tének (Huasteca), Tabasco: Yok'ot'an (Chontal of Tabasco), Sonora: Yoreme (May), Veracruz: Popoluca, Nahuatl and Yucatan Maya.

During the period from 1997 to 2011 were designed and conducted various activities, both inside the country and internationally. Among the activities carried out actions in different areas include: EDITORIAL. The collection has been formed: voices of ancient roots, editing 10 bilingual books and the quarterly Edition of the magazine Nuni/grains of corn which reached number 16 in 2008, they released five bilingual books for children of the collection: the colors of the corn.

DISSEMINATION. The Continental indigenous literature prize was instituted: song of America (1998), in collaboration with UNESCO and the Secretariat of public education (SEP). In that year the Association awarded the first continental Prize, the second prize has been supported by FONCA and delivered in February 2009, the third surrendered in August, 2010. With the support of the Ministry of Foreign Affairs, the Germany Expo-Hannover, was carried out in the year 2000 with a sample on the cultural and linguistic diversity of Mexico. The series of the Recital were organized: Fiesta de la Palabra, singing in various forums of the city of Mexico and diversity in the interior of the country. From March to December of 2011, in order to disseminate indigenous languages Mexican develops the project: communication in Indian languages in Radio FM-UAM.

The results of the institutional action of the National Council for Culture and the Arts, through the Directorate General of Popular Culture are:

National Program of Food, a repeat of the Kitchen Collection indigenous and popular in Mexico, with 54 titles and a collection of Ancient Mexican cuisine Recipe of the XVIII, XIX and XX, 13 volumes.

Popular Art Program, the publication of 4 books Collections: Textile Art Nahua (23 textiles), The tenangos. Myths and Rites Embroidery (12 textiles), Geometries of Imagination. Design and Iconography of Mexico, with 11 titles published and Cultural Heritage Images of Mexico, which in the first three issues were central theme of the Feast Day of the Dead. The first issue of Altars and offerings of the Day of the Dead in Mexico attended by 300 photographers, 25 states of the country and received 1.247 pictures. With that title, was published a sample of the material received. The second issue (2010) was market places for the Day of the Dead, 273 photographers from 21 participating institutions with a total of 723 photographs. The publication is in press. For 2011, the third issue closes the matter: Music and Dance for the Dead. Included 116 contestants, the publication are being edited.

Comprehensive Development Program of the Cultures of Indigenous Peoples and Communities (PRODICI) Nezahualcóyotl Prize for Literature in Mexican Languages, awarded biennially for an economic stimulus and the publication of the winning. So far, 13 have won the prize writers of 7 peoples. The edition of the collection of Nezahualcóyotl Prize winning works has so far with 7 titles. The PRODICI has funded since 2005, 567 development projects in indigenous cultures.

Regional Cultural Development Programs (Huasteca, Isthmus, Maya, Sotavento, Tierra Caliente and Yoreme), conducting more than 100 training workshops in traditional music, 22 Cultural Festivals, the publication of 38 books, the edition of 12 videos, 46 phonograms and the publication of 8 themed magazines. All these programs from various fields, promote the development of the cultural manifestations of the popular artists that strengthens the identity of the different cultural regions of the country.

In the course of 22 years, the Program of Support for Municipal and Community Cultures (PACMYC), funded cultural projects around 23.800, of which over 50% comes from the various peoples of the country. In the period 2008-2011, the PACMYC funded projects around 5.800. Projects supported include more than 45 themes, as a manifestation of the cultural diversity of Mexico. Half of the supported projects focus on three themes: the musical expressions dance and crafts. Of all the projects funded in the period, in 42% of cases the groups were headed by women and half of the projects involve the participation of indigenous people. See Annex 1.

The activities promoted by the national movement for the Cultural diversity of Mexico from 2007 to 2011, are as follows:

Academic: Cycle of panel discussion: challenges for the protection and promotion of cultural diversity. I and II Forum for the promotion of the Cultural, educational and linguistic diversity. Awareness-raising program in health (workshops). Course on "Attention to diversity in government institutions" (2 pilot courses were implemented in August 2009).

Cultural: Five days by the Cultural diversity of Mexico to commemorate the 21 may world day for Cultural diversity for dialogue and development (with official and cultural Act of 2007 to 2011). Finals for the right to Cultural diversity in the villages of Tlalpan.

Have also been cured same photographic exhibitions have been presented in public open spaces as cultural showcases Metro Public Transport System and public squares, which have helped to make visible the cultural diversity that is expressed in the classrooms of our country. The objective of the implementation of this outreach program is to promote knowledge, recognition and appreciation of cultural diversity of Mexico.

National Commission for the Development of Indigenous Peoples (CDI)

Through the Development and Promotion Program of Indigenous Cultures (PROFODEC) were established and applied 24 Differentiated Service Model (MAD), allowing to efficiently respond to the problems and proposed cultural characteristics of indigenous peoples in 26 states.

From 2008 to 2011 the program served \$ 159.11 million pesos. The resources provided were intended to support the implementation of cultural projects 2.838, benefiting themselves as many cultural organizations supported by their community assemblies, which are regarded as the highest body for making decisions of indigenous peoples and communities, thereby strengthening the internal organization of localities 2.727 1.316 indigenous municipalities in 26 states in the country. With the above is supported directly to indigenous 52.245, 33.229 and 19.016 men women.

These actions produced the following results: Support for cultural projects in the following areas: 1,168 Indian music, Indian dance 695, 511 ceremonial tradition, 174 rescue and innovative craftsmanship, 84 cultural and community history 38 literacy and orality, 37 traditional medicine, 24 sacred places and historical sites, 23 rescue and innovation of traditional techniques for the use and exploitation of natural resources, 21 musical composition and performance, visual arts 15, 14 rescue Indian cuisine, 12 indigenous community museums, 10 of Indian theater, 7 games and traditional toys, 3 research and registration forms of community organization and 2 of literature (stories, essays, novels, poetry). Thereby achieving empowerment, recovery and preservation of cultural manifestations 2.838 48 indigenous peoples, as part of their identity, world view and historical development, with strict adherence to their forms of internal organization and community in 26 states.

Additionally, it promoted the education, training and cultural work of 100 cultural promoters in indigenous regions of 18 states in the country with the aim of fostering and promoting the development of indigenous cultures and regional community, with full respect for the forms of organization and customs of the indigenous population (s) region (s) Indian (s) entrusted (s), whose languages and cultural events are in danger of extinction. Among the functions of cultural promoters stand out: the rise of cultural diagnostics through community participatory processes, diffusion and promotion of indigenous culture, Traditional Indigenous training organizations for the development of cultural projects that respond to cultural needs felt by the indigenous population.

The reflection of the result reached by the cultural promoters enabled in 2011, is the attention to 524 locations, which resulted in 326 completed cultural diagnoses, representing a 60.3% efficiency at work. In the period 2008 - 2011, were carried out 7 National Intercultural Encounters Indians: in the states of Puebla, Nayarit, Oaxaca, Mexico State, Hidalgo and Chiapas, which were subject to disseminating and promoting the rich heritage of indigenous peoples of 21 states contributing to the construction of intercultural relations between the indigenous population and the larger society.

Through the Indigenous Culture Radio Broadcasting System (SRCI), the Commission transmitted in 33 Indian languages besides Spanish, thereby encourages the preservation of indigenous languages. During the 2007-2011 period were transmitted 440.126 hours, in 1.695 municipalities under coverage in 15 states and indigenous potential population of 5, 535.876. By SRCI 316 campaigns were promoted in health, education, comprehensive development and indigenous rights, among others. There were 1.170 news Here we are, and 1.310 special programs such as information and music was the People's Voices Series, the Red gender Mira leaned on the production of capsules

for IMSS-Oportunidades, Agrarian, Ministry of Education National Institute for Adult Education, Federal Electoral Institute, Attorney General's Office, Interior Ministry and the National Forestry Commission, among others. From 2007 to 2011, averaged approximately 268.472 hours of broadcast in 31 languages and 171.649 hours under coverage in Spanish.

Number of internet radio stations: 19 stations of SRCI transmit their full program online, on the microsite "Indian Echoes" page of the IDC, www.cdi.gob.mx

Number of community radio stations: The 20 stations of the indigenous culture radio system operated by Indians, in the strict sense are public radio stations serving the communities and indigenous peoples.

Books: Number of titles published between 2007 and 2011: 59. 18 titles of Indigenous Peoples of Mexico, 6, Social Anthropology, 5 of literature in indigenous languages and 30 different titles on indigenous issues.

Number of libraries; 1 "indigenous Mexico."

Cultural events: Between 2007 and 2011, there were 646 cultural events spread with an estimated attendance of 130 000 people, with the aim of contributing to the dissemination of cultural wealth.

#### Attorney General of the DF (PGJDF)

The agreement A/008/07 PGJDF issued by establishing the Public Ministry in Specialized Care for Indigenous Peoples, whose competence is the integration of the previous investigations in which a person is related to belonging to any people or indigenous community, which has bilingual staff trained on the rights of indigenous peoples, cultural diversity and indigenous legal systems. As part of the "Days of the Rights and Youth, Your Rights, Your Responsibility" on July 30, 2010, a meeting was held with 112 service providers of the institution, where the main theme was the Cultural Diversity. The Vocational Training Institute offered the course "Cultural Diversity and Anthropological Expertise", from 4 to November 18, 2011, by which provided methodological and cognitive tools needed to understand the cultural diversity of the peoples of the country through translation and interpreting reliable and anthropological expertise to be used during the integration of the preliminary investigation.

#### National Pedagogic University (UPN)

For the preparation of this report were considered in the following Education Programs: Bachelor of Indian Education (LEI), Bachelor in Early Childhood Education and Elementary Education Environment Indigenous (LEP and LEPMI), Specialization in Gender and Education. They also took into account the reports of the Academic Area of Diversity and Interculturalism on the activities of the forums I and II for the Promotion of Cultural Diversity, Education and Linguistics (2008 and 2011), the Boards of Expression of Cultural Diversity organized by the students of the LEI, the National Congress of Indigenous and Intercultural Education, University Inclusion Days, Meetings of Masculinity, the Forum for Education and Youth and Adult Program Support for Indigenous Students supported by ANUIES.

The results were: awareness of the university community to different cultural expressions of indigenous peoples, youth, adults, sexual minorities, the growth of enrollment in educational programs for indigenous education and gender, external assistance wide forums and events issues of diversity, organized by the UPN and linkage with various bodies and educational institutions, NGOs and cultural groups related to sociocultural and linguistic diversity.

#### University Program Mexico Multicultural Nation-(PUMC / UNAM)

Their projects focus on research, teaching and training, dissemination, communication and publishing, and international relations, and multicultural information systems.

Research Matters are, to date: the states of economic and social development of indigenous peoples of Mexico, the Index of Social Development of Indigenous Peoples of Mexico (IDSPIM), the impact of mega development projects in indigenous and black Latin America, the analysis of monetary remittances and prospects for indigenous development, production and development of welfare indicators for indigenous peoples, the diagnosis of indigenous and Afro-Mexican companies in Mexico, the indigenous movements in Latin America, the historical situation current of black people in Mexico (its history, current population size and the struggle for constitutional recognition), immigration and cultural diversity of Mexico, traditional medicine and health indicators for indigenous peoples.

Regarding the Teaching and Training, are the System Indigenous Student Scholarship (550 fellows from 28 different ethnic groups, 92 enrolled in university courses at UNAM) and the National Multicultural Teacher Project (or enrolled in an elective 15.158 students have attended 14 schools, mostly from the UNAM). Graduates also organize courses and workshops on cultural diversity, indigenous women, and justice and pluralism, basically.

Particularly active is the area of Outreach, Communication and Publishing, which develops an intense activity that included poetry festivals and Afro-Mexican culture, courses, forums, roundtables, book and presence in print and electronic media within and outside the UNAM. The records publishing 43 books divided into three collections: The cultural diversity of Mexico (28 titles), Reports and Studies (4) and Special Publications (11). Also, the Digital Library of Mexican traditions.

With regard to the promotion, conservation and development of indigenous languages, the PUMC / UNAM conducts a series of activities on the subject in almost all of their projects and academic activities. Specifically highlight: the I, II, III and IV Poetry Festival American Tongues "Carlos Montemayor," the preparation, publication and distribution of the Dictionary of Nahuatl in the Spanish of Mexico, the Teacher Training Course in Nahuatl and the Course Nahuatl.

#### b) main challenges encountered or foreseen

Lack of economic resources to projects, activities and programs are developed in all the municipalities of consistently and long-term. Non-existence of a law for the protection of the cultural heritage in some States to regulate and accessing resources devoted exclusively to this subject.

Lack of knowledge among the population of the goals and objectives of the Convention.

In many indigenous cultural values and customs give marginal role women in decision-making and in the distribution of existing assets.

#### c) solutions found or envisaged to overcome those challenges

Establishment of a permanent register of cultural expressions and dissemination through conventions of working with civil associations. Establish jointly with the State bodies and the municipal culture, agreements or conventions of work addresses to actions for the promotion and protection of cultural expressions, will result in the production of dissemination materials directed at the population in general.

Invitation to organizations of indigenous women and institutions of the three levels of Government working with women, in order to create a space where indigenous women express issues they face daily in different social and cultural spaces.

# d) steps planned for the next four years towards implementation of the Convention and priority activities to be undertaken during that period

Disseminate the guidelines and objectives of the Convention through workshops and courses and program already provided, based on the principles of the Convention as a conceptual framework.

Monitoring and registration of the following activities:

Promoting: the realization of events, meetings, gatherings and festivals, among other activities, enabling the sharing and enjoyment of the various cultural manifestations of different groups and sectors of national society, its presentation and safeguard. Also, the opening of spaces for the dissemination of cultural expressions, as well as the social and cultural coexistence of groups and peoples, involving cultural institutions and organizations of civil society.

Dissemination: presentation at regional, municipal and State levels, of exhibitions showing the cultural diversity of peoples and communities, originating and migrants, as well as from other Nations rooted in our country, which revalued the cultural contributions of these peoples in the formation of the national society. The involvement of community groups and civil associations, through the Organization of cultural, calls meetings and competitions, the means of communication and social networks, to promote intercultural dialogue and cultural expressions in native languages, that also promote initiatives and projects aimed at production, distribution and enjoyment of cultural goods and services.

Research: the realization of conferences, meetings and forums of analysis on the elements that underpin cultural diversity, regional identity and diverse regional cultural expressions. Conducting research to update the vision on the conformation of the traits that characterize the cultural regions, local identities and national identity.
