Issues – evidence-based advocacy

Environmental groups have succeeded in positioning the issue at the top of the agenda

- Tangible threats to health and safety
- Universally accepted concepts and methodology
- Measurable evidence
- Targets and performance indicators

For the cultural lobby, the risks and benefits are largely intangible and long term

- Social inclusion through cultural participation and intercultural dialogue
- Healing in post-conflict recovery
- Personal and collective wellness.
- Social and spiritual wellbeing of indigenous peoples
- Self-identity under the influence of virtual communities

Issues – turning R&D into best practices

Culture is seen as part of the solution to social exclusion, especially with youth and disenfranchised populations.

Best practices:

- Innovative: new and creative solutions to common problems.
- Make a difference: positive and tangible impact on the targeted objectives.
- Sustainable effect: lasting change to a situation, especially through involvement of participants.
- Potential for replication: models for generating policies and initiatives elsewhere.
- Maximum efficiency: combines good planning and good execution

Issues – citizen engagement

The Hangzhou declaration can only be the first step:

- a cultural change of mentality
- individual and collective engagement
- action for change
- from the best minds and most promising youth
- Human rights are largely understood. Citizens do not need to refer to the Universal Declaration of Human Rights to recognize abuses and uphold their rights.
- The media also plays a monitoring role. Same consciousness with biodiversity and environment.
- What narrative: stories, images, abuses and injustices to serve as indicators? For citizens to claim and assess their cultural rights?
