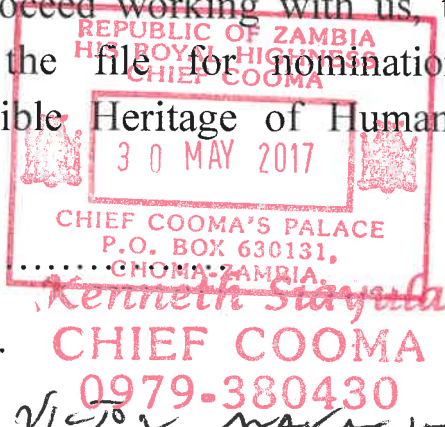

Reference is made to your letter of 20th February, 2018.

As National Museums Board we strongly support the documentation of the *Budima* Dance also known as the *Buntibe*. The dance is performed by the Tonga people of the Zambezi Valley both during funerals and happy occasions. This is one of the oldest dances in Zambia.

The construction of the Kariba Dam in the late 1950s had an impact on the performance of the dance. The dam separated the people, some remaining on the Zambia side of the Zambezi River while others went to the Zimbabwean side of the River.

It is absolutely necessary to document this dance before it loses its authenticity due to the proliferation of other dances and new musical instruments.

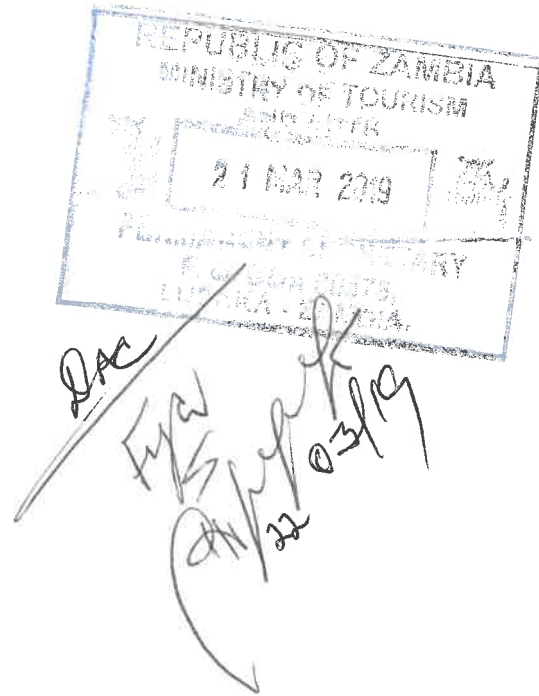
