

Leo Diaz	Immediate investigation was conducted after receiving information of the murder of Leo Diaz. The Diaz family and an eyewitness have secured a complaint affidavit and a judicial affidavit, respectively. Charges will be filed by the Philippine National Police.
Rudy Alicaway	Based on initial investigation, Rudy Alicaway was an entertainment radio commentator. It is possible that his murder was related to his work as a Barangay (Village) Councilman.

It would be highly appreciated if this information could be included in the next Director-General's Report on the issue of the safety of journalists and the issue of impunity.



Dear Mr. Berger,

I wish to provide you a copy of Administrative Order No. 1 creating the *Presidential Task Force on Violations of the Right to Life, Liberty and Security of the Members of the Media* signed by President Rodrigo Duterte on 11 October 2016.

The Task Force, mandated to ensure a safe environment for media workers, will be co-chaired by the Department of Justice and the Presidential Communications Office. Its members include the Department of Interior and Local Government, Department of National Defense, Office of the Solicitor General, Presidential Human Rights Committee, Armed Forces of the Philippines, Philippine National Police, and the National Bureau of Investigation.

The Commission on Human Rights of the Philippines and national press associations shall be invited as observers by the Task Force.

The Task Force shall undertake an inventory of cases and prioritize unsolved cases. It shall also designate a special team of investigators and prosecutors of perpetrators.

The Task Force shall receive, monitor, and take action on developments, and submit reports every six months to the President.

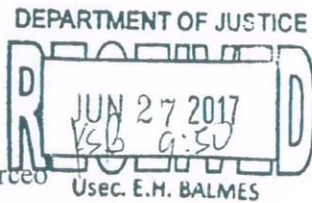
