Abstract

Open Educational Resources (OER) are learning, teaching and research materials in any form that use and apply in the public domain or are under copyright that have been released under an open license that permit no-cost access, re-use, re-purpose, adaptation and redistribution by others (UNESCO 2019). The new UNESCO OER Recommendation was announced to support the development and sharing of openly licensed learning and teaching materials, benefitting students, teachers and researchers worldwide.

Due to COVID-19 pandemic, China was the first to adopt the policy of "Disrupted Classes, Undisrupted Learning" by providing online, distance and remote teaching. However, several educational challenges appeared during this unexpected critical situation. For instance, in this first-ever application of pure long-term online learning (without face-to-face learning or blended learning), both teachers and learners should not feel that they are left alone during the teaching and learning processes. Additionally, new effective pedagogical approaches are needed to keep learners motivated and engaged during this long period of online learning. To overcome the above challenges, new teaching approaches are needed. At this time, several researchers suggested the use of Open Educational Practices (OEP) and Resources (OER) to reduce the time and cost of preparing quality-learning resources during this critical situation, as well as provide engaging and interactive open educational experiences.

On behalf of UNESCO INULRED and our co-organizer UNESCO IITE, we will co-organize an international webinar entitled "Advancing Open Educational Practice in line with UNESCO OER Recommendations during COVID-19 Pandemic". This webinar aims to explore the themes of Open Educational Practices (OEP), Open Educational Resources (OER) and distance learning during COVID-19 pandemic. It also aims to discuss the application of OEP and OER for teaching and learning remotely, hence provide guidelines to facilitate OEP and OER adoption worldwide. In this context, several experts will be invited to share their thoughts and expertise on OEP/OER.
