Last year we held 5 conferences on the preservation and promotion of traditional sports and games: Montreal (Canada, 2018), Khanty-Mansiysk (Russia, 2018), Kuwait (2018), Varanasi (India, 2018), Beijing (2018). Our innovative formula for the promotion of traditional sports and games, which allows us to overcome the lack of famous athlets and cultural isolation, makes it possible to update this part of the intangible cultural heritage. The World Series of Ethnosport Challenge tournaments consist of competitions are held according to the rules and with the inventory of local traditional games in order to preserve and develop the intangible cultural heritage of ethnic groups. The Ethnosport Challenge World Series started in 2018 and have already been held with an authentic names of events: Kulachki Ethnosport Challenge (Russia), Badang Ethnosport Challenge (Malaysia), Ilhabela Ethnosport Challenge (Brazil) and Vilnius Ethnosport Challenge (Lithuania). Continuation will follow in 2019 in Russia, India, China, Togo and Latvia.

- for the village Atmanov Ugol in Tambov Region, Russia, we spent Kulachki Ethnosport Challenge;
- for the indigenous peoples of Brazil we spent Ilhabela Ethnosport Challenge;
- for the Khant indigenous peoples of Ugra, Russia, we spent during 6 years annual International Cup of the Governor of Khanty-Mansiysk Autonomous Okrug Ugra for Oblas kayaking on the Vit Hon Hatl festive;
- for the Livs people we spent in Latvia first revivle traditional games in XX century thanks to cooperation with other Finno-Ugric peoples;
- for the the townspeople of Varanasi we sponsored two events: 1) Dangal traditional games of strongman dumbbell, naal (stone), gada (mace) and jori (spiked mace) competitions; 2) Fan-E-Sipah Gari traditional games are Hindu martial arts, consisting of competition lahti (stick fighting), pata (fire stick fighting) and baha (sword fighting).

WORLD ETHNOSPORT SOCIETY

Statutes (New Edition)

Approved on June 20, 2018 at the meeting of the Society (Minutes No. 18/06 / 20-01) in Riga, Latria.

CHAPTER 1. NAME OF THE SOCIETY AND BASIC CONCEPTS

1.1. Name of the Society.

The name of the Society is "World Ethnosport" (hereinafter - the Society). The Society is a legal entity.

The Ethnosport World Society was registered on 6 February 2012 in Montreal (Canada).

By a resolution of Board of the Ethnosport World Society of 7 June 2018, the powers of the main international organization of ethnosport is transferred to the organization registered on 3 August 2010 in Latvia and renamed as the World Ethnosport Society on 20 June 2018 by a resolution of the Society's meeting (Minutes No. 18/06 / 20-01) in Riga, Latvia.

1.2. Basic concepts.

- 1.2.1. Ethnosport is a modern folklore form of sports aimed at preservation of traditional sports and games. Thus, each ethnic group creates its ethnosport based on traditional sports and games, so it is correct to point to ethnicity for example, Russian ethnosport. The key difference from sports the division is based on ethnicity, and not on the disciplines of physical activity. It is unacceptable to appeal to a national identity uniting and levelling ethnic differences. For example, it is inadmissible to use the name "Turkish ethnosport", it is necessary to specify ethnic groups Turkic ethnosport, Kurdish ethnosport, Greek ethnosport.
 - a) Ethnosport is based on the ethnosport theory, which proves the need for valorisation of traditional sports and games in the modern society. Development of the ethnosport meets the goals and objectives of UNESCO's programs in promoting cultural diversity, intracultural dialogue and preservation of the intangible cultural heritage.
 - b) Ethnosport competitions are held:
 - outside, within the framework of public festivals and may be local or international by decision of the organizers;

- based on the rules of traditional sports and games, but with using (at the discretion of the organizers) of modern means of control and equipment adopted in the sport;
- the result of ethnosport competitions is determined by historically established traditional criteria without time scoring.
- c) Names of ethnosport disciplines are formed according to the principle of adding the word "ethno" (ethno-strongmen, ethno-wrestling, ethno-racing) to the sport through the hyphen. Translation of the ethnosport disciplines into national languages not allowed, only transcribed vocabulary of names in English is used.
- d) Ethnosport is a part of the "Sport for All" movement due to the openness and accessibility of competitions for athletes from any sports.
- e) Ethnosport Challenge World Series of Tournaments are the main games of ethnosport and are conducted everywhere on the following principles:
 - number of tournaments during the year and their location is determined by the Board of Society;
 - application for the tournament is accompanied by a letter on the support
 of the regional government and a license fee (the amount is determined
 by the Board of the Society), which is not returned if the applicant is
 given the right to organize the tournament, as well as in case of possible
 refusal to organise such;
 - all expenses for the tournament are paid by the organizing committee;
 - the tournaments are held according to the system of challenge of the team of four local participants VS the World Ethnosport team of four foreign participants invited by the Society's Board in agreement with the organizing committee of a particular tournament;
 - the Society selects the participants of the tournament from famous athletes proposed by the organizing committee and sends to them personal invitations;
 - tournament winner is a team whose members gained more wins in individual competitions;
 - the program of tournaments consists of traditional sports;
 - competitions are held according to the rules and with the inventory of local traditional games;
 - referees are appointed by the Society;
 - The Ethnosport Challenge World Series of Tournaments consists of two types of tournaments: Ethnosport Challenge Country vs World and World Ethnosport Challenge winners of Ethnosport Challenge tournaments of one year;

- The Society approves the General Regulations of the Ethnosport Challenge World Series of Tournaments. All rights to the Ethnosport Challenge World Series of Tournaments, the names of the ethnosport disciplines and the declared concept of the World Series of Tournaments reserved by the Society.
- 1.2.2. Traditional sports and games have historically evolved in a traditional lifestyle as a means of leisure; they can be of two types: a) plays without revealing the winner (for pleasure); b) competition with choosing of a winner. In the traditional lifestyle, competitions held without any organization in the modern sense. Where traditional sports and games are preserved, and they held until now, we recognize their authenticity, but only after the verification procedure, by the experts of the Society involved. Traditional sports and games are universal and in many respects similar in different ethnic groups, we classify them according to the types of competitions as follows:
- a) Traditional gymnastics and dances.
- b) Traditional races (running, swimming, canoe, kayaks, horses, camels, elephants, dogs, etc.).
- c) Traditional martial arts (traditional wrestling, fist and sticks fighting, fighting with weapons, mixed martial arts).
- d) Traditional game contests (duels and team games).
- e) Traditional logic and board games.
- f) Traditional strongman competitions in holding, lifting, pulling, racing and throwing of weights (stones, logs, bags, etc.).
- g) Traditional jumps (in length, in height, through an obstacle, using a pole, bowstring, etc.).
- h) Traditional competitions for accuracy (throwing a knife, an axe, a dart, archery, slingshot, etc.).
- 1.2.3. Traditional games are held within the traditional holidays of the solar-lunar calendar, which now represent ethno-cultural festivals with performances of folklore groups, with fairs of products of folk crafts and ethno-cuisine dishes.

CHAPTER 2. GOALS, OBJECTIVES AND ACTIVITIES

- 2.1. The main goal of the Society is to develop ethnosport in order to preserve traditional sports and games. To achieve the stated goal, the Society sets itself the following tasks:
 - 2.1.1. To create a network of organizations for the development of ethnosport in Latvia and in the world.

- 2.1.2. Carry out ethnosport activities, including the main event the Ethnosport Challenge World Series of tournaments.
- 2.1.3. Cooperate with intergovernmental and State bodies and institutions of different countries on issues related to the development of ethnosport, as well as traditional sports and games.
- 2.1.4. Cooperate with international non-governmental organizations that influence development of ethnosport, as well as traditional sports and games.
- 2.2. Activities carried out on a voluntary basis, in accordance with the applicable legislation of the Republic of Latvia, regardless of partner organizations, municipalities, and regardless of the principles of political and public institutions. The following types of activities aimed at the fulfilment of the goal and tasks:
 - 2.1.1. Management of ethnosport network.
 - 2.1.2. Holding of the Ethnosport Challenge World Series of Tournaments, as well as competitions of ethnosport disciplines and festivals.
 - 2.1.3. Development and improvement of regulations of traditional games and rules of ethnosport, along with expertise of authenticity of ethnosport and traditional games developing in ethnic groups.
 - 2.1.4. Fundraising and granting to scientific organizations and individual scientists for research in the field of ethnosport, as well as for holding international conferences.
 - 2.1.5. Educational activities to develop curricula and teaching aids, as well as seminars and master classes for managers, referees and trainers.
 - 2.1.6. Development and promotion of visualization: emblem, flag, logo of tournaments, premium attributes, growth dolls, souvenirs, etc.
 - 2.1.7. Advertising and publishing activities to promote ethnosport, including the production and distribution of printed products, audio and video content, including distribution and sale of broadcast rights to ethnosport events.
 - 2.1.8. Commercial activities, including production and marketing of goods for development of ethnosport.
 - 2.1.9. To sell and donate, change and rent, transfer for free or give to other companies, organizations and institutions equipment, inventory, raw materials and other tangible assets owned by the Society, as well as write off from the balance sheet in an appropriate manner.
- 2.1.10. Other activities not prohibited by law.

CHAPTER 3. VALIDITY TERM OF THE SOCIETY

3.1. The Society is established for an indefinite period.

CHAPTER 4. FORMATION AND USE OF FUNDS

- 4.1. The Funds of the Society consist of material, intangible and monetary resources intended for the Society's activities.
- 4.2. The resources of the Society's funds are:
 - 4.2.1. Admission and membership fees.
 - 4.2.2. Grants of the State and international organizations.
 - 4.2.3. Donations from commercial and non-profit organizations.
 - 4.2.4. Donations from private persons, including gifts, as well as property inherited.
 - 4.2.5. Revenue from activities, including income from sponsors and advertising.
 - 4.2.6. Dividends or interest received from investments.
 - 4.2.7. Revenue from the commercial use of exclusive rights to the results of intellectual activity and means of individualization.
 - 4.2.8. Other revenue received from sources not prohibited by law.
- 4.3. The Society's funds are used for the purposes and tasks stipulated by the Statutes of the Society, and for other types of activities that comply with the Statutes and the applicable legislation of the Republic of Latvia.
- 4.4. The funds of the Society are used for administrative, transportation and other expenses.

CHAPTER 5. GENERAL MEETING AND DECISION-MAKING

- 5.1. The General Meeting of members is the supreme decision-making body of the Society.
- 5.2 A summon for the General Meeting shall be sent not later than 14 (fourteen) days before the date of its holding. The summon must be sent to each member to the email address stated at the time of establishment of the Society or membership. The summon must indicate the place, time and agenda of the Meeting.
- 5.3. The General Meeting is legitimate, if all members of the Society are present.
- 5.4. All members of the Society have a right to participate in the General Meeting, and they must be present personally.

- 5.5. Each member of the Society has one vote at the General Meeting.
- 5.6. A member of the Society loses the right to vote if the General Meeting terminates his powers.
- 5.7. The General Meeting is held once a year.
- 5.8. Powers of the General Meeting:
 - 5.8.1. Amendments to the Statutes.
 - 5.8.2. Election and early termination of powers of the Board members and the Auditor.
 - 5.8.3. Approval of the annual report prepared by the President.
 - 5.8.4. Approval of the annual report prepared by the Auditor.
 - 5.8.5. Decision-making on termination of activities or reorganization of the Society.
- 5.9 Resolutions of the General Meeting on amending the Statutes, on election and remination of powers of the Board members, are adopted by more than a half of the members present.

CHAPTER 6. MEMBERSHIP

- Membership in the Society is individual, it is provided to qualified specialists who experience in organizing traditional games, ethnosport events or significant contribution to the study of gaming heritage.
- A candidate for membership in the Society must have an impeccable reputation, a recommendation from one of the members of the Society, and have experience in organizing traditional games for at least 5 years, or have experience in organizing enhancements with international participation of representatives of more than 5 countries or have scientific publications on traditional sports and games for at least 10 articles in reviewed journals or 2 monographs.
- 6.3. The Board accepts membership in the Society.
- A motivated decision of the Board must be sent to the e-mail address of the applicant on the day of the meeting.
- 6.4. Grounds for refusing admission to the Society:
 - 6.4.1. Absence of a guarantee (recommendation for the candidate) from one of the members of the Society.

- 6.4.2. Lack of sufficient experience in organizing ethnosport events or their quality.
- 6.4.3. Lack of sufficient number of scientific publications or their quality.
- 6.4.4. Activities that damage the reputation of the Society.
- 6.4.5. Cooperation with organizations in respect of which the Society's resolutions on the inadmissibility of cooperation have been adopted.
- 6.5. The applicant can file the second application one year after the refusal. The application should indicate at elimination of the causes that prevented from granting the membership of the Society.
- 5.6. Grounds for termination of membership:
 - 6.6.1. Personal application of a member sent to the Society's e-mail address.
 - 6.6.2. Failure to pay the entrance fee within 30 days of the date of the Board's resolution on its admission to the membership of the Society.
 - 6.6.3. Failure to pay the annual membership fee during the period of payment specified in the Statutes.
 - 6.6.4. Absence of activities for organization of ethnosport activities for one year without valid reasons.
 - 6.6.5. Missing the sittings of the General Meeting or ignoring electronic voting without good reason.
 - 6.6.6. Activities that damage the reputation of the Society, failure to comply with the resolutions of the General Meeting or the Board.
 - 6.6.7. Cooperation with organizations in respect of which the resolutions of the Board on the inadmissibility of cooperation have been adopted.
- Possible exclusion of a member of the Society or imposition of a disciplinary penalty shall be considered by the Board at the next meeting with a personal invitation for individual participation, which can be replaced by a written response to the Society's e-mail address. The Board shall notify the member of the Society about the resolution taken on the day of the meeting orally in case of his presence, or in a letter to his e-mail address.
- The excluded member of the Society has no right to use the name, symbols, emblem flag names or documents of the Society in its further activity.
- 6.9. The excluded member of the Society is responsible for compensation of damage and debts incurred on the Society because of his actions or omission.

CHAPTER 7. RIGHTS AND OBLIGATIONS OF MEMBERS

- 7.1. Members of the Society have the following rights:
 - 7.1.1. Participate in the management of the Society.
 - 7.1.2. Receive information about the activities of the Society, including getting acquainted with all protocols, resolutions and orders of the Society.
 - 7.1.3. Participate in all events organized by the Society, submit proposals on the development of the Society.
 - 7.1.4. Use the name, symbols, emblem, and flag of the Society, information about the awards of the Society, documents of the Society in Latvia and abroad.
- 72 Obligations of the members of the Society:
 - 7.2.1. Comply with the Statutes of the Society and implement the decisions of the General Meeting and the Board.
 - 7.2.2. Pay membership fees regularly.
 - 7.2.3. Participate in the activities of the Society.

CHAPTER 8. THE BOARD

- 8.1. The Board manages the activities of the Society and represents it.
- 82 The Board holds meetings as necessary, but at least 2 (two) times a year.
- The Board is appointed for an indefinite period and consists of 2 (two) members.
- 8.4. The Board elects the President, possibly among of the members of the Board.
- 8.5. The Powers of the President:
 - 8.5.1. Organize and manage the activities of the Society.
 - 8.5.2. Represent the Society in Latvia and abroad in relations with third parties (organizations), as well as in State bodies and institutions.
 - 8.5.3. Summon and conduct meetings of the Board and General Meetings.
 - 8.5.4. Sign the documents and letters of the Society.

16 The Powers of the Board:

- 8.6.1. Admission and exclusion of members of the Society, changes in the Statutes.
- 8.6.2. Management of the Society's property in accordance with the laws, the Statutes, resolutions of the General Meeting and resolutions of the Board itself.

- 8.6.3. Each member of the Board may represent the Society.
- 8.6.4. Issues licenses and certificates to the members of the Society.
- 8.6.5. Takes resolutions on organisation of events and approves their regulations, as well as the rules of the competition.
- 8.6.6. Takes resolutions on holding seminars for managers and referees, as well as their testing.
- 8.6.7. Takes resolutions on all activities of the Society in accordance with the Statutes, as well as other activities not prohibited by law.

CHAPTER 9. ELECTION AND TERMINATION OF THE AUTHORITY OF MEMBERS OF THE BOARD

- 9.1. The members of the Board are elected by a resolution of more than 1/2 members of the General Meeting.
- 9.2. A member of the Board does not have the right to subdelegate his powers to third parties.
- A member of the Board can be withdrawn only due to important reason. Such reason is failure to fulfil obligations or inadequate execution, inability to manage the society, damage to the interests of the Society, non-compliance or violation of the society's Statutes and/or decisions of the Board.
- 34. A member of the Board may at any time give a notice of a violation of duties of a violation of the Board.
- 9.5. Adoption of the Board resolutions:
 - 9.5.1. The Board is authorized to take resolutions if all members of the Board participate in the meeting.
 - 9.5.2. Resolutions that received more than half of the votes are considered taken. The minutes must reflect each vote of each member voting for or against the resolution.
 - 953. All resolutions of the Board are taken electronically and are kept in form of files.

CHAPTER 10. COOPERATION WITH OTHER ORGANIZATIONS

Cooperation of the Society with other organizations is based on principles of mutual recognition of leadership, mutually beneficial cooperation, aimed a molementation of the main goals and tasks.

- 10.2. The Society expresses willingness to cooperate with global organizations that promote development of ethnosport and valorisation of traditional sports and games such as the UN, UNESCO, CIGEPS, GAISF, IOC and others. The following forms of cooperation are possible:
 - 10.2.1. Associating the Society with these organizations.
 - 10.2.2. Inclusion of the Society's representatives in advisory bodies and work groups of these organizations.
 - 10.2.3. Holding of events of the Society under the patronage of these organizations.
- The Society expresses readiness for cooperation with other international organizations and establishes relations with them in form of the Memorandum of Understanding (hereinafter as MoU):
 - 10.3.1. The Society can conclude MoU with international organizations that hold a status of a legal entity, which develops traditional sports and games, or contribute to the development of ethnosport.
 - 10.3.2. The procedure of entering into MoU consists of a mutual exchange of the following documents that are sent to e-mail addresses: letter of intent, Statutes, activity description, list of proposed joint projects.
 - 10.3.3. The Society has a right to invite international organizations that have signed the MoU to coordinate activities in the field of ethnosport, as well as traditional sports and games. Refusal to agree can be the basis for termination of MoU.
 - 10.3.4. A resolution on entering into or terminating of the MoU is made by the Board, recorded in the MoU register and published on the Society's website.
 - 10.3.5. The rights of organizations that have concluded the MoU with the Society:
 - a) Participation of the representative of the organization as a permanent member of the Society's Council (See Chapter 11. The Council).
 - b) To conduct the actions coordinated with the Society within the framework of the Ethnosport Challenge World Series Tournaments.
 - Receiving material (the size determined by the Board), organizational and methodological assistance from the Society.
 - d) Use of symbols and visualization tools of the Society.
 - 10.36 Responsibilities of international organizations that have concluded the MoU with the Society are limited to the implementation of agreements and the annual reporting of activities within the MoU.
 - 1037 MoU can be terminated, in case of:

a) Absence of activities stipulated in the MoU.

b) Activities that damage the reputation of the Society.

- c) Cooperation with third organizations in respect of which the Society have adopted resolutions on the inadmissibility of cooperation.
- 10.3.8. Termination of the MoU is preceded by the Society's claim sent to the e-mail address. If changes in the activities of the MoU partner occurred within a month after receiving the Society's claim, he notifies the Society about this in an e-mail. The absence of changes in the activities of the MoU partner, as well as the lack of response, serves to terminate the MoU.
- 10.4. Efforts of the Society aimed at creating a network of ethnosport organizations, cooperation with which are carried out on the principles of recognition:
 - 10.4.1. Official recognition of the Society can be received by organizations that have the status of a legal entity, developing ethnosport, as well as traditional sports and games, at the local, regional, national, continental and world level.
 - 10.4.2. The Society can recognize international federations of certain types of ethnosport and international sports federations developing ethnosport as sport disciplines. The recognition of the Society allows the international federations to include competitions ethnosport disciplines in the program of the Ethnosport Challenge World Series Tournaments.
 - 10.4.3. The Society has a right to propose amendments to the Statutes of organizations claiming recognition. Refusal to accept amendments proposed by the Society, serves as a basis for refusal of recognition.
 - 10.4.4. The Society has the right to propose to the international federations applying for recognition, amendments to the rules of the ethnosport disciplines. Refusal to accept amendments proposed by the Society, serves as a basis for refusal of recognition.
 - 10.4.5. Organizations applying for recognition must send an application, Statutes and description of activity to the e-mail address of the Society, as well as to pay a registration fee, size of which is determined by the Board.
 - 10.4.6. A resolution on recognition or revocation us made by the Board and recorded in the register of recognized organizations, which is published on the Society's website.
 - 10.4.7. Rights of organizations recognized by the Society:
 - a) Participation of the representative of the organization as a permanent member of the Society's Council (See Chapter 11. The Council).
 - b) Advantage in nominating candidate cities for hosting Ethnosport Challenge World Series Tournaments.

c) Inclusion of local types of ethnosport (for organizations) or ethnosport disciplines (for international federations) in the program of the Ethnosport Challenge World Series Tournaments.

d) Receiving material (the size determined by the Board), organizational

and methodological assistance from the Society.

e) Use of symbols and visualization tools of the Society.

- 10.4.8. Obligations of the organizations recognized by the Society are limited to the implementation of the Board's resolutions related to cooperation with the Society and the annual reporting of activities.
- 10.4.9. Recognition of the Society may be withdrawn in the following case:
 - a) Lack of development activities for ethnosport or traditional games.
 - b) Absence of representatives of the organization at meetings of the Council of Society for one year.

c) Carrying out activities that harm the Society's reputation.

- d) Cooperation with third organizations in respect of which the Society has made a resolution on the inadmissibility of cooperation.
- 10.4.10. Termination of the recognition is preceded by the Society's claim, sent to the e-mail address of the organization. If changes in the activities of a recognized organization occurred within a month after the receipt of the Society's claim, the Society shall be notified by email. Absence of changes in the activities of the recognized organization, as well as the absence of a response, serves as a reason to derecognize.

CHAPTER 11. THE COUNCIL

- The Council formed by the Board as a permanent advisory body for preparation resolutions. The Council consists of permanent members of the Council and observers.
 - 11.1.1. Permanent members of the Council are representatives of organizations that have contractual relations with the Society (see sub-sections 10.2, 10.3, 10.4).
 - 11.1.2. Special observers of the Council can be public figures, scientists, representatives of the State bodies and institutions, international organizations, businesspersons who have experience in organizing or supporting ethnosport events and traditional sports and games.
- Members of the Council do not receive remuneration for the performance of the duties. It is allowed to compensate the expenses of the members of the Board to compensate the work of the meetings, as well as the Society's events.

- 11.3. The Board can terminate the position of any member of the Council, and the members of the Council themselves can vote for mistrust, supported by a majority.
- 11.4. Meetings of the Council are held as necessary, but not less than once a year.
- 11.5. Adoption of resolutions of the Council:
 - 11.5.1. The agenda and materials of the Council meetings approved by the Board.
 - 11.5.2. The Council may adopt resolutions at a meeting or by correspondence by e-mail. The absent person is voting within 24 hours from the dispatch of agenda items to the Council members, discussion materials and a voting questionnaire.
 - 11.5.3. Decisions of the Council are adopted as resolutions in an electronic form and are stored as files. Resolutions are considered adopted if more than half of the votes cast for them. The protocol should reflect the votes of each member of the Council in favour of or against each decision.

CHAPTER 12. AUDIT OF ECONOMIC AND FINANCIAL ACTIVITIES

- The financial and economic control over the activities of the Society is carried by the Auditor, who is elected in the General Meeting by a majority of votes with the authority for one year.
- 12.2 The competence of the Auditor:
 - 12.2.1. To give the General Meeting an opinion on the budget and the annual report of the Society.
 - 1222 Evaluate the accounting and accounting work of the Society.
 - 12.23. Make recommendations on improving the financial and economic accordes of the Society.

CHAPTER 13. LIQUIDATION AND REORGANIZATION OF THE SOCIETY

- A resolution on reorganization or termination of the Society's activities is accepted with unanimous vote from all members.
- Liquidation or reorganization of the Society is carried out in accordance with the Associations and Foundations Law of the Republic of Latvia.


Meeting with UNESCO / Tencent ODLTG Project Coordinator

President of World Ethnosport Alexey Kylasov held an official meeting with the coordinator of the UNESCO / Tencent Open Digital Library on Traditional Games Project Mrs. Qingyi Zeng, UNESCO Beijing National Professional Officer Communication and Information Sector.




