

Aigine Cultural Research Center works in the field of traditional knowledge, education, humanities and social research. Founded in 2004, the Center set a goal of studying and preserving natural and cultural heritage and diversity in Kyrgyzstan. Having started with primarily academic projects such as study and documentation of the ancient tradition of pilgrimage to sacred sites, the Center adopted Participatory Action Research approach as the main working principle of the Center. The majority of Aigine's projects are aimed at safeguarding biocultural heritage with focus on three domains a) sacred sites including its natural, spiritual, social components and dimensions, b) the great heroic epic "Manas.Semetey. Seitek" as well as small Kyrgyz epics, c) the folk music. All elements of biocultural heritage that Aigine aims to preserve comprise in themselves intangible cultural elements.

Over the course of its work Aigine came to realize that biocultural heritage can be best preserved when it is integrated in contemporary life and when stakeholders and rigthsholders manage to build meaningful collaboration. Thus, since 2007, Aigine identified two additional objectives:

Seeking points of rapprochement and interconnection among esoteric knowledge and science, nature and culture, traditions and innovations, West and East, and other experiences often seen as oppositions.

Designed to meet Center's objectives, Aigine projects have directly contributed to safeguarding intangible cultural heritage in Kyrgyzstan. Aigine has been building effective connections with both traditional practitioners and state agencies, thus bridging important stakeholders and rightsholders involved in preservation of biocultural heritage. Since 2007, Aigine have been promoting inclusion of elements of traditional knowledge on sacred sites and revived folk musical systems into formal education. Some Aigine projects contributed to safeguarding intangible cultural heritage through exposing positive potential of traditional culture in preventing conflicts in the society and empowering vulnerable social groups (e.g. disabled youth). Thus, Aigine's broader objectives aiming to preserve biocultural heritage at whole explicitly encompass an objective of preserving intangible cultural heritage.

Since 2005 till present, Aigine CRC has been conducting a study on sacred sites in all provinces of Kyrgyzstan. The study includes identification, documentation and inventory of sacred sites throughout the country. Students of local universities, «village intellectuals» and practitioners have been involved in field research in each province. Findings of the study made it possible for Aigine to define an outline of Sacred Geography of Kyrgyzstan. It contains the inventory of 920 sacred sites, which includes locations and descriptions with pictures of the places, recognized by local people as sacred or holy. Besides the inventory, the study investigated intangible cultural elements such as historical and contemporary dimensions of sacred sites, as well as, beliefs, rituals and traditional practices. The study results suggest that sacred sites in Kyrgyzstan should be considered as both natural and cultural heritage, which represents local land and indigenous culture in unity.

Aigine has been working for safeguarding a tradition of reciting the Manas epic, which is considered to be unique element of intangible cultural heritage of Kyrgyzstan. Working in close cooperation with epic chanters, Aigine has helped to build strong nationwide network of epic narrators. In last three years, Aigine has pioneered creation of a video compilation of the entire Manas, Semetei, Seitek epic trilogy recited by the contemporary epic chanters. This 67 hour-long video compilation is the first and the only video version of the entire epic trilogy ever created in Kyrgyzstan and beyond. The video compilation meets standards of modern 'digital age' and serves as a documented baseline of the current state of the contemporary epic recitation. The video compilation of the epic trilogy has been distributed free of charge among all the educational intuitions throughout the country so that students and teachers can have better access to study materials on the epic heritage. Also, the video compilation was made available on local and international video-sharing websites to contribute to preservation and promotion of the epic heritage in the Kyrgyz Republic and abroad.

Aigine sees promoting diversity to be a key component of preserving epic heritage. Thus, Aigine has been working on studying and supporting newly emerging version of the epic presented by a female practitioner. This version evoked numerous debates in the society at large at Aigine has conducted a series of workshops on mitigating contention points between male and female practitioners.

Aigine's another groundbreaking project aimed at safeguarding epic heritage was a School for Novice Manaschys conducted from 2010 to 2012. One of the main objectives of the School was to revitalize and enhance traditional mentor-apprentice system that has been lost. Over the course of the project, nine young epic reciters were recruited out of more than thirty applicants from all over Kyrgyzstan. This School gave the young manaschys a unique opportunity to meet with and learn from recognized epic chanters during few-day-long workshops three times a year. The School became a ground for sharing manaschys' spiritual experiences and improving their recitation skills. Aigine's projects contributed a great deal to a successful nomination of Manas. Semetei. Setek epic trilogy for the UNESCO ICH List.

In 2009-2014, Aigine implemented a project called En Belgi on promoting traditional musical heritage. En Belgi is music note system developed by a prominent traditional musician – Nurak Abdrakhmanov, which facilitates learning to play komuz, the folk musical instrument. The system builds on intangible traditional cultural elements such as traditional mentorship, values and practices. In 2011-2012, Aigine introduced the En Belgi system in formal education.

Senior researchers at Aigine hold advanced degrees in humanities and social sciences. Both senior and junior researchers constantly thrive to improve their research skills and expertise by combining academic research and education with applied projects. Dr.Gulnara Aitpaeva, Director and Founder of Aigine worked for a long time at the Department of Anthropology at American University of Central Asia and attended special courses on Methods in Ethnoecology at Duke University in 2007. Dr. Aitpaeva's expertise in intangible cultural heritage is built mostly as a result of her research on Kyrgyz 'small epics' and Sacred Geography of Kyrgyzstan. Dr. Kojobekova's and Cholponai Usubalieva-Grishuk's expertise based on practical experience from managing Aigine projects on cultural heritage. Other researchers such as Aida Alymbaeva (PhD student at Maxs Plank Institution, Germany) and Aibek Samakov (Master's student at the University of Manitoba, Canada) are obtaining their graduate degrees based on their previous research in Aigine and continue to work for Aigine from the distance.

Since 2005, Aigine CRC has been using PAR – participatory action research in order to preserve and promote the phenomena of intangible cultural heritage related to Kyrgyz epics, folk music, sacred sites, practices related to weather and environment, and many others. By its essence PAR demands involvement of all stakeholders, but in the first turn it requires putting practitioners, bearers and custodians in the center of a problem solving process.

Aigne has been successful in building fruitful and meaningful cooperation with traditional practitioners and local communities. For instance, a series of national and international level gatherings with the epic chanters in 2010-2014 allowed conceiving and implementing the idea of creating a video compilation of the Manas. Semetey. Seitek trilogy. En Belgi project resulted in creating informal country-wide network of music teachers, while the research on sacred sites and consecutive workshops with traditional practitioners created a basis for establishing an informal network of sacred sites' guardians.

Aigine thrives to build trust-based and long term cooperation with all its partners and prioritizes interests and needs of local communities, traditional practitioners and knowledge holders. This approach proved effectives since it fosters self-organization and strong horizontal ties among stakeholders. For example, the community of the epic reciters took a lead in identifying the list of core episodes for the video compilation and the epic chanters who were to recite each episode. The epic chanters were directly involved in video-shooting and editing of the final version.

Aigine constantly keeps communication with the members of the sacred site guardians' network. Strong ties allow Aigine to update information on sacred sites on a regular basis. Aigine's publications (more than 10 books in Kyrgyz, Russian and English) and electronic resources allow traditional practitioners to have their say. For example, trust-based and mutually respectful cooperation between Aigine and the informal network of the sacred site guardians resulted in joint attempts to lobby and advocate legal recognition of sacred sites and related intangible cultural elements




Organizational Structure of the Aigne CRC





CHARTER of PUBLIC FOUNDATION

AIGINE Cultural Research Center

GENERAL PROVISIONS

- 1.1 "Aigine Cultural Research Center" Public Foundation hereinafter referred as "the Fund" is a non-profit charitable organization established by individuals on the basis of voluntary contributions, pursuing humanistic, social, historical, cultural, educational, charitable, spiritual and other socially useful purposes.
- 1.2 The Fund is a legal entity under the laws of the Kyrgyz Republic and has separate property recorded on its balance sheet. The Fund operates in strict accordance with the applicable legislation of the Kyrgyz Republic, the Constitution of the Kyrgyz Republic, the Law of the Kyrgyz Republic "On noncommercial organizations" and other normative legal acts of the Kyrgyz Republic, international laws and the Charter of the Fund.
- 1.3 The Fund operates on the principles of self-governance, voluntary participation, rule of law, transparency, openness and self-financing. The Fund has its own balance, current account and other bank accounts in the Kyrgyz Republic and abroad. The Fund may acquire and exercise property and non-property rights, incur obligations, sue and be sued.
- 1.4 The Fund is a legal entity in accordance with the civil legislation of the Kyrgyz Republic.
- 1.5 Legal organization form is Public Foundation.
- 1.6 Public Foundation has an official name: "Aigine Cultural Research Center " Public Foundation

Full Name: "Aigine Cultural Research Center" Public Foundation

Kyrgyz: Koomduk Fond Madaniy-izildoo borboru "Aigine",

Abbreviated Name: "Aigine CRC" PF

The Fund has a seal with its name, letterhead, their own symbols and other necessary requisites.

- 1.7 Postal Address: 93-24 MKR Alamedin-1, Bishkek, Kyrgyzstan.
- 1.8 Duration of the Fund is not limited.
- 1.9 The Foundation may establish branches and representative offices in the territory of the Kyrgyz Republic, the CIS and abroad, in accordance with the legislation of the Kyrgyz Republic and the legislation of the countries where branch or representative offices are set up. Branch and representative offices of the Fund are not legal entities, endowed with the Fund's assets and operates under the provisions approved by the Fund. Head of the branch or representative appointed by the Fund and acts on the basis of power of attorney issued by the authorized body of the Foundation.

- 1.10 The Fund is responsible for its obligations with all its assets in cash, for which it can be levied in accordance with the current legislation of the Kyrgyz Republic. The Fund is not liable for the obligations of participants, and participants are not liable for the obligations of the Fund.
- 1.11 The Fund participants do not retain the rights to the contributions transferred to Fund, including property contributions.
- 1.12 Fund has the right to determine the ways of using its income, forms and size of wages for its employees.
- 1.13 Fund is not liable for the obligations of the State, and the State is not liable for the obligations of the Fund
- 1.14 Interference by public authorities or officials to the Fund activities, just as intervention of the Fund to state bodies or officials activities are not permitted except in cases stipulated by the legislation of the Kyrgyz Republic
- 1.15 Fund has the right to perform creative activities, in accordance with the legislation of the Kyrgyz Republic
- 1.16 Fund has the right to join international associations and maintain direct international connections
- 1.17 Fund is a nonprofit organization that does not seek profit in its activities. Fund carries out its activities including production without distribution of revenues, financial benefits between the founders, officers and employees of the Fund

All income from the Fund activities to be used exclusively for pursuit of its statutory goals and objectives

2. FUND'S GOALS, TASKS AND ACTIVITIES

The main objectives of the fund are:

Documentation, study and protection of Sacred Sites (Mazars) of Kyrgyzstan, creation of a map of Sacred sites in Kyrgyzstan;

Study, documentation and protection of historical, archaeological, folklore and literary heritage of Kyrgyzstan;

The study of the cultural and ethnic diversity of the peoples of Kyrgyzstan

The adaptation study of ancient cultures and peoples in modern conditions

Introduction of the Kyrgyz language and cultural heritage into formal education (the elementary, middle and high schools and universities of Kyrgyzstan)

Joint activities with various groups and NGOs to carry out Fund's goals identified in the Fund's Charter

The conservation and use of natural landscapes and resources of the country for the development of culture and education

Activities:

Conducting applied researches on various aspects of culture, education and science Conducting trainings, round tables, seminars, conferences and other activities related the mission of the fund:

Conducting joint research with practitioners, NGO, state structures of the country and from abroad:

To issue summaries and experience guidelines, exhibitions from the collected materials (posters, videos, photos, stands, slides, badges, calendars).

Conducting other activities not being contrary with the purposes and objectives of the Fund and without distribution of profits between the founders and members of the organization.

In cases established by the legislation of the Kyrgyz Republic, the individual activities will be done under a license or special permit.

The Foundation carries out other activities in accordance with the legislation of the Kyrgyz Republic.

4. PROPERTY AND ECONOMIC ACTIVITIES

Fund has the right to carry out production and business activities necessary to achieve public goals for which the Fund was established, and corresponding to these purposes in the manner determined by the legislation of the Kyrgyz Republic.

The Fund's properties are financial assets, tangible properties on the balance sheet and the property of the Fund.

The Fund uses the property for the purposes specified in this Charter

The Fund's properties constituted by:

- -property and funds transferred by the participants,
- -private donations, sponsors, public, commercial, religious and other organizations, and foundations:
- -proceeds permitted by law from production and business activities carried out in accordance with the Fund's objectives identified in the Charter;
- -long-term and short-term loans;
- -the income derived from the property of the Fund,
- -income from holding charity events, concerts, competitions, fairs, exhibitions, lectures, raffles and other events:
- -grants from organizations and institutions any form of property, international public funds, non-governmental organizations and foreign countries;
- -other income, which do not contradict to the Fund's goal and not prohibited by the legislation of the Kyrgyz Republic.

The Foundation is the owner of the property transferred by the participants to perform activities under this Charter, as well as property acquired or created by them at their own expense, including income from business activities.

The Fund is not responsible to obligations of its members, and members are not liable for the obligations of the Fund. The members have no property rights to the assets of the Fund.

Proceeds from the production and economic activities cannot be distributed among the participants of the Fund and can used only for pursuit of Fund's goals identified in the Charter. Public fund can use the fund for charitable purposes, even if it is not specified in the Charter.

4. REGULATORY BODIES

Regulatory Bodies of the Fund are:

- 1. Advisory Board
- 2. Experts
- 3. Executive Body President of the Fund (the President)

5.GENERAL MEETING OF FUND MEMBERS

General meeting of members is the highest governing body of the Fund. General meeting is competent to make decisions in the presence of all the founders of the Fund, the decision shall be deemed adopted if it receives two thirds of those present.

General Meeting of Members shall be convened at least once in six months, where decisions on the most important issues of the Fund are considered and adopted.

Exclusive competence of the General Meeting of Members is:

- Amendments and additions to the Charter and other internal regulations of the Fund.
- Making decisions on the establishment and liquidation of branches, representative offices, their approval;
- Approval of transactions with alleged conflict of interest;
- -Approval of the annual report on the activities of the Fund;
- Election and early dismissal of Advisory Board members;
- Approval of Presidential transactions exceeding the sum of 200 minimum wages at the time of pronouncement;
- Decision on the disposition of the Fund's certain type of assets;
- Approval of the Fund's financial plan and its amendments;
- President Elections and the early termination of his power;
- Approval of long-term and most important programs and Fund's major activities;
- Taking decisions on joining the Fund to other organizations and associations in the Kyrgyz Republic, as well as international organizations, if it does not contradict with the legislation of the Kyrgyz Republic;
- The General meeting of founders may transfer some issues related to its competence to other organs for the Fund's resolution. At the same time issues within the exclusive competence of the General meeting of founders are not subject for permission to transfer to other management bodies of the Fund.

6. ADVISORY BOARD

The Advisory Board is the controlling body of the Fund, which oversees:

- Fund activities;
- Taking decisions by the other bodies of the Fund and their implementation;
- The use of the fund:
- Statutory compliance of the Kyrgyz Republic's legislation by Fund;
- Fund purposes compliance, in whose interests it was created;

The Advisory Board appointed by the General Meeting of Staff Members for 3 years and consists of 3-5 members. It is led by the Chairman of the Advisory Board elected for 3 years, and presides over the Advisory Boar d's meetings.

Resolutions of the Advisory Board shall be adopted at meetings by a simple majority.

Advisory Board meetings are held when necessary but at least once a year.

Meetings of the Advisory Board are entitled if quorum is available. A quorum is the presence of two thirds of the Advisory Board members.

7.THE PRESIDENT

The President of the Fund is executive body carrying out the daily management of the Fund's activities.

The President.

President approves the organizational structure of the Fund;

- Realizes the general management of the Fund, coordinates, provides strategic direction of the Fund;
- Deals with any civil transactions and employment agreements (contracts) on behalf of the Fund;
- Performs hiring of the Fund's employees and their dismissal;
- Grants power of attorney;
- Represents the Fund to state, private, public organizations and associations;
- Defines the terms of payment and bonuses for the Fund's employees;
- Disposes of the Fund's assets determined by the Fund's General Meeting of the founders:
- The President issues orders and instructions required for all staff of the Fund within its power.
- Acts without a warrant on behalf of the Fund;
- Sets up settlement and other accounts:
- Exercises other powers that do not belong to the exclusive competence of other controls.

8. REORGANIZATION AND TERMINATION OF THE FUND ACTIVITIES

Termination of the Fund can be made only by a court decision with a statement of stakeholders in the order established by the legislation of the Kyrgyz Republic.

The court ordered the liquidation of the Fund appoints a liquidation commission, acting in accordance with the legislation of the Kyrgyz Republic with the mandatory drafting of the liquidation balance.

Assets of the Fund remaining after payments to the budget and other creditors, goes to the purposes specified in this Charter.

Reorganization of the Fund made in the order established by the legislation of the Kyrgyz Republic

In case of Fund liquidation documents aroused in the course of the Fund, shall be stored and used in accordance with the requirements of the Law "On the National Archival Fund of the Kyrgyz Republic."

общие положения.

- 1.1. Общественный Фонд Культурно-исследовательский центр "АЙГИНЕ", именуемое в дальнейшем "Фонд" является не имеющей членства некоммерческой, благотворительной организацией, учрежденная физическими лицами на основе добровольных имущественных взносов, преследующая гуманистические, социальные, историко-культурные, образовательные, благотворительные, духовные и иные общественно-полезные цели.
- 1.2. Фонд является юридическим лицом по законодательству Кыргызской Республики, имеет в собственности обособленное имущество, учитываемое на его самостоятельном балансе. Фонд осуществляет свою деятельность в строгом соответствии с требованиями действующего законодательства Кыргызской Республики, руководствуется Конституцией Кыргызской Республики, Законом Кыргызской Республики "О некоммерческих организациях", другими нормативноправовыми актами Кыргызской Республики, нормами международного права и настоящим Уставом.
- 1.3. Фонд действует на принципах самоуправления, добровольности, законности, гласности, открытости и самофинансирования. Фонд имеет самостоятельный баланс, расчетный и иные счета в банках Кыргызской Республики и за рубежом, может от своего имени приобретать и осуществлять имущественные и неимущественные права, нести обязанности, быть истцом и ответчиком в суде.
- 1.4. Фонд является юридическим лицом в соответствии с гражданским законодательством Кыргызской Республики.
- 1.5. Организационно-правовая форма Общественный фонд.
- 1.6. Общественный фонд имеет официальное наименование: Общественный фонд Культурно-исследовательский центр «АЙГИНЕ»

Полное наименование: Общественный фонд Культурно-исследовательский центр «АЙГИНЕ»,

на кыргызском: Коомдук фонд Маданий – изилдөө борбору «АЙГИНЕ»,

Сокращенное наименование: ОФ КИЦ «АЙГИНЕ».

Фонд имеет печать со своим наименованием, фирменные бланки, собственную символику и другие необходимые реквизиты.

- 1.7. <u>Местонахождение Фонда: Кыргызская Республика, г. Бишкек, мкр. Аламедин-1, д. 93 кв.24.</u>
- 1.8. Срок деятельности Фонда неограничен.
- 1.9. Фонд вправе создавать свои филиалы и представительства на территории Кыргызской Республики, стран СНГ и за рубежом, в соответствии с действующим законодательством Кыргызской Республики и стран, на территории которых создается филиал или представительство. Филиалы и представительства Фонда не являются юридическими лицами, наделяются имуществом Фонда и действуют на основании утвержденного Фондом положения. Руководитель филиала или представительства назначается Фондом и действует на основании доверенности, выданной уполномоченным органом Фонда.
- 1.10. Фонд отвечает по своим обязательствам всем принадлежащим, ему имуществом денежными средствами, на которое в соответствии с действующим законодательством Кыргызской Республики может быть обращено взыскание. Фонд не отвечает по обязательствам участников, а участники не отвечает по обязательствам Фонда.

- 1.11. Участники Фонда не сохраняют прав на переданное им Фонду в собственность имущество, в том числе и имущественные взносы.
- 1.12. Фонд вправе самостоятельно определять порядок использования своих поступлений, формы и размер оплаты труда и поощрения своих работников.
- 1.13. Фонд не отвечает по обязательствам государства, а государство не отвечает по обязательствам Фонда.
- 1.14. Вмешательство государственных органов или должностных лиц в деятельность Фонда, равно как и вмешательство Фонда в деятельность государственных органов или должностных лиц не допускается, за исключением случаев, предусмотренных законодательством Кыргызской Республики.
- 1.15. Фонд вправе осуществлять творческую деятельность, в соответствии с законодательством Кыргызской Республики.
- 1.16. Фонд вправе вступать в международные объединения и поддерживать прямые международные связи.
- 1.17. Фонд является некоммерческой организацией, не преследующей извлечение прибыли в своей деятельности. Фонд осуществляет свою деятельность в том числе производственную, без распределения полученных доходов, финансовых поступлений между учредителями, должностными лицами, работниками Фонда.

Все поступления от деятельности Фонда используются исключительно на решение его уставных целей и задач.

2. ЦЕЛИ, ЗАДАЧИ И ВИДЫ ДЕЯТЕЛЬНОСТИ ФОНДА

2.1. Основными целями Фонда являются:

описание и изучение мазаров (священных мест) Кыргызстана, создание карты мазаров Кыргызстана;

поиск, изучение и защита других (исторических, археологических, культурных, литературных) памятников Кыргызстана;

исследование культурного многообразия народов Кыргызстана;

исследование адаптации древних культур и народов в современных условиях (на примере кыргызов);

поддержка деятельности по развитию теории и практики преподавания кыргызского языка в средних и высших учебных заведениях КР;

содействие развитию культуры, образования, социальных и гуманитарных наук в Кыргызстане;

совместная деятельность с различными группами, HIIO для выполнения уставных задач;

сохранение и использование природных ландшафтов и ресурсов страны в целях развития культуры и образования;

2.2. Виды деятельности:

проведение прикладных исследований по различным аспектам культуры, образования и науки;

проведение тренингов, круглых столов, семинаров, конференций и других активных форм деятельности по направлениям, соответствующим основным целям фонда:

- «Био-культурные особенности священных мест Кыргызстана»
- «Сохранение культурного многообразия Кыргызстана»
- « Адаптация древних культурных и социальных институтов в современных условиях»
- Проблемы культурной, этнической, гражданской, религиозной идентификации народов Кыргызстана»
- Мифология и фольклор: современное звучание»
- Развитие теории и современных методик преподавания кыргызского языка»
- «Образование в современном мире»
- «Человек и окружающая среда»
- «Природа и культура»
- «Ландшафт и архитектура»
- « Современная идеология и возраждение традиций»

освещение деятельности Фонда в собственно или самостоятельно создаваемом интернет-сайте, местной печати, по местному радио или телевидению;

организация информационной сети;

проведение совместных исследований с общественными движениями республики и других стран;

выпуск сборников и методических рекомендаций по опыту работы, организация выставок из собранных материалов (плакаты, видеоматериалы, фотограции, стенды, слайды, значки, календари).

2.3. Другие виды предпринимательской деятельности, не противоречащие целям и задачам Фонда без распределения полученной прибыли между учредителями и членами организации.

В случаях, установленных законодательством Кыргызской Республики, отдельные виды деятельности осуществляются при наличии лицензии или специального разрешения.

2.4. Фонд осуществляет иные виды деятельность в соответствии с законодательством Кыргызской Республики.

3. ИМУЩЕСТВО И ХОЗЯЙСТВЕННАЯ ДЕЯТЕЛЬНОСТЬ ФОНДА

- 3.1. Фонд в порядке, определяемом законодательством Кыргызской Республики, имеет право на осуществление производственной и хозяйственной деятельности, необходимой для достижения общественно-полезных целей, ради которых создан Фонд, и соответствующей этим целям.
- 3.2. Имущество Фонда составляют финансовые средства, материальные ценности, находящиеся на его балансе и являющиеся собственностью Фонда.
- 3.3. Фонд использует имущество для целей, определенных в настоящем Уставе.
- 3.4. Имущество Фонда формируется за счет:
- -имущества и денежных средств, переданных его участниками,
- -пожертвований частных лиц, спонсоров, общественных, коммерческих, религиозных и иных организаций, фондов;

- -поступлений от разрешенной законодательством производственно-хозяйственной деятельности, осуществляемой в соответствии с уставными целями Фонда;
- -долгосрочных и краткосрочных кредитов;
- -поступлений, получаемых от собственности Фонда,
- -поступлений от проведения благотворительных акций, концертов, конкурсов, ярмарок, выставок, лекций, лотерей и иных мероприятий;
- -получения грантов от организаций и учреждений любой формы собственности, международных общественных фондов, неправительственных и правительственных организаций зарубежных стран;
- -других поступлений, не противоречащих уставным целям Фонда и не запрещенных действующим законодательством Кыргызской Республики.
- 3.5. Фонд является собственником имущества, переданного его участниками, для выполнения деятельности, предусмотренной его Уставом, а также имущества, приобретенного или созданного им за счет собственных средств, включая поступления от хозяйственной деятельности.
- 3.6. Фонд не отвечает, по обязательствам своих участников, а участники не отвечают по обязательствам созданного им Фонда и не имеют имущественных прав на имущество Фонда.
- 3.7.Поступления от производственной и хозяйственной деятельности не могут перераспределяться между участниками Фонда и используются только для выполнения уставных задач. Допускается использование общественным фондом своих средств на благотворительные цели, даже если это не указано в Уставе.

4. ОРГАНЫ УПРАВЛЕНИЯ

- 4.1. Органами управления Фонда являются:
- 1. Высший орган Общее собрание участников;
- 2. Надзорный орган Наблюдательный совет;
- 3. Исполнительный орган Президент Фонда (далее Президент).

5. ОБЩЕЕ СОБРАНИЕ УЧАСТНИКОВ ФОНДА

- 5.1. Общее собрание участников является высшим органом управления Фонда. Общего собрания участников правомочно принимать решения в присутствии всех учредителей Фонда, решение считается принятым если за него проголосовало 2/3 присутствующих.
- 5.2. Общее собрание участников созывается не реже одного раза в полгода, на котором рассматриваются и принимаются решения по наиболее важным вопросам деятельности Фонда.
- 5.3. Исключительной компетенцией Общего собрания участников является:
- внесение изменений и дополнений в настоящий Устав и другие локальные нормативные акты Фонда;
- принятие решения о создании и ликвидации филиалов, представительств, утверждение Положений о них;
- утверждение сделок в которых предполагается конфликт интересов;
- утверждение годового отчета о деятельности фонда;
- избрание и досрочное освобождение от должности членов Наблюдательного Совета;

- утверждение сделок Президента превышающие сумму 200 минимальных зарплат на момент заключения;
- решения о распоряжении определенным видом имущества Фонда;
- утверждение финансового плана фонда и внесение в него изменений;
- избрание Президента и досрочное прекращение его полномочий;
- утверждение долгосрочных и наиболее важных программ и основных направлений деятельности Фонда;
- принятие решений о вступлении Фонда в другие организации и объединения в Кыргызской Республике, а также международные организации, если это не противоречит законодательству Кыргызской Республики;
- 5.3. Общее собрание учредителей вправе передать на разрешение других органов управления Фонда, часть вопросов, отнесенных к своей компетенции. При этом вопросы, отнесенные к исключительной компетенции Общего собрания участников, передачи на разрешение другим органам управления Фонда не подлежат.

6. НАБЛЮДАТЕЛЬНЫЙ СОВЕТ

- 6.1. Наблюдательный совет является надзорным органом Фонда, осуществляющим надзор за:
- деятельностью фонда;
- принятием другими органами фонда решений и их исполнения;
- использованием средств фонда;
- соблюдением фондом законодательства Кыргызской Республики;
- соблюдением фондом целей, в интересах которых он был создан.
 - 6.2. Наблюдательный совет назначается Общим собранием участников сроком на 3 года в составе 3 членов, во главе с председателем Наблюдательного Совета избираемым сроком на 3 года, который председательствует на заседаниях Наблюдательного Совета.
- 6.3. Решения Наблюдательного совета принимаются на его заседаниях простым большинством голосов.
- 6.4. Заседания Наблюдательного совета проводятся по мере необходимости, но не реже одного раза в год.
- 6.5. Заседания Наблюдательного совета правомочны при наличии кворума. Кворумом является присутствие 2\3 членов Наблюдательного Совета.

7. ПРЕЗИДЕНТ ФОНДА

Президент Фонда является его исполнительным органом, осуществляющим повседневное руководство деятельностью Фонда.

7.1. Президент.

Президент утверждает организационную структуру Фонда;

- осуществляет общее руководство Фонда, координирует, определяет стратегические* направления деятельностиФонда;
- -заключает от имени Фонда любые гражданско-правовые сделки и трудовые договора (контракты);
- -осуществляет прием на работу сотрудников Фонда и их увольнение;
- -выдает доверенности;

- -представляет Фонд во всех государственных, частных, общественных организациях и объединениях;
- -определяет условия оплаты и премирования сотрудников Фонда;
- распоряжается имуществом Фонда в пределах определяемых Общим собранием учредителей Фонда;
- Президент в пределах своих полномочий издает приказы и распоряжения обязательные для всего персонала Фонда.
- действует без доверенности от имени Фонда;
- открывает расчетные и иные счета;
- осуществляет иные полномочия, не относящиеся к исключительной компетенции других органов управления.

8. РЕОРГАНИЗАЦИЯ И ЛИКВИДАЦИЯ ФОНДА

- 8.1. Ликвидация Фонда производится только в судебном порядке с заявления заинтересованных лиц, в порядке установленном законодательством Кыргызской Республики.
- 8.2. Суд принявший решение о ликвидации Фонда, назначает ликвидационную комиссию, действующую в соответствии с законодательством Кыргызской Республики с обязательным составлением ликвидационного баланса.
- 8.3. Имущество Фонда, оставшееся после расчетов с бюджетом и другими кредиторами, направляется на цели, указанные в настоящем Уставе.
- 8.4. Реорганизация Фонда производится в порядке установленном законодательством Кыргызской Республики
- 8.5. Документы, возникшие в процессе деятельности Фонда, в случае его ликвидации, подлежат хранению и использованию в соответствии с требованиями Закона Кыргызской Республики "О национальном архивном фонде Кыргызской Республики".
