During the 37th session of the World Heritage Committee (Phnom Penh, 2013), the **Latin America and Caribbean** community (LAC) presented the results of the 2nd Cycle of Periodic Reporting for LAC (2019-2013). In Decision **37 COM 10A**, the Committee requested the World Heritage Centre (WHC) to develop a regional Action Plan in collaboration with the States Parties of the region.

In response to Decision **37 COM 10A**, the **Regional Action Plan for Latin America and the Caribbean (PARALC), 2014-2024** was developed by the States Parties during the regional meeting in Brasilia in April of 2014, in collaboration with the WHC, Advisory Bodies – ICOMOS, IUCN and ICCROM – and the Category 2 Centres. This Plan was adopted in Decision **30 COM 10B.4** (Doha, 2014) with the objective of serving as a guide for action in the three sub-regions of LAC.

Following the regional strategy, the present *Action Plan for World Heritage in Mexico and Central America (PAMAC), 2018-2023* is the result of a reflection on the key challenges and opportunities related to World Heritage in the sub-region, and proposes a series of actions and activities focused on the principal threats and potential of the sub-region, taking into consideration the diverse realities of each country.

The *PAMAC 2018-2023* will serve as a reference for the future actions that the States Parties will need to implement in order to reach the Expected Results, which have been defined and agreed upon within a framework of sub-regional collaboration and cooperation.

The present document is an Executive Summary of the original Spanish-language version of the *Action Plan for World Heritage in Mexico and Central America (PAMAC), 2018-2023* analyzed and approved for its effective application by the States Parties conforming the sub-region of Mexico and Central America during the sub-regional meeting that took place in Zacatecas, Mexico from 23 to 25 April 2018.
