- For the 2018-2019 biennium, Dominican Republic submitted five national requests and one regional request. Two national requests were approved for a total amount of 48,000 US\$.
- 2016-2017: 4 requests were approved for a total amount of US\$83000.
- Moreover, following the rainfall caused by Hurricane Matthew in October 2016, the Dominican Republic made a request for Emergency Assistance under the Participation Programme for an amount of US\$43,250 with a view to repairing the structural damage to the Felix Moreno Marcona Primary School located in Sabana Perdida. The DG approved this Emergency Assistance project for the requested amount.
