# Call for a Short-Term Consultancy Service

## Overview of the functions of the consultancy

The Better Education for Africa's Rise II project (BEAR II) is a joint initiative of UNESCO and the Republic of Korea (RoK) to cooperate with five countries of Eastern Africa – Ethiopia, Kenya, Madagascar, the United Republic of Tanzania and Uganda – to improve the relevance, quality and perception of Technical and Vocational Education and Training (TVET) systems.

The project builds on national reforms and strategies as well as on UNESCO's existing work in the region, namely the Mahe Process to strengthen TVET in Eastern Africa, which includes recommendations to develop quality assurance mechanisms; enhance the quality of TVET teacher training; strengthen the teaching of entrepreneurship, basic and generic skills in TVET; facilitate the transition to self-employment; and develop and strengthen partnerships with the private sector. The project is also aligned with the 2030 Education Agenda and the UNESCO Strategy for TVET 2016-21. In general, the project objective is contribute to the global efforts to implement the Education 2030 Agenda and the Continental Education Strategy for Africa (2016-2025).

Polish the different documents (study report, 13 Occupational Standared, 11program curriculum, 172 unit competence Training modules prepared/developed in Ethiopia under the BEAR II project including the necessary adjustment the form and content of the document in close collaboration with the different firms and technical institutions which are produced those documents.(research document, curriculum and Training material of agro processing training program)
  - Polish different documents using the correct language/ grammatical expressions and vocabulary

in line with the UNESCO glossary of terms in TVET sector and logical order (learning taxonomy), operational flow of teaching and learning.
