They speak closely related Bantu dialects which are used and preserved through the cultural practices associated with the Kaya forests.

К.	SUMMARY PROJECT DESCRIPTION:
	The Traditions and practices associated to the Kayas in the sacred forests of the Mijikenda are diminishing from generation to generation. These practices are the codes of ethics and governance systems, traditions, rituals and practices that sustained peaceful coexistence among the Mijikenda communities. Due to changes of socialisation brought about by urbanisation, the Mijikenda left their Kaya settlement in search of employment in the sisal plantations where they abandoned their traditions and practices associated with the Kaya forests. It is these traditions and practices that protected the Mijikenda communities and guaranteed their harmonious coexistence with the natural environment and the entire ecosystem. There is therefore an urgent need to safeguard the traditions and practices associated with the Kayas peace and harmony amongst the communities.
1.	BACKGROUND AND RATIONALE
	The ancestors of the Mijikenda settled in the exclusive Kaya forests from the 16 th century where they lived as one people. The majority of them left the forests in search of formal employment in sisal plantations where they live as squatters abandoning the practices and traditions associated to the Kaya forests. This movement from the forests to the informal settlements has resulted to the loss of social fabric that held them together and they are now confronted with conflicts arising from social misunderstanding. These traditions and practices include; A) Kuhasa Koma (prayer rituals): Their prayers were directed to God and the living dead to maintain close relationship between them. The ritual involves the pouring of libation on the ground to appease the living dead as a sign of reconciliation. This practice is passed on to the younger members of the community for their protection against calamities that may befall the communities as a result of sin against the gods, the living dead or nature. B) Kuzika Lufu (Burying the dead): This is the traditional send off of the dead. During burial ceremonies, songs and dances are

performed to condemn death, unravel the secrecy and the myth surrounding it, and console the bereaved. They also educate the youth on moral life, prescribe treatment for ailments that might have caused the death, ridicule bad behaviour and social deviance. C) Kurya Chiraho (Oath taking): Oath taking is a vow taken by Mijikenda to enhance conflict resolution. The Mijikenda who are the custodians of this practice believe that a strange occurrence would befall individuals who are dishonest and a fine or penalty would then be imposed to those found guilty. This practice is used to conceal top secrets of the community and to instil good virtues and justice among community members. D) Fingo (Talisman or burial charm): The Fingo is a charm secretly buried at designated areas within the Kaya to protect the community against witchcraft, bad omen, environmental calamity and social distress. E) Kambi (Council of Elders): This is the traditional institution that oversees the day to day activities for Mijikenda community. It is the highest social and political organ in the community drawing its powers from oaths taken by the members and rituals performed to ordain them into the Kambi. The Council of Elders presides over religious ceremonies, formulates and regulates rules by consensus and administers justice. They also coordinate transfer of indigenous knowledge to young members of the community. The practices and traditions of the Mijikenda are a regulating mechanism whereby the leaders seek for the blessings of the Elders before undertaking any major decision. The practices also serve as a measure of controlling unbecoming behaviour in community since people fear curses. Some of these traditions and practices which brought people together are increasingly diminishing thus threatening the integration of the Mijikenda community and require urgent safeguarding measures and transmitted to the young generation through participation and apprenticeship as a way of taking over responsibilities from the older folk.

2. OBJECTIVES AND EXPECTED RESULTS

To conserve and enhance the unique cultural and natural heritage of the Kaya forests as well as increase the additional income of the Mijikenda community and empower them in order to ensure viability and transmission of the proposed element. At least one income generating activity will be implemented for each Mijikenda community to raise an additional income of approximately Kshs. 100,000 per month whereby 25% of the generated income will be used to support the enactment of their rituals. The enhanced income will contribute towards meeting subsistence and livelihood needs of the local communities in Kaya areas. The youth will be educated and acquainted with the traditional practices, rituals and knowledge associated to Mijikenda Kayas. The promotion, cooperation and networking amongst communities through festivals will strengthen inter-community relations. The existing information regarding the Mijikenda traditions and practices associated with Kayas will be availed to the public and put in place favourable legislative framework in support of the safeguarding measures. Increased public knowledge of the traditions and practices would be a source of pride in our heritage beyond the local village environment and this will attract foreign visitors and tourists.

3. ACTIVITIES

The activities geared to be undertaken includes bee-keeping, eco-tourism and craft, taking into consideration the specificities of each Mijikenda community. Two or three communities will be targeted each year during the implementation period. A team of the Department of Culture experts will compile the existing information on the traditions and practices of the Mijikenda associated with the Kayas to be reviewed and integrated into the National inventory. Annual community cultural festivals, inter-and intra community cultural exchange programmes and regular visits by the youth to the Kayas will be encouraged to acquaint the public with traditional practices, rituals and knowledge

associated with Mijikenda Kayas.Creation of awareness to the young members of the community will be done through the school and college set up. School and college cultural festivals will be held in conformity with the schools calendar of events. School and college visitation to the Kayas as well as school and college talk-days will be given priority. Besides these, cultural experts will be identified to give talks in schools and colleges on various thematic areas of focus with relevance to culture. Recruitment and training of the youth in knowledge and skills relevant to the conservation of the environment, and of the practices and traditions will be undertaken with respect to living treasures, oral traditions; folklore will be collected and stored in both print and electronic. Research and documentation of all the practices and traditions of the Mijikenda will also be undertaken. To promote the conservation of sacred Kayas of the Mijikenda, community guards will be employed and operational resources acquired in order to enhance conservation efforts.

4. PROJECT MANAGEMENT AND IMPLEMENTATION

4.a. COMMUNITY INVOLVEMENT:

The Kaya Council of Elders are still influential among the Mijikenda communities as custodians of the practices and traditions associated to the Kaya forests. Kaya traditional ceremonies and rituals are led by Elders, some of whom are of an advanced age as well as inadequacy of resources to undertake cultural activities and ceremonies. Due to this, there is a danger of traditional knowledge being lost as the Elders die without the opportunity to pass on their knowledge to others. Furthermore this is continually eroded among the youth by formal education, travel and employment and has a decreasing effect in the community. The Mijikenda communities will start income generating activities such as bee-keeping and butterfly-keeping in order to earn more income. In turn the community will protect the natural forest and use their earned income to hold annual cultural festivals and community cultural exchange programmes as well as educate the youth on the importance of the traditions and practices associated to the Kaya forests. Community conservation groups consisting of the youth and older members of the community has been formed to sensitize schools and colleges on the importance of safeguarding Mijikenda traditions and practices associated to the Kayas through schools and colleges cultural days and festivals, visitation programmes to the Kayas and school and college cultural talk-days, where cultural experts within the Mijikenda community can deliver talks on different thematic areas of focus on the Kayas and their traditions and practices.

4.b. IMPLEMENTING ORGANIZATION:

Department of Culture in the Ministry of State for National Heritage and Culture has District Cultural Officers based at the grassroot level with support staff to implement the project. The District Cultural Officers will be coordinated by the Provincial Director of Culture who will in turn report to the Director of Culture at the national level.

4.c. PARTNERS:

National Museums of Kenya, National Environment Management Agency and Kaya Council of Elders. The National Museums of Kenya falls under the same Ministry with the Department of Culture and has enough personnel manning the sites and monuments and are in close contact with the Mijikenda community. The same applies to the National Environment Management Agency whose staff are stretched and managing the conservation of the forests. Already the Department of Culture has formed a working committee involving the National Museums of Kenya, National Environment Management Agency and the representatives of the Kaya Council of Elders. The committee will liaise

with relevant organs of the government in the implementation of the project.

4.d. MONITORING, REPORTING AND EVALUATION:

The Department of culture in collaboration with National Museums of Kenya, NGOs, Civil Society and other stakeholders will monitor, report and evaluate the project on monthly, quarterly and annually. The monitoring and evaluation will be based on the performance targets set and an independent external monitoring evaluator will be engaged to verify the facts on the ground. The District cultural officers manning the Mijikenda region will work closely with the Council of Elders and report the progress of the respective projects.

5. CAPACITY-BUILDING, SUSTAINABILITY AND LONG-TERM IMPACTS OF THE PROJECT

5.a. CAPACITY-BUILDING:

Some of the learning and recruitment processes require ceremonies and by extension the resources to carry them out. These resources at times may lack in the surrounding communities and this situation also affects the Elder's ability to maintain cultural objects. At some sites Elders have indicated that there is a declining interest among the middle aged men who will customarily undertake an apprenticeship with the senior elders. As a result of the foregoing, the project will be geared towards raising some income to organize community cultural festivals, inter- and intra community cultural exchange programmes, and workshops where community representatives can exchange ideas and share common challenges and way forward. This will strengthen the community's effort in safeguarding the traditions and practices associated to the Mijikenda Kayas. Using local and international assistance community guards will be recruited to help in the conservation of the Kaya forest and operational resources such as vehicles will be procured to enhance conservation efforts. School curriculum will be tailored to allocate specific time periods for orienting students on cultural matters. Organisation of school cultural festival and school cultural days where the school fraternity can culture-exchange will be given preference. Students will be highly encouraged to have frequent visitation to the Kayas where they can learn and observe various cultural practices and traditions and how they can harmoniously co-exist with the environment and other communities other than their own.

5.b. SUSTAINABILITY:

The majority of the Mijikenda believes and practice the traditions associated with the Kayas. The sustainability of these traditions is depended on the fact that the Mijikenda community respects them and is committed to safeguarding them for posterity. The community in collaboration with government, civil society and stakeholders have initiated joint efforts to safeguard the traditions and practices. The various activities outlined such as bee-keeping, community cultural festivals, inter-community cultural exchange programmes and involvement of the youth will definitely lead to the sustainability of the traditions and practices associated with the Mijikenda Kayas. The Department of Culture has set aside grants to support cultural practitioners, community cultural festival and cultural exchange programmes. The Ministry of Livestock supports initiated bee-keeping projects and through Constituency Development Fund, Youth Revolving Enterprise Fund other activities will be sustained as well. The Department of Culture will train beneficiaries of the supported projects on financial management skills and encourage them to make savings in order to be self reliant.

5.c. MULTIPLIER EFFECTS:

The success of the project will be replicated in other regions with similar traditions and practices. Through inter-community exchange programmes, conservation, protection and sefeguarding measures, other communities through apprenticeship will acquire

knowledge and best practices that can promote and safeguard their own. It is foreseen that the traditions of most Bantu communities are similar and therefore the Mijikenda would find it easier to involve other Bantu communities in their community activities. Because Kenya has a uniform education system, replicability of this project within the school curriculum will be easier. Inter-school visits will enhance the transfer of most of the best practices regarding the protection and conservation of the traditions and practices to other ethnic communities. The inter-school cultural festivals will be the best vehicle for the transfer of such practices and traditions.
