REGIONAL INSTITUTE OF WORLD HERITAGE IN ZACATECAS, INSTITUTE FOR CATEGORY 2 MEXICO, CENTRAL AMERICA AND THE CARIBBEAN

Report to the 38th Session of the World Heritage Committee Doha, Qatar (15 - June 25 2014).

Report Date: March 11, 2014.

1.- Background and mandate of the Centre.

The 35th Session of the General Conference of UNESCO (Paris, 2009), approved the creation of the Regional Institute in Zacatecas Mexico, Central America and the Caribbean.

A year later, 10/34.COM/9C Decision adopted by the World Heritage Committee at its meeting in Brasilia (2010), established as the major aim of helping countries in the region in the correct implementation of the Convention, paying more attention to the main types of world heritage in the area: archaeological sites, historic towns, Native American goods, natural sites, landscapes and cultural routes.

The Agreement establishing the Regional World Heritage Institute in Zacatecas state government of Zacatecas and under UNESCO was signed on April 12, 2010, between the Government of the United Mexican States, with the principles and guidelines for the establishment and functioning of institutes and centers Category 2, sponsored by UNESCO.

The August 19, 2011, was held the first session and Installation of the Board of the Centre, which formal operations of the Institute of Zacatecas Category 2 was launched.

Subsequent to the Agreement establishing the Institute Category 2, they were observed some inconsistencies, so it was subjected to a review process by interministerial meetings in Mexico and exchange of diplomatic notes with UNESCO, to redefine the objectives and functions of the Institute. At the present date, it has pending signing of the Amended Agreement between the Mexican authorities and UNESCO.

Mandate:

- 1. Contribute to strengthening capacity building for the implementation of the Convention in the region;
- 2. Contribute to enhance international cooperation, especially between the States Parties to the UNESCO in the region;
- 3. Contribute to sustainable development by promoting good practice in the conservation and management of cultural and natural heritage;
- 4. Promoting research on natural and cultural heritage, in particular on the properties inscribed on the World Heritage List;

- 5. Contribute to the creation and dissemination of information, through the establishment of a documentation center on the property of the State on the List of World Heritage, and
- 6. Share expertise with UNESCO, especially with the World Heritage Centre and cooperate with the secretariats of other cultural and environmental conventions related to World Heritage.

2. Institutional and operational structure of the Center (Board of Directors, staff, funding operations and local)

- Governing Board: Board of Directors.
- o Personal: 7 reviewers.
- Operation of Resources: The State Government grants Zacatecas resources for the support of the Institute and other sources of funding from Federal Government contemplated, States Parties and international organizations.
- Local: Building Zacatecas State Government delivered on loan to Regional World Heritage Institute.
