2. Institutional and operational structure of the Centre (governing board, staffing, operational funding and premises)

The Lucio Costa Heritage Management Regional Training Centre is based in Rio de Janeiro at the premises of the Institute of National Historical and Artistic Heritage (IPHAN), a federal public agency that presently reports to Brazil's Ministry of Citizenship. This arrangement was established in the first agreement signed by the Brazilian government and UNESCO on 26 July 2010, and in renewed agreement signed on 13 June 2018.

The Category 2 Centre Lucio Costa was created aiming at improving the management capabilities of institutions and professionals involved in the conservation of cultural and natural heritage in the region composed of Portuguese and Spanish-speaking countries in South America (Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Paraguay, Peru, Uruguay and Venezuela), Africa (Angola, Cabo Verde, Guinea-Bissau, Equatorial Guinea, Mozambique and Sao Tome and Principe) and Asia (Timor-Leste). countries (two African Portuguese-speaking countries, Mozambique and Cabo Verde; and seven South American Spanish-speaking countries, Argentina, Chile, Colombia, Ecuador, Uruguay and Peru and Venezuela) have signed up to participate in activities at the Lucio Costa Centre.

The institutional structure of the Centre is composed by the Governing Board, the Executive Committee, the Advisory Committee and the Secretariat. The former composed by the Director of the Centre (elected by the Governing Board) and currently staffed by a team of IPHAN civil servants assigned to work with the C2C.

3. Updates on the management of the Centre – particularly on meetings of the Governing Board and key decisions adopted

The Center's Governing Board is currently chaired by the President of IPHAN and composed by representatives of all Participant States and a representative of UNESCO Director-General. Whereas the Executive Committee - as defined during the II Meeting of the Governing Board (August 2018) - is currently composed by Argentina, Cap-Vert, Chile, Ecuador and Uruguay for a mandate of 2 years. The provisions regarding the Advisory Committee are pending definition.

The Centre's budget for 2019 is USD 180,000.

The biannual work plan for 2018-2020 was adopted in August 2018 at the II Meeting of the Governing Board of the Lucio Costa Centre. Subsequently in March 2019 a meeting of the Executive Committee rescheduled the activities foreseen in the Plan. The activities for which implementation is foreseen for 2019-2020 are: a workshop on sustainable tourism/community participation(to be organized in collaboration with Colombia and scheduled for next October); a capacity building workshop on Environmental and Heritage Impact Assessments (to be organized in collaboration with Peru); a workshop for site managers of natural, mixed and serial properties (to be organized in collaboration with

Ecuador); a thematic meeting on Climate Change and Underwater heritage (to be organized and hosted by the CLC-C2C); the dissemination of the publication on Heritage Assessment related to a nomination file for a serial property "Brazilian Fortressess Ensemble"; a pilot comparative research on three world heritage historic centres: Cartagena (Colombia), Salvador (Brasil), Old Town (CapeVerde), to be developed in collaboration with Colombia and Cape Verde).

From the above-mentioned list, the first activity to be undertaken will be the workshop on sustainable tourism/community participation, which was confirmed for next October by the Ministries of Culture, and the Ministry of Commerce, Industry and Tourism from Colombia.
