(2011 - Documentos oficiales MINED)Implementación del curso de profesionalización "Maestro de educación primaria con énfasis en Educación de jóvenes y adultos" dirigido a personal técnico que labora en Educación de jóvenes y adultos; esta es la primera experiencia que se desarrolla en el país y a nivel centroamericano. Este curso se desarrolla en las escuelas Normales del país bajo la conducción, asesoramiento y acompañamiento administrativo de la Dirección de Educación de Adultos y la Dirección de Formación Docente. Para garantizar la preparación, retención y promoción de los participantes de este curso, el gobierno de Nicaragua, a través del Ministerio de Educación entrega una beca de responsabilidad compartida.
