It carries out coordination and consultation among the central government bodies, the civil society, trade unions on a national level, and employer organizations on a national level for the implementation of the national lifelong learning and adult learning and education policies. It is presided by a Deputy Minister of Education and Science. The group includes representatives of the Ministry of Labour and Social Policy, the Ministry of Economy and Energy, the Ministry of Culture, the Ministry of Youth and Sports, the Ministry of Agriculture and Foods, the Ministry of Justice, the National Statistical Institute, the National Agency for Vocational Education and Training, the Employment Agency, the Centre for Human Resource Development, representative organizations of the employers and employees on national level, non-governmental organizations, etc.: <a href="http://lll.mon.bg/?page_id=818">http://lll.mon.bg/?page_id=818</a>.
