Decision required: paragraph 3

- 1. In accordance with the Rules of Procedure of the Conference of Parties (Rule 5), the Conference shall elect a chairperson, one or more vice-chairpersons and a rapporteur. The Conference of Parties may wish to consider electing a Bureau comprising a total of six members, that is, one member from each of the electoral groups established by the General Conference of UNESCO (see Annex).
- 2. The term of office of the chairperson, the vice-chairperson(s) and the rapporteur will run from the opening of the current session until the opening of the next regular session of the Conference of Parties, when a new Bureau will be elected.
